CRIMINAL LAW AND CROSS-DRESSING

It should be noted that in many of the municipal ordinances the word "dress" is used. In the context used the word means apparel or outer clothing rather than the specific item of women's apparel defined as "a dress", although the word does, of course, encompass that specific item.

With two significant exceptions the preoperative transsexual, whose anatomical sex is incongruous with the individual's psychological disposition and preferences, there is no reason, in general, to believe the transsexual will run afoul of criminal law more often than anybody else. First, the transsexual may indeed have sexual contacts that will be regarded by unsympathetic police and prosecutors as homosexual. Second, the preoperative transsexual's more serious problem is with "cross-dressing," i.e. wearing the clothes of and generally presenting oneself to others as being of the "opposite", but desired, sex.

As of 1982, there were approximately ten states still having laws which could be construed to prohibit "cross-dressing" or "disguising" oneself as a member of the opposite sex. Many more prohibitions may be in effect at the municipal level. Consequently, regardless of State, the transsexual is potentially in danger of being confronted by law enforcement personnel.

Examples of how courts have dealt with cross-dressing can be illustrated by:

City of Columbus v. Zanders. ((1970) 266 N.E.2d 602, 25 Ohio Misc. 144, 54 Ohio Ops2d 142.)

Defendant Zanders was apprehended,

while wearing women's clothing and make-up, arrested, charged and tried under §2343.04 of the Columbus Municipal Code, which reads: "No person shall appear upon any public street or other public place in a state of nudity or in a dress not belonging to his or her sex, or in an indecent or lewd dress." The court, after receiving expert testimony that defendant was a true transsexual, dismissed the charge based on a finding that "a person is not responsible for criminal conduct if, at the time of such conduct as a result of a mental defect, he lacks substantial capacity either to appreciate the wrongfulness of his conduct or to conform his conduct to the requirements of the law."

Columbus v. Rogers, ((1975) 324 N.E.2d 563, 41 Ohio St.2d 161, 70 Ohio Ops2d 308.)

The same city ordinance as that in Zanders, supra, was held unconstitutionally vague on its face, on the grounds that it failed to give fair notice of the conduct forbidden by the ordinance and to provide guidelines to law enforcement officials charged with its enforcement. The Court noted that modes of dress for both men and women are historically subject to changes in fashion, with clothing presently being sold for both sexes which was so similar in appearance that a person of ordinary intelligence might not be able to identify it as male or female dress. Moreover, said the Court, it is not uncommon today, for individuals to purposely, but innocently, wear apparel which is intended for wear by those of the opposite sex. The Court stated that once it is recognized that present-day dress may not be capable of being characterized as being intended for male or female wear by a person of ordinary intelligence, the constitutional defect in the ordinance becomes apparent. The defect, said the Court, is that the terms of the ordinance, "dress not belonging to his or her sex", when considered in the light of contemporary dress habits is so vague that men of common intelligence must necessarily guess at its meaning and differ as to its application.

Finally, the effect that the transsexual's so-called cross-dressing could conceivably have on the public will be addressed. Although some members of the public may view the subject of transsexualism or the preoperative transsexual who appears in public in the clothing not gender-typic for the individual to be offensive, it should be pointed out that the act of wearing the clothing of the "opposite" gender is not, in and of itself, an "immoral" act. It is an act which can only be viewed with individual preference by other members of the public. "There is no evidence, however, that cross-dressing, when done as a part of a preoperative therapy program or otherwise, is, in and of itself, harmful to Society." (*Doe* supra, at 80).

*City of Cincinnati v. Adams* ((1974) 330 N.E.2d 463, 42 Ohio Misc. 48, 71 Ohio Ops2d 455.)

Defendant Adams was charged with a violation of a city ordinance prohibiting any person to "appear in a dress or costume not customarily worn by his or her sex, or in a disguise when such dress, apparel, or disguise is worn with the intent of committing any indecent or immoral act ...". Defendant, a male, was standing in a parking lot wearing a woman's wig, earrings and carrying a purse. The court struck down the ordinance on due process grounds, ruling that the law did not give the defendant fair notice of what was prohibited because of its vagueness and overbreadth. The court implied, in its opinion, that any ordinance prohibiting transvestism, unaccompanied by criminal activity or solicitation, would be unconstitutional.

*People v. Simmons* ((1974) 357 N.Y.S.2d 362, 79 Misc.2d 249.)

Defendant Simons, a male, was dressed in female clothing and, after soliciting another male for sex, stole some money from him. One charge against him was violation of a New York statute prohibiting criminal impersonation, defined as when one "impersonates another and does an act in such assumed character with intent to injure or defraud another." The court, after a lengthy discussion of definitions of the words used in the statute and other cases, concluded that the statute did not apply to this defendant because he was not impersonating but simply being himself.

*City of Chicago v. Wallace Wilson, et al.* ((1978) 389 N.E.2d 522, 75 Ill.2d 525, 27 Ill Dec. 458, 12 ALR4th 1242.)

Defendants, two preoperative male-to-female transsexuals, attired in female clothing when arrested as they left a restaurant following an early Sunday morning breakfast. Convicted and fined they appealed their case to the Illinois Supreme Court, which upheld the constitutionality of the ordinance but overturned the lower court's action, recognizing the need for cross-dressing of the preoperative transsexual undergoing treatment for eventual sex reassignment.

*Doe v. McConn* (489 F. Supp 76 (U.S.D.C. S.D. Tex. 1980).)

The court declared, in the case of preoperative transsexuals who crossdress in preparation for sex reassignment surgery, a Houston, Texas city ordinance making it illegal to appear in public areas "dressed with the designed intent to disguise his or her true sex as that of the opposite sex," unconstitutional as it was applied to the plaintiffs. The court noted that an integral part of the presurgical process requires that a transsexual wear the clothing of the gender to which reassignment is sought throughout the preoperative stage, and that the ordinance in question, therefore, directly prohibited the treatment of the transsexual plaintiffs and their reassignments. The court noted that there was no exception of defense under the ordinance for the transsexual, including those under a doctor's care. The court also pointed out that the defendants, past and present city officials, charged with the responsibility of enforcing the ordinance had not submitted evidence of a state of interest in the enforcement of the ordinance. ("Wearing dress of opposite sex", 12LR4th 1249, 1251.)

In his four page opinion U.S. District Judge Norman W. Black described, at length, the transsexual syndrome and the generally agreed upon treatment program which a presurgical candidate must follow in order to receive sex reassignment surgery, stating, "[t]ranssexualism is a rare syndrome of gender identity disturbance which appears to occur more frequently in male than female subjects. The cause of the syndrome is unknown. Treatment for

this condition in adults by psychotherapy alone has been futile. Administration of hormones of the opposite sex followed by sex-conversion operations has resulted in better emotional and social adjustment by the transsexual individual in the majority of cases. Prior to undergoing surgery, the patient is required to be seen by a team of specialists in physical and psychological medicine over an extended period of time, generally one to two years." [Emphasis added - authors.]

Judge Black continued his discussion of the treatment program, stating "To date, it has been generally agreed that the common requirement of a pre-operative period of six to twenty-four months of living and working in the gender role of choice provides the best index of judgement for eliminating non-transsexuals." The judge stated the finding indicated that the transsexual individual has not made a choice to be "... as he is," but has instead found the choice made (for him or her) as the result of numerous causes prior to and out of the control of the individual.

One of the reasons for the requirement that the preoperative transsexual live and work in the gender role of reassignment, is that this "real-life test" is presently the most relied upon indices of how well the transsexual can adjust to the demands of everyday living in the gender of reassignment. It provides the individual, as well as the treatment team, with an accurate indication of the individual's ability to function in society as a member of the opposite sex. Also, as stated by the court in McConn, supra, "[s]ince some patients presenting transsexual symptoms and desiring surgery may change their mind, a period of hormone therapy and of living in the desired gender role is strongly indicated, so that those whose motives are confused or weak may discover this for themselves through direct experience."

Thus it can be seen that "cross-dressing," as noted supra, is an integral part of the presurgical process and requires that a transsexual wear clothing of the gender to which assignment is sought throughout the preoperative stage. Said procedures are "medically and psychologically necessary" for the true integration of the body and mind throughout the transition period of the developing gender. (Doe v. McConn, supra at 79.) In fact, it is mandatory, as

surgery will generally not be performed unless the transsexual has dressed in the clothing that is gender-typic for that sex for a minimum specified period of time. Id.

State statutes or local municipal ordinances which restrict or prohibit an individual, particularly a preoperative transsexual, from dressing in the clothing usually associated with a particular gender, as seen above, can be challenged in court as impermissibly denying the individual the right to express one's gender identity, which is related to the constitutional right to privacy and the pursuit of happiness guaranteed by the Bill of Rights.

At least one court has recognized the individual's right to self-expression in their manner of dress or personal appearance, non-confined by any constitutional strictures whatsoever, is fundamentally inconsistent with "values of privacy, self-identity, autonomy and personal integrity that .... the Constitution was designed to protect." (The City of Chicago, citing Kelly v. Johnson (Marshall, J., dissenting). Moreover, the Supreme Court has recognized a constitutionally-derived right to control one's own body. (See, Roe v. Wade, 410 U.S. 113, 93 S. Ct. 705, 35 L.Ed 147 (1973); Griswold v. Connecticut, 381 U.S. 479, 85 S.Ct. 1678, 14 L.Ed.2d 510 (1965)).

In recent cases a trend seems to have developed in the use of the phrase "gender of choice". As noted in the text, the use of the word "choice" is wholly inaccurate. The true transsexual has not chosen to be transsexual — he or she just is — and will not have made a conscious "choice" to be a transsexual any more than the heterosexual individual chooses, during the early stages of sex differentiation, to be heterosexual.

Also, in recent years the use of the term "cross-dressing" has developed in cases pertaining to the transsexual. This term, when used to denote the manner in which preoperative transsexual dresses, is inaccurate. The true transsexual does not "cross-dress," as to do so, from the viewpoint of the transsexual, would be to wear the clothing of "opposite" sex, i.e., the preoperative male-to-female transsexual, since "she" feels she is already female, wears the clothing "normally" associated with the female gender, and, hence is not, as such "cross-dressing;" however, she would be if she chose to wear clothing



"normally" associated with the male gender. The same, but opposite, would be true for the female-to-male preoperative transsexual.

A note of caution is warranted in conclusion. The preoperative transsexual who is presently, or considering, wearing the clothing normally associated with the individual's gender of reassignment should be cautioned to give some thought to the activities in which the person will be involved while dressed as a member of the gender of reassignment. If you are an individual who may be involved in prostitution, etc., you should be aware that to do so while so dressed opens you up to the possibility, more likely probability, of verbal and physical assaults by either the jail staff or other inmates or both. In many States it is commonplace for judges and their staffs to be unsympathetic to the plight of the preoperative transsexual who may be making a living from such activities.

If you feel it necessary to so dress while engaged in such activities you must realize the possible consequences for such actions. It is strongly advised that if you don't want to be the target for such assaults, you do not place yourself in situations which would tend to encourage abusive behavior toward you from those within the criminal justice system with whom you would come in contact.

#### SKIN CARE, BEARD COVER FOUNDATION and FACIAL MAKE-UP by Muriel Olive

Most men have heavy beards and a rather coarse skin. Daily shaving is **very** hard on the skin and skin care should be used by **every** man (whether he dresses or not). Many men, in all walks of life, have facials regularly.



Facials are not just for women and should be considered a **must** for everyone. People who live and work before the public — public relations of any kind, who want to look their best for their job, especially to maintain a more youthful or ageless look to insure longer employment and to always look attractive to friends and for other relationships, should certainly take good care of their skin by having regular facials even if it is done secretly by special appointment with a cosmetologist or skin care specialist — many of whom have men customers.

The skin is the **first** place to show a person's age and health status. All women know this and now, I'm passing it on to you.

Make-up covers a lot, but it **doesn't** cover wrinkles, bags under the eyes and large pores very well. It is as essential to take care of the skin from the inside with good nutrition as the outside with cleansing, toning and lubricating on a daily basis.

Skin care is essential under **all** make-up; especially if it is opaque and applied heavily enough to cover a heavy beard shadow or other skin flaws. **All** make-up is rough on the skin as it tends to clog the pores. The more facials one has the better the skin and the more perfect the make-up looks. Women's skin is not as coarse as men's, but they certainly **do** get wrinkles and have large pores and other flaws. As a rule, however, women's skin is much finer and make-up can cover her wrinkles and pores much better but, she still needs facials. So, if one wants to look like a woman one **must** do what a caring woman does.

Skin care can be broken down into three basic procedures on a daily routine:

1. cleansing. 2. toning. 3. lubricating.

**CLEANSING:** Use specially formulated preparations for the cleansing of the skin. **Never use soap of any kind.** On the occasions when you are wearing eye make-up, remove same with preparations specifically made for this purpose. (The most efficient and thorough is Revlon's 30 Second Eye Make-Up Remover). It's a good practice to follow this step with a liquid "soap" (as opposed to regular bar soap).

**TONING:** is meant to stimulate the circulation of the blood vessels, firm the skin's pores and create a bacteriostatic condition, as well as remove any remaining oil lingering on the skin's surface. **Never use around eyes.**

Toning the skin is essential. Regular skin care will also prevent excessive oiliness. Excessive perspiration of the upper lip can be controlled by using an anti-perspirant in that area **under** the make-up. It is important to understand that "fresheners" are used on normal or dry skin while "astringents" are used on oily complexions. Also, the use of a freshener or astringent for an after-shave lotion is far more gentle than any after-shave preparation.

**LUBRICATING:** The purpose of this step is to condition the skin, and by this step, moisture as well as necessary oils are replenished. Moisturizer is used to conserve or replenish water content in the skin's cells. Many oily complexions suffer from surface dryness because of cell dehydration — although there may be an underlying excessiveness of oils; therefore, oily skins need moisturizing like any other complexion would.

At bedtime a fine-textured and light night cream should be used. Night creams function as restoratives — for while the body repairs itself during the night, the skin is repaired too. Night cream is a vital part of your skin care program and is as necessary to the oily skin as to the dry. Night creams also are made to augment the skin's natural oils and should be used very sparingly, with special attention to the area around the eyes and the throat.

Once a week your skin care program should include a deep-cleansing and conditioning. The various types of treatment pro-

ducts for the skin fundamentally are made to slough off dead cells clinging to the skin's surface and absorb the embedded debris, and finally to firm up the skin's structure. The steps **must** occur in their proper sequence:

1. cleanse. 2. steam. 3. exfoliate
4. re-surface. 5. tone. 6. lubricate.

**STEAMING:** is a very simple procedure which is done by allowing hot steam to bathe the face from a running tap or pan of hot water. When the face is heavily perspiring, the pores are open as widely as they can be, allowing all the impurities to be unlocked from deep within the pores. A wonderful way to enhance the activity of the steaming/sauna is to use Gaylord Hauser's "Swiss Kriss", following the simple directions. This is an herbal mixture which is very stimulating and therapeutic.

**EXFOLIATING:** is generally done with a gritty or grainy product. **Never use around the eyes. Be absolutely certain to work it around very gently** and pay particular attention to the creases around the nose and the general T-zone (across the forehead and down the center of the face and around the chin).

**RE-SURFACE:** Both of this and the above heading are interchangeable. Because the sophistication of today's treatment preparations is such most of the available products — a huge array — tend to overlap in these two functions. To make your new skin treatment program easier, just think of re-surfacing and exfoliating as **one** step utilizing two separate products.

Masks will "re-surface" the skin (as the sloughing products do, also) better than any other preparation. They are available in various forms — peel-off types, clay, lotions, foams, etc. As a general rule-of-thumb peeling types are the most effective in removing completely dead cells, while the clay types are more efficient in absorbing the deep-down grime and impurities.

Lotions, creams and foams are more stimulating to the circulation. All are intended to make the walls of the pores more firm, therefore causing a tighter appearance to the skin and giving a smoother, firmer and softer surface and brighter, clearer translucence to the natural glow of the complexion.

\*\*\*\*\*

A terrific opaque foundation that does a great job in transforming a bearded shadow area into a smooth illusionary transparent women's complexion is Covermark. This product was created by Lydia O'Leary to cover a hideous, flaming "port wine stain" birth mark covering all of one side of her face from chin to forehead. With the help of a chemist, after many experiments using a variety of ingredients she discovered the wonderful formula for a **creamy** foundation cream which would completely cover and disguise the disfiguring birth mark so no one could possibly detect it. Little did she realize she also discovered the perfect disguise for a dark grey "beard shadow" that would disfigure a woman's face if she were actually a man. Now, thanks to Lydia and her wonderful line of foundation cosmetics "his" skin can pass for "her" skin. It can be set with powder for a soft matte finish and is actually waterproof; does not rub off on clothing and will **only** come off entirely with make-up remover. So perfect for both fantasy and reality!

### The Foundation

Pick **two** shades — one that matches the **all over** skin color and a lighter shade, perhaps 2 or 3 times lighter depending on the darkness of the "shadow".

Apply the lighter shade around the eye area, over the beard and mustache area and down to the neck — just enough to cover the shadow area. Blend the edges at the line of the skin.



Cover the rest of the face and the lighter areas with the darker shade and blend the two shades together using just enough foundation to cover and look natural. Too heavy an application will look artificial. If one has deep or enlarged pores a little heavier application should be made in that area, working the foundation down into the pores — heavy enough to make the skin smooth looking.

### Cream Rouge

Find the cheek bone by placing the forefinger along the cheek at an angle to the eye area. Apply cream rouge in a wedge shape along the cheek bone with the widest part of the wedge nearest the hairline and the narrowest part of the wedge no farther forward than the back corner of the eye.



The rouge must be blended along the edges so it fades into the surrounding complexion tones and doesn't look painted on.

### Contouring or Shading Cream

A much darker cream foundation is used for contouring the face, narrowing down jawlines, the forehead and the tip of the nose and for narrowing the width of the neck.



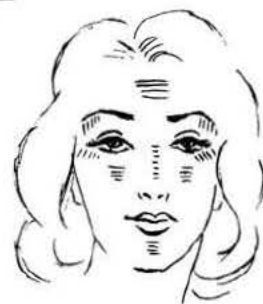
Apply as illustrated.

Blend at the edges so there is no line of demarcation. The jawline shading should connect softly at the edge of the rouge to create the illusion of a hollow cheek and narrower, feminine jawlines.

Remember: Dark colors project while light colors recede.

### Highlights

Using a very light shade of foundation cream or a foundation cream in highlighter stick form, apply highlights (as shown in the sketch at the right) on forehead, under the back edge of eyebrows, the top of cheek bone



under back corner of the the eyes, front of cheeks at edge of rouge, a straight line down the center of the nose and one the chin.

Blend **all** edges softly (Covermark Stick is excellent for highlighting as well as for covering spots of touch-ups).
