### Gloria's Report... Gloria Wright IL-1191-M

The January meeting began with Naomi asking everyone to introduce themselves and to relate where they were 10 years ago, and where they heped to be 10 years from now. There were many interesting responses, with the majority saying that they were in the closet back then, and hoped to either be the same as now or "progress" over the next 10 years.

Naomi stressed that crossdressing in not illegal in Illinois.

Naomi is attempting to arrange outings to the Pheasant Run Theater for the La Cage Aux Folles performances, to be held January 26-May 19 (Cost is \$28-35 per); and the Le Ballet La Trockadero, in Skokie to be performed Feb 23 & 24 (Cost is \$20-22 per). We all know about La Cage Aux Folles and the plan is that we'd go "en femme". Naomi's feet are a little bit cold about the ballet, and I'll bet you a pair of panty hose that the "uniform of choice" will be male attire unless our pewers of persuasion win out.

Mariette Pathy Allen's book, <u>Transfermations</u> is out! It can be procured from Kroch's and Brentanno's, or ordered through IFGE (International Foundation for Gender Education). It's chock full of pictures and stories about folks like you and me.

The arrangements for the "Be All You Want To Be" weekend, to be held in Pittsburgh, PA June 5-10 are coming together well. It will be at the Sheraton Warrendale (about 15 miles north of Pittsburgh). This event will have a square dance (we promise), appearance seminars, a boat cruise, a seminar on the history of crossdressing, sessions on photography, and a bunch of other neat stuff for your crossdressing pleasure. Flyers on this event will be sent to you soon.

The IFGE Convention, to be held near Boston, MA March 27 - April 1 is another event chock full of fun and business stuff for those of us who like those things.

The officers of Chi Chapter finally decided what to do with the monies collected from "Charitable Night". You may recall that tons of clothing, toys, and the like were collected. Well, those things were donated to the Brown Elephant Resale shop. The proceeds of sales from that shop go to help AIDS patients at the Howard Brown Memorial clinic in Chicago. We also sold clothing and got cash donations. We decided to split the money (\$110.00) equally between the IFGE general fund, and Wally Phillip's Neediest Kid's Fund. Deanna will handle the details.

Naomi next announced the formation of a Tax Committee, composed of Mary Ann and Carole, to investigate our obtaining a tax exemption status, so that donations to our chapter can be tax deductible.

We next had a rather spirited discussion about by-laws, and the reception ideas about the chapter receive.

First and foremost we unanimously approved duties for the five officers. Those duties are:

PRESIDENT: Shall preside at all

chapter meetings and/or activities and serve as an ex-officio member ( all committees. The President will t responsible for securing, preparing and opening the chapter meeting room

**PROGRAM VICE-PRESIDENT:** Sha be responsible for securing suitabl guest speakers or programs for chapte meetings, and performing all duties c the President in her absence. Th Program Vice-President shall b responsible for providing suitabl refreshments for chapter meetings an activities (but not the cost thereof).

**RECORDING VICE-PRESIDENT** Shall be responsible for taking th minutes of all regular meetings an maintaining the chapter library. Eac year the Recording Vice-Presiden shall be responsible for publishing "Year in Review" summary of chapte activities for inclusion in the chapte newsletter.

OUTREACH VICE-PRESIDENT Chairs the Membership Investigatin Committee and shall be responsible fo securing and welcoming new member: to the chapter.

SECRETARY/TREASURER: Sha publish the chapter newsletter maintain an accurate membershij roster, conduct all correspondence receive all monies payable to the chapter, and disburse funds in paymen of obligations incurred and authorize by the chapter. A report of chapte meetings and activities, and financial report of chapter funds shall be made in each issue of the chapte newsletter. In addition, an annua chapter financial report shall b published in the February issue of the chapter newsletter.

That, in a nutshell, is what we agreed to at the meeting. What's really new is that now when we elect officers, we know what they're supposed to do, and how to tell if they did it or not. Also, if you've ever wanted to actively participate in the chapter, you now know what you'd be getting yourself involved in.



Personally (If you'll just allow me to step onto my soapbox here) I think working in the chapter can be an exciting and energiaing experience. I'm not the only officer that's just a joy to work

with. There is a lot of fun doing the things that make the chapter successful. And there's the recognition that comes with performing these tasks. So even though some people have described this stuff as a chore, I beg to differ. And I have unwavering faith in you out there. I've stuck my neck our saying that we have talented and energetic people out there dying to show what they can do if just given the chance. Please don't let me down. Think about what you'd like to do for the chapter, or who you think would make a great officer, and encourage that person to run. The more of you out there who participate, the more exciting our group will be.

Things next got a little excited, with some difference of opinion about how receptive or leadership has been to assistance and suggestions from the floor. ## Naomi's Notes...



Since we are entering a new decade I asked each person the at January meeting to comment on his crossdressing level

ten years ago, in 1980, and where he hoped to be ten years from now. Except for a handful of "old timers", few of those in attendance knew of TRI-ESS in 1980. In fact, most of our current members were not even "out of the closet" in 1980. With regard to the future, most of us hoped for better public acceptance, improved support from family members, and an opportunity to attend Chi Chapter meetings (even if it meant being rolled into the meeting in a wheel chair!) Reflecting on these comments there is much food for thought.

I look back at 1980 with a sigh of relief! Fortunately, Chi Chapter today is significantly different - and better. As Deanna pointed out in her January newsletter comments, we had, in 1980, members who had unusual interests. Her example, the member who brought the four hookers to a meeting, also had a reputation for visiting sleazy bars and hangouts dressed only in lingerie (bra, panties, garter belt and hose) and a raincoat. This femme flasher delighted in shocking people with her appearance. I am told that when she appeared that way at a meeting the few wives who were there fled in horror and most of the other members felt extremely uncomfortable. The result was that the chapter decided that an "appropriate" appearance was necessary to attend chapter events. This included suitable apparel, feminine hair styles, no mustaches, etc. This is one change for the better.

In 1980 chapter meetings were usually



held at a member's home under the tightest security. Originally, prospective Chi Chapter members could not attend a chapter meeting until after they joined TRI-ESS; had subscribed to <u>Transvestia</u> magazine for at least two years; and were privately interviewed and approved by a Chapter

leader. These barriers to entry were significant and scared away many good

sisters who we really needed, and who really needed us. Although we are still discreet in our solicitation of members the procedure today is more relaxed and with much less paranoia. Most prospective members contact us by letter or telephone. 'We sent them information about TRI-ESS and if they are interested we invite them to attend up to three meetings before making a decision to join. Another change for the better.

Once in a while we did have meetings at at motel but the motel management was never told in advance what kind of group we were. The procedure was for a member to go to a motel and rent a suite under an assumed name for a reunion of his old army buddies. I remember when one, now demolished, motel told us never to come back after one of our members shocked the desk clerk when she went to the lobby while crossdressed to buy a pack of cigarettes from a vending machine. The motel management, not knowing who we were or what we were doing, suspected the worse. In 1982, I recall when we rented three apartments for a weekend at a Michigan resort without telling management the nature of our group. They found out guite by accident when the maid walked in one of the apartments while one of the members (dressed only in panties and a bra) was shaving at the bathroom mirror. The maid fled and we never went back there again.



There were a few of us in the early 1980's who thought our meetings should be something more than

sneaking into an unsuspecting motel or sitting around someone's kitchen table behind locked doors and closed shades. Gradually we began having a regular agenda and a program with guest speakers at our meetings. We met at a dive "drag" bar that is now out of business (I could tell you a few stories about that place!) until we were lucky enough to find the Midway. I remember having a meeting with the Midway staff in 1984. I showed up in my best "lawyer's" suit and showed them pictures of our group. (Fortunately, our femme flasher was long gone by that time.) I talked openly about our group,

told them who we were and what went on at a meeting, and persuaded them to let us have our meeting room on a regular basis.

Who would have thought in 1980 that we would be able to have open conventions, awards banquets, Christmas parties, fashion shows, and



meetings at respectable places like the Midway, or the Sheraton International, or the O'Hare Plaza Hotel? Over the past several years we have had three outings to the Candlelight Dinner Playhouse. In 1980 I don't think anybody even dreamed of doing that. "We originated the "BE ALL..." weekend which in seven years has grown to be the biggest, best organized, most successful weekend of its type, anywhere. To use the vernacular of advertising: "We've come a long way, baby!"

In 1983 Leslie and Mary Ann Broer appeared on Donahue and Lappeared on the David Suskind Show. Since then, Deanna and Rhonda have been on Donahue and I have been on Sally Jesse Raphael twice. About the same time Eve and I started our outreach program. Since then we have made over two hundred appearances on local television and radio and before college, university. law enforcement, and professional groups. Others from Chi Chapter have joined us on occasion and some of us have made appearances on their own. Each time we outreach to the public we are judged. And each time we handle ourselves with pride, with dignity, and with ability, we increase the public's knowledge of us and respect for us. Another change for the better!

Why bring all this up? Well, most of you have joined TRI-ESS in the last few years and are probably not aware of the dramatic changes in Chi Chapter. The "old timers" will tell you that in the past 6 to 8 years Chi Chapter has initiated many new activities and programs. They will also tell you that we have grown in size and in stature because we have a reputation for quality; for sound management; for carry through: for good taste; and for fiscal responsibility. In short: We are a "class" act! Yes, there is plenty room for fantasy and fun and personal growth and development, and there are many sisters and their wives and partners who have not yet found us and who need our support, help and understanding, but let's not forget that we are a highly misunderstood minority and we must do our best to earn public respect by that showing them we are decent,respectful and accomplished persons.

We come from all different backgrounds and experiences and yet we have a common bond. Let's respect the differences but work together. There are shakers, movers, and doers in this world and there are gripers. There are people who like to tear down and people who like to build. There are people who care only about their self and people who care about others. There are people who offer good ideas and never seen to be available to help implement them. Don't be a person who offers an idea (good or bad) and then gets insulted when someone else doesn't view it in the same way you do. If you really care about your sisters and about Chi Chapter and wish to build a better chapter, step forward and offer your services. I promise to bring your idea and offer to help to the attention of the Officers and let the officers as a group decide if it has merit and is feasible.

### AND NOW FOR SOMETHING COMPLETELY DIFFERENT:

Have you noticed how many crossdressing events have appeared in the entertainment section of your newspaper lately? Let me cite some examples:

The Broadway hit <u>musical La Cage Aux</u> <u>Folles</u> opened at the Pheasant Run Theater on January 26th and will be there until May 19th. Seeing this show is a must for every crossdresser. I have contacted the theater group sales manager and have told her about Chi Chapter and that we would like to attend as a group. After consulting management she contacted me and said they would be delighted to have us and that we can come "dressed". We are now in the process of selecting a date and will get back to you as soon as possible with the details. We will probably be attending on a Saturday evening in April. The regular cost for a Saturday night is \$39 for dinner and the show. Our group rate will be \$35 or \$33 if we can sell 50 or more tickets.

On February 23rd and 24th the Les Ballets Trockadero de Monte Carlo all male ballet troupe will be appearing at the Centre East Theater in Skokie. This spoof of classical ballet is guaranteed to entertain you. Rachel and I saw them perform about six years ago when they last visited Chicago. They are outstanding. Tickets are \$20 and \$22. Because of the shortness of time and the nature of the audience this show does not lend itself to coming crossdressed. In any event it promises to be a sellout. Tickets are available through Ticketmaster. Rachel and I plan to be there on Saturday, the 24th.

Also on February 24th and 25th the Las Vegas review, <u>An Evening at La Cage</u> will be appearing at the Rialto Theater in Joliet. I have never seen this nightclub type review but I understand it is pretty good. Tickets are also available through Ticketmaster.

If you saw the Friday entertainment section of the Tribune last week you would have noticed a full page advertisement for Charles Busch's <u>Vampire Lesbians of Sodom</u> which opens at the Royal George Theater on Halsted Street in Chicago on January 27th. The show stars Shante who until recently was a star at the Baton. Don't be put off by the outrageous title. The show has played in New York for five years and is a smash hit, hilarious comedy. Maybe we can get a group together for this one. (We haven't been to the Baton as a group for several years. Our friends there, including Chili Pepper and Ginger Grant, have asked me when we are coming back.)



In the movie world Rachel and I have seen <u>Back</u> to the <u>Future</u>. <u>Part II</u> which is just so-so. In the movie there is a short scene

where Michael J Fox plays his own daughter. He does a pretty good job of it. Also, in <u>Tango and Cash</u> Kurt Russell plays a scene as an undercover cop in full cocktail dress drag. We haven't seen it yet. It's supposed to be a dog movie.
