

## **Body In Drag Dredged** From Hudson

The Harbor Unit discovered the body of a young man partially clad in women's dothing floating in the Hudson River near W. 34th St. Tuesday afternoon, said 10th Precinct police.

According to police, the man was wearing high-heels and a wig when his body was discovered, but no identification was found. Police said that the time and cause of death were unknown.

## Mystery surrounds new pier death

Atsuko Mori, a 22-year-old Japanese woman studying English in Manhattan, last Friday took her friend's dalmatian for a walk. Like many people, she walked along the West Side waterfront. But they never finished the walk. There are still no official witnesses, but police say they believe the dog dived over the traffic barriers at the water's edge. Mori, police believe, dived in after the dog to retrieve it.

Police, and then divers, arrived and Mori was still alive when she was rescued. But she died soon after at St. Vincent's Hospital. The Medical Examiner's report, released yesterday.

says the cause was accidental drowning.

And now, on the parking lot beside the piers, as has happened before, mourners cluster. this time around an altar made of candles, bouquets and offerings on broken pilings

She was [a] very kind person," said Yasue Otsuki, a friend of Mori, after placing some food she said Mori liked on the altar.

Despite the official report, some people are still trying to figure out what happened.

'She was a good swimmer." said Marion Butler, the director of the Cambridge Schools, where Mori was studying. "The family could not

understand how this happened."

Mori's parents who arrived from Japan, Butler said, have confirmed that she swam well. Mori, police said, may have slipped or jumped in after the dog, but they say there is no evidence that anything else happened.

The water was 38 degrees," an officer for the harbor police said.

According to the harbor police, there are dozens of deaths "in the water" every year in New York City, and many people are pulled

from the water at the West Side piers. Most deaths are due to hypothermia, according to police. After a few minutes, the cold water begins to lower body temperature, people grow weak and slowly the system shuts down.

"A lot of times there are suicides there." Sgt. Edelle James, a police department spokesperson, said of other cases. "They just jump in.

One harbor police officer, who asked not to be identified, said: "If there was a fence, it'd make our job a lot easier.

So far there are no witnesses to what happened. At least one person, apparently, heard Mori once she fell in the water. They shouted for help at around 6:25 P.M. Officers Christopher DelSante and Patricia Palmer, mounted police at the time nearby in a car, responded minutes later. According to police, they put the alert over the radio, reaching 911 the harbor police and fire department by 6:34 P.M.

Police were on the scene first and got people walking dogs to provide their leashes to form acord. But apparently. Mori was unable to hold on or tried to swim unaided.

In the best possible world, maybe there could be life preservers here. But how long you think they would last?" another officer said.

The piers and the parking lots next to them belong to the State Department of Transportation. The State D.O.T. bought it for Westway, the highway that never got past the drawing board. Plans are now underway to build Route 7A there, but it is expected to be a decade before that

But the fences are repeatedly broken and as spring arrives, the crowds are beginning to grow bigger. And, as people walked along the waterfront, some talking of safety and others taking in the sun, the memorial for Mori also grew, with pickled plums and bouquets of flowers.

"She came to study movies," said Junko Henmi, another friend. "First, English."

According to Mori's application to the Cambridge Schools, she was interested in art and had studied art in Japan. She came to New York early last year, studied at the Center for English Study and then transferred to Cambridge Schools on 43rd St. She lived most recently at the Martha Washington Hotel in Gramercy Park.

After Mori's death, the owner of the dalmatian claimed the dog from the policestation. Mori's parents arrived in New York with her younger sister. The Japanese Consulate organized funeral services, which were held vesterday evening at Walsh and Cassese Funeral Home on Jamaica Ave. in Queens.
