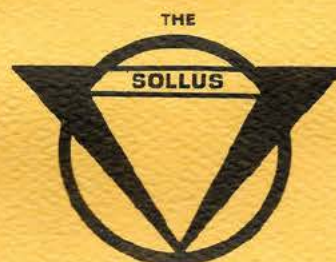

FROM CATERPILLAR TO BUTTERFLY  
by Bobbie (FL-19)

That first Success Week-end was a happy one. Husbands and wives, guys and girl-friends gathered together for a gala experience in crossdressing. There were dresses, blouses, skirts and "unmentionables" to be tried on and displayed; beauty tips and helpful hints to be exchanged. It was a delightful and fulfilling experience where men could be ladies and the attending women understood.

Toward the end of this interlude of bliss my wife, Shannon, had to go out to procure certain items of necessity at a nearby shopping center. Bobbie tagged along, but waited discreetly near the cashier's counter. There stands Bobbie; square of jaw, long wide nose, heavy masculine brows, long ear lobes, thin mouth and sagging bags under the eyes. While Shannon pays for her purchases two teeny-boppers are heard to say

"There's a man (giggle) dressed in women's clothes (giggle). Look at him! Look at him! Look at that face, at that dress. How gross!"

Shannon had the shattering experience that many wives of crossdressers may encounter -- she must join this "man in women's clothing" and walk out of the store with him.

Such an experience requires a solution. The obsession to go public was overpowering even though, obviously, Bobbie could not pass. This was not a matter of remaining in the closet permanently. The problems were great, the alternatives few and the stakes high.

Obviously, the most happy solution would be for Bobbie to be transformed into a woman in manner and appearance. This would require a fairy-godmother of extraordinary talent who could turn mice into breasts and a pumpkin into a feminine featured, mannered and sounding Cinderella. Such a fairy-godmother was found in the form of a doctor of plastic surgery and sexology. The godmother's magic wand consisted of the tools of his trade; scalpels, chisels, needles and thread plus fantastic knowledge and

skill. Bob was assured that with these tools the doctor could transform the sagging fifty+ Bob into a woman appearing to be in her forties.

This godmother, like ones in fairy tales, was authoritarian. Rules were formulated and the whole process developed in conferences with Bobbie and Shannon. A strict set of procedures were written -- in stone; four hours of fast efficient electrology per week; hormones as prescribed; intensive training in the nuances of feminine voice patterns and inflection by a speech therapist; and the most depressing provision, loose 35 pounds.

Since breast development and feminine features (arrived at surgically) will transform Bob to the extent he can no longer pass as a man how will Shannon interrelate with this situation? For Shannon's adjustment the doctor prescribes a behavior pattern that is not immediately understood by the participants. During the transitional period Bobbie will appear only on week-ends. By this means Shannon will realize he is still basically a male; moreover, all of Bob's acquaintances and neighbors will continue to interact with him as a man, at least until Bobbie takes over and Bob no longer exists.

Thus the stage is set for an exciting adventure of change from a "pot scrubber" to Cinderella - a metamorphosis about which many can only dream.

There now follows a diary of the Transition of Bobbie.  
Tuesday, January 12, 1982.

My first appointment with the doctor in Jacksonville, Fl. One hour consultation with me. Asked me to bring Shannon when I returned on Saturday the 16th.  
Saturday, January 16th.

I met with the doctor for two hours. Then Shannon was interviewed for an hour, after which the doctor agreed to undertake the monumental task of changing a very masculine appearing male into a feminine female.

An extensive physical was given, including height, weight and body measurements with pictures taken from every conceivable angle.

Both Shannon and I were interviewed together and many rules for me to follow were laid down. The object of these rules is to allow a smooth and logical transition from masculinity to femininity with the least embarrassment and complications

for the principal characters and friends and neighbors.

Saturday, February 20th.

The doctor was surprised with my progress. I've lost twenty-five pounds; a substantial portion of my beard is gone; sessions with the speech therapist have been initiated. My first surgical appointment is set for March 12th when the doctor will shorten and thin my nose, shorten the upper lip and shave the Adam's apple. It will take three or four hours to complete the procedures and I'll spend five or six days in the hospital.

I'm overjoyed. At last something is being done. The doctor also changed my hormone procedure from capsules to injections.

While waiting for March 12th to arrive I will, with the help of my wonderful Shannon, practice my new speech patterns, walking in heels, sitting, standing and the art of make-up. I'm also continuing my diet which both Shannon and I find easy to follow. Yes Shannon, also on the diet, has lost 15 pounds.

This Saturday Bob and Shannon went shopping and saw, among other things, a darling oyster jacket with navy belt and buttons, a straight oyster skirt and a navy pleated skirt, but horror of horrors it was only available in size 14. Shannon said "Buy it." I couldn't wait to get home and try it. Surprise! It fit beautifully. I was on Cloud Nine. Imagine, from size 20 to size 14. Wow!

Friday, March 15th.

Mary Lou, my speech therapist, has requested that I come to the sessions crossdressed so she can get a better perspective of me using a feminine voice. I need little persuading.

So, here I sit all dressed up waiting for the time to go. I know this will be quite an experience and I wouldn't miss it for the world. While waiting I took some pictures of myself. It will be interesting to compare these with ones I'll take post-surgically.

I've lost more weight. I'm down to 164 with only four more to go.

Friday, March 15th (8 p.m.)

Mary Lou was really surprised and impressed. She said I looked so much better than my pictures. While dressed, my voice really was more feminine and persisted in

a higher pitch. After a little while she made a notation for a modification and not thinking wrote "Have her speak more breathless". Now she wants me to dress for each session, if possible. She said, dressed, I would be much easier to work with. (Mary Lou, stop twisting my arm so.)

Thursday, March 11th.

Checked into the hospital at 3:30 p.m. and was assigned a room. After the usual tests were taken I was served the last food I would have prior to surgery.

Thursday (Midnight).

I decided to add to my diary since I can't sleep anyway. I'm very nervous, but I guess that's only natural. Doctor talked to me this evening and said he will do each segment of my transformation as soon as he feels I'm ready. Obviously he's a very careful and precise person. Also, he's quite demanding. I know he's doing this to protect me, but it sometimes is hard to follow his instructions. He's checked me into the hospital under an assumed name. I've had x-rays, blood taken, pressure and pulse taken three times and of course no food or drink. I wonder what I'll look like after tomorrow. What we ladies go through to look beautiful!

Sunday, March 14th.

I haven't been able to add anything 'til now because I've had ice packs on my face and eyes. The ice packs have to be changed every twenty to thirty minutes. My nose is packed, eyes black and blue, lip swollen and I have to breathe through my mouth. I have a two inch cut across my throat, but no soreness there unless it's bumped. Wonder of wonders, the prominent Adam's apple with which I've lived all my life is gone. Only a smooth semblance remains.

Shannon has been my nurse and stayed with me throughout. What a wonderful person. She has changed the ice packs, waited on me hand and foot and even bathed me yesterday. She left for home at 2 p.m. today but will be back Wednesday to take me home. By that time all the stitches and packing will have been removed. The doctor says I'm recuperating well and progressing well with my change to Bobbie.

Monday, March 15th.

Doctor removed the stitches and then removed the packing from my nose. I had the distinct impression he was pulling my brain out through my nose. The packing

removal has been the most painful part of the whole procedure -- so far.

Wednesday, March 17th.

Shannon checked me out of the hospital and drove me home. It is so nice to sleep in our own bed. Most of the discoloration has disappeared, but I still have quite a bit of swelling and numbness in my nose and upper lip.

Friday, March 19th.

I went in for a check-up today and the doctor asked me to stay over (in Jacksonville) and return to his office Saturday morning. He provided me with details of my transitional period. He told me some of the things to expect as a woman and how to react to different situations. (Possibly a woman would be better qualified for this.)

Monday, April 15th.

Another check-up. Still swelling and numbness in the nose and upper lip. But no discoloration. Doctor said I could expect the swelling and numbness to last six to eight months. He also said I was progressing exceptionally well and fast. My hormones were increased from one to two injections per month. He said I could begin injecting them myself. My breasts were sore twelve days or so.

Saturday, April 17th.

Shannon and I had a three hour consultation with doctor today. He is helping Shannon to cope with Bobbie. I think it's helping too. She is more understanding of me and my problems now and I'm more aware of her feelings. I'm sure, when the time comes for me to change completely both of us will be prepared for another woman to come into the house.

Doctor has scheduled my next surgery for May 28th during which he'll remove the folds of skin from over my eyes, the bags from underneath and the wrinkles from the sides.

Why am I going through all this trouble, pain and expense? Having been a closet crossdresser all my life, my children grown and gone and having such a wonderful and understanding wife I feel the time has now come for me to live out the balance of my life in the only way I want to - as a woman. Also, I have accumulated enough money and have a reasonably comfortable income so I'm not depriving Shannon of anything and I feel I should be able to spend the time and money in a way that makes me the happiest so long as it doesn't deprive Shannon of

happiness.

Since losing all that weight I have the body of a forty year old woman who has taken care of herself. My waist has gotten smaller, my hips larger and I'm now filling a 38-B bra. For the first time in my life I'm in love with my own body and feel I have something of which to be proud. With this body I don't want the face of a sixty year old topping it.

Sunday, April 18th.

A move from the old neighborhood was in order so we bought and moved into a new home on a canal where we can keep our boat right at the seawall by the back door. We had the inside walls painted, new carpeting throughout, new drapes on all the windows and sliding glass doors. Our furniture fits as though made for the new house. We just love it. There is a screened, private patio facing the canal where we plan to spend much of our time. The move may be premature in Bobbie's transition but I do have a plan.

Wednesday, May 5th.

Bobbie has been a bad girl not strictly following doctor's orders. Since she passes so much better now she has been going out quite a lot. In fact, she has been trying on ladies clothing in many of the department stores.

Mary Lou, my speech therapist, has released me and sent a good report to the doctor indicating my voice and mannerisms have become more feminine and I have gone from very male to female in only three months. She also said she was amazed that I could do it in such a short time.

Friday, May 28th.

Back to the hospital via the out-patient clinic for my eye surgery. The operation took two hours and a half. Shannon drove me home because I had to keep ice packs on my eyes.

Tuesday, June 2nd.

Doctor removed all the stitches in his office. Let me tell you, he did a marvelous job. Absolutely no scars can be seen, there is very little swelling, little pain and only a dime sized blue spot on each cheek bone. The worst part was keeping ice packs on my eyes for three days. When I did see my eyes I couldn't believe how good they looked.

Another consultation with Shannon and me is scheduled for Saturday, the 26th, when the next surgical procedure will be discussed. The frontal bone above and between my eyes will be shaved down and he will make my chin less square. After

this procedure I will have a definite feminine face. Doctor wants me to stay in Jacksonville and start living full-time as a woman, although I won't, for several reasons, have reassignment surgery but will rather simply live as a woman everywhere except the bedroom. The details are being worked out.

Electrology is progressing well and I now only shave my neck. A side-effect of the hormones is the hair on my head is growing back. I had a bald spot the size of an old fashioned silver dollar at the crown which is completely covered now and the hair at the front is filling in. My body hair is much finer and there is much less of it.

Their swing as my head turned pulled at my ears to reminded me of my feminine mode as did the tug of my garter on my hip when I sat. The swish of hose as legs crossed - ah ecstasy. It's almost pornographic to walk on plush carpets in spikes. But I must admit, it's great,

My escort arrived and came inside to get me. As we went out to his car I realized its small size would afford someone a good leg show as I got in - no matter how demurely I tried to act. Well, on with the show - what a sight it must have been. The slit skirt, the leg and gold trimmed spike heel, the black lace edged slip - wickedly pausing just for a moment as I got into the little Jaguar seat. Then we were off to a large British home in the Peak Area. My hostess, Rosemary [redacted] is a local TV. We were met

WELL, I FINALLY MADE THE TRIP

This happy woman had her surgery June 10th and I feel GREAT, both physically and mentally. I've a few tips to pass on and they go something like this:

I suggest you stay at the Columbian Hotel in Trinidad. It's right across the street from the doctor's office, comfortable, steeped in local history and best of all inexpensive. The Trinidad Motor Inn is also comfortable but somewhat higher priced.

The Day Manager, at the elegant old Columbian, Jaunita is a fabulous, sweet, kind and considerate person and will help anyone who asks.

We all know the surgery itself is expensive so I won't delve into that. What I want to suggest are a few ways to reduce your costs without sacrificing any quality.

First, take enough hormones to last until surgery and to see you home. In case you don't know, it is dangerous to take hormones during your immediate post-surgical recovery period. They sometimes cause blood clots and we certainly can do without additional complications. The doctor will give you a prescription when you leave but, if you have enough of your own to see you home you won't need to go to the considerable expense of having the prescription filled at the hospital pharmacy. In all probability you can get the same prescription filled less expensively at home. The doctor will also give you a prescription for pain pills. I suggest you have this one filled because regardless of how strong you think you are you'll need them.

You're going to need a stint for dilating. The stint costs \$250.00 at the hospital. I suggest you do what I did. I bought my stint from another post-op for half price. The hospital will sterilize it for you so there's no problem there. You won't need it after 6 to 8 weeks post-surgically so you can of course sell it when you're done with it.

Douche bags -- you'll need one -- are available from hospital supply, but here again the price is higher than your local drug store.

One thing you can't take with you is a television set -- unless you have one of those little four-inchers. The Auxiliary at the hospital will allow you rent one

from them. Perhaps you and your roommate can split the cost.

My recuperation from surgery went swimmingly and I was allowed out of bed on the seventh day. What a great feeling it was to be able to walk around again. One must remember to take it easy when first getting out of bed after such a long supine period.

Before trying to urinate post-surgically relax, drink plenty of water and do some breathing exercises. All of these things will help. It feels so natural to sit and urinate.

I know you've heard it a hundred times, but it really is necessary for you to know who you are before surgery. It's too late after they roll you into the Recovery Room. Let me tell you about an incident which occurred while I was recuperating.

Another surgical candidate arrived. I showed her my surgery and explained all about the surgery and how I felt. I found she hadn't even tried to modulate her voice or change her mannerisms. She was truly an embarrassment to the TS community, to say nothing of the professionals who recommended her/him for surgery and, I felt, a totally confused individual. Anyway, she left, wearing men's clothing, before surgery. I wonder why she had men's clothing with her. Anyway, I cannot emphasize too strongly that you live the role for the prescribed period -- I lived as a woman two years pre-surgically; find and stay with a therapist qualified in the field of gender dysphoria who knows the difference between the TV the TS, the Drag Queen and homosexual male escaping into the temporary identity of a TS because he may no longer be able to cope with his gayness.

Ask yourself, over and over, "Is this necessary for me? Is it right for me? Is it really what I want/need?"

I pray that each of you finds what you want.

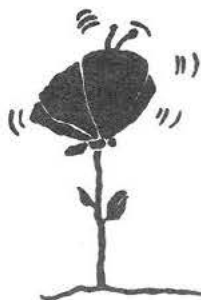
