The City of Lakes Crossgender Community is one of the oldest transgender organizations in the country. Primarily a social group, the organization also participates in educational programming and peer support for the crossgender community and its allies. Membership is open to all, with meetings held on a monthly basis in the Twin Cities area. The CLCC's newsletter is distributed free of charge to all members on a monthly basis; members also receive access to the group's community web site.
