

SEX AND GENDER



Myth: Becoming a transsexual (TS) is a matter of choice. FALSE.

While transsexuals are commonly lumped with homosexuals it is erroneous popular wisdom that choosing one's gender is similar to choosing one's sexual preference. Gender is programmed in the individual's brain prenatally and/or during the first 18 months of life. There has been no appreciable success in changing this initial polarization through psychoanalysis or other types of therapy such as aversion therapy. The syndrome is accurately described as a birth defect rather then a preference. Most transsexuals would, if given the choice, opt for being "normal" to escape the anguish entailed in transsexualism.

There is a big difference between sometimes fantasizing what it would be like to have been born a woman and suffering with the transsexual syndrome. Men. regardless of their physical appearance or sexual orientation, sometimes say they would accept the opportunity to have been born Cheryl Tiegs or Bo Derek had it been offered them, but that is a hypothetical situation. Rather, we are discussing a serious and chronic cross-gender identification. Studies reveal that more women than men would prefer to have been born the opposite sex, but that does not make them transsexuals since they know they are women and are reconciled to remain in their gender of birth for the remainder of this incarnation; and yet, paradoxically, there are many more out-of-the-closet and/or self-diagnosed male-to-female than female-to-male transsexuals.

Bearing in mind that all fetuses start out female we should, rather than saying a TS is a man who changes into a woman, say a TS is a female who failed to develop completely into a man and therefore has to be assisted, through medical intervention, back to an externally female physical state.

Myth: A TS is a male homosexual. FALSE.

Transsexualism is a function of gender-identification. A gay man has male gender-indentification. Gender-identification is distinct from sexual preference. A TS does not identify with gay men. Likewise, gay men do not like transsexuals. In the unlikely event a gay man takes a TS for another gay man he will tend to treat the TS as a male. Being so treated is most discomforting to the TS who wants, above all to be treated as a "straight" woman and likes "straight" men.

## Myth: A transsexual is a transvestite. FALSE.

The reverse, namely that transvestites are latent, undeveloped or potential transsexuals, is also false. Most popular, and any other form of, ignorance is the result of oversimplification and the failure to make distinctions. It is true both the transvestite and transsexual wear feminine clothing, but they do so for different purposes. While the transvestite often dresses for the physical pleasure of this form of fetishism he always retains or reverts back to and maintains his male gender-identity. Strictly speaking transsexual is not crossdressing when she feminine clothing. Rather transsexual is crossdressing when she wears masculine clothing to conform with Society's dress code for the physical male.

Myth: All transvestites are gay. FALSE. Another oversimplification which is, I understand, quite popular with Latin, especially law enforcement and judicial, and U.S. Customs and Immigration authorities. In fact, most transvestites are heterosexual while a small minority are bi-sexual.

Myth: A transsexual is created (manufactured) simply by lopping off the the male genitalia and replacing it with a surgically created vagina. FALSE.

Alas, another oversimplification. The only parts excised are the gonads (testicles) and the spongy inner tissue of the penis. All other tissue is reconstructed to form the female genitalia. A vagina is formed, but it is lined with the inverted penile tissue while the scrotal tissue is used to form the labia majora and minora. The results are more a reconstruction of what Nature, herself, would have used had She decided to do the job correctly rather then requiring surgical intervention to correct Her mistake. The state-of-the-art of reassignment surgery has advanced so far that gynecologists are often, at least initially, deceived by the reconstructed female genitalia and identify the post-operative TS as a hysterectomized genetic female.

# Myth: A transsexual is neither a woman nor female, but simply a feminized male. FALSE.

Some Fundamentalist Christians, conservative medical and Behavioral Science practitioners affirm this belief. However, sex and gender as not as simple as some would like to believe. It is true that some publicly known transsexuals look like partially feminized males, but the degree to which a person is a woman or female should be judged on a profile of several factors, not solely by or on outward appearance. The predominant theory is:

transsexualism is a type of birth defect and gender reassignment is its remedy.

While a TS can never be 100% female, primarily because of her lack of internal secondary sexual characteristics, she can be 100% woman and certainly 100% feminine.

Myth: A TS liking girls/women cannot be a true TS. FALSE.

Here again, gender-identification is

distinct from sexual preference. Most transsexuals are heterosexual (preferring males) while some are bi-sexual and a few are obligatory (exclusively) lesbian.

Myth: A TS with serious psychological and/or social problems cannot be a true TS or stable enough to attempt cross-living and/or surgery. FALSE.

This myth is oft times subscribed to by the so-called professionals operating TS "programs". What bigger problem could there be then having the body of the wrong sex? And what bigger step to solve the person's problem than to correct this problem before attacking others? Many of the problems, both psychological and social, are direct results of the individual's transsexualism.

### Physical, Social and Psychological Factors in Gender and Sex

The study of sex and gender begins to resemble nuclear physics with the splitting of a particle only to find it made up of other particles, in combination or newly discovered particles. The basic particles of "nuclear sex and gender" are eight different layers of sex and gender. There are, consequently, 36 or 49 theoretical combinations. Probably they occur in all combinations. Given in order of chronological development they are:

- a. Genetic sex
- b. Gonadal sex
- c. Chemical/neurological sex
- d. Gender-identity (made up of genetic, pre- and post-natal components).
- e. Gender role-identity.
- f. Gender social/legal role.
- g. Sex preference.
- h. Pubertal/hormonal/morphological sex.

The preceding breakdown of sex and gender components is based on the standard scientific method and particularly that of positivistic psychology. From the view point of philosophical or psychoanalytical psychology the level would be (from the core outward): the philosophically transcendent-self; gender self-identity; gender-role and sexual proclivity. To meld these two methods one need only sandwich the philosophically transcendent-self between hormonal/morphological sex and gender

self-identity (numbers 5 thru 8) in the above list.

One could even argue for a philosophically transcendent sex although at that level one is usually androgynous. Additionally, there may be influences from the sex/gender of one's previous life and the sex/gender one is preparing for in one's next life.

Needless to say, these are approximations and the whole idea remains highly theoretical.

Genetic sex is, of course, determined at the instant of conception. The genetic components of gender-identity (if there be any) may be pre-existing and passed to the embryo in the genes of the parents. The other layers seem to have their own time windows during which the layer is subject to outside influences and after which the layer is permanently crystallized.

Chemical/neurological - the brain and particularly the gender self-identity center (if one exists) is susceptible to hormonal and chemical changes and imbalances during an undetermined (but relatively short) period of prenatal development. To what extent and by what mechanisms or chemical/neurological imbalances, contamination and other abnormal phenomena influence gonadal development is not completely known.

Gonadal - nominally speaking, the next window to open is the gonadal sex, stimulated to develop prenatal hormonal dynamics of the fetus. (Precise temporal and parallel processing between gonadal development and chemical/neurological factors is little explored.) Gonadal sex development flows normally from genetic sex. At a certain point in fetal development genetic factors trigger the gonads to become sexually differentiated.

Gender self-identity - might appropriately be called "self-gender" of "core-gender" as distinguished from "role-gender". Since this is the key to transsexualism many of the following paragraphs are devoted to it. The most important factor having a bearing on transsexualism is gender-identity. Gender self-identity is made up of genetic, pre-

and post-natal components, the meaning of "genetic" here is "in the genes and fetal development therefrom". The pre-natal components are subject to the influences of genetic and chemical/neurological factors. The post-partum and early childhood component is maternal and social conditioning.

All other factors are secondary and form an environment or milieu for gender self-identity. Except for gender role and sex preference the other factors are physiological. Transsexualism is, therefore, (at least at this point in the evolution of medical science and art) primarily a psychological, psychoanalytical and philosophical, that is, non-positivistic, problem.

Gender self-identity (or role-identity) is a permanently imprinted interface with society the individual develops in early child-hood and is based on roughly dichotomized, typically male and female social behavior. This factor is the second most important in transsexualism. In a scale of influence upon transsexuality this factor is less important (genetically) then gender self-identity and for more important than the remaining factors. Fortunately, it most often tags along with gender self-identity.

Gender social/legal role is simply one's day-to-day gender role as seen by the eyes of Society. It is functionally external to one's own inner psychodynamics. For the "average" person it is in harmony with personal gender, but in the cross-gendered person it becomes a rack of torture and conflict. The transsexual who has not, as yet, started to cross-live often conforms, albeit involuntarily, to it just to survive socially or so as not to attract undue attention to herself.

Sex preference - the sex preference window opens at about the age of 5 years and remains open to about age 7, or in extreme cases to age eleven. (This is not to imply that homosexuality does not have prenatal components.) Sex preference is not directly related to the existence or causes of transsexualism. Transsexuals are not transsexuals because they're homosexual males. Sex preference is determined long before gender is established. Transsexuals, as a group, are found to run the complete gamut of sexual preference.

Pubertal/hormonal/morphological sex - the pubertal window may fail to close for the male in that testosterone levels may be abnormally low and/or post-natal testosterone insensitivity may leave the male child with a morphologically pre-adolescent or feminine body. But, by then, the gender self-identity is already permanently fixed. Testosterone levels at or after puberty are not causative factors in transsexualism. Most transsexual have normal or hyper-normal testosterone levels. Many do, however, have subnormal serum testosterone levels but, that may be a result rather than a cause.

Doctors Stoller and Green point out in their many books, the influence a mother has on a male child in neither necessarily unilateral nor arbitrary. It is the result of the interaction between the child's personality and innate qualities on the one the one hand and the mother's reaction on the other. If the male baby is pretty, feminine and passive the mother may give him "pseudo-girl" treatment. The perceptive feed-back can intensify these qualities and become a self-fulfilling prophesy.

### Socially Conditioned Self-gender Identity

We shall call the post-natal component the "socially-programmable gender-self identity" component which lasts approximately, through the first 18 months after birth. Maternal conditioning is by far the most important factor in the programmable component of gender self-identity. For obvious reasons it is far easier for a mother to impart gender and role identity to a daughter than to a son. This probably past of the reason there are fewer identified female-to-male than male-to-female transsexuals. It is a subtle thing a mother does to a son to let him know he differs from her. (In Sex and Gender Dr. Stoller thoroughly documents and analyzes this factor. Except for puberty, childhood conditioning is the last hurdle a male faces in his acquisition of a normal male development. And, there is nothing he can do about it. Normally, it's all over by age 18 months and, in some cases possibly up to age 24 months.

### Self-gender and Gender-role

A distinction should be made between gender-identity and gender-role. Gender-

identity is self-identity at the very deepest core level. Gender-role is also a question of identity, but it is the next outer laver imprinted upon the individual as a child and which she has assumed because of the circumstances of up-bringing. It is an outer-role one assumes in order to survive in one's relationships with those closest when growing up. It's chief function is through the psychoanalytic function of "identification". The two layers are distinct not only by virtue of their psychological and personal depth, but also because they are solidified in independent time frames or windows (the social-gender role adaptation) extends from about 18 months to possibly 5 years of age or more. It is possible the have the identity of one gender and the role of the other while having the body of either. A transsexual is a morphological male whose core gender-identity is female. It is also, theoretically, possible to have a TS whose gender self-identity is female but whose social role-identity is male. In this case we have a TS who is a hard core dyke. It may not be possible to have a hard core dyke who is a lesbian. This dichotomy indicates that the sexual preference (in women) trails closely behind the social gender-role. In fact, one might call it the socio-sexual gender-role.

To thoroughly elucidate this subtle, but crucial, distinction let us take an example from the homosexuals of both sexes. Many homosexuals, of both sexes, have reversed their gender-roles but retained their core gender-identity. They pair up in a parody of the traditional marriage in which one partner is the "male" while the other is the "female". For example, two females live together; one considers herself as having the role of the husband while the other is the "wife". Or, two males living together; again, one considers himself the "husband" while the other considers himself the "wife". In the example of the two males the husband, of course, considers himself to be a man while the wife considers himself to be a woman to the extent of assuming the role of a woman even though he is aware of his body and identifies with it without a desire to change his sex. Neither the female "husband" not the male "wife" is considered to be, nor do they self-diagnose as, transsexual.

## More Example of Cross-gendered Identities and Roles

As an example of cross-gendered role and self-identity picture a genetic, gonadal female with a female self-identity who has assumed, or even been imprinted with, her father's gender role-identity; she is an exclusive (obligatory) lesbian. She had a more or less normal puberty and remains, for the most part, physically normal. She is an example of what is called a "dyke". Although a butch lesbian imitates a kind of a parallel mode with a real male she is not in direct competition with men. Her assumption of the gender-role without the corresponding gender-identity results in more than a parody of masculinity. It is a most poignant statement to her femm (female lover) and to the world that she is a better version of a man than the real thing. Dykes assume the pseudo-male role at an early age. Classic circumstances producing dykes are: the father fails to care for the mother properly and falls down in his responsible role; the mother is feminine, in need of a protector and/or in distress. The daughter steps in to fill the role of her defaulting father, imitating the best man with whom she happens to come in contact - an uncle, a cousin, the man next door. There can be an infinite number of twists on this theme. If, for example, she is weak or does not carry it off perfectly she might pick up some of the traits of the father who failed her mother. These are social and familial circumstances which affect the child long before gender-identity has formed. Thus, she remains a woman. but one who assumed the man's role.

Some dykes, at first, seem to be female-to-male transsexuals. I knew one who not only assumed the male gender-role but also said she had always wanted a penis. There is no doubt a strong and close association between the male social-role and the male sexual role, both of which the dyke usually takes on with amazing faithfulness. Identification with one's primary sex organ would ordinarily be more closely associated with one's gender self-identification than with one's gender-role identification, as is the case of the average male-to-female transsexual. There is no doubt this dyke has the self-gender of a woman; she just wanted to be a woman with a penis or at least a larger clitoris. A dyke is, by definition as well as experimentally, a butch lesbian. Taking over the male gender-role seems to be an outgrowth of their sexuality; or perhaps their sexuality is an outgrowth of the male gender-role assumption. The fact that most dykes seem to have a reversed Electra complex reinforces this observation. This kind of penis envy, which would gladden the heart of Sigmund Freud, is fairly common in dykes, some of whom even go so far as to take testosterone (male hormones) to enlarge their clitoris. The easiest way to distinguish a dyke from a female-to-male transsexual is their attitude, not toward their clitoris but, toward their breasts. The dyke doesn't mind having breasts, in fact she usually likes her breasts where as the female-to-male transsexual cannot wait to have his breast reduction surgery. One of the amazing things about dykes is that after they have taken over so much of the male gender-role, from dress and mannerisms to personality, there is still much that is feminine and womanly about them. By the way, a lesbian, whether butch or femm, is far more accepting of the pre-operative male-to-female transsexual then is the gay male.

Most dykes are incredible examples of androgynism. And they are often outstanding examples of how profound and deep the female instincts really are. The male instincts are, by comparison tenous and abstract at best, often resulting in much insecurity in his masculinity. A woman is like the earth itself; a man is like a tall, slender tree swaying in the breeze above the earth's surface.

### The TS Dyke, the Feminine Male

It is most difficult to diagnose the case of the male-to-female transsexual who has assumed the male role - the TS dyke.

Conversely, as another example, probably the most difficult case confronting the professional in trying to distinguish a "true" transsexual is that of a male who has male self-identity but a female gender role-identity. And, to really confuse the issue, has sexual preference for males.

"Now, these," he said taking two thick booklets from his attache case, "are contracts. One for two cable TV shows and one for a commercial television show. A half hour for just you.


"Of course the money may not be what you're used to, but I'll hold them up for as much as I can."

"When I made the decision to pursue surgery I simply read all the transsexual's autobiographies I could find. I joined a marvelous support organization with members and chapters all over the country. I was able to meet and talk to quite a large number of both pre- and post-ops. I learned the questions shrinks asked and the answers they expected. It was, after all, just another role to be played."

"But haven't you ever regretted

what you did? I mean the surgery?"

"No. I'm quite happy. I'm at home with my body and my psyche. Let's face it girls, we've always looked more like quads than widely spaced sisters and brother. You know the problems we had with that as kids. I'll bet you still have it as adults. Not when you're together but when people meet you in an unexpected place or situation. There's still the confusion about your identity. Now it'll be even worse with one more sister in the act. Look, if we stand side by side in front of a mirror and I'm not wearing these glasses we do look alike.

"I do have one regret. I had to give up all contact with you and Mom and Dad. And of course that followed for Two. That was difficult. But I didn't see that I had a choice. It's difficult for you to accept now. What would it have been like four or five years ago?

"You have a bit of a problem here. You can't tell the folks or Danni that you've seen Court, because he doesn't exist anymore. You certainly can't tell them what's happened to him."

#### SHOTS FOR THE FEMALE-TO-MALE

David (NV-10) asks the following so we're throwing it out to you for possible response.

"Has anyone, especially a FTM, used the new Medi-Jector distributed by Derata Corporation, 7380 32nd Avenue N., Minneapolis, MN 59421, for giving/taking hormones? Normally the Medi-Jector is used by people on insulin, but should be adaptable for us.

"After taking hormone shots every two weeks for  $3\frac{1}{2}$  years my tail has developed quite a bit of scar tissue and I don't look forward to taking the needle in the leg(s). I use water based testosterone.

"I'm curious to find out whether others have used the Medi-Jector and if so with what success?"

The above appeared in the September Phoenix and we are happy to pass on a response from one of our Pennsylvania Associates, who is a medical practitoner.

"I wrote to the Derata Corporation [about the Medi-jector] and also spoke with them on the phone. The Vice President of their company said that the testosterone preparations normally used could not be administered with the Medi-jector since oil based preparations would not work in their device. Therefore, this device is not suitable for use by FTM transsexuals."

#### DEAR GEORGIA

I have a fairly nicely rounded fanny, but I lack hips. I've tried the padded girdles but they don't quite seem to do the job. Any suggestions?.

Dear Hipless,

The least expensive and one of the best ways to obtain the "hips" you're looking for is to go to a variety store — K-Mart, Woolco, etc. and purchase enough polyurethane padding to do the job. The material comes in sheets and/or rolls so you should be able to purchase the quantity needed.

Okay, you've got the padding now what? Cut two pieces about 14 inches square. Use a serreted knife and don't press down on the material while cutting. Once the pads are cut bevel the edges on the outside to make the line smooth.

The pads may be inserted in your pantyhose or girdle. Depending on the thickness of the material you should be able to add at least an inch to your hips with this type pad.






