society by gay women and men, and also provides an arena for educational, cultural, and political discourse relevant to the experience of gay men and women. Most important, bringing this information to the straight television viewer de-mystifies homosexuality and prompts an understanding of gay life which creates a more empathic community for everyone.

POWARS is a nonprofit organization of volunteers who work to provide all aspects of maintaining an animal to keep people with AIDS together with their pets because they have a beneficial effect that few forms of therapy can match, and no medication can rival for safety. POWARS not only ensures a normal continuity in the lives of these animals, but it eliminates the financial hardships, anxiety and physical stress resulting from concerns about what might happen to a pet whose owner is in crisis. POWARS supplies scientifically accurate information about potential health problems in order to prevent unnecessary pet-owner separations. They can also provide dog walking, food and supplies, vet care including transportation, counseling, grooming, in-home foster care, pet-related cleaning, as well as adoption if necessary.




