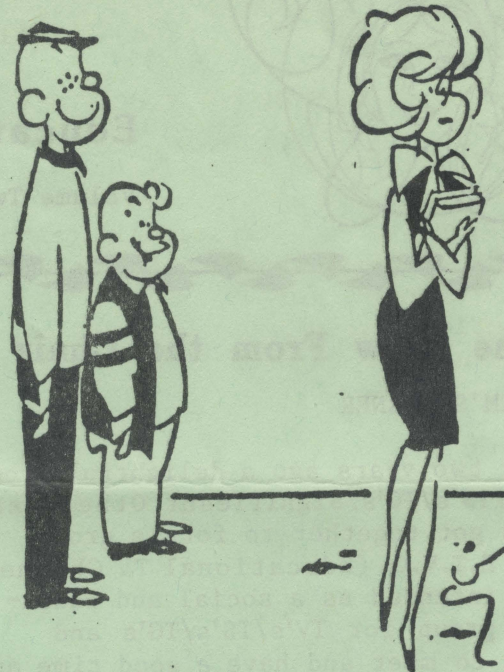

## Statement of Purpose

(from the BYLAWS OF THE EDUCATIONAL TV CHANNEL)

The purpose of the "Educational TV Channel" (hereinafter "ETVC") is two-fold: (1) to serve the educational, social and recreational needs of transvestites (either female or male), transsexuals (either female or male), and all other persons (either female or male) whose social role differs in any degree from that role considered to be appropriate for an individual of his or her genetic sex, and (2) to undertake educational activities intended to assist the general public in comprehending transvestism, transsexualism, and transgenderism.

(BYLAWS adopted May 31, 1984)

### MEMBERSHIP IN ETVC

## ***Judge to airline: Give job back to transsexual pilot***

CHICAGO — A federal judge yesterday ordered Eastern Airlines to reinstate transsexual pilot Karen F. Ulane, fired after her sex-change operation.

"I plan to go on flying," Ulane told reporters after the decision. She said she hopes to return to her job "as soon as possible."

U.S. District Court Judge John F. Grady also ordered the airline to give the woman, her back pay.

Grady said the airline's contentions that the pilot's presence in the cockpit posed safety hazards were "a pretext and sham of the first order."

Ulane, 42, sued Eastern in 1981 after the airline refused her request to return as a pilot. Eastern's attorney, David Brown, said he will appeal the decision.

The woman, formerly Kenneth Ulane, underwent the operation in 1980.

The airline's arguments were "not advanced in good faith, and but for being a transsexual and for having the operation and assuming a lifestyle of a woman, the plaintiff would not have been discharged," Grady said.

## TREASURER'S REPORT

Our net worth after the June 28th party is \$419.87! Whoopee!! We are finally out of the financial hole we have been in all year and even have some money to our name.

Three parties have passed since the last newsletter. On April 26 we had our Easter Bonnet party which 33 people attended. \$165 was collected in admission fees and \$25 was paid the Chez Mollet for room rental, resulting in a surplus of \$140.

We held our Annual Business Meeting concurrently with our 2nd Birthday Party on May 31st. About 40 people attended which was a gratifying turnout, but only 32 paid the \$4.00 fee for a total of \$128. I didn't approach people personally at this meeting (the way I did in April), choosing instead to rely on everyone to approach me in response to our exhortations, repeated during the evening, to do so. That turned out to be a bad move. Our expenses, for cake, ice cream sundaes and room rental, were \$150.94, so we lost \$22.94.

The Senior Prom occurred on June 28th. 36 people attended, contributing \$178 in admission fees. After deducting \$54.41 in expenses (for room rental, waiter's salary and streamers), a surplus of \$123.59 was realized.
