## Chapter officer wins Pocono prize

The fifth "Princess of the Poconos" award was handed out last month to Michelle [REDACTED], director of membership activities for the Greater Philadelphia Chapter. This was the second time that a Philadelphia chapter officer has garnered this award. Former chapter leader Teri Kay was the first princess.

A Princess of the Poconos is named each spring and fall at the CDS Paradise In The Poconos weekends. The princess and her court are chosen by popular vote from among the event's participants.

"Michelle was the overwhelming choice for princess," said JoAnn Roberts, the event organizer. "What amazes me even more," she said, "is that all five princesses have been first-timers at the weekend."

[REDACTED] was astounded when her name was called for the award. "I'll remember this for as long as I can," she bubbled while posing with her court for photographs.

This was the second award in as many weeks for [REDACTED], who received recognition at the Spring Ball for her chapter activities.

## Mayor Goode cites Pride month

Philadelphia Mayor W. Wilson Goode marked June as Gay and Lesbian Pride Month with this message, sent to all 32,000 city employees with their paychecks: "Mayor Goode Salutes All Sexual Minorities During Pride Month."

Peg Conway, executive director of the Mayor's Commission for Sexual Minorities (MCSM), said the message recognizes transgendered people as well as gays and lesbians. "During Pride Month we must not forget that bisexual and transgendered people are a part of this community and part of this civil rights struggle. The role of the MCSM is to represent all of these groups and to ensure fair and equal access ... for all sexual minorities."

## National officer honored at Ball

A surprise award ceremony took place during the Spring Ball and Birthday party to honor the contributions of three individuals to Renaissance.

Angela Gardner, presiding over the ball, first made two award presentations to Michelle [REDACTED] and Gloria A. [REDACTED], officers of the Greater Philadelphia chapter.

Gardner then called Alison Laing to the podium for brief, surprise remarks about JoAnn Roberts. Melanie Bryan, Trudi Henry, Paula Sinclair and Gardner, who along with Laing and Roberts formed the first Renaissance board of directors also spoke about Roberts' contribution to the organization. Together they all presented Roberts with a framed certificate which reads:

*"We, the undersigned, hereby sincerely declare our eternal love, appreciation and respect to JoAnn Roberts for her dedication, caring and exemplary efforts in the found-*

*ing and development of the Renaissance Education Association. Awarded on the occasion of the celebration of the third anniversary of the founding of Renaissance, May 11, 1990 A.D."*

Roberts is considered the motivating force behind the founding of Renaissance. She brought the five presenters together to form the organization, and she served as the first managing director.

Roberts, for once, was caught totally off-guard. At the podium, she said she was speechless, but quickly recovered. She thanked each of the five presenters and called them her "extended family." She then thanked all those present who had signed the certificate.

In closing, Roberts said that while she may have had a major part in getting the group started, it was, and still is, the effort and determination of its current members that keep it going so strongly.

## Some Statistics

A student at San Francisco State University surveyed people attending ETVC and RGA meetings. Some of the results were:

**Sexual Orientation** — 62% straight; 28% bisexual; 6% unsure, 3% non-sexual, 1% gay

**Of those married** — 98% wife knew; 46% wife supportive; 27% wife indifferent; 27% wife upset

**Fantasize about** — 18% other TVs; 15% transsexuals; 14% B&D; 12% leather/latex/lace; 9% shoes/boots; 6% S&M; 5% being a real woman; 5% being a lesbian; 5% water sports; 3% forced transvestism; 1% forced homosexuality; 1% don't fantasize at all

**Other** — 60% considered themselves passable; 49% wondered if they were a TS; 18% used hormones. ETVC Newsletter, March-April 1990.

### **Know Your Reasons**

Recently three individuals appeared on "The Sally Jesse Raphael" show. Here we have a lady who not only mixes metaphors but probably has red wine with fish as well. She had one each pre-op and post-op transsexual and a female impersonator, and entitled this segment: "Men who cross the gender gap to get better jobs."

From the producer's point of view this must have seemed a topic no other show had done. But, from the viewpoint of those of us in the gender community, it's like having a show about the similarities between rocks, oranges and balloons. The sad part is the millions of viewers who got trapped in the middle learning nothing, being misinformed and misdirected as to the realities of the gender-conflicted.

Sally's guests included: a self-touted, post-op, M-t-F transsexual running for mayor of her California town; a pre-op, M-t-F transsexual who is an ex-biker and appeared on the show with 'her' wife; and a male who "changes his sex" to get work as a singer.

The whole premise of this show was that in their original sex roles these individuals could not cut it in society. They were supposedly either outcast (the biker), couldn't get work (the singer), or were more successful (the would-be mayor and businesswoman).

I am not going to take anything away from any of the panelists for indeed they were seemingly all successful or better people as women than as men. Each of their achievements were notable. But this program gave the viewing audience the wrong impression; it is okay to change sex simply because you ain't cuttin' it as a dude.

Let's dissect each of the individuals to uncover some meaning to this mindless show.

Probably the least harmful was

the male/female singer. Though he had a lot of talent, the entertainment world was not beating a path to his door for singing gigs. His wife, as a joke one evening, made him up and he rehearsed in the female voice. They were both surprised when he came across better sans the male image. He tried out his new act and was hired on the spot. Since he changed sex roles for his onstage work, he has worked continuously, but he never lets the audience, or most employers, know of his true sex. (He is not a transvestite.) Is he wrong to do this? No, he's not. His reasons are valid. He is merely doing an act, nothing more, nothing less.

The pre-op TS (with wife) in "before" and "after" photos was remarkable. Before, he was the icon of what Mad magazine would epitomize as the bearded, tattooed, beer drinkin', leather-clad biker. The kind that crushes Coors cans on his forehead - before they're empty. The "after" shots showed a mild mannered, meek, yet husky woman. She went for reassignment in Belgium and had a heart attack in surgery. Her reassignment has been on hold until her health improves. From the discussion that followed we learned the tough exterior was just a put-on show for her true feminine feelings.

We can all identify with that thought, but is she a better person as a female than male? From what we could see on the show, maybe. But is it a logical decision to seek sex reassignment simply because you think people will like you better as a woman than as a man? Her rationale is a bit twisted. I can't condone, nor recommend, anybody do what she's doing because they think they'll be better liked.

You have to like yourself before you start the road to transition in order to successfully finish. This woman didn't like her old self, and I don't think she is too happy with the new one either.

Finally, we come to the post-op transsexual woman. Terri made no bones about her gender issues, and seems to have gotten a good response from the local public vis-a-vis her honesty. She had been a very successful businesswoman for over 15 years before the bid for political office. She noted that although successful before the change, she was even more so following the surgeon's snip. She did not, as we are lead to believe by the show's title, jump the gender fence to get a better job. Terri was simply taking advantage of her gregarious personality and ability to influence people. No problem here with the reasons; I applaud her efforts in the political ring. Sally tried to make it sound like Terri changed sexes just so she could become mayor. Terri's motives were sound. Sally's efforts at responsible journalism were not.

Besides unmasking thinly veiled attempts to raise talk-shows ratings, this article has another point: analyze why you may want to cross the gender line. Is it because of your inner feelings, or is it because you are not successful in your current gender/sex role? If you're unhappy in your life, you can't be happy in your work. If you're unhappy at work, you can't be successful. But that's something you need to take a long hard look at before you do anything rash. I was very successful in a pseudo-male role, and have been very successful in my many years in the female role. Don't try "the other sex" just because you aren't happy in your work!

As for Sally, I will only say that she set back the public's understanding of transsexualism 5,000 years. She caused more problems than she made contributions. I wish she would do a show about transsexualism, talking only about personal gender issues and problems.

I give Sally and her stupid show two thumbs down.

**SOAPBOX**

I've lost a friend to "transsexual fever" My "lost" friend, we'll call her Tes, is planning on a new life in a femme persona. The problem is she's doing it outside of the Standards of Care. Tes is taking female hormones without proper medical supervision, and has had facial plastic surgery. But she has had no psychological counseling. She thinks that reassignment will make all of her present personal problems disappear. Tes is headed for disaster, but won't listen to anyone.

Issue #6 of *Gender Expressions* is a diatribe on the Standards of Care which were developed by the Harry Benjamin International Gender Dysphoria Association. Most ethical gender clinicians follow the standards, which include counseling and a two-year real life test.

The polemicists at *GenEx* want

the standards abolished. They want "surgery on demand" for all self-diagnosed transsexuals. That's fine except for two problems: the diagnosis of transsexualism itself and a refusal to accept responsibility for one's actions.

There generally seems to be two very different types of people who label themselves M-t-F transsexuals. The first type has known they are transsexual from a very early age. From their teen years forward their only goal is to correct the error that nature appears to have set on them. If you meet one of these people, you have no doubt that reassignment is exactly what they need.

The other type is Dr. Richard Docter's "secondary" transsexual, a person who identifies as transsexual in middle age or later following years and years of crossdressing. If

you meet one of these people, you may wonder if they are making the right choice, the evidence of masculinity is so strong in them.

So what? If they want reassignment, why not just give it to them, like cosmetic surgery? Because people change their minds; they make mistakes. And a lot of people are not willing to accept the responsibility for their own mistakes. They look for a scapegoat. The doctor shouldn't have done the surgery without being absolutely sure. It's not my fault. Blame him.

You can't expect surgery on demand unless you are able to accept the responsibility that YOU might be making a mistake. My ex-friend, Tes, is not accepting responsibility for her actions and the editors of *GenEx* neglected to discuss accepting responsible at all.

The political season is rapidly approaching, and that makes us wonder if there are any transgendered folks who profess to be Republicans, especially if they have read what Rep. William E. Dannemeyer (R-Calif.) told his Golden State GOP colleagues.

"We do not endorse special recognition for gays or cannibals, transvestites or people who practice bestiality. Any acts of human indecency, we'll leave that element to the Democrats."

Unfortunately, there are those people who crossdress, do terrible things, and give the rest of us bad reputations. One of those people is Florida Highway Patrolman Timothy Scott Harris.

Harris, an eight year veteran of the patrol, confessed to murdering a woman he stopped for a traffic violation. He said he killed the woman after they had sex on the I-95 median strip because of stress from his impending divorce. Harris became a strong suspect in the murder after his estranged wife said that Harris broke into her house wearing nothing but panties and pantyhose and tried to beat her.

Not only was this story from Florida bad enough for the public image of transgendered people, but last month we may have lost one of our oldest role models — Viscount Cornbury, Royal Governor of the British colonies of New York and New Jersey from 1702 to 1708. A scholar now claims the reports that Cornbury paraded about the street of New York dressed as a woman were a vicious libel begun by his political enemies in the colonies. Patricia U. Bonomi, a professor at New York University, also claims that the famous portrait reputed to be of Cornbury in drag is actually the likeness of an unknown — but undoubtedly ugly — woman.

Cornbury has long been held up, depending on your point of view, as a transvestite who became successful in spite of his crossdressing, or as an example of the eccentricity of transvestism. Part of the story is that Cornbury, who was a cousin of England's Queen Anne, believed that he resembled his cousin so much that he dressed like her in order to better represent her to the colonies. The story has been repeated in so many books that Bonomi is seen as something of a rebel.

Meanwhile, the New York Historical Society, which still has the painting on prominent display at its New York City museum, and still identifies it as a portrait of Cornbury, will conduct its own research into the matter.

While we lose one famous member of the club, we perhaps gain another. According to a supermarket tabloid, Barbra Streisand is worried that her son Jason Gould, 23, is a gay drag queen. The reasons for the maternal concern? Since he was a teenager, Jason has shown a desire to do drag and displayed talent for impersonating Dianna Ross and Streisand herself. Then again, she could have been angry because he had ripped out the seams in the \$6,000 gown.

Sir John Falstaff in Shakespeare's *The Merry Wives of Windsor* at the Folger Theater in Washington. While it was common in the Bard's day for boys to play female roles, it is uncommon for a woman to take on a leading male role. *New York Times* critic Frank Rich said Carroll played Falstaff "so convincingly as a man ... that he still seems masculine when the plot requires him to adopt the drag outfit of a witch."

Actress Tilda Winton's next film role allows her to change sexes in the midst of a movie. She's been cast as Orlando in the upcoming film version of the peculiar 1929 novel by Virginia Woolf, also called *Orlando*. The fable, which involves the transformation of a man into a woman, gave Woolf the opportunity to explore gender roles and sexual orientation.



Real life sex changes are some-

times as dramatic as those in books or in the movies. Take New Hampshire transsexual Sarah Luiz for example. Her sex reassignment was halted after Blue Cross said they would no longer pay for the procedures, and so Luiz had decided to stop hormone therapy and revert to being a man. Just as things looked darkest for the 24-year-old transsexual, an unnamed surgeon stepped forward to donate surgery after he saw a television report on Luiz and her \$30 million lawsuit against Blue Cross.



Things were just as bright for a transsexual student at the University of Alabama in Birmingham who won a seat in the school's Undergraduate Student Government Association after campaigning as "the only transsexual to run."

The student qualified for the race under the name of Kenneth Wright,

but later changed his name to Caitlin Kiernan. She received the second highest number of votes for any candidate in the election.

Kiernan attributes her win to her visibility. She stands 6 feet 4 inches tall and sometimes dresses as a woman for classes.



The issue of visibility came too late to prevent a 38-year-old Chinese peasant from being bilked out of the \$155 he paid to a marriage broker to find him a wife.

The couple hit it off well, and the wedding was held in the eastern province of Shan-dong. It wasn't until the honeymoon that the peasant discovered that his bride was a man.

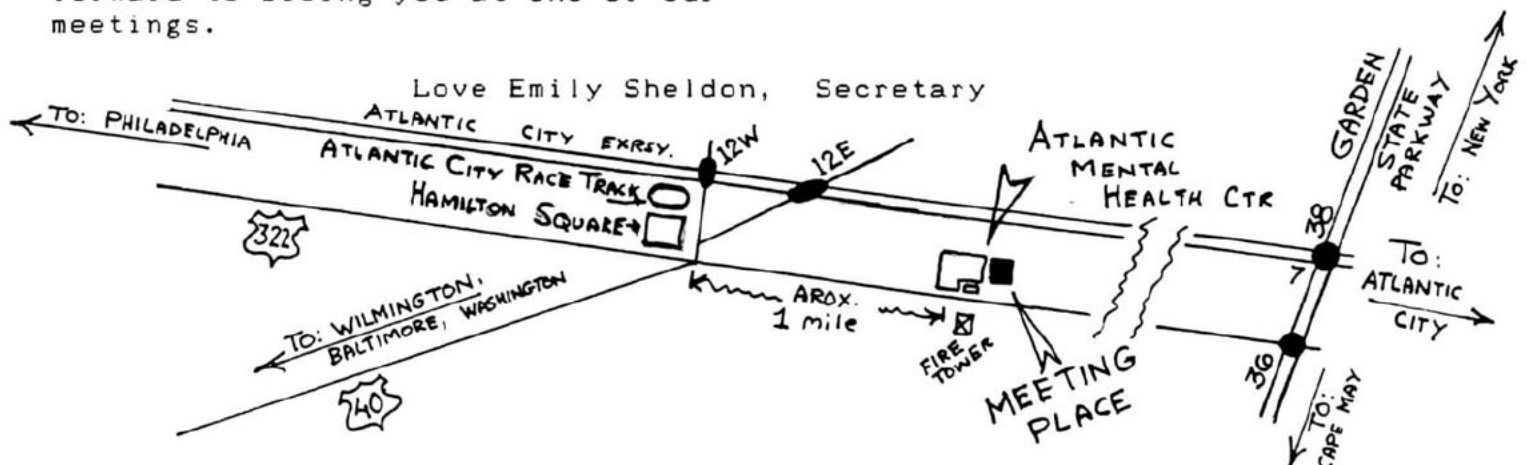
Hi girls (and boys) here we are in the Renaissance News at last!

## TIPPING TIPS
