### PROVENANCE

The collection was donated by Judy Greenspan in 1997.

### **USE RESTRICTIONS**

No names may be published unless (1) the persons are publicly known as gay and HIV positive, or (2) their permission has been obtained, or (3) they are deceased. Restrictions are only in regards to publication; any researcher may view or copy any document in the collection. The collection contains clilent files and may also contain other forms of personally identifiable Information. Researchers must redact any such information in consideration of the privacy of individuals as described above.

### SCOPE AND CONTENT

The collection consists of inmate medical records. correspondence, and legal documents. To search for specific Inmate names please speak with the archivist. Additionally, the collection holds prison newsletters, conference books, literature on HIV/AIDS, Hepatitis C, sexually transmitted diseases, and LGBT issues in prisons. While the collection concentrates primarily on the California prison system, there is also material on prisons in other US states and Canada.

### **HISTORY OR BIO**

Judy Greenspan is a prisoner rights activist concentrating on HIV/AIDS inmates in California. In 1991, Judy moved to California, joining (the original) San Francisco ACT UP. She later founded the HIV/AIDS in Prison Project of Catholic Charities of the East Bay, an advocacy group working on behalf of women with HIV and AIDS. The group was critically important in improving medical care in the prison system and was instrumental in making the Vacaville medical prison a model for HIV health care. The group also worked to improve procedures for the compassionate release of dying prisoners. In 1998, her project closed due to lack of funding, but was absorbed by California Prison Focus, a statewide prisoners' rights organization. Undaunted by the end of one program, Judy continued her advocacy and organized the HIV/Hepatitis C in Prison (HIP) Committee within California Prison Focus. Judy's last visit to women prisoners (August 2005) ended with a phone call from her doctor informing her that she had breast
