## Topical Cream Numbs Skin to Pain

**Q:** Since the birth of my three sons, many little skin tags have developed around my breasts and armpits. I'd like to have them removed, but the thought of needing an injection for each little tag seems laborious and painful. Recently, I heard of a cream that numbs the skin. Can this be used? — E.S. Lowell, Mass.

**A:** An anesthetic skin cream approved by the FDA in 1992, called EMLA, can significantly reduce pain from medical procedures that go beneath the skin, such as injections or incisions. And it can eliminate all pain from procedures at the skin's surface, such as drawing blood, establishing an intravenous line, removing birthmarks or snipping skin tags.

However, it may not be available for everyone who would like to have it. Wholesale, EMLA costs \$2 to \$4 per application; it may cost the patient \$4 to \$10. It will likely be widely used by patients — especially children — who must endure numerous needle sticks.

Another drawback to EMLA is the hour or two it takes to work. With health care in a cost-cutting mode, physicians are reluctant to adopt procedures that require longer office visits, especially when the outcome may not be improved.

One way to circumvent this problem is to apply the cream at home before going to the doctor's office. Several studies have found that home application of EMLA is feasible and produces comparable results to office application. A study in Norway of 228 patients scheduled for outpatient surgery showed that home application of EMLA cream is safe, easy to perform and well tolerated. Dr. A. B. Guttormsen's findings were reported in the January issue of the International Journal of Pediatric Otorhinolaryngology.

For more than 30 years, two anesthetizing agents named lidocaine and prilocaine have been used to numb open or damaged

skin, or mucous membranes such as the lips or genitalia. They're common in treatments of sunburn and other burns, cuts, and abrasions, and teething pain. But neither lidocaine nor prilocaine alone can numb undamaged or intact skin.

Then, more than a decade ago, a Swedish scientist mixed lidocaine and prilocaine. Both are powders at room temperature, but when combined, they form an oil compound. And this compound could do something neither lidocaine nor prilocaine could do: It could penetrate and numb intact skin. The product was dubbed a eutectic mixture of local anesthetics, or EMLA. (When two solids mix to form a liquid, it is called a eutectic process.)

EMLA had been available in Europe for more than 10 years, and Canada made it available without prescription in May 1991.

In late 1992, the FDA approved EMLA to be used by prescription in the United States in adults and in children over 3 months old. In April 1993, Astra USA, an American subsidiary of a Swedish pharmaceutical company, began distribution.

In order to be effective, EMLA must be applied to the skin and covered for one to two hours by a bandage such as Band-Aid, Tegaderm or plastic wrap. EMLA numbs the top 5 millimeters of skin and tissue. (Five millimeters is about the thickness of the skin that moves on the back of your hand.) When the cream is wiped off, the numbness will remain for around three hours.

EMLA's qualities make it appropriate for a number of uses.

- EMLA has made it possible to remove skin lesions called molluscum contagiosum by scalpel without pain.

- Flat, off-color, frecklelike lesions called lentigines have been removed using the razor-shave biopsy technique without pain.

- Other procedures that EMLA renders pain-free include: skin grafting, finger sticks, lumbar punctures, venipunctures (drawing blood), debridement (through cleaning of a wound), mole removal and other superficial procedures. It can take the sting out of hair removal by electrolysis, waxing or epilation.

## IFGE'S Alison Laing urges "Put Unity in Community"

"Isn't this a great time to be transgendered?" So asked Ms. Alison Laing, Executive Director of The International Foundation for Gender Education's (IFGE) in an address to the Tri-Ess Alpha Chapter in Burbank at their January meeting. Ms. Laing pointed out that as recently as 10 years ago, support group meetings would have been difficult to even hold. But now, there are many local and national transgender groups serving the community; people have been able to successfully transition on the job! She even jokes that a Lane Bryant saleslady once confided in her that "10% of our customers are crossdressers!"

Ms. Laing has a long history of leadership in our community. She is co-founder of the Philadelphia group, *Renaissance*, which now has branches and affiliates in half-a-dozen states. She has been director of the New England area *Fantasia Fair* convention for the past 10 years, and is a recipient of the "Trinity Award" for her many services. In the Spring of 1995, she was appointed to head IFGE during its current restructuring.

But, she hastened to add, "If we're not careful, it's going to rain on our parade." There are many people out there who do not understand us, who think this is wrong. And if the enemy is ignorance, then the weapon is education.

Education is one of IFGE's primary functions. The newly renamed *Transgender Tapestry* magazine, which is published quarterly, features community events, legal and medical issues, a personal classified section, a directory of groups and resources, and social commentary editorials. IFGE also works closely with the professional community, and tries to get a trans-presence at Psychological and Social worker gatherings. But their "Hot Line" is one of their most important functions. Every day they receive calls from all parts of the country ranging from, "My wife just found out," to "I think my son may be transsexual." Alison tells us that, "Every day there's a tragedy," including people who have contemplated or attempted suicide. IFGE tries to refer callers to local support groups when possible, recognizing the need for

proximity of resources.

In terms of a personal mission, Alison spoke poignantly on the situation of the urban disadvantaged transgendered youth; sometimes called 'Street Queens' or 'She-Male Prostitutes'. "Almost every week in every major city, a transgendered minority youth is murdered." If they aren't killed, many spend time in and out of jail, become HIV positive, develop a drug habit, share needles, or damage themselves with street hormones or silicone injections from fly-by-night vendors.

During the question and answer session, the topic of congressional legislation came up. The gay community's recent Employment Non-discrimination bill (ENDA) last year pointedly excluded transgender rights. It has been conjectured that some in the gay community leadership felt that the bill was an "iffy" proposition for many legislators, and inclusion of "transvestites, queens, and fairies" would kill it. However, such groups as *Transsexual Menace* did leafletting and advocacy to call attention to this in a positive way. This all played a role in last October's Transgender Lobbying Day, when representatives from many groups met with members of congress and staffers on Capitol Hill.

Special attention also needs to be focused on areas where anti-gay (and by extension, anti-transgender) legislation is proposed or pending. States such as Colorado, Washington, and Oregon have become the new hot spots for this. Many on the political right cleverly introduce such legislation by attaching discriminatory provisions to "Family Values" legislation or school funding. Moreover, these same individuals get elected to local positions, and use their accumulated grass-roots power to put forth their agenda. The transgender community needs to be ever vigilant against these candidates and their proposals.

In conclusion, Alison emphasized the need for harmony and cooperation in the often disparate and clashing transgender world. In closing, Alison left us with this quote from writer M. Scott Peck, "A true community is like a salad; lettuce, tomato, cucumber, radishes. It's not a green soup. You don't all have to be alike."

## Why do women seem to have more foot problems than men do?

It's a simple matter of cause and effect — men generally don't wear high heels, so they're less prone to the various discomforts associated with heels. In fact, many "fashion-statement" shoes have narrow, pointed toe boxes that crowd the toes and force them into an unnatural triangular shape. This is where many foot problems begin.

"High-heels shoes distribute the body's weight unevenly, placing excess stress on the ball of the foot and the forefoot," notes Dr. Carol C. Frey, associate professor of orthopedic surgery at the University of Southern California in Los Angeles. "This uneven distribution of weight — coupled with the narrow toe-box characteristic of most high heels — can lead to discomfort, painful bunions, hammertoes and other deformities."

Science proves it: Recent studies have made the connection between fashion footwear and foot problems. The studies found that women are nine times more likely than men to develop a foot problem because of improperly fitting shoes. They also found that nine women in 10 wear shoes that are too small for their feet, and eight women in 10 say their shoes are "painful." More than seven women in 10 have bunions, hammertoes or some other painful deformity — with 90 percent of these deformities caused by tight shoes.

Here are some common-sense guidelines that Dr. Frey and I suggest women follow when purchasing shoes:

- Do not wear shoes with a heel higher than 2 1/4 inches.
- Make sure that shoes conform to the natural shape of your feet and that the back of the shoe fits snugly, without slipping.
- Plan ahead so that you wear heels only when absolutely necessary. Example: Commute to and from work in comfortable walking shoes and keep a pair of heels at work for meetings.

No adverse effects have been reported with the use of EMLA cream. Studies have found that EMLA application prior to skin-testing injections did not jeopardize the validity of the results.

But because EMLA is so expensive, you probably won't see cost-conscious physicians commonly offering it.

"No one likes needles. Should we use EMLA routinely? Yes, but as a society we can't afford to," said Dr. Linda Jo Rice, professor of anesthesiology and pediatrics at Children's National Medical Center in Washington, D.C., in an interview. "EMLA is a wonderful scientific advancement, but its usage becomes an issue of priority."

Rice was the chief consultant and study designer of the Children's Hospital EMLA Efficacy Research Trial, a study that tested EMLA in 160 U.S. hospitals on 8,000 children ages 7 to 15.
