Ingersoll Center was founded in 1977 by Marsha Boizer, MA, to offer referrals to experienced, professional counselors and offers support, education and advocacy and publications for transsexual, transgender and transvestite people, their families and significant others. Our aim is to offer support in dealing with the issues of daily living and changes in life style. We also offer support in preparation for surgery when appropriate and referral to post-operative counseling. Ingersoll Center uses the Standards of Care established by the Harry Benjamin International Gender Dysphoria Association as guidelines for its overall policies.

MISSION STATEMENT

Ingersoll Gender Center supports openness and awareness of gender identity and expression. We foster personal development, integrity of self, and interrelationships of worth and respect. We value a climate of freedom, learning, love, and wisdom.

GOALS AND OBJECTIVES

Ingersoll Gender Center provides referrals to experienced, professional counselors and offers support, education, advocacy, and publications for transsexual, transgender and transvestite people, their families and significant others to help them deal with the issues of daily living and changes in life style. We also offer support in preparation for surgery, when appropriate, and referral to post-operative counseling. Ingersoll Gender uses the Standards of Care established by the Harry Benjamin International Gender Dysphoria Association as guidelines for its overall policies. In support of its mission, Ingersoll Gender Center also has the following goals and objectives:

1. Ingersoll Gender Center seeks to advocate for the rights of the individuals it serves, and works with existing service providers to insure adequate access to services and facilities.
2. Ingersoll Gender Center does not subscribe to any one particular theory of the origin of gender identity and/or gender dysphoria, and welcomes individuals with diverse gender identity issues.
3. Ingersoll Gender Center does not discriminate on the basis of race, socio-economic status, creed, national origin, gender, sexual orientation, physical or mental handicap.
4. Because sex/gender change may involve radical surgery, Ingersoll Gender Center believes that an ongoing process including goal formation and evaluation, along with interactive individual and group therapy is essential for a person considering such a change.
5. The goal of the program at Ingersoll Gender Center is to enable individuals to have improved intrapersonal and interpersonal relationships, increased stability in employment, and self-confidence in social situations so that the person can more clearly define their sex/gender role.

BENJAMIN ASSOCIATION ELECTS NEW BOARD MEMBERS

At the recent Harry Benjamin International Gender Dysphoria Association (HIBIGDA) convention held in Vancouver, B.C., elections were held for open Board positions. For the first time, two members of the gender community were nominated and elected members of the Board of Directors of HIBIGDA. Sheila Kirk, MD and Jude Patton CMHC, CMFT, PA-C were elected to four-year terms on the Board.

The incoming president of the HIBIGDA, Richard Green, MD, JD, has asked Dr. Kirk and Mr. Patton to establish a committee to address consumer concerns. Some of the intent in establishing the consumer concerns committee is to give the trans-community a voice in HIBIGDA's activities, to support consumer advocacy for current and future proposed Standards of Care revisions, and to provide empirical data and research data supporting consumer concerns.

Patton and Dr. Kirk hope that members from the trans-community will serve on this committee along with them. Since HIBIGDA is a professional organization, they have specific membership requirements to become a voting member. Patton said that he understood that HIBIGDA's bylaws limit any committee membership to voting members. Persons who qualify for voting membership, are urged to join. Those who already hold HIBIGDA voting membership and wish to serve on the consumer concerns committee, please contact Dr. Kirk immediately. HIBIGDA members who choose not to participate on the committee at least will have a chance to vote for various items and specifically for changes in the Standards of Care. EVERYONE HAS A VOICE NOW! Any suggestions for changes in proposed Standards of Care need to get directly to the committee working on them, or can be sent to Jude Patton or to Sheila Kirk to present to that committee and the HIBIGDA Board of Directors. This should be done immediately, since president Richard Green had indicated he wants the new Standards ready for a membership vote within a few months, at the latest.

Patton also thinks that those who do not qualify for HIBIGDA membership could form an Ad Hoc consumer concerns committee, and could funnel their suggestions and ideas through him and Dr. Kirk to the Board of Directors and to the HIBIGDA consumer concerns committee. The goal is for EVERY voice to be heard.

"I especially want to reach out to people who have other self-definitions than 'trans' for their gender and sexual identities," said Patton. "I also want to reach out to the world-wide community for input. We should not be USA-centric in our considerations for improving consumer welfare."

Your help is needed to disseminate this information, particularly the fact that an HIBIGDA consumer concerns committee is being formed, and that Dr. Kirk and Mr. Patton, as members of that committee, and as members of the HIBIGDA Board of Directors, welcome any suggestions that enhance consumer welfare. This might be accomplished by getting this information out to the general trans-community and to other trans-organizations by e-mail, into newsletters and on websites.

"Thanks for any help you can provide," Patton said. "Again, our goal is for everyone who wants to contribute suggestions to have an opportunity to be heard. While I do not believe we can accomplish EVERY change in the Standards that we feel is vital for the consumer's welfare, we CAN make a strong impact, now and in the future."

'HEY, GOOD COOKIN!'

Easy Christmas Cookies

I know, I know. If you want *really easy* Christmas cookies, you go to Safeway or QFC and buy them by the box! But what if you really long for the taste of home baked cookies? What if you love the smell of cookies baking, evoking wonderful memories of childhood? Well, here is an *almost* painless way of achieving the above.

Ingredients:

One or two packages of prepared sugar cookie dough
(Pillsbury, Betty Crocker, etc.)

Waxed paper or plastic wrap

Colored sugar decorations to sprinkle (red, green, gold and silver)

Tubes of cake-decorating frosting

Small bowls of vanilla and/or chocolate frosting

White sugar and Cinnamon

Preparation:

Heat up the oven according to the directions on the package. There are two ways of proceeding here. You can simply leave the dough in a long tube (Make sure it's very cold so you can slice it easily) Slice it according to the directions on the package. Lay the slices on a cookie sheet. Next, decorate the raw dough with the sugar decorations. (Be sure to wait until the cookies have cooked and are cool before you put frosting on them.)

For another, more time-consuming way of making Christmas cookies. Let the cookie dough warm up to room temperature and roll it out between two sheets of waxed paper or plastic wrap until it is about 1/4 of an inch thick. Place the dough, plastic wrap and all, back into the refrigerator to chill. (You can *loosely* fold the dough to get it in the refrigerator.)

When the dough is chilled, remove from refrigerator and lay out flat. Use cookie cutters or with the point of a sharp knife, cut out your cookies free-hand. Decorate and bake and then frost, and stand back and wait for the compliments!

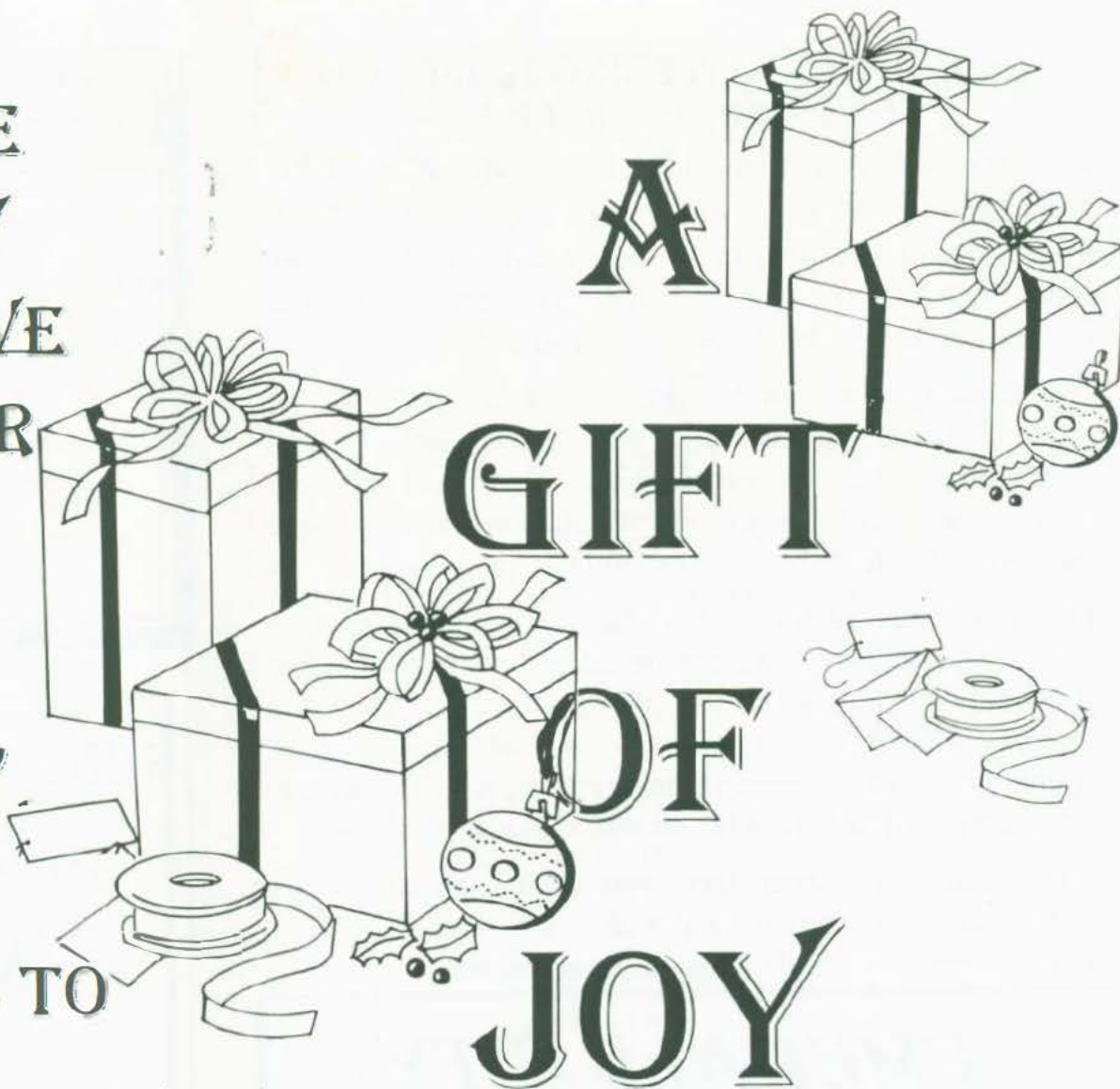

While the girls were just trying to get rid of the pests.

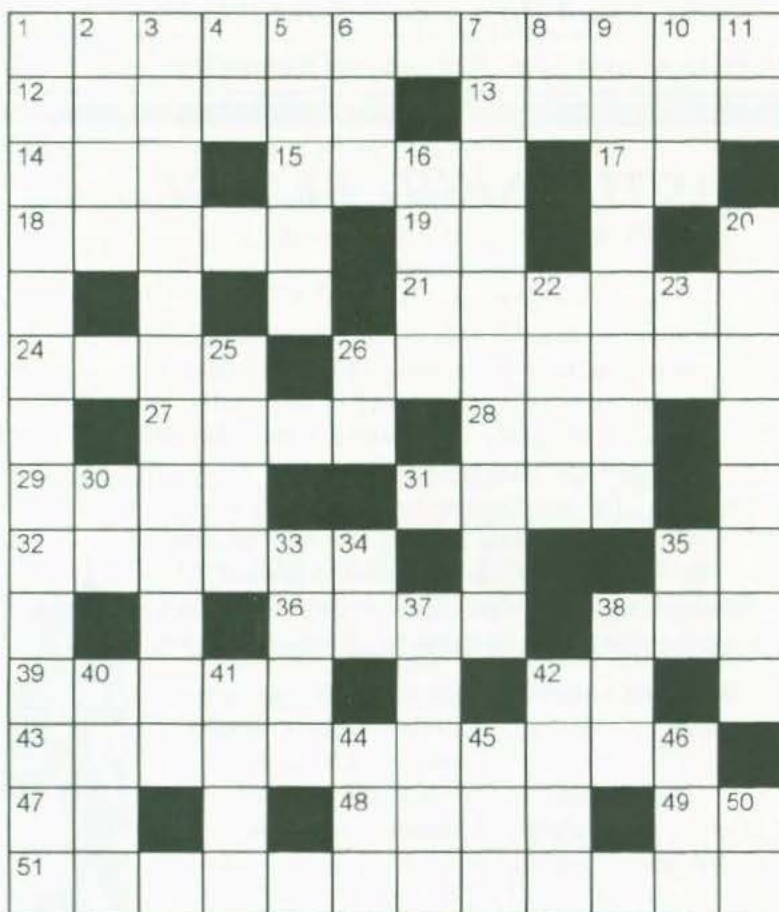
When out on the lawn their arose such a clatter;
