HOW TO GET TO PROVINCETOWN

BY CAR— Leaving Boston, take 128 south, or Southeast Expressway to Rte. 3. Continue on Rte. 3 over the Sagamore Bridge to Rte. 6, which takes you all the way to P-Town. From the south, take I-95 to Providence, then 195 to Wareham, Mass., where you can get on Rte. 6 to P-Town.

BY PLANE — On arrival at Logan Airport (Boston), contact PBA Airline for flight times and reservations. For flight reservations in Boston, call (617) 567-6090, or (toll free) Delta Airlines at 800-962-3500.

BY BUS — Trailways and Greyhound buslines have frequent daily service from Boston to Hyannis, with a change at Hyannis to P-Town. Call bus line for schedule.

Fantasia Fair is part of THE OUTREACH FOUNDATION. The Outreach Foundation is a non-profit organization providing services to the TV-TG-TS, the medical/psychological profession, and interested members of the general public.

The Outreach Foundation also provides the following services:

- * A speakers bureau, members of which have appeared on radio and television talk shows as well as many private speaking engagements.

Accommodations and Rates:

Two basic types of accommodations are available to Fantasia Fair participants. We have single and double occupancy hotel rooms, all with private bath, which are available on an individual or shared basis to full-week, week-end, and part-time participants. We also have a limited number of guest-house apartments. These are double occupancy only, available on a first-come-first-served basis only to those registering for the full nine-day fair period. In addition, we have limited facilities for multiple occupancy. (3 or more) Please write for information concerning multiple occupancy facilities.

Wives and girlfriends are cordially invited to attend.

Included in the full plan are two brunches, three dinners, one banquet, one pot-luck supper, two cocktail receptions, two late-evening socials and three happy hours. Continental breakfast will be available daily. Participants are free to make their own plans for other meals.

Conditions of Participation:

In these conditions, the term "organization" refers to Fantasia Fair, Ltd., and the term "participant" refers to the person signing the registration form.

(1) Registrations will be accepted from all persons who have reached their 18th birthday prior to 7 October, 1977.

(2) It is requested that femme attire, appropriate to the occasion, be worn throughout a participant's stay.

(3) The deposit of \$50.00 per person shall be treated as partial payment of the total sum due, as stated in this brochure and by agreement between organization and participant.

(4) The cost of full participation in Fantasia Fair is based on a minimum of 50 participants. Should participation fall below this number, all monies will be refunded except for a \$25.00 overhead charge.

(5) Refunds for cancelled registration are as follows:

- (a) Cancellation before June 15: \$25.00 (half of \$50 deposit).
- (b) Cancellation between June 16 and Sept. 1: 50% of total cost of selected plan.
- (c) Cancellation between Sept. 1 and Oct. 1: 25% of total cost of selected plan.

(6) Except in cases of late registration, all payments are due no later than 1 September, 1977. If payments are delinquent as of 1 Sept., unless special arrangements are made, the organization reserves the right to cancel the reservation as per #5 above.

(7) The organization reserves the right to make necessary program changes. Participants will be informed of changes where possible, and will be offered these alternatives:

- (a) To accept these changes.
- (b) To cancel participation and accept a refund of 80% of all monies paid.

(8) Fantasia Fair participants are expected to maintain certain minimum standards of deportment that are appropriate to individuals of any respectable group. If a participant's behavior continues to be inappropriate, the organization reserves the right to terminate that participant's stay, refunding to the participant 50% of the charges for participation following the time participation is terminated.

(9) The organization reserves the right to make a service charge for room/facility changes made at the request of a participant once the Fair period begins.

(10) Except where otherwise stated, the organization acts only as an agent in securing accommodations and other personal services. The organization shall not be liable in the event of failure of contracting parties to honor their commitments. The organization will not be responsible for injuries or lost personal effects.
