A well-deserved celebration at Cherry's went on until dawn, but we managed to chat with the winnahs nonetheless:

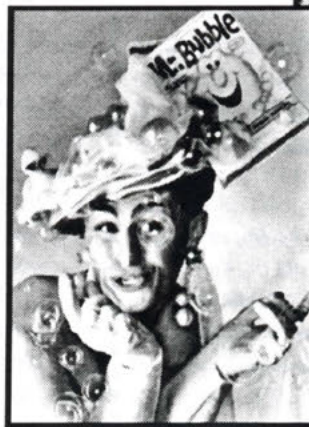
FABU: Leeza, were you surprised to win? I thought you were having a heart attack.

## A MESSAGE FROM THE PRESIDENT

As you know, the election of monarchs and board members is coming soon. Voting is a privilege and a responsibility. You must be a member in good standing to vote, as defined below:

1. Payment of annual dues (\$30) at the first meeting of the fiscal year (September).
2. Attendance at a minimum of 50% of general membership meetings for the fiscal year.
3. Plus at least one of the following:
  - a) Participation in at least two (2) Court affiliated fund-raisers/philanthropic events.
  - b) Purchase or sale of one (1) advertisement in the annual NOATG journal (may be your own ad at reduced members' rate).
  - c) Participation in at least one ICNY

event working committee (may include NOATG, Hallowe'en dance committees, etc.).

d) Attendance at at least one (1) out-of-town Coronation.

Basically, your responsibilities are to uphold the purposes of the Court as outlined in the by-laws. Our election should not be a popularity contest; rather, the selection of those individuals best qualified and deserving to serve our organization.

As you look over the candidates, please keep this in mind.

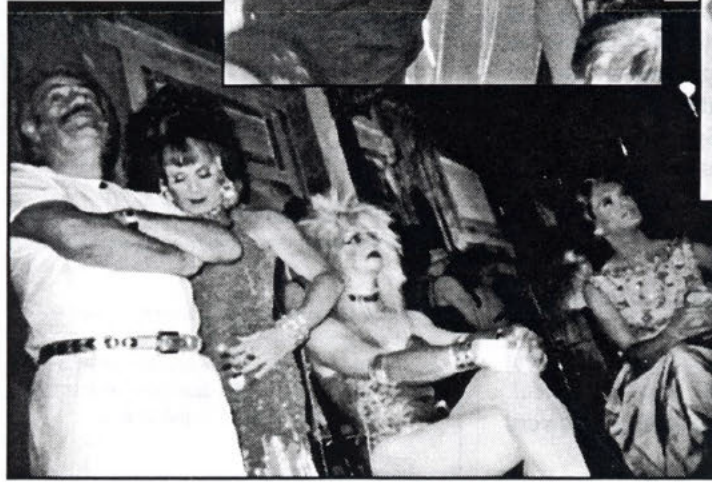

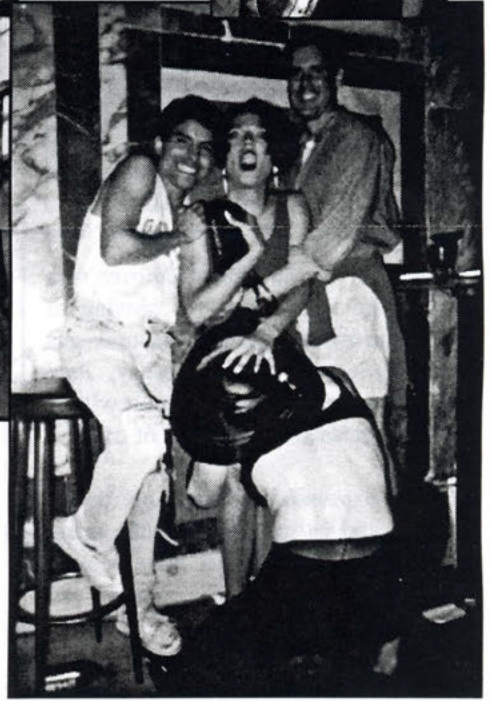
