### THE GIFT by Sheila (CT-102-W)

How many of us I wonder, have ever stopped to think, in a POSITIVE way, about the "woman within us". For me this mystery has been, as I am sure it has for nearly all of my "Sisters of the heart", an almost never ending succession of negative thoughts from a very early age. Then about three years ago, something very special happened to me from within. I don't mean to suggest that my feelings about myself changed instantaneously. It took some time, and even to this day I am still learning. But gradually, and with much help, I began to think about my "feminine side" in a very gentle and open way. It wasn't an easy thing to do. All of those old negatives kept creeping in; guilt, shame, fear, hurt, confusion, rejection and the rest. my sisters know them all top well.

Much to my surprise, I found in time that there was a positive aspect for every one of those old negatives. I have long since stopped finding the bad things about my feminine self and doubt that there will ever be an end to the discovery of good thoughts about "her" for me.

And so it should be for all of us no matter what our problems may be. After all, WE did not make ourselves the way that we are. In fact, it is becoming ever increasingly more evident that our families and life circumstances may have had little or nothing to do with the development of our second selves. I am not saying that our second self may not have been influenced to some extent by our upbringing and or childhood experiences, for in fact many of us, myself included, know very well that we may never have become conciously aware of our feelings had something in our childhood not triggered them in the first place.

For those of us who have been fortunate enough to have access to fairly up to date written material on the subject of gender identity, we are aware that there is a fair consensus among the experts in this field, that genetics may have much to do with this phenomenon "we" know as transvestism.

Genetics! you say? Well I admit that possability was a real shocker for me too! And here is where the positive thinking comes in. We know fully well that no one (so far) has any control over our individual genetic patterns. No one except God! That's right dear Sisters, God made us, EACH AND EVERY ONE, just exactly the way we are right now. This being the case, which it most definitely is, then what we have perhaps believed to be a "curse" or emotional disturbance, turns out to be one of the most amazing mysteries of human nature. Yes, God does work in serendipitous ways, and ours is not to question why, but to accept with gratitude the gifts that have been given us and to share them.

Not only with those, myself included, who love and understand you, but especially with those who DO NOT understand the many, many reasons why God has given us "the best of both worlds" as a "very special" gift!

#### "Expert says it shows our secret desire to switch roles"

"...Dr. Hebert Z. Francelli told the EXAMINER: 'We would all like to change sexual identity, if not actual gender, even the most macho and feminine among us. No matter how secure we may believe we feel in our own sexuality, there is a secret yearning in everyone to step over the 'line at some time and find out for ourselves if the grass is greener on the other side. The movie 'Tootsie' permits us to live the experience vicariously through the actor, Dustin Hoffman. And that of course is the very safest way.'

...(Dorothy Michaels)...'What surprised me is that at 45 I've spent a lifetime observing women and didn't know how they feel.' Hoffman admitted that playing a woman realized a lifetime ambition, but is was more complicated than he had expected. The Academy Award winner's success in the role of Dorothy isn't at all surprising to Francelli. 'It's just part of the fascination the public has with crossdressing,' he said. 'Keep in mind that this is not the first time an actor or actress has scored a triumph as a crossdresser. It's been going on since before the time of Shakespeare and some of the world's most popular stage and screen idols have dressed as the opposite sex for unforgettable roles.'

... The southern-California family counselor said that crossdressing isn't confined to the movies and stage, nor to homosexuals. 'Because of accepted clothing styles today it's quite easy for women to get away with dressing in what not so long ago was considered to be strictly male attire', he said. 'But a surprising number of men, executives to truck drivers, secretly wear frilly feminine underthings to work and to social gatherings under their outer clothing. Or they wear feminine clothing at home, often with the full knowledge and cooperation of their wives. Yet these are people whose romantic relationships are absolutely heterosexual. They merely enjoy crossing-over. The phenomena is more common than you might expect, especially here in California."

Research

"Dear Ms. Moran:

I am a PhD candidate at the Institute for Advanced Study of Human Sexuality in San Francisco. My dissertation topic is a study of women who are in relationship with a man who, sometimes, wears women's clothing.

Little is known about such women. What is known either comes from the man, or from women who are therapy situations. I want to get in information directly from the women, so that their feelings and thoughts can be expressed without being diluted. I am making a national request for women who are willing to take about an hour to fill out a detailed questionnaire. Complete anonymity is assured. The completed questionnaire will be returned in a post paid, pre-addressed envelope. While my -questionnaire contains personal questions, I am not asking for any information that would identify the sender. The completed questionnaire will be seen only by myself. My final report will combine the responses in such a way that individual responses can not be identified.

There will also be an opportunity for the research participants to be interviewed directly, if they wish to do so. Such an interview will allow me to gain more insight into their feelings and situations.

My intent is only to describe and from that description, learn more about women who relate to men who crossdress and also more about the relationship that they share. I have no intention of providing theraputic or etiological explanations about crossdressing nor of providing therapy for the respondant.

I want to gather as diverse and varied a sample as possible. Your Chapter of Tri Sigma has the potential of helping me reach many such women. I would appreciate it if you would place my request in an upcoming issue of your newsletter, <u>Our Special Joy</u>, asking that any women who are interested in participating in this important research contact me at the below address for a copy of my questionnaire.

## COURT RULES CITY MUST NOT DISCRIMINATE

Femina, N. Y. February 26, 2023 (Combined Dispatch)

The U.S. Supreme Court ruled today that this upstate New York city of 22,000 can no longer bar residence to anyone regardless of their preference in attire. Femina, known for permitting only crossdressers and their families to live within its boundries, had fought the case for four years. The community's basis was that no resident wanted to sell their property, so there really was no case.

Mr. John Birdswell, of New York City, wanted to move into a house he says that he inherited. But the matter was disputed by Femina, claiming that the property should revert back to the city as the former owners, Pam and Tammy Birdswell, have died. The property would have been auctioned to qualified applicants who want to live in Femina. Birdswell said that his Aunt Fam and Aunt Tammy's only child, Sammi, now preferred to be called Sam and had no interest in the house. He said that he is now the rightful owner, and is anxious to move into the home on Lace Lane.

"I have no problem living with crossdressers. They are very nice people", stated Birdswell. Mayor Patricia Gallagher said: "We are lawbiding people, and we will, reluctantly,obey the law". In her eighties, Mayor Gallagher continued: "It really is a shame that Birdswell has persisted in this matter".

Mayor Gallagher related that in 2019 Birdswell showed-up at the Mayor's office asking for permission to move into his aunts' house. Birdswell, who was dressed at the time, apparently didn't fool Mayor Gallagher. She said that Birdswell was really not a TV. "He wasn't wearing a slip, a give — away", recalled SULCA Birdswell Gallagher. persisted, and now has finally won his case through the courts.

City Treasurer Mary Jane Moran was uncertain as to what the financial impact will be on the community as a result of the decision. "Back in '07, when the court ruled that we had to have urinals in all public buildings, we really suffered. Why it cost \$1,930,681.35 just to install the one in the rest room at Felicity's Garden next to City Hall. We had to replace it two years later because the pipes rotted out from lack of use". Other concerns were cited by both residents and nonresidents alike as a result of the decision. Mrs. Fred Custer lives in Denver, some 20 minutes from Femina by aerocar, but does most of her shopping here. "I just don't know what will happen, but I hope that things will not change", said Mrs. Custer.

was busy discussing She hemlengths with Sue Parsons, owner of Sue's Nails and Pails, when the decision was " I announced over the air. turned to Sue and said, 'I'd hate it if you had to leave. I don't want to buy Fred's junk in Joe's Hardware in our town. Why, Fred is always telling me to get this or that at your place because Sears is out of stock" Ms. Parsons said she was not worried about losing her business because of the ruling, but was concerned with the overall impact on the city in the future.

"Out in New Femina, California, they permitted the open purchase of homes and businesses five years ago. It really did nothing for them, and soon Georgette's Foundry became New Fem Found. Very tacky. Things went downhill quickly", said Ms. Parsons.

The city's Planning Board apparantly has similar concerns, for they said in a report prepared last year that: "The main arterial in and out of Femina, Pumpkin Boulevard, was rapidly developed. There are on the average two lingerie shoppes, four dress boutiques, and five beauty salons per block. The ability of these businesses to survive under open market conditions is questionable". However, Marlene, the owner of M & M's Motel off the Boulevard at Nora Helene Court, said that business is doing just fine. "With all the tourists we get in Femina, I'm sure that we'll survive. Why, we have just added on to the Darling Wing of the motel, and we're booked solid for the next three months".

Founded some thirty years ago, this busy community is used to change. Mayor Gallagher quipped how crossdressers were once looked down upon by society, and that a lot of effort was required to overcome prejudice and ignorance. "Look at us now. Our taxes are the lowest in the State, no wonder why everyone wants to live here", stated Mayor Gallagher.

Police Officer Joan Debbs perhaps best expressed Femina's reaction to the ruling when, speaking from her pink aero — patrol car, she stated: "I just hope tha Birdswell will at least ge into the community spirit o things and wear a ball gown a the annual Founders' Da affair".
