#### NATIONAL DUES POLICY CLARIFIED...

...The following comments from Donna [REDACTED], National Membership Director, are provided on this matter:

"Over the years, the renewal dues have varied in amount (and at one time were actually \$30). However, as a non-profit organization, we attempt to keep our dues to a realistic amount based upon our actual expenses and will adjust our dues (up or down) periodically as may be required. The current \$25 renewal fee has been in effect for approximately four years, and is listed at least once each year in the FEMME MIRROR...Although each National member now receives an annual dues renewal notice from me indicating the current fee, many recognize how closely we hold the line between renewal fees and expenses and enclose an additional donation. While neither requested or required, such donations are always appreciated!...The entry fee for NEW Sorority members is currently \$30. This fee includes one

year's dues of \$25, plus \$5 'initiation' which covers our start-up costs in establishing a new membership record, expense of a variety of printed materials sent to new members, plus a minimum \$2.40 postage charge for the initial new member mailing; this just about takes care of the \$5. As I am sure that you know, through association with the publication of OSJ, the paper, envelopes, printing costs, and postage will eat up a good 'chunk' of any member's dues! So, if CHI DELTA MU processes a NEW member, their fee is \$30. But, if you transmit any renewals, the current fee is \$25. I hope that this clears up your confusion."

**Question:** I like to wear women's clothes but I have no desire to interact with males when I am cross-dressed. I have read several articles that seem to connect cross-dressing with homosexuality. Am I gay and just do not know it?

**Answer:** One of the most common misunderstandings about cross-dressing is that if you dress like a woman, then you MUST have all the same feelings as a woman. We all carry in our heads a collection of concepts that define for us the appropriate behaviors for men and women. When we see a person who appears to be a woman or who does things that are associated with women, we attach to that person ALL the behaviors that are appropriate to women in this society. Just because a cross-dresser wears women's clothes does not mean that he has the same motivations and feelings as a woman. Since most women prefer men as sexual partners, there can be an assumption that a male who likes to wear women's clothes must also want a male as a sexual partner. Also, there have been things written about "latent homosexuality" which simply meant that you were gay and didn't know it!!!! Current information has shown that people who are gay are fully aware of it and often at an early age. As for cross-dressers, the best information available indicates that more than 90% of them prefer women as sexual partners. So if you are the typical cross-dresser you are most probably not gay, for if you were you would be aware of it.

One other thing — there appears to be a hidden concern in your question — it seems that you may be thinking that being homosexual is bad. There is nothing wrong in choosing persons of the same sex for sexual partners. If there is a loving, caring relationship between the two people, the type of genitalia each person has is immaterial. The major problem that most gay people have is rejection by judgemental people who do not understand the gay lifestyle.

**Question:** I would like to take female hormones. Is this dangerous?

**Answer:** It is most assuredly dangerous even if you are under a physician's care. There are two different kinds of effects — physical and psychological. Physically, taking female hormones can cause many undesirable side-effects, even in women. Birth control pills (female hormones) effect every organ in the body. (One thing that is particularly dangerous is taking your wife's birth control pills. These are prescribed for her particular situation and may be very wrong for you.) If a person has had liver problems, high blood pressure, diabetes and many other diseases, they are often not used, because they can aggravate the condition. In males, female hormones also reduce male hormone production and action. (Female hormones may slow balding but will not grow hair nor reduce body/facial hair, nor will they change a masculine voice to a feminine one.) Since the body's hormone system has many interrelated actions, the radical changing of one component can change other (non-sexual) hormone levels. These changes may result in psychological changes in addition to the desired physical changes (such as breast growth). The psychological changes may include such things as reduced sex drive and general apathy. In addition, there is the social aspect — how does one explain increased breast growth and loss of muscle tissue? In sum, the 'benefits' of taking the female hormones can be more than cancelled by the negative side-effects, so for the average cross-dresser, taking female hormones is not a good idea.

# Quick study gets 'A' for Learning Annex

Bill Zanker's life-crisis came when he was 27 and still a student (film-making). His father said he was an academic bum and he was through supporting him.

"Get a job," commanded Zanker senior. But school was all Zanker knew, so he began to think — maybe he could start his own school. He believed many courses were too long and too costly.

He polled classmates at the New School, found a ready market for quickie, cheapie courses, and plenty of instructors too. So Zanker went to the bank, took out \$5000 in bar mitzvah money, opened an office, and found a printer willing to give him 30 days credit to run off catalogs.

That was the start of the Learning Annex, which offers pop-ed courses in a sort of "Yuppie U." A sampling: *How to Find a Lover*, *How to Start a Business*, *Photographing the Nude* (too many students showed up without cameras) *Tax Shelters for the Middle Class*, *Skydiving This Thing*, *Success Now — Why Wait?*

Zanker started in 1980 as a one-man show. He put on

clown's white-face to hand out catalogs at Grand Central, dashed to his office to answer phones.

Today he has a \$2 million business, with branches in Atlanta, Pittsburgh and Dallas.

Last summer he sold a third of the business for \$3 million on the over-the-counter market.

Last week, he acquired a Washington, D.C., adult education school — Open University — which is expected to increase revenues by \$1.5 million this year. The purchase price was not disclosed.

Zanker also reported a \$44,000 loss for the last quarter of 1984. He attributed this to startup costs in Atlanta and Chicago.

Zanker's curriculum is limited only by demand: *201 Ways to Moonlight with your Computer*, *How to*

*Tend Great Bar*, *Hot Air Ballooning*, *How to Win on the Telephone*, *How to Get Accepted to Medical School*, *What to do when Your Shrink is on Vacation*.

"We're the McDonald's of Education," says Zanker. "We offer quick, inexpensive courses." Most run three to six hours, cost under \$150.

"No course is too crazy," he says. "What's out today could be hot tomorrow." For instance, Zanker rejected "cross-dressing" (men dressing as women, and vice-versa) a few years ago, but is offering it in March. The Boy George phenomenon boomed registration.

Zanker struck out, however, with a course in herpes. "We couldn't sell it at all," says Zanker. "Maybe people were too embarrassed to sign up. But it might go as a videotape or book. We'll give it a try."

Zanker, 30, enrolls 36,000 students a year. He grew up in Teaneck, took Middle Eastern Studies at Hebrew University in Jerusalem. He came home to study

film — until his father called him a bum, inspiring him to start his "Funiversity."

But it's all high-tech. Every registration is computer-coded to tell in an instant if it came off a mailing list, a catalog handed out on a subway or a retail store.

Every student's history is in the computer, "so we know how much he spent and what was the last course he took. That way we know when to hit him up again. If he took basic photography, we send a letter six months later that it's time for Level II."

Zanker is a bachelor. He lives in a two-room apartment on Central Park West at 100th Street. He takes some of his own courses.

"A marketing expert wanted \$5000 for a day's consulting," he said. "Instead I suggested he give a course for the publicity and feedback business he'd get from students. He agreed. I went to all five classes and learned a lot. And I made money on the course instead of laying out \$5000."

The budget for next year calls for no increase in the annual dues for Chapter membership (\$15/year), and no increase in the Meeting Fee (\$10, including your wife/girlfriend). Increases in categories such as Newsletter, Programs, Special Events, etc., reflect continued, anticipated growth in the numbers of Chapter members and, of course, the vast majority of current members renewing their membership next year.

Experience has been that Meeting Fees cover the cost of food and motel rooms, with a small amount left over; your annual dues likewise cover the cost of the newsletter, with a small amount remaining. These monies which are left after the cost of the meeting and newsletter is paid, plus those which are generated by the 50/50, Pink Elephant, Donations, etc., are use for Programs, Advertising, Book Purchase, and other purposes.

No change in dues payable month is reflected,



although a few members feel that all dues should be paid in the same month (i.e., January). This matter will be pursued if enough interest is expressed by the membership to make this change.

The elimination of any funds for the Transfer Res. reflects the projected \$1802 "nest egg" anticipated to be rolled into 1985-86 from the current and prior years' operations. Surpluses are not programmed for 1985-86; these monies which would have been "transferred to reserves", are deployed to Programs, Advertising, etc. Special Events such as Family Day and Spring Weekend are planned to be break-even affairs (i.e., fees collected cover expenses incurred). Those of you who cannot make these events will therefore not subsidize them if all goes according to the financial plan.

The 1985-86 budget for the Chapter is a PRELIMINARY plan for taking in monies and spending them. Major changes such as increasing/decreasing the dues and meeting fees would significantly effect other components of the budget. The membership should consider such possibilities and their ramifications. Your participation in voice or in letter on this important planning tool for the Chapter is most welcomed; the budget is subject to change considering the members' needs and desires.

It is anticipated that the budget will be reviewed and commented upon by the membership in April and May, with approval sought at the June meeting.

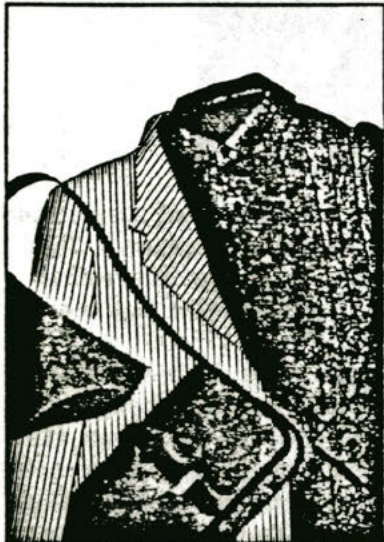

# On The Value of Committees to Chi Delta Mu

There is a well known joke that the camel is a horse designed by committee. While it is true that committee and group decision making can be cumbersome and difficult, there is an underlying value to organizations and social groups like ours. The value becomes apparent during election time when we are seeking capable people for the leadership roles in our chapter.

During the first meeting of the nominating committee, it was realized that many members aren't familiar with the workings of the chapter. We have several people who are very willing to help the chapter. The problem is not in desire, but in perceived capability i.e., they just don't FEEL capable. This is due in a large extent to the limited exposure and experience they have had in chapter workings.

To some degree the notable efforts of our officers to curb non-productive and repetitious discussions during regular business meetings may have produced some undesirable outcomes. No one wants to sit through long debates on minor points, but the current system leaves out participation opportunities for those interested in giving opinions, getting involved or doing some legwork.

There is a popular theory which compares the growth of organizations to the growth stages of other living systems. Within this framework we in Chi Delta Mu have gone through a growth stage; we are coming out of our first life crisis and we are approaching our next growth and crisis stage. The first growth stage, Birthing, was characterized by the growth due to the spontaneous and entrepreneurial efforts of our charter members. The first challenge or crisis to the new organization became one of coordination. Each of the major functions had to work together effectively to bring about the desired result. The progress of the officers this year seems to indicate that good responses have been made to the challenge of coordination. Some "bugs" still remain to be worked out, but progress has been made.

The next predicted crisis organizations face occurs when the effects of coordination cause an excessive centralization of control. Coordination requires the forming of central people performing or directing the majority of

activities. They work together for the best interest of the organization. The amount of inter-communication is high, but the amount of external communication is limited and often one-way. Good growth occurs, but the inevitable next crisis is a result. In order to make transitions through crisis as easy and painless as possible, it is helpful for organizations to anticipate and take early action to prepare for the approaching problem.

Since we are a volunteer social organization, we are also faced with the added challenges of: (1) getting and keeping members willing to accept the various tasks at hand; and (2) trying to get the jobs done in a timely and accurate manner.

To summarize the problem, we have an active chapter where not enough people know enough to help continue the leadership efforts. We have no system for educating members in the manners and methods of chapter decision-making. And, we have no mechanism for utilizing the enthusiastic volunteerism of some new members. We therefore must develop a balanced compromise between participation and centralization in a way volunteers can contribute their talents and time and the core leadership can coordinate the major functions.

So we come to the point of this article, the value of committees. An effective committee system can meet many of the challenges facing the chapter by bringing more interested and willing people into the decision making process. Committee work can provide the confidence and experience members need to feel capable of holding elected office. And, committee work is a useful outlet for the enthusiasm new members often display.

Effective committee system is a skill of management which requires: (1) quality communication among and between members; (2) ability to make and carry out decisions, and (3) timely coordination between the committees and the larger system, i.e., the chapter. The job of the officers becomes one of guiding the committee in participative decision making, coordinating the committee's output, and resolving differences between committees.

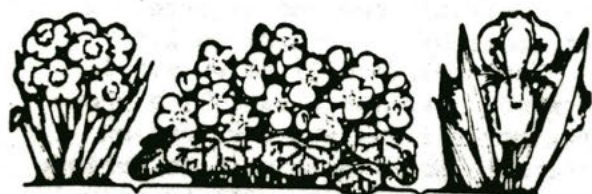
If recommendations are in order, here are some suggestions for the chapter to consider. The creation and maintenance of a standing committee system to address the major purposes and functions of the chapter. Therefore, committees such as Program, Finance, Membership, Newsletter, Publicity (media) and Public Relations, etc., are

created, have regular meetings and report progress at business meetings. Ad-hoc committees are created for special projects on an as needed basis and discontinued when objectives are met. An example of this might be a committee to examine the by-laws when it seems appropriate to update or revise them. Where possible and practical, chapter officers function as members (or chairs) of the standing committees in their area of responsibility. Where the chapter officer is the chair, a second chairperson or vice-chair should be delegated in the event of absence and representation on the executive

committee. In addition to the meetings of the executive board (elected chapter officers), there should be regular meetings of an expanded executive committee. This committee should include the executive board (President, Vice President, Treasurer and Secretary), the GALs, and the standing committee chairpersons (or vice chairs).

No solution is implemented without difficulty and resistance. It's reasonable to assume that problems will occur trying to get a committee system started. However, when we compare the difficulty of implementing an effective committee system against the problems which result from too little involvement, the direction for the chapter seems obvious. The chapter can grow and flourish, reaching out to more crossdressers and their families, and better serve the current membership by fully utilizing its human potential.

Through correspondence over the past ten months we shared our thoughts and feelings about crossdressing, about family, about religion and about many other things. Joanne really enjoyed her "second self" and was quite comfortable in the feminine role. She cheerfully handled the household chores such as the laundry, the cleaning and cooking. She liked to go out shopping for food, clothing and gifts. She loved to visit with her girlfriends and share "girl talk". Joanne was faithful in church attendance and her close friends were encouraging her to join one of the women's groups.

Joanne was a truly warm, gentle, sincere and loving person. Those of her confidantes who knew both Joanne and John were doubly fortunate, indeed. I feel especially sad for them because Joanne's death must have brought them a double measure of grief.

I will always treasure her photographs and letters. The last words I received from her were, "Love, Joanne." That's the way she was. That is how I will remember her.
