Core myths...JoAnn Roberts, adapted from a column in the *Philadelphia Inquirer*

I've heard them so many times now it's like a litany. People keep telling me why they "can't" do a particular thing. It's their "core myth" that is the barrier to action, nothing else. A "core myth" is a personal belief we hold to be true for ourselves that makes life more difficult for us.

The most common core myths are those of failure; "I'll never be able to..., I can't do anything about..., I can't...anything." These myths may or may not have a basis in fact, but we act like they do, so they become self-fulfilling.

Everyone has a core myth and we invent our own antidotes from a neurotic need for specialness. If the core myth is "Everybody lets me down," the neurotic need for

specialness is probably, "I'm an especially good people manager." If the myth is "I can't control my life," the antidote is "I am especially good at controlling things."

This need for specialness works as long as we get others to support it. We depend on other people's reactions. They have to treat us in our "special" way or else we can't feel "special". For many TVs and TSs, seeking this validation is what drives them to find peer support. But what happens, as it often does, when they don't get the "special" treatment they think they need? The absence of this validation can cause an emotional crash. I've seen it happen in our group already.

Instead of feeling special, we

should work toward feeling unique. You don't need an outside validation source to feel unique. You can acknowledge that you are unique and if others don't see that, then it's their problem, not yours. You are not limited by the recognition of your peers.

You can discover your own core myth by asking yourself, "What is it that I am not getting from the most important people in my life?" Whatever you come up with is your myth. Then ask yourself, "What am I doing to to create that?" You must recognize that you create your own sense of success and failure and you must take responsibility for it. You have the capacity to get your emotional needs met, so do it. And, stop that whining!

Re: The washroom problem...Elsa [REDACTED] York, Pa.

Ms. Matheson's good intentions are obvious but she seems to have hangups about bodily functions and bathrooms that have clouded her judgment. She starts out with an inaccuracy that is obvious to most males who have seen snow. Competitive urinating is not unknown among males when a semi-permanent record of distance and accuracy can remain visible in the snow for weeks. (Don't eat yellow snow!) And urinating into a trench or common urinal certainly has absolutely no privacy and could be considered communal.

Her suggestion to limit intake of fluids and to delay urinating/defecating until returning to the safety of home or hotel is fine as long as one is close to home or hotel. Does this mean that Ms. Matheson never goes far from such safety? If she goes shopping more than an hour from home, does she rent a room? This seems an unreasonable expense.

While I agree that most of us

should avoid unnecessary trips to the lady's room, it is naive to believe that one will never require a WC while away from safety and even though we may not be planning to use any restroom, we all need to consider how we would deal with emergencies. It's the same kind of thought that goes into defensive driving.

How about being able to deal with emergency situations such as:

- A fast-acting virus or food poisoning threatens imminent diarrhea or vomiting?
- Your hands get badly soiled?
- Salad dressing runs down your chin and dissolves your makeup?
- Your stockinged legs get splashed with gritty water?
- You must rinse out a stain immediately?

Until you consider how to deal with these situations, you need to stay very close to home or hotel.

Although actors do not neces-

sarily study how they will deal with disasters like falling scenery, missing props or dropped lines, a well prepared actor will stay cool and stay in character. When we go out onto the stage of real life, we need to know our part well enough to muddle through common disasters. And we must remember that often, the worst that will happen is embarrassment.

Do remember that women have been spied on, robbed, assaulted, raped and worse in lady's rooms by women and by men. It's no wonder that some will misinterpret the intentions of a TV. But if you mind your manners, keep to your own business and are wearing your pantyhose on your legs instead of over your head, you should be safe.

Here are some considerations for reducing risks:

- Reduce intake of water and bulky foods prior to the trip.
- Be aware of the locations of

But, on the other hand, maybe it's time to get out and DO SOME-

THING for those who can't get to K of P or who have never heard of Renaissance. Maybe it's time that we make ourselves known.

What geographic area should we target? If we consider those who could drive to Harrisburg or York in an hour or less, we also need to include Baltimore. Rather than calling ourselves "South Central Pa. Chapter," how about "Lower Susquehanna Valley Chapter."

I hate to think I am the only one who would consider organizing a local chapter. I'm much more comfortable as an advisor than as a leader but as it happens I have the time to devote to this and I am more open about my crossdressing than many of you. Plus, I felt so bad about crossdressing for so long that I feel I owe my support to Renaissance in its outreach and education efforts.

The first one to find out about

my crossdressing was my former wife, after two years of courtship and one year into the marriage. Eventually, I learned to tell my closest friends about my crossdressing. When I began a new dating relationship, it sometimes took weeks to get up the nerve to "confess my perversion". Now, I have learned to "share my individuality" with anyone who seems to like me. I am continually amazed at how well most people accept me and my crossdressing. I have been to two Pocono weekends and have made three public appearances for Renaissance. I can take time from work and I have a PC for newsletter and mailing list.

Here I sit, broken hearted; tried to write but...

Some days even the NewsQueen suffers from writers block. Fortunately, those days occur when the news itself is mercifully light.

Those politicians in Chicago are at it again. You'll recall that last year a student exhibition at the Art Institute was thrown into an uproar over a painting of late Mayor Harold Washington decked out in a bra, panties, garter belt and stockings. There must be something about the early spring in the Windy City that makes artists turn to thoughts of crossdressing politicians. The latest target is Alderman Luis Gutierrez. He was pictured in a political cartoon wearing lingerie and high-heeled boots published in an Hispanic community newspaper. The newspaper belongs to Leticia Soliz, wife of Alderman Juan Soliz, the chair of the City Council Human Rights Committee and a political opponent of Gutierrez.

Gutierrez claims that the cartoon figure (whose name is "Luisito") not only mocks him, but invites violence against "those men who may have feminine attributes, and it also clearly attempts to gay bash."

Publisher Soliz denied that the figure in the cartoon represents Gutierrez, but she was unable to say whom or what the cartoon represented. The crossdressed man is shown first saying in Spanish, "A bird in the hand is worth more than seeing a hundred of them flying." Then he adds in English, "Read my lips."



Last year's brouhaha over a painting of Mayor Washington involved fashionable white lingerie. We hope that the figure of Luisito was clothed in black lingerie to reflect the change in fashion that has occurred over the past

twelve months.

According to December sales figures reported recently by Fredericks of Hollywood, black has finally edged out red as the color of choice among the customers of the famed purveyor of exotic underwear. Thirty percent of the garter belts, teddies, camisoles, bustiers and g-strings Fredericks sold in December were in black; 25 percent were red and the remainder were in white, off-white or pastels.

Black lingerie "is seductive somehow. It's the dark side of white—very luring and dangerous," said Jeff Land, a sales clerk at Noir Leather in Royal Oak, Mich.

David Brown, owner of Brown Bag-it Lingerie in Clawson, Mich., notes that the color change is a sign of good taste. "Red is sometimes too florescent," he said, "but black makes any body look good"—even those bodies who wait until the anonymity of the Christmas rush to add to their lingerie collection.

Industry observers (don't you just love that term?) say that the new popularity of black lingerie can be traced to movie stars who recently wowed audiences by wearing sexy, black unmentionables on the screen, stars like Melanie Griffith in *Working Girl* and Susan Sarandon and Tim Robbins in *Bull Durham*.



But for some people, it's not the color of their lingerie that matters, but the fact that they can wear it at all.

For the past 10 years, Angela Williamson has been undergoing surgical and hormone treatments for gender reassignment, and according to her, the process was 95 percent complete although she still has part of her male sex organs. In September of last year she was convicted of theft, and was sent to a men's prison. But within three days, officials noted the sex-

ual ambiguity and she was transferred to a woman's prison after an examination at the University of Kentucky Medical Center.

At first she blended into the prison population, but eventually rumors began to circulate that she was having sex with the inmates. Williamson also complained of complications from her previous surgery. Until the rumors of sexual activity can be investigated and until her medical condition can be reevaluated, Williamson is being held in isolation.

Establishing a new identity...by Jackie K., a pre-op TS in the Real Life Test

I - Getting a driver's license.

Are you a full time TS or TG? are you tired of worrying about getting stopped by the local "finest" and getting weird looks because of your MALE driver's license? If you live in Pennsylvania, read on.

Wait until your license expires and the state sends you the pink form for your photo license. Fill out this form in your FEMALE name. Go to a notary and obtain state form DL80. Fill out the form at the top section in your MALE name and in the Change of Name section put your FEMALE name.

Go to your attending physician (you know the guy who gives you the pills) or your psychiatrist, or your psychologist, and have him/her write a letter, preferably on impressive stationery, attesting to the fact that you are known as this female person, that you live exclusively as this female person, and

that you should be afforded the PRIVILEGE of a driver's license in a female name.

Send this letter with your check, the duplicate license form, and the DL80 form to the address shown on the DL80 form. (Do not send it in the pink envelope.) Then pray to the Goddess.

I used this method to obtain my license even though I have not had SRS, or legally changed my name. When I went to obtain my photo license, I used my Employee Photo ID instead of my old driver's license. You can also use a voter registration card, obtainable by mail.

II - Getting a passport.

Dr. Harry Benjamin, the late Right Hand of God (to a TS), used this method to obtain a passport for a patient of his who wanted to travel outside the country exclusively as a female. Since I have not


had SRS or changed my name, legally, I used a variation of his method to obtain a passport in my female name.

I had to appear at the Passport Office (usually in the county courthouse) in person to execute form DSP-11, Application for Passport. It cannot be done by mail; I tried!

I submitted my old passport, two photographs of me as a female, and personal identification in my female name (in this case my new driver's license.)

In addition, I submitted, on the aforementioned impressive stationery, a statement from my attending physician that I am a pre-operative transsexual in the final stages of treatment prior to surgery. I also submitted form 11-75 (DSP-60) Affidavit Regarding Change of Name, signed by a blood relative (in this case my sister.) I

"safe" restrooms.

- Keep a jar or bottle in the car in case you need to urinate.
- Carry "Wash & Dry" towels in the car and in your purse.

- When in the stall, put your purse where it cannot be grabbed from over/under the door or partition. Even GGs lose purses this way.

• If you are read, some people may think you are a cop.

• Do not go crossdressed into areas where you are in danger of assault.

• Take a friend. Going into the ladies room with a GG friend/wife who will speak up for you will help a lot.

• If you are easily read, consider using the men's room.
