Reported by playboy Dec 1980; St. Louis; The 8th U.S. Circuit Court of Appeals has ruled that the state of Iowa should have paid Medicaid benefits to a man who underwent a sex change operation. The Iowa Dept. of Social Service had rehad refused to pay for treatment, claiming that it did not qualify as "Medically necessary." The appellate court disagreed:" From this record, it appears that radical sex conversion surgery is the only medical treatment available to relieve or solve the problems of a true transexual." The decision upheld a distric court award of \$3024 in medical payments and \$500 for mental anguish and suffering resulting from the wrongful denial of benefits.

Reported by THE GA Recently Toni Ann won \$775,000 in a court settlement granted by a jury of 8 women and 4 me m the Oakland Tribune and columnist Sidney Jones for an article **EDDERE** appearing in the Trib in 1977, which referred to past-operative Tina as a "he" Ms. Diaz charged that the article caused "two years of emotional hell" and

Ms. Diaz charged that the article caused "two years of emotional hell" and that the item by Jones was a "callous in ion of privacy." Jones had written that #the student body president, Toni in , is no lady, but in fact is a man whose real name is Antonio." At the tim I the incident Ms. Diaz was the student body president of Alamed ollege.

dent body president of Alamed llege. The jury, in finding for Ms. , said the item was not newsworthy and would be "highly offensive to a rea ble person of ordinary sensibilities," and that the article was written "with knowledge that it was highly offensive or not."

Of course, the verdict will be appealed. Tribune attorney John Mahoney said the verdicts would be appealed on the grounds, among others, thatDiaz was as a matter of law, a public figure and that therefor the newspaper has a right to factual comment about her.

In the Sept/Oct 1980 issue of Science Digest a column entitled IDENTITY CRISIS provided some small amount of information concerning sex reassignment surgery. In the article Dr. Gene Able, New York State Psychiatric Institute and Dr. Jon K. Meyer of the Johns Hopkins Gender Clinic were quoted concerning their views on reassignment surgery. Dr. Meyer offers the following explanation concerning the cessation of reassignment surgery at John Hopkins. "After several years of elation, a transsexual may discover a bitter fact. He realizes, in a thousand subtle ways," that he is not, and never will be, a

realizes, in a thousand subtle ways," that he is not, and never will be, a real girl, but is at best a convincing simulated female. Such an adjustment cannot compensate forvthe tragedy of having lost all chance to be male and of having no way to be really female.

Changing your sex may not be the best Rx

Baltimore-A study by a Johns Hopkins University psychiatrist suggests that men who wish they were women and women who wish they were men do not benefit from sexchange surgery.

Dr. Jon K. Meyer reached this conclusion after interviewing 50 patients who sought the surgery during or before 1971. Comparing the 24 who were operated on with the 26 who were not, he found that both groups were better adjusted than they had been. But he also found that the showed more improvement in terms of jobs, educational status and social stability.

Few older than 30

Meyer, director of the Johns Hopkins Sexual Behavioral Consultation Unit, told a news conference that he sees few people older than 30 who wish to change their gender surgically, and that this was also true when his study began. Growing older seems to make the

difference. Whether surgery is really in the best interests of the patient is debat-able, he said. "What is really important is

that at a time of crisis in the patient's life, some kind of therapy is offered. It prob-ably doesn't really matter what."

About 100 to 150 patients whose gender- identity problems are entirely psychological consult Meyer's clinic each year, many of them adolescents brought by their parents, and some of the children are as young as four years old.

Meyer said this is not surprising be-cause human beings distinguish them-selves from others in their first 30 months when they also begin to explore their own bodies. If family relationships do not allow these steps to proceed normally, the boy or girl can come to feel that he or she is trapped in the wrong body, he said.

The wish to change sex is not limited to some types of families. "Patients who seek sex- change surgery as adults range all the way from the poor and unemployed to physicians, bank presidents and lawyers," Meyer said. Men wishing to change their sex out-

number the women, and this goes back to childhood too. Meyer said all children identify with their mothers, "but one of the things boys have to do that girls do not is to give this up if they are to double normality" develop normally."

Bridgeport, Conn. (UPI)-A policeman who underwent a sex-change operation plans to return to duty in about two weeks as a woman. Chester Collins, a 13-year veteran of the force, said this weekend he has taken
