## NAME CHANGE

A rose by any other name may still be a rose, but a woman named Marvin or a man named Sue are questionable commodities. Regardless of whether one is a transsexual or crossdresser the necessity to have the legal use of a name appropriate to apparent sex/gender is obvious. There are several ways in which one can obtain the legal use of a name other than the one assigned at birth. One can obtain the use of a name on either a permanent or temporary basis. Transsexuals should understand the hows and wherefores of obtaining the legal use of a name. There are two methods used to change one's name permanently.

Common Law/Usage. The trick here is consistency. You must use the same name on all your documents and to all the people knowing you. You must never use a different name than the one you commonly use since there may be a time when affidavits may be required and the people you call on for these documents must know you only by the name you use. This is the least known and probably the least desirable method of changing one's name since many agencies don't recognize it as an accepted method of name change.

Legal Name Change. The first thing you must do is decide on the name you wish to be known by for the rest of your life. The next thing you should do is purchase a copy of the softback book "How To Change Your Name" (California Edition), by David Ventura Loeb, published by Nolo Press. This book is available in many large book stores and there are other State Editions of it. For specific information as to which States are covered by an edition similar to the California Edition, contact Nolo Press at 950 Parker St, Berkeley, CA, 94710. The book is written in an easy to understand and straight-

forward manner, and the forms necessary for completion and submission to courts and County Clerks of California are included. Before completing any of the forms, it would be a good idea to Xerox off a couple of copies of each to use as work copies and then transpose the finalized data to the original. Judges and court clerks don't like messy papers so keep the forms neat and clean.

The book shows/tells how to complete all the forms; how to complete the Court Petition (Step 1) and the Order to Show Cause, i.e., the hearing date (Step 2); how to select a newspaper for publication of the Order to Show Cause; and how to file the forms with the County Clerk. The forms must be filed with the Clerk of the County in which you reside only. A valuable list of reminders of all the various agencies to be notified of the name change, once it is "official," is also provided.

The only fees required are the initial Superior Court filing fee, which will vary from County to County, and the publication fee which will vary from paper to paper. Since the publication fees vary, be sure and shop around to get the least expensive. By the way, you are not required to publish the notice in a large circulation daily paper, use one of the small papers specializing in legal notice publication. Check with the County Clerk's office for a list of the local ones and then select the least expensive one. Often these smaller papers will publish the notice for the required number of times and then forward the proof of publication to the County Clerk, have it stamped, and recorded and send the complete paperwork to you. Look around and get the best deal for the money.

Theoretically the judge cannot refuse to sign the name change so long as there is no proof of fraudulent intent. In reality, however, the judge can do as he/she pleases; and, if he/she refuses to sign the forms, the only recourse you have is to sue and there goes the money you

planned on saving right down the drain. In all probability, the judge will require a letter from your medical doctor, not your therapist, so have one handy just in case it's asked for. It might also be a good idea to have a letter from your employer to show that you are gainfully employed. Cover all bases, you never know what the judge will ask for.

The pamphlet **"Transsexualism and the Law"** reprint **"Chapter F - Identifications"** by Joanna M. Clark, contains samples of name change petitions and affidavits specific to the transsexual.

Before taking the steps to legally change your name, you'll probably want to begin establishing credit and open a bank account under your new name. An easy method of obtaining the paperwork necessary to do this is to obtain the use of your new name as a fictitious name. By the way, the fictitious name procedures are as applicable to the non-transsexual as well as the transsexual.

To obtain a fictitious name, you need only go to, or call, the office of the County Clerk and get the forms used in your State. The forms are easy to fill out. All the entries are self-explanatory. Complete the form, return it to the County Clerk, and pay the recording fee. These statements, like the Legal Name Change, must be published a requisite number of times before they can be finally recorded. The reason for the publication is to be absolutely sure no one else is using the name. Here again, use one of the papers specializing in legal notice publication. Shop around for the paper in which you publish the notice as the publication costs vary from paper to paper and will run from \$20.00 to \$50.00. Generally, the publisher will provide the County Clerk with proof of publication and send you a duly recorded copy of your statement, once publication is completed.

If you want to open a bank account under the fictitious name, take a copy of the form with the filing number on it to the bank and open the account. The account is of little use to you as a reference or bill paying service unless you pass money through it. So use it! To obtain credit cards in the fictitious name, find some places where credit is easily established and open accounts. If you pay them off as the bills become due, you will become known as a "prompt pay" in the credit business and therefore a good risk and assigned a good credit rating. Generally credit card companies, such as Visa and Master Charge, will not issue a card in a family name different then the one in which the account was originally established. So you'll want to establish credit in the fictitious name so that in the future you will have no difficulty in proving that you have credit in the

new name. If we could all pay cash for large purchases, such as an automobile and so on, we wouldn't need a credit line; but since few of us can do that, we need the credit line. An easy way to establish credit is to contact mail order houses, such as Lane Bryant, Roaman's, etc., and establish an account with them. Order a few things on the account and pay it off as it becomes due. After a few transactions with the smaller credit accounts, apply for larger credit cards. They will make a credit check; and if you laid the ground work properly, they will issue you a credit card in the fictitious name. Once you have credit and credit card identity, you are on the way to becoming at least a "paper person" with a degree of legitimacy.

Check out the procedures for obtaining a fictitious name in your State/County and then obtain one if you feel the need. Once the fictitious name gets on a few mailing lists, you will get an abundance of mail in that name, as most mail order houses lease or sell their mailing lists--this is especially true around the Christmas shopping season. When the Christmas shopping catalogs come out, you will be inundated with "junk mail."

Getting A Post Office Box. This is one of the simplest things to do. Simply apply for a P.O.B. in your real name and in the spaces reserved on the form for "Others Using This Box" fill in the fem/butch name you will be using. Now you can receive mail in that name at the P.O.B. Use your real name and address applying for the P.O.B., because the name and address you use on the upper portion of the P.O.B. form will be checked by the postperson delivering mail to that address. If it is non-existent or if you are unknown at the address, they will not issue the P.O.B. Once the box is issued, you can start using it to receive mail for the fictitious name.

## **BIRTH CERTIFICATE CHANGES**

Alabama, Florida and Idaho do not change or amend birth certificates. Ohio changes only the name on the birth certificate and a Court Order is required.

Alaska, Connecticut, Kansas, Main, Massachusetts, Minnesota, Nebraska, Pennsylvania, Utah, and Washington amend the name and sex on the original birth certificate. A court order is required for the name change and an affidavit is required for the sex change on the birth certificate.

Maryland, New Hampshire, South Dakota and Texas issue an amended certificate. A court order is required to change the name and/or sex.

Arizona, Colorado, Hawaii, Indiana, Iowa, Michigan, New York, and North Carolina issue a new birth certificate. A court order is required for the name change and an affidavit for the sex change.

Arkansas, California, Louisiana, Nevada and Vermont issue a new birth certificate with a court order required for the name and/or sex changes.

Georgia and Kentucky issue new birth certificates and require a court order for the name change and both a court order and an affidavit for the sex change.

Illinois issues a new birth certificate. Affidavits are required for both the name and/or sex change.

Wisconsin will amend the original birth certificate and requires affidavits for both the name and sex changes.

Virginia and Tennessee changes only the name on an amend birth certificate. An affidavit is required to change the name.

What is the difference between an "amended" and "new" birth certificate? Generally states that amend a birth certificate retain the old certificate on file with the amended one. In some states the old certificate is "sealed" and not available to the general public but is probably available to courts through court orders.

Where new certificates are issued, generally the original certificate is destroyed. Once the original is destroyed, there is, of course, no way to relate it to the "new" certificate. If you are going to have your birth certificate changed, it may be better to change it only once; that is, have both the name and the sex changed at the same time. However, it is possible to have it changed once for the name and then once again later for the sex. If there are fees, and generally there are, changing it twice incurs payment of a fee each time.

The affidavit required is generally that of the surgeon who performs the sex change surgery. In any case, it is wise to obtain a certificate from the surgeon performing the reassignment that your sex was changed by him/her. Better to be safe than sorry.

## HOW DO YOU TELL THAT SPECIAL SOMEONE?

First of all, there is no way it is going to be easy. And there is no way of being sure of the other's reaction. Be prepared for confusion, misunderstanding, mixed emotions, and even total rejection. Think out what you are going to say well in advance. Practice it in your mind. Even ask and answer questions you think the other person will bring up.

Remember that even educated and intelligent people are not likely to be informed on transsexualism beyond what appears in the popular press and bad jokes. You will have to offer information. Your friend probably won't even know enough to know what questions to ask.

Use analogies. Compare gender dysphoria to other birth defects such as heart murmurs, club feet, cleft palates, etc. . . . Birth defects that are routinely repaired by surgery. Compare the need for hormone therapy to medical conditions such as diabetes, hyperactivity, and epilepsy, which are routinely treated with drugs.

If you are up on biology, explain the similarities between the male and female reproductive systems--that the penis and clitoris grow from the same organ as do the testes and ovaries.

If you have not yet had surgery, explain what can be done. If you have already had it, explain what was done and what you now have. You might even "show and tell."

Offer to give the person literature on transsexualism.

No matter how open-minded and intelligent your friend is, accepting and understanding will not be easy. But from all the loving, understanding, and supportive spouses I have met, I am confident that you will find a special someone who will love you for your personality, not what you have between your legs.

With me, the day after my "special someone" told me about himself, I agreed to marry him.

I am a TV male physically and a total woman mentally. Here's my problem, I'm 6'3" and 190 pounds, husky, big or wide-boned, and have absolutely no female physical features. I die inside every time I go out and see a girl wishing it were me. I cannot, for obvious reasons, do the year or two living as a woman. I would do almost anything if I could be accessible to the operation.

I am 30, single, and holding a very good job. I have felt myself torn apart by the identity crisis since I was 5 years old. I do realize, in a thousand subtle ways, that I am and was meant to be a real woman not at best a convincing simulated female. To lose my manhood is a dream not a tragedy.

Our country, big and beautiful, as it is has hurt many people like me permanently. The operation should really be available to those who feel they need it. That is what freedom is all about. I have served in the armed forces and am a veteran of 'NAM. I spent 4 years in the armed forces, received an honorable discharge. I was a volunteer and volunteered to

go to 'NAM to fight, and die, if necessary, for this country without question. I have asked nothing in return, yet, as a TV or TS, there is no freedom. It is sickening how this has left us unable to live with peace of mind.

In this life, we need to be ourselves, not what is forced on us. We hurt no one in our quest for our womanhood.

I think that a mental problem can be a lot worse than a physical handicap. Millions and millions of dollars are spent each year to win over mental diseases, cancer, diabetes, retardation, etc. Yet the medical expenses for the TS, the therapy, operation, etc., is outrageous and way out of the means for the average person.

If this operation were accessible to me, I wouldn't think twice before being in the hospital immediately. Yet, as I said, I'd not be able to live as a total woman because I'm big physically. But I know and my mind would be at a rest that I was the woman I was always meant to be. I would love to have the operation and show Drs. Meyer, Restak and Able how wrong, ill advised and unqualified they really are. These doctors are apparently worrying.

## WIFE LINE!!!

Dear Sandy,

I wrote to you several months ago about coming home two days early from a visit to the children and finding my husband dressed in several articles of MY clothing. At the time I was quite upset and incensed about his conduct--so much so that I threatened to divorce him after 22 years of marriage and insisted that HE see a psychiatrist about his disgusting desires.

At that time, you responded with the question of whether or not I would prefer to be married to an "old drunk" or a "womanizer." You also suggested that possibly I was the one who should see the "shrink" since I apparently was having a problem with MY identity.

Initially, I thought your answer flippant and cold--obviously, you having been married to a crossdresser for more years than I were more supportive and sympathetic toward your husband's needs than I was to mine.

Well, Sandy, I took your advice and both of us had several sessions with a psychologist "into" gender dysphoria. I now understand the needs of my husband to crossdress and cross-identify--when dressed Liz lives in our home.

I have now really gotten into helping Liz become a person. We have been out for late evening drives and even had some of her friends over. I must say, that in anticipation of the first visit of two of her friends (crossdressers like her), I was more than a little nervous. But, as the evening with them wore on, I became less and less aware that they were not what they appeared to be and now I am quite "at home" with Liz's friends. I find that they are all intelligent, hard-working family oriented and in love with their wives--if I may use that term.

In short, I find this life with "two" people very enjoyable and certainly would not want to see it change.

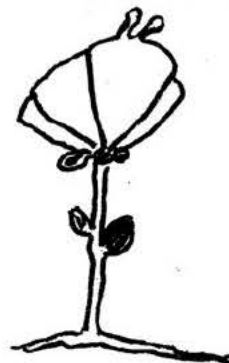

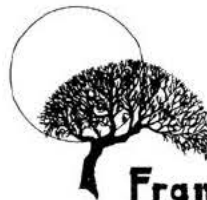

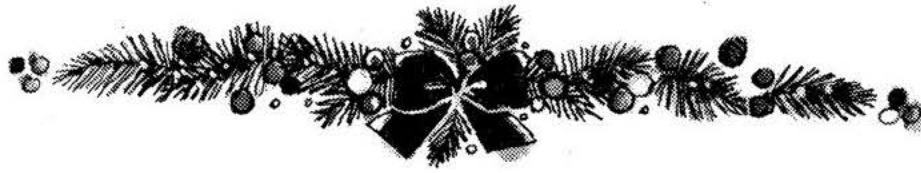
