### Hi.

I am Sarah Douglas, an attorney in Brentwood with a practice in transgender law. I, myself, am transsexual and in the midst of my own transition. I am writing to get out the word that I am available for legal services to the transgender community and for speaking engagements to gender organizations, civic groups, support groups and employers. I offer legal and speaking services to the entire gender community.

I am the only lawyer in SoCal with a specific transgender practice. My clients consist of cross-dressers, transgenders, transsexuals, mtf's, ftm's, spouses and S.O.'s, gays, lesbians and bisexuals, and my practice covers all areas of the law affecting the gender community including family, criminal, employment, civil rights, personal injury/defamation, and workplace law. I am the Employment Law Moderator for the International Conference on Transgender Law and Employment Policy (I.C.T.L.E.P.) and a public speaker for the gender community, employers and civic groups.

My spouse and I have an interest in support for partners of transgendered persons, and can offer support and education to spouses and S.O.'s. In our own marriage we have been through cross-dressing and transsexual issues, as well as the challenges to the relationship that gender transition imposes. Our survival and success through the process has inspired us to offer support to others similarly situated.

Please pass this information on to your membership. Those with a need for understanding and expert legal support need to know that there is someone they can talk to. Additionally, if I can offer my services as a speaker on the legal issues relevant to the gender community, please let me know.

Thank you for your kind attention to this. There is a great need in our community and almost no one to fill it.

## **Rutgers Includes** Transgendered

After almost two years of difficult struggle over transgender and gendervariant inclusion in the Non-Discrimination Policy at Rutgers University, Executive Vice-President Joe Seneca released a memo which expanded discrimination protections at Rutgers University to include "people who have changed or are in the process of changing their sex." The change effectively expands the policy to cover transsexuality.



# **President's Page**

I recently subscribed to *Bottom Line Personal*, semi-monthly periodical which gives its subscribers helpful hints on everything from personal health to tips on how to invest. I did not figure on it doing much to help with anything much more than that. But guess what? I found some articles which could help you when planning your trip to San Francisco for *California Dreamin'* 1998.

The first one is entitled Shrewder Shaving, by Neal Schultz, MD, a dermatologist in private practice in New York City.

1) If one uses razor blades, wait two minutes after applying shaving cream or gel to give the product more time to work into the beard.

2) To minimize irritation, shave no more than twice over any area. Shave with the grain first, then against the grain.

3) For sensitive skin, shave at the end of the shower while still in the shower and use a gel. Avoid shaving just before exercising. Perspiration irritates newly shaved skin.

4) Shave only once a day, if possible. If one shaves more than twice a day, then switch to an electric shaver to lower irritation. Some people get best results by alternating between an electric razor and wet shaving.

What about getting to San Francisco? Many of us will be flying. From *Friendlier Flying*, by Ed Perkins, editor of Consumer Reports Travel Letter, if you plan to fly coach, choose a plane with comfortable seats. Wide body planes like the 767 are more comfortable than the 747. For narrow body planes, choose the A-320 over the 737 or 757. Don't want any neighbors? Request a seat towards the back of the plane... Ask for a center section aisle seat on a 767 or 747. Usually middle seats often go unfilled.

From *Travel Holiday* magazine, once you get to the hotel, play it safe. Rooms safest from "uninvited guests" (and I'm not talking Christine bless-her-heart) are near elevators and open interior hallways - not outdoors. Avoid rooms on the first two floors or at the end of long hallways. Never leave the PLEASE MAKE UP THIS ROOM sign outside the door. The housekeeping staff will make up the room anyway. The sign advertises you are out of the room. When going out, leave on a light and the TV or radio. and hand the DO NOT DISTURB sign on the door.

Ready to go out on the town? Michael Bauer of the *San Francisco Chronicle* gives his favorite places. Farallon 450 Post St, is a bit expensive, but is great for seafood. 42 Degrees 235 16th street in moderately price, has a grand dining room with floor to ceiling windows, and has live jazz music. Globe, 2090 Pacific Ave. is also expensive and is set in a turn-of-the-century livery stable. Jardiniere, 300 Grove St, has a spectacular dining room with brick walls. The chef/owner was named Rising Star Chef by the James Beard Foundation. PlumpJack Cafe, 3127 Fillmore St. is a stylish restaurant with Southern French and Northern Italian cuisines. Finally Zuni Cafe, 1658 Market St, is best for people watching. The dining room has an open. loft-like feel. The prices here are moderate.

Hope these ideas and hints help to make your Convention stay an enjoyable one.

I am appreciative of Jim's place because it is available to us couples to go and feel comfortable in learning together. Now, providing safe shopping for clothes and place to try them on. YES I know many of you go right into

Nordstrom, Penney or, Macys and try the clothes on. But how many of you have your wives willing to go with you and chance running into someone from work, family, church or wherever. Not much chance at Jim's. We go to Jim's shop in groups and take over the shop trying on clothes and having a ball. Jim does not get upset if we just play and don't always buy.

Why do I feel an important tug at my heart to share this information: First, the dresses that so many complimented Chrissy and I on Saturday night were purchased from Jim Bridges. Also, I felt there were some comments in the article in your newsletter that pointed out that even though many of you have portrayed the part of a woman for a long time. There is a chance you still have missed some things in life that we GG's know to be factual and should be pointed out. If you are a petite or a large person you know you have to pay extra at the specialty shops designed for our special size bodies. The reason for clothing cost being higher at the petite store is not because it takes more material to make the clothes. So the cute remarks about, "what do you expect at the larger women's stores, it takes more material" doesn't hold water. The cost of their clothes at both types of stores is higher because they are special, made to specifications to fit a special need. One of the stores I have to shop is Petite Sophisticate their clothing is more expensive versus less quality compared to other regular sized clothes. I can shop both Macys' petite department and women's department and

, find the same exact style blouse, suit or dress made by the same manufacturer in both departments. You would expect they would be equal in price but you are wrong a petite 6 is usually \$10.00 or more than sizes 6-18 in the regular sizes. Fair NO! But they are meeting a SPECIAL need. Same with Jim, if you try his clothes on you will find the sleeves much longer and the shoulders much wider — Meeting a special need — bigger shoulders and longer arms that men have a hard time getting covered. He also has designs made with long sleeves and high necklines to hide the areas that many do not dare shave. Meeting a need most women do not have. Last but not least if any of you have ever shopped a Penney catalog or Sears old catalog you pay \$5.00 and receive a \$5.00 discount off your first order. I was upset when they started charging for their catalog but they have been able to upgrade the quality of their clothing by cutting their losses giving away thousands of unused catalogs. If you buy Jim's catalog you get a certificate for \$10.00 off your first order. Jim mailed some freebies to people he thought were friends. Of course he did not include a \$10.00 off certificate with the freebies. ALL businesses try to cut their cost, this is not taking advantage of people, and it is just good business. Since we received so many compliments Saturday night about our clothes I feel all of you were not lying about how nice the clothes looked. So there must be good quality clothes, clothes that you will feel are in good taste and available to wear to work, to church or play in Jim's new line. There are also clothes for those who want that special look that many wives would prefer our husbands stay away from. Like the too short -- too low -too tight -- little black nothing Arlene wore Saturday night. But, that was a Macys' Get Got dress. I truly feel it is not were you buy the clothes, are how much you pay, its what you do with them and the way you fit it, plus what accessories you use with the clothes. The clothes could be from Nordstrom, Wal-Mart or Jim Bridges. Each business is meeting a need. I prefer to just leave your choice of stores to each of you.

Thank you for allowing me to share my view with you. It is my opinion and each of us have the right to our own opinion but after being hurt so many times and being chased away from one of the most important things in my life by someone's opinion in this community. I have a hard time understanding why when there are so many more people falling into that "NORMAL WORLD" against us, we can't just encourage one another instead of discourage in order to work together to build a stronger better world for our community. You know those famous words "Why can't we just get along?" I personally live for that day
