Campaign begins for change to Pa. hate crimes law

Prompted by an article in last month's *Renaissance News*, a Greater Philadelphia Chapter member has begun a personal lobbying effort to support the proposed amendment to the Pennsylvania hate crimes law, House Bill 1353.

The amendment, sponsored by State Rep. Babette Josephs (D-Phila.) would add the words "actual or perceived ... sexual orientation" to Section 2710, Title 18 of the Pennsylvania Consolidated Statutes. This law now calls for more severe penalties when a violent crime is "motivated by hatred toward the race, color, religion, or national origin" of the victim. The Josephs amendment would require the same stiffer penalties when the victims are lesbian or gay, or are perceived by their attacker to be lesbian or gay.

The proposed change in the law would provide some protection for

transgendered people even though they are not specifically mentioned in the amendment. This is because violence against transsexuals and transvestites is often prompted by the belief that these people are "queer." By including perceived sexual orientation, the amendment would ban this type of attack.

"Many crossdressers go to gay clubs due to the greater acceptance we get there. If someone decided to beat me up when I'm leaving a gay club in drag and they think I'm gay, I should have the additional remedies the law provides," Joann [redacted] of the Greater Philadelphia Chapter said to explain why she is working to help pass the amendment.

[redacted] contacted Josephs' office and asked what she could do to help get the amendment approved by the state House of Representatives. Andrea Friedman, and aide to Josephs, told her that lawmakers needed to hear from their constitu-

ents. Post cards were available, and if [redacted] could get them signed and returned to Josephs' office or to the Philadelphia Mayor's Commission for Sexual Minorities, they would be forwarded to the appropriate legislator.

When asked about security for the crossdresser who is closeted, Friedman said that the cards could be signed with the individual's femme name, but that it must carry that person's correct Zip code so the card would reach the proper lawmaker.

"The cards don't say anything about the sender's sexual orientation or gender role," Friedman added. "All they say is that the sender is asking her legislator to support the Hate Crimes Amendment."

If the bill is approved by the state House, a similar lobbying effort must be directed toward the Senate.

Vikki, who lives in a Philadelphia suburb, was driving to the February Greater Philadelphia meeting when she realized the worst fear of many transvestites — car trouble. The transmission in her van died while she was on the Pennsylvania Turnpike just before the exit for Route 202; she was stuck in the center lane with no power.

Being dressed up for a meeting with the girls is one thing, but

being dressed while stranded on a busy limited access highway is quite another.

"I considered changing into my street clothes which were in the back of my van," she said. "But after about five minutes, a state police car pulled up and the troopers asked if had car problems."

Following routine, one of the troopers took her license and registration and checked it out, then

SURVIVAL

During the Vietnam War, I was the producer and chief photographer for Charles Kuralt, and was the creator of his "On the Road" looks at life. As we turned our cameras toward life in America, from small town to metropolitan city, I became very aware of the differences in social attitudes. This curiosity motivated me to explore this unique phenomena further... especially where gender issues are concerned.

Attitudes have changed very little in 1991 from what we learned about in the 60's and 70's. By that I mean many American people think and believe much the same way as they did 25 years ago. Sure we made some great strides in racial equality and in women's rights, but these issues are merely the symptom of the problem, rather than the real cause. In short, we have been treating the symptoms of the illness, not the cause, and now the patient is dying.

The reasons *why* people believe the way they do have not changed primarily because of the way people are socialized. Someone growing up in Los Angeles is going to be socialized in today's world much differently than someone reared in Sandy Hook, Mississippi. Quite simply, it comes down to the issue of large versus small city.

My cousin, Sandi, and I have spoken of this difference quite often relative to gender issues (primarily my personal issues).

I grew up in a very rural area in Idaho. My parents had been reared here as had theirs before them. Much of the local interest centered around friends and neighbors, farm and ranch issues, and local high school sports. Grangerville was such a small town that it seemed totally separated from the rest of America. Things occurring in the Middle East or in New York didn't affect us much, so most people weren't much interested in outside goings on. The val-

ues passed on to the new generation of children were those probably stemming from what great grandpa believed. And in such a small town you really didn't see a crossdresser parading around in public. Even homosexuality was taboo, never to be talked about. I mean, no one in that little town could ever be gay, or transsexual. At least that is what those people in small-town America believed. Those kind of things just didn't happen there.

Since my cousin had grown up in the gigantic megalopolis of L.A., she was aware at a very early age of the varieties and types of people that inhabit our world. She learned at a very young age the many problems affecting would could be termed normal society Sandi was witness to gays, lesbians, crossdressers, transsexuals, S&M, and all the rest. It *was* a part of her world where it was *not* part of the micro world of Grangerville. Her sociological upbringing allowed her the opportunity to see more variances in life that could be found in the small city.

Too, her parents did pass on to Sandi values that were 100 years out of date. When she learned of my transsexual issues, Sandi immediately had a rudimentary understanding of my problems (though she had known for years). It was not a shock nor did her teeth fall out when she heard of my sex reassignment surgery. In fact, Sandi became my most ardent supporter, and today is more as sister to me than my own sister.

There are more issues that affect transsexuals in this small versus large town argument, things much more basic to survival.

Gender conflicted individuals in the small town, partly due to this "small town thinking" and socialization will find professional support extremely limited. Physicians in a little berg probably won't know anything about the medical treatment of the transsexual in transi-

tion — especially endocrine management. Psychologists and psychiatrists in this same setting, too, most likely won't know much about your problem and how to deal with it. I had one psychologist in a small town tell me, "I have never dealt with transsexualism before, but we can explore it together." Sure we could; I could give him an education while paying him \$75 an hour for that honor. Bull crackers!

Trying to fight the prejudiced intellect in a smaller city while attempting to find work as the person you wish to be is akin to bashing your head against a brick wall. More doors will be closed in your face than at a magician's convention. Most probably, word will have gone through the grapevine before you ever walk into the employer's office.

In a city larger than 100,000, the number of available jobs is greatly increased simply because of the population size. Employers will possibly know something about transsexualism, and will not be likely to be negatively biased. Medical and counseling services will be more knowledgeable. And neighbors aren't going to be afraid you will molest their cat or children.

So, what is the answer to those transsexuals struggling in small-town America? Your search may prove to be more fruitful in the larger area in all capacities of transition. But it may mean moving away from family and friends to an unknown city. In the new area you may also find gender support groups that will make the move easier.

There is no way to change the idiom of small-town thinking. If you can't change the way the world around you thinks, you certainly can change where you live.

At University of Pennsylvania

Murder of crossdressed king may hold lessons for freshmen

Next month, 2,300 freshmen at the University of Pennsylvania will form small groups and discuss the story of a man who was murdered by his mother and her friends when they discovered him dressed in women's clothes.

No, the Penn freshmen will not be discussing a story from *The Weekly World News*; instead, they will be talking about the classical Greek play by Euripides *The Bacchae*.

As an experiment to prompt student debate on several contemporary subjects, all incoming freshmen at the Ivy League school have been asked to read the play over the summer. During freshmen orientation week, more than 150 faculty members will lead discussions

among small groups of students. Courses will also be offered about they play during the school year

Penn officials hope that discussions about the play will lead the students to talk about contemporary issues affecting the campus.

So how does crossdressing fit into this plan?

The play is about Pentheus, king of the ancient Greek city-state of Thebes, and his efforts to drive the effeminate Dionysus, the god of orgies, wine, and the theater, out of Thebes. One of Pentheus' failures is his inability to recognize the irresistible nature of the Dionysian cult with its frenzied celebration of wine, women, and song.

The king is tricked into dressing like a woman so he can spy on the

frolicking women, including his own mother. She joins the other women in killing and dismembering Pentheus after they discover his true gender. Only after the deed is accomplished does she realize that it is her son's head that she has impaled on the tip of her spear.

"The play is as current as a Spike Lee movie," said Normas S. Adler, associate dean for undergraduate studies in Penn's School of Arts and Sciences.

He adds that "it questions some of our basic tenets" such as rationalism, masculinity, the role of the state, power, and the psyche of a society.

It is also likely to keep crossdressing Penn freshman deep in the closet.

Back home again

Clothes make the transvestite at 25th high school reunion

Walking into my 25th high school reunion in drag made me think about what happened to Carrie at her senior prom. I quickly checked the rafters of the local Elk's lodge — no buckets of blood. Only two doors led out of the room — a snap to close with my psychokinetic powers if I needed to incinerate the place for revenge.

Unnecessary fears? Hardly, judging by the response of my classmates to my smart black cocktail dress, tastefully accessorized with simple rhinestone jewelry and a name badge that carried my '66 yearbook picture. Many classmates merely nodded to acknowledge my presence; others gave me a perfunctory greeting after first checking my name badge and my cleavage (but not in that order), and some walked away while I was talking to them. Only one or two actually conversed with me, and they didn't even ask why I was dressed as a woman. I had to prompt them to inquire so I could explain.

"I have been a transvestite since before I started school," I said. "Until recently, this had given me a lot of guilt. When I was in school I kept people at arm's length so they would

not discover my secret. But now that I have accepted this part of my personality, I want to share it with you so that you have a better understanding of who I am."

This went over well with all but one friend. After my little speech, he replied, "This is a joke, right?" No, Jack, I'm serious. But he insisted, "you were such a kidder in high school, this has got to be a joke." I left him standing there waiting for a laugh that wouldn't come.

By pacing myself, I was able to occupy the cocktail hour with enough small talk so I didn't feel too much like an outcast. In fact, I began to enjoy my peculiar method of crowd control; I would go to one side of the room and my classmates would move to the other. That game ended when everyone went into the dining room.

With my chaperone for the evening, a reporter from a local newspaper, I went to several tables in search of seats. "Sorry, these are saved," we were told on more than one occasion. Finally, we found two chairs at a table in the corner.

I had not been close to the woman at the table, but she remembered me (prompted by my photogenic name badge) and introduced me to

her husband after asking how I wanted to be addressed. After exchanging some pleasantries, she leaned close to me and whispered, "I don't want to pry, but when did you have your sex change?"

At last, I thought, someone is acknowledging the difference between the way I looked in high school and the way I look tonight. Even though her question was off the mark, she at least had identified me as being transgendered. She caught on quickly when I explained the difference between transsexuals and transvestites, adding that the way I was dressed didn't bother her because she was sophisticated — she had moved away from Dowagiac, Mich., (pop. 6,409) to the state capital!

The only other memorable occurrence during dinner was when a guy at a neighboring table kept hissing at me, "Stop fanning yourself; you're just trying to attract attention!" I replied that the only way I could attract *more* attention was if I had been accompanied by a naked man waving an long-handled ostrich-plumed fan. He didn't get the joke.

The third phase of the evening's festivities began after dinner: the requisite awards for class members' "achievements." First was the award for the person who had come the farthest. This prompted a debate on the distances to California and Washington (Washington won). The award for the most grandchildren sparked discussion on whether step-grandchildren counted (they did). Finally came the award for the person who had changed the most.

"I am sure we all agree," the reunion chairman said, "that person is Paul Hanson."

█████ will have the postcards available at Greater Philadelphia Chapter meetings. But she also recommends that members write a letter or call their legislators' offices and tell them to vote for the bill.

"A postcard is great," she said, "but a personal letter or a phone call from a constituent will have an ever greater impact."

ther in Philadelphia, (215) 977-7732, or in Harrisburg, (717) 787-8529.

"It's not a perfect world," said █████. "In a perfect world no one would beat you up for being different. As long as people who act like that are around, we're going to need things like the Hate Crimes Law. It may not give our community everything we need, but it is a start. I think transgendered people who don't help get it approved are extremely foolish."

Being unaccustomed to driving in flats, Miss Sinclair fears that she may have exceeded the speed limit while crossing Pennsylvania, Ohio, and Indiana. Yet she was fortunate in not meeting any state troopers. She would have been especially fortunate not to meet a man in Maryland who was posing as a police officer and stopping lady motorists.

Justine Fahringer told actual authorities that at first she wasn't suspicious when the person dressed in a low-cut T-shirt and wearing makeup and a long wig stopped her and identified himself as an undercover police officer. "He wasn't trying to disguise the fact that he was a male," she said.

After the man displayed what Fahringer thought was a Maryland state police badge, she handed over her driver's license and her car

registration. Then he told her to get into his car and he would take her to the police station for questioning about a hit-and-run accident.

"That's when I knew he wasn't a police officer," she said. When she refused to leave her car, the impersonator told her she was resisting arrest. "I told him I'm resisting whatever it is you are trying to do."

Maryland authorities had no leads in their investigation into the crossdressing impostor.

You have got to give the impostor credit for having a good line. But not as good as the crossdressed man arrested in a women's bathroom in Turin, Italy. He told police he only wanted to read the feminine graffiti.

If you are in Syracuse, N.Y., and are stopped by men dressed as women claiming to be police officers — they probably are.

To crack down on prostitution, two officers dressed as hookers (complete with mini skirts) and offered sex for \$20 or \$30 to unsuspecting johns. When the men agreed, other police officers moved in to make the arrests. According to reports, the johns never knew what hit them. The decoys never dropped out of character even after the arrests were made, and did not divulge their true gender to the arrested men.

John Corbit of the department's Special Investigations Division admitted that normally female police officers are used for this type of decoy operation, but that both officers volunteered for the assignment and were very serious about their jobs.

"Besides," Corbit said, "they already had all the clothes and real frilly lingerie. Next time, I want to do it."

No, he didn't actually say that. Miss Sinclair just wanted to see if

you were paying attention.

A former police officer from Rock Hill, S.C., donned a different type of drag, to avoid being arrested, and it worked for more than six years.

After she was charged with grand theft while on the force in 1985, Renee Brown went on the lam, taking on the identity of a man and calling herself John D'Amanda. She took male hormones and had her breasts removed. She even married a woman named Linda Cleveland, although Renee had not actually become a man.

"When I saw the relationship was becoming serious, I sat Linda down and told her I had once been a woman," Renee said from her prison cell. "She was shocked. She said 'I can't picture you as a woman.' After thinking things over for a week, she said, 'I fell in love with you as John.'"

The pair lived together for a year, and then were married. But their happiness was cut short when Renee was arrested. She believes her brother-in-law tipped off police.

She said that the reason she tried to avoid arrest was that she was fearful of the treatment she would receive from her former colleagues on the force and prison guards.

Fear of the police can cause people to do strange things. Take Rodney King's case, for example.

King, you may remember, is the Los Angeles man whose videotaped beating at the hands (and clubs and feet) of several of L.A.P.D.'s "finest" made national news last March, and caused a shake-up in the department.

Several months later, King was stopped by police for soliciting a prostitute in Hollywood. When confronted, he tried to run down the vice cops with his car.

The cops were working undercover at the time they tried to arrest King, who claimed he didn't know

they were cops. No, it's not what you think. The police were dressed as men. It was the prostitute who was in drag.

The prostitute King hired and then ejected from his car fared better than one of her sisters from the Hollywood streets, Chris (Chantel) Lopez. His dead body was thrown from a speeding car. He had been shot. Witnesses didn't get a good description of the driver, but they easily identified the car as a powerful Camaro with wide tires, chrome wheels, and a raised rear end with a spoiler fin.

This was the third killing of a transgendered prostitute in Hollywood this year.

Police officers in Raleigh, N.C., have been busy keeping the town safe for decent people. No, they haven't been posing as prostitutes and arresting johns, or even preventing murders; they have been cleaning out adult bookstores. Earlier this year, six employees at two establishments were arrested, and last month four pleaded guilty to distributing pornography.

The businesses remain open even after the employees paid their fines. But the stores no longer stock the type material that the vice cops seized as being beyond the community's standard. The citizens of Raleigh can enjoy their straight porn, free from the scourge of she-male, gay, and bisexual erotica.

The Raleigh police obviously can't recognize the important educational value of she-male erotica. For example, having viewed a video tape entitled *Bangkok Lady Boys*, Miss Sinclair is fully able to understand the social implications of the following Reuters dispatch...

BANGKOK - A Thai court has annulled an Italian man's marriage to a man he thought was a woman.

Paolo Edoardo Boeris, 27, the owner of a soft-drink business in Asti, Italy, married Riam Kuemjan, 33, last year.

They had sex several times, but always in the dark, and Riam was able to disguise the fact that he was a man, Boeris's lawyer, Prechab Nuan-samlee, told reporters.

Was Boeris so inexperienced with sex that he couldn't tell a man from a woman? Is it a myth that Italian men are sexual animals? Is there a hit Broadway play in this story? These questions naturally would come to mind after reading this news story. But thanks to the educational video she was able to rent at 12th and Spruce Streets (far from the reach of the Raleigh police), Miss Sinclair understands (and admires) the clever tricks used by the "lady boys," of Thailand and has only sympathy for poor Paolo.

♣♣♣

The desire to "have a relationship with a man as a woman" and perhaps avoid an embarrassing annulment, was one of the motivations for a sex change cited by a celebrity in our community from Texas.

Kathryn McGuire (*nee* Charles McGuire) became a woman in London last month following a career as a highway contractor, Houston's premier socialite transvestite, and first openly transgendered (but unsuccessful) City Council candidate.

After years of crossdressing — at first secretly and then openly — McGuire found transvestism unsatisfying. "The more I dressed that way, the more I realized that I wanted to be all woman and have a relationship with a man as a woman," she said in a telephone interview with *The Houston Post* from her London hospital bed.

"So many socialites have said they'll give me tips on how to please a man," she said.

McGuire, who has never let money or modesty stand in her way,

said her story will be the focus of a documentary that Hollywood filmmaker Brian Huberman plans to air on the Fox network, but she gave no air date.

"I'm excited about it," she said of the film project, "but I just hate the thought that people are going to see me without my makeup and wigs. I just hope it doesn't turn off too many good-looking men. I'm sure it won't turn off this one guy in Cleveland who met me when I gave a speech there. He says he's sure he'll love me because I'm Texas-tough."

♣♣♣

We don't know about "Texas-tough," but we do know about "Pittsburgh-tough," at least as practiced by a pair of rock 'n' roll DJs: Jim Quinn and "Banana" Don Jefferson of WBZZ-FM. The pair recently posed for an advertising photo wearing women's wigs. A third person in the photo was a female model. The ad read "two out of three women listen to" Quinn and Jefferson.

The ad campaign began after (but not because) the station was ordered by a court to pay \$694,000 in response to a sexual harassment complaint filed by the station's former news director, Liz Randolph. The station later settled a second complaint filed by Randolph out of court. She alleged that between 1986 and 1988, the morning team subjected her to jokes about sex and troubles with men, yet the station did nothing to stop them.

Are these guys *real men* or what? First, they insult a female co-worker, then, they pose as women. It's circumstances like this that give credibility to the allegation by some that drag is demeaning to women.

Miss Sinclair is determined to add to her anthropologic knowledge by renting many more video tapes. Therefore, she may not see some news stories concerning crossdressing. Won't you help her out like Mary Ann [redacted] and R. Fenner did this month by sending her clippings? Be sure to note the date and name of publication.

they pushed the van to the side of the road and asked where she was going.

Vikki figured it was time to make a clean breast of it, so to speak.

"I told him I was heading for a Renaissance meeting, and I asked if he had ever heard of Renaissance, an organization for transvestites and transsexuals."

"That's interesting," was all one trooper said.

So far, so good, Vikki figured, so she asked if they would drop her off at the meeting so she could get a ride home. They agreed.

"When we arrived at The Woods," Vikki said, "one of the troopers asked if all the cars were there for the meeting. He seemed amazed by the number of people attending."

The members standing outside when Vikki pulled up in a state police car were no less surprised than the troopers. But Vikki was calm because she had an earlier encounter with police while

crossdressed. It happened several months earlier following a Mary Kay makeover.

Vikki was driving home in drag for the first time. A block from her house, she ran past a newly-erected stop sign. A policeman instructed her to pull over to the curb right in front of her house.

"I thought 'Oh my God! What should I say?' she recalled. "When I handed over my license and registration I told the cop, 'I'm in drag.' He kind of smiled a bit and said 'So you occasionally get dressed up like this?' I would have had a hard time denying it under the circumstances. He gave me a warning about the stop sign, but didn't say another thing about the clothes I was wearing."

But her ordeal wasn't quite over. Just as the policeman was leaving, Vikki's next door neighbor pulled up to see what was happening. Vikki drove away as quickly as she could and returned to her house when the coast was clear.

Who is Richard F. Docter?

Richard Docter received his Ph.D. from Stanford University, and since 1966 has been Professor of Psychology at California State University, Northridge. He is also a clinical psychologist specializing in gender concerns. His work includes both counseling and research. Data collected during the 1980s resulted in publication of his book *Transvestites and Transsexuals; Toward a Theory of Cross Gender Behavior* (Plenum Press, 1988). A modest proposal to gain public acceptance of crossdressing

Should transvestites stampede out of the closet? Certainly not! If every man who has ever secretly sneaked into his wife's/sister's/mother's knickers emerged from the closet, the closet industry would collapse and thousands of workers would be made redundant.

We must remain in the closet at all costs, if only to protect the world from mini-skirted, pony-tailed, rouged, and dangerous middle-aged teenyboppers!

This is not the time to tamper with hard-won prejudices and blind societal hatred. If society didn't have us to despise, it would batter its babies harder than it already does. Besides, "respectable" people need someone to look down on, otherwise they might be forced to examine their own questionable morals.

But if dedicated decloseters insist on pursuing this tantalizing dream, I would like to suggest that they are going about it in the wrong way.

First, we need to tackle the question asked by so many: "What is a true transvestite?"

There are those we suggest that a "true" transvestite isn't a man who crossdresses to attract other males, and it certainly isn't a full-on, bum-wiggling homosexual.

Therefore, to hit the public between the eyes with hordes of fully dressed male sheilas demanding acceptance is a bit much, I think.

I believe the public, particularly the male of the species, should be introduced gradually and progressively to transvestism, taking the same route each of us did.

Furthermore, I think we should turn them on sexually to transvestism. The respectably married, 100 percent heterosexual transvestite will probably disapprove of what follows, but others amongst you may agree with what I'm about to say.

A visit to Fantasyland need not be a 'guilt trip'

So you've adjusted to your desire to wear women's clothes. Perhaps you told yourself "it's natural — people have been doing it throughout recorded human history and in all cultures." Or, maybe you justified it as a "hobby." Maybe you called it an expression of a masculine-feminine duality in your personality. But by whatever means, you have come to terms with the clothes.

But what about the eroticism you still feel when you get dressed up, that warm glow in your loins? Is there still a little bit of guilt in that department? No? Well then, what about those *really wild* fantasies that creep into your mind. No sane person thinks about doing *those* things, right? Not according to a recent article in the science section of the *The New York Times*.

Sex fantasies are normal

"Therapists who once viewed perverse sexual fantasies as the furtive compulsions of a lonely minority are seeing them in a new light, as more and more 'normal' people report them in therapy and new studies suggest that even vio-

lent fantasies are surprisingly common," the article states.

Dr. David Barlow, director of the Sexuality Research Program at the State University of New York (SUNY) at Albany says, "Most people have a number of sex fantasies, some of which are so bizarre that they would prefer not to admit to them."

What about perversions?

These aberrant fantasies, other experts note, often include crossdressing or bondage. Furthermore, a study of college-age men found that 12 percent have sexual fantasies involving children. Another study found that 30 percent of men are aroused by watching portrayals of physical violence against women.

Most therapists see nothing wrong in fantasies per se, and the standard response is that fantasies are not a problem unless they harm someone. In fact, some influential psychoanalysts believe that fantasies can serve important purposes, such as filling empty relationships, relieving depression, and increasing self-esteem.

But some of these fantasies are actually *perverted*, right? Not necessarily, experts say. The issue of sexual perversion arises when a person is compelled to bring to mind a specific aberrant sexual fantasy in order to become sexually aroused or have an orgasm.

If sexual fantasies "become essential for sexual arousal, (they) can become a substitute for life, diminishing your capacity to empathize with your partner," said Dr. Gerald Fogel, a psychoanalyst at Columbia University.

Yet other therapists have a more benign view of perverse fantasies, seeing them as of concern only when they cause a person distress, or when they leave the realm of fantasy and enter reality, such as actual child abuse or wife beating.

Perverse fantasies can be healthy too

Even perverse fantasies can have a healthy purpose, says Dr. Louise Kaplan, a psychologist at the Margaret Mahler Research Foundation in New York.

"In perversion, affirmations of self-esteem and security blend with sexuality," she said. "The erotic (continued on page 21)"

Newsletter is well done

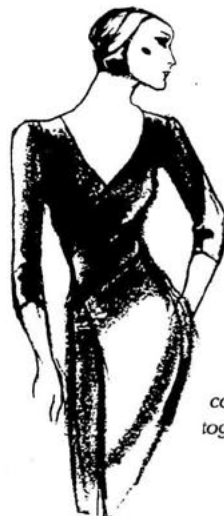

If we really want to emerge from the closet, we should make the idea of transvestism universally desirable to men. Next, women must be encouraged to see the sexciting possibilities of transvestism rather than the shock/horror side of it.

One way to achieve this would be to design underwear specifically for men which is so close to femme gear it'd be hard to tell the difference. There is already a trend toward this: bikini briefs and silk boxer shorts. But these don't go far enough. We need shinier material and lacy trims, plus a range of pretty colors. Then the product has to be properly marketed.

I can visualize bold colored advertising in top fashion magazines: photos of big, macho men wearing the most revealing feminine knickers which would accentuate their masculinity to such a degree that

the average wife or girlfriend would sacrifice the bingo money to buy her man a pair!

You see, I believe that most men are just a split-hair's breadth away from being sexual aroused at the prospect of themselves in feminine undies, and that accounts to some degree for their violent reaction against transvestism; "queer" bashing is a way of defending their egos against the awful suspicion that they themselves might be "weird."

What I'm suggesting is that we take the weirdness out of fem-dressing and turn the world on to it, gradually, a little bit at a time. Arouse men sexually, and their partners too. Once they've gotten used to wearing sexy little panties, the idea should be sold to them that their penises need framing in a delicate lacy suspender belt and a pair of sheer black stockings. And then, "Darling, you may as well

complete the picture with this divine little lacy bra..."

This isn't as impossible as you may think. Almost everything everybody wears is due not to necessity but to cultural conditioning. In Australia's summer climate the most sensible garment for both men and woman would be a loose-fitting sarong. But custom dictates that men in particular wear highly inappropriate clothing, especially in the business sector. A bra is no more frivolous a garment for a man to wear than is a tie. Both are unnecessary, but one is culturally acceptable, while the other is not. Little girls wear two-piece bathing costumes ten years before the first stirring of puberty; totally ridiculous but culturally unremarkable.

Correct marketing is the key. With correct marketing anyone could be made to wear anything. If

men were encouraged to feel that frilly knickers enhanced their sexuality rather than detracted from it, you couldn't get near the lingerie counter for all the rugby players and skinheads!

Yes, I can definitely see those sexy lingerie ads in *GQ* magazine — Tom Selleck in a black lacy bra, frilly black panties, and a matching suspender belt — “What the modern man is wearing.” I just know that women would go overboard for the idea, providing it was sold to them properly.

That, in my opinion, is the way to go if we are serious about dismissing the closet.

I regret to say that 20 of us turning up *en masse* at a restaurant, dressed respectably and behaving impeccably will continue to have the affect of arousing mirth, pity, or hatred. Nothing more.

Transvestism needs to be marketed in the same way that religion is. You don't leap out in front of an agnostic and say, “Hey man, come and worship this god-guy whose mother was a virgin, and who

brought dead bodies back to life, and after the pigs had murdered him he rolled the stone out the way and walked around Jerusalem with holes in his hands and feet, and then after a final nosh-up with his mates he gets sucked up to heaven!” — do you now?

You lead them gradually into it, a little bit at a time, and that's how we should market transvestism.

I say convert the world with enormous masculine bulges bursting out of minuscule feminine panties.

pleasures in a perverse fantasy is secondary to the emotional reassurance it offers.” In other words, a particular fantasy may turn a childhood trauma into a triumph by adding the dimension of sexual pleasure.

There is a danger here, however. Repeatedly playing out a fantasy makes the sexual partner “a non-person, someone with no feelings. In perversion, the other person is

just a player in your own fantasy,” said Dr. Arnold Cooper, a Cornell University psychiatrist.

Okay, so some level of perverse fantasy is okay, for men that is. But you shouldn't have these kind of thoughts when you are feeling like a woman, right? Wrong again. SUNY professors Dr. Jennifer Jones and Dr. Barlow report that women have about as many fantasies as men; both groups reported two to three fantasies a day.

One common perversion among women, Dr. Kaplan notes, is what she calls “female impersonation” in which women adopt an exaggerated stereotype of sexiness. She says that these women were often sexually abused as children or exposed to inappropriate sexual stimulation. As a result, they feel deep uncertainty about their identity as women. By playing the *femme fatale*, these women find reassurance about their womanliness “and a sense of vengeance” on childhood abusers, she said.

Other common female fantasies are outlined in Kaplan's book *Female Perversions* (Doubleday).

“Fantasies are normal and healthy for everyone,” including transvestites, said Dr. Kenneth D. George, a Philadelphia therapist whose clients include transgendered persons.

“The key is what the fantasy does for the person. It is a turn-on, no big deal. But if it causes problems, or guilt, or hangups, then you have to look at why you are using a fantasy that is not pleasurable,” he said.

“Why create something that is not pleasant for you?” he asked.

I was speaking with an officer of an "open" support group recently. The topic was how to get more people to come out to their meeting. This person had just been to a Renaissance chapter meeting where about fifty percent of the membership attended the June meeting.

We discussed her group, its officers and policies. The group leader is married but his wife doesn't know about his crossdressing. The second-in-charge is in the same situation. The membership/outreach person is homophobic. You may not attend a meeting nor will you receive a newsletter until you have joined the group. In spite of this, they have about 150 paying members, but they're lucky to get 20 at a meeting. "Why?" my friend mused.

It seemed pretty obvious to me. The whole tone of the organization is built on the fear and shame of being discovered. It is beyond me how a group can function with leaders that are so fearful about who they really are. How do you call a board meeting? How can you do any public relations? How do you get your name in the newspaper or on radio and television if you are so scared that someone will find out

you're a crossdresser?

Worse than that, it seems that my friend is willing to take the risks, but the other officers won't even let her do that!

I'm not suggesting that these officers make a public declaration of their crossdressing, but I would strongly recommend that they examine their motives for accepting the positions they did. It's pretty obvious by the lack of attendance that the meetings are not serving the needs of the membership. Perhaps, the meetings only serve the needs of the officers. If that's the case, they ought to resign and let someone run the group who can do the job the way it needs to be done.

After the laugh, I thanked my classmates for the award and for the kindness and understanding they had shown to me that evening. (So I lied a little bit.) I closed by saying that I was dressed that way for a personal reason which I would be happy to share with them later. Returning to my seat, I was certain there was applause.

That award had broken the dam. No sooner had the program ended than classmates came up to me to ask questions or just to visit. "What's the story?" "Do you live like this all the time?" "Where did you get that

dress?" "Is that cleavage real?" But more importantly, several classmates really understood when I told them of my childhood secret and why I had been aloof in school.

I even got to make peace with one guy whose third and fourth grade Halloween costumes had haunted me all of my life. He had dressed up as a girl and (damn him!) *hadn't been guilty about it*. Of course, he had forgotten the homemade bridal gown and ballerina tutu. But when I told him how much they had bothered me all these years, he actually apologized for the pain he had inadvertently caused.
