Well, I've heard more so-called pseudo-experts who know very little about these pills berate their capabillities, discourage their use, score you because of their "danders," etc. Well, I've heard this chitter-chatter until I'm blue in the face-and I've decided to speak out and and give some facts in the PILL'S favor, much to the surprise of many critics

There comes a time in every person's life when he sees himself in a mirror on thatbleak morning and comes face to face with linesabout the eyes and lips, sagging face, and a general haggard look. It doesn't stop with the face either. There is a threat of blood clots, gallbladder problems, but in this is rare and I've been informed not to worry about it.

Most important - Medical research shows that estrogens do not cause either breast or uterine cancer!! In fact, in one study of large numbers of women on replacement estrogen therapy over a long period of time, cancer did not occur at any <u>tim</u> different ratr. It has proven to control cancer at the "normal" rate - and this was in women. In men, there is no appreciable problems caus-

ing cancer. Now, I'm not telling you to run to your local doctor and start taking hor-mones. This decision is a very deep, soul-searching one, Many factors must be weighed. Your present living conditions and your goals should be analyzed. I only wanted to bring out the seldom-mentioned valid points of this "wonder pill." What is right for one individual may not be right for another.

BY SHIRLEY ARMSTRONG Denise R., a 42-year-old "genetic male" of New York City, who considers himself a woman trapped in a man's body, is not entitled to Medicaid assistance for sex change surgery, the Court of Appeals ruled Tuesday in a 4-3 decision.

Reversing an Appellate Division decision, the high court upheld the state Department of Social Service commissioner's denial of state financing of the conversion, estimated to cost from \$2,000 to \$15,000.

Denise R., whose true name has not been disclosed, has maintained a female identity for 18 years, has a history of employment as a salesperson in a women's dress shop, and since September, 1970, has attempted to arrange sex changeover surgery. There have been conflicting medical opinions on its necessity.

The court case developed after one doctor applied for financing of the operation under a section of the Social Services Law, which makes it available when "necessary to prevent, diagnose, correct or cure conditions ... that cause acute

suffering, endanger life, result in illness or infirmity, interfere with capacity for normal activity or threaten some significant handicap."

The New York City Social Services Department denied the application on medical grounds. After a hearing, the state commissioner upheld that ruling. He relied primarily upon an opinion by a staff psychiatrist at Coney Island Hospital, who said Denise R. suffered from no disturbance or suicidal tendencies in his thinking.

The commissioner apparently discounted a later report of the hospital's chief of endrocrinology and metabolism that the requested surgery is a life or death matter.

Judge Sol Wachtler, writing the majority opinion Tuesday said the department was under no obligation to conduct its own medical evaluation of Denise R., "although we believe that it would have been desirable" to do so He said the commissioner had the right to adopt any of the conflicting opinions advanced during the hearing and, under the circumstances, "it is not

the province of the court to substitute its judgment."

Wachtler noted that, in discounting the testimony of one Dr. Shagan, the commissioner might well have considered the facts that the physician had evidently disregarded an earlier admonition of a Dr. Ettinger that Denise R. should not be encouraged to believe the operation could be performed at Coney Island Hospital

The decision to ignore Dr. Shagan's opinion, Wachtler said, might also have been influenced by the fact that he had initiated hormonal (estrogen) therapy prior to a clear medical decision to operate, although continuation of such therapy without definite prospect of surgery poses the danger of cancer or severe psychological reaction.

"Indeed," wrote Wachtler, "this hormonal therapy may have assisted not only in the development of female characteristics but in an exaggeration of the petitioner's 'psychopathic' personality."

Justice Lawrence Cooke, writing a dissenting opinion in which Judges Hugh Jones and Jacob Fuchsberg concurred, said there was a lack of medical evidence supporting denial of the Medicaid application.

"A person is not cast outside the pale of the statute's eligibility," he wrote, "because, on the basis of medical advice for the treatment of a bona fide condition, he has embarked in good faith on a course of medical treatment.'

TSs LEGALLY FEMALES

A New Jersey judge has ruled that Post-operative transsexuals should legally be considered members of their chosen sex. Judge Charles DiGisi of the Juvenile and Domestic Relations court made that ruling when he decided that the marriage between a post-op TS and her husband [who knew about her TSism before marriage] was legally binding. Although the decision is being appealed, if it is upheld, it will be a landmark case for the rights of the transsexual.

Karlton W. Hudson, an inmate at the State Prison in Hartford, Conn., may be the first inmate to receive a sex change operation as part of his rehabilitation. The 25-year-old prisoner has been taking female hormones for over a year, and the

U. S. District Court Judge Spencer Williams issued the opinion that it is not sex discrimination for an employer to fire a man who has changed into a woman.

Carol Voyles, formerly Charles Voyles, claimed that the Ralph K. Davies Medical Center, where she was employed as a kidney machine technician until last January had violated her civil rights by discrimination based on her sex change operation.
