### Why Should We Change Our Policy? by Miranda Stevens

At last month's meeting, I introduced an amendment to change our membership policy to one that is nondiscriminatory. When it was submitted it had 16 signatures, which represents about 10% of our membership. We could have had many more sign on if I had continued to ask for signatures. But only 5% is required to submit a proposed amendment. With a few exceptions, people were eager to sign on to the amendment. Let me explain why.

Whatever else it is, Tri-Ess is primarily a support group. For most crossdressers, it is an entry point into an amazing transgender world beyond their own closet doors. Most of us come to Tri-Ess scared, unsure of ourselves, not knowing who we are or what we are. As we learn more about ourselves, we realize that there is a spectrum of transgender expressions. Along this continuum of gender identities, we find ourselves at some point at any given time. But we don't know where we are along that continuum unless we are free to explore our gender honestly in a nurturing, nonthreatening environment. A support group should provide that environment.

Everything in this world is not always black and white, there are shades of gray. Many of us, like myself, don't easily fit into a rigid category. Many of us have a hard time defining ourselves as crossdresser or transsexual, straight or gay/lesbian. Why should we have to? Gender is a continuum after all, it is not all rigid boxes. But what if you come into Tri-Ess, learn to love the organization, make closer friends than you have ever had in your life... and then find that you may at a different place on the spectrum than you originally thought! If you are open and honest about it, you may find yourself threatened with

The FULL membership is for Heterosexual crossdressers and their spouses/family. The FRIEND membership includes ALL OTHERS who support our mission.

This leaves the proposed Affiliate member as some who does not meet

#### The New Miranda Or, How to take away the rights of heterosexual crossdressers to govern themselves.

Miranda Stevens, our very able vice-president of Programming, has proposed an amendment to our by-laws. It reads beautifully and is totally politically correct! It was also written by a master in political phraseology and intrigue who in the last month was able to get the City of Evanston to pass an ordinance providing rights and protection to "transgendered" individuals. She is to be commended for changing a government body's laws to recognize that such individuals do exist and need protection.

However, such an amendment is not for everybody. It is for government bodies. .

either of these requirements, obviously they must be someone who DOES NOT SUPPORT the mission of Tri-Ess, voting members will include vendors, professionals, admirers, friends of Tri-Ess, enemies of crossdressers - anyone with an agenda who wants to darken Chi's doors. This makes sense once you filter out all the gobbly gook, double talk and sweetness of the proposed amendment and the rhetoric of its supporters. Take for example, Miranda mentions in her column that her proposal requires some level of membership in National to be a member of Chi, but the proposal speaks a different language and says just the opposite. The sweetness is so thick you can't even make out the gobbly gook.

The old complaint that TS's and gay CD's can't join is a bunch of BULL, they may join as friends, and they ARE welcome at our meetings. All we ask is that they not hold public discussion of TS related situations.

The pro-amendment people want to take the choice away from our members, by pretending that they favor diversity, "while promoting a resolution that would actually destroy the diversity of the transgendered community in Chicago. At present, Chicagoans have the choice of a diversity-membership group (CGS) and a family-oriented crossdressers support group. Under this proposal there would be only one type of group in Chicago. Where is the freedom of choice in that?

A vote for this proposal is a vote to draw the chapter out of compliance with the policies of National Tri-Ess. The proposal is incompatible with Article I and with Article III, A & B of the Chi Chapter Bylaws, as well as Art 9. It has the effect of dividing the bylaws against themselves. It is not possible to amend Art 6 without amending Art 1, 3, and 9. Allowing 'Friends of Tri-Ess' members to vote in elections and hold office (Section 3, of the proposal) is a violation of Tri-Ess National policy, and will lead to revocation of Chi Chapter's Charter.

We as Transgender people need to get past this "My way is the only way": syndrome and to get our way by cloaking ourselves in false morality. That their views are morally right but at the same time suppressing contrary views.

This amendment is not about discrimination but about a selfish attempt at control. 'If I can't get everything my way, I will destroy it' attitude. If these people believed that there was no open group like CGS, there would be cogent arguments for the need of a diverse-membership group and they could start their own. But to foist their viewpoint on an existing group, Chi Chapter, and control the entire area, suppressing contrary points of view, is wrong. The Great Lakes Gender Leadership Conference which Carol Rodgers and I started last year is an example of the co-operation between groups that exists. Why do we need only one group???

All around our country there is a manifest need for groups focused on Crossdressing & Spouses. No matter how hard the proponents of this amendment try, they cannot legislate away the need for a family-oriented crossdresser-focused group; you can legislate policy but not need. The need will cry out until it is met. If this proposal passes, Chi Chapter will cease to exist. But there will ALWAYS be a Tri-Ess group in Chicago.

Why is this proposed 'Affiliate' membership charged \$36 for dues compared to the regular dues of \$24 ??? Are we attracting someone who is willing to pay for the privilege to vote???? We are proud to be a part of Tri-Ess, and to be a part of the support & education that Tri-Ess provides. It means a lot to us. We won't sell out our Tri-Ess identity for any amount of money.

Now think about this, we have over 160 members, half of which have never attended a meeting. These are the people we are here to support,

expulsion from membership, or relegated to second-class status called "Friend of Tri-Ess," with no voice in the organization. Does this sound like a support group to you?

It just isn't fair. Our membership policy as it stands now is discriminatory. It is one's basic humanity that qualifies a person to support that frightened crossdresser and her worried partner and family. What do gender and sexuality have to do with one's basic humanity and ability to respond to the needs of another human being? There are numerous analogies I can cite. The current policy reminds me of a whites-only country club. What does being white have to do with playing golf? (Maybe you should ask Tiger Woods.) One does not need to be a heterosexual crossdresser to support the needs of a heterosexual crossdresser.

Read over the proposed amendment. Pay particular attention to the fact that the focus of Chi Chapter remains exactly the same as it always was. Note that some level of membership in National Tri-Ess is required to be a member of Chi. The only change is that the new policy does not discriminate against our friends, the people who want to support us, the very same people who are helping us gain human rights protection in Illinois.

We are not a government body.

Nobody is at risk here.

We are a social/support group for the heterosexual cross dresser.

Miranda's amendment provides that the current category of members that we call "Friends of Tri Ess" be merged with the Full member and be allowed to vote and hold office, and a new category of member called "Affiliate" be allowed to vote, pay higher dues and not be required to belong to Tri-Ess National.

This new "Affiliate" member does not have to be and I emphasize the "does not have to be" part, a crossdresser or a supporter of its mission toward heterosexual crossdressers. It can be anyone.

This is like allowing anyone in the Metropolitan area of Chicago to vote for the Mayor and the aldermen of Chicago if they pay taxes of some sort, or the Fraternal Order of Police allowing crooks to join and vote since they put their money up.

To me this is akin to having the inmates run the asylum. Miranda bases her argument on the following premise which reads "And Whereas: Criteria such as ethnicity, religion, sex, sexual orientation and gender identity in no way diminish one's ability to support the mission of Chi Chapter or perform the functions of an Officer of Chi Chapter."

It reads so nice and is so politically correct! The key words here are "no way diminish....". That's wrong! So wrong it sucks. If you are not a crossdresser no way will you know how a crossdresser and his family feel and your ability to support crossdressing is severely diminished by your own needs which, if you are not a crossdresser, could be entirely different from a crossdresser's.

This technically would allow damn near anyone to vote whether they are crossdressers, or openly gay, or Drag Queens, or transsexuals, or transgendered (whatever that means), and even purple truck drivers to vote in our elections. Unfortunately our type of group does attract all sorts of people and we should not just let anyone in and give them the privilege to vote for us.

Its like letting all the people whose countries are in the UN vote for our President!

Several years ago due to the flack we were getting because we were not an "open" group, a category called "Friends of Tri Ess." was created. We have only one, a vendor.

The "Affiliate" that Miranda wants given voting privileges does not have to be a heterosexual crossdressers They would not be required to support our mission. They would not have to be our "Friends". And--they would not have to be members of Tri Ess National!

That makes us an "open" group that supports anyone who is so-called "transgendered" or anything else.

We already have two wonderful "open" groups in the Chicago area, CGS of which I'm a member and Toni's group in Indiana. These groups include gay, bi, and heterosexual crossdressers, transvestites (which is the same as a crossdresser only more so), and pre-op and post-op transsexuals. A third group is definitely not needed.

We are by design a social/support group for heterosexual crossdressers and their families so our social and support events are geared toward the heterosexual crossdresser not some other transgendered person who may want information on sex change operations.

As Kiki's Bible says, "Render to Tri Ess the things that are Tri Ess's and to CGS (or Toni's), the things that are CGS's and Toni's.

As I have said before this new amendment takes away out rights as heterosexual crossdressers to vote for ourselves and govern ourselves!

Save Tri Ess for heterosexual crossdressers only!

Vote "NO."

the ones who rely on this newsletter and the national publications. Out of the more than 160 members are approximately 30 CGS members, myself included. NOW what happens if Chi Chapter becomes an open group? Oh the 30 or so CGS members will remain there, the other 130 or so will be left with an open, unfocused group, not attached to any national group. These 130 members have, in the past, selected NOT to join an open group, it doesn't serve their needs. Do you really think they will want to remain in an OPEN group, I think not. There won't be two open groups in Chicago, there will only be one and it won't be any larger than it is now. These 130 members, YOU, have been left out in the open because a group with a misguided sense of morality says so.

I am a crossdresser....Life long and only out for the past 6+ years. I identify with those who don't want to go out shopping, afraid to go to a meeting....these are normal concerns, I have been there and done it. I don't have any desire to ride in parades, picket buildings, or flaunt myself to the public. In fact it scares me. I dress a few times a month that's all I need...I don't wish to make myself known at work or else where. More power to the people that can do all these things, I wish it was easy, but it is not. Miranda stated in the Chicago Tribune that she is a "Transgendered Women", I state: "I AM NOT A TRANSGENDERED WOMAN but a Heterosexual Crossdresser w/ spouse, receiving and giving support.....no more—no less.

My job is to get to those afraid to go out to a meeting, those who are afraid because they are not sure what they are, TS, CD, or Gay, those who are afraid that their spouse or partner may find out or may need support also. Our goal is to ensure them that it is safe, they need this... Once out they may decide for them selves which way they travel the roads available. We openly work with the other groups to interface and give the member the best possible support.

This is really a referendum if Chi remains in Tri-Ess; it flies in the face of Tri-Ess policy and its vision and its mission. A vote for this amendment is a vote to take Chi Chapter out of Tri-Ess and it is a virtual certainty that the chapter charter would be revoked. The amendment (can be seen in the insert in it's entirety) reeks of glaring ignorance of the purpose we at Chi Chapter provide and an outright disregard for the very people who have chosen to be Chi/Tri-Ess members.

## **Candace for V.P. Outreach**

Once again it is time to consider running for an office in Chi Chapter. We officially place Candace D. Mahne, as a candidate for the office of Vice President in charge of Membership and Outreach.

Her focus is to continue the time honored tradition of the Chi Chapter Hot Line. The "hot line" requires a personal touch. Someone with patience, empathy and the ability to help the caller to relax. First listen, then dialogue with the caller, helping him (her) feel at ease. Reassuring the caller that they are not alone. In fact there is many of us out...And the meetings are where we gather to share our stories, real and fancied.

Typical callers are primarily crossdressers. Curious, frightened and lonely men, wanting affirmation of their wholeness. Our primary purpose and life blood is the newcomer. We pride ourselves as a "hatchery" in transgenderland.

Some nights, hours are spent listening, affirming and encouraging our telephone callers, assuring them our "gift" is wholesome. Although hundreds of letters are mailed each year, this form of communication is impersonal. It, too, lacks the "human touch of our feminine side. Often, there are lapses of months between calls of some individuals. And they feel secure in talking to the same person.

The World Wide Web, has most recently broadened, our outreach and exposure to the world. People communicate with typed words and never feel the warmth of a person's voice. It is as if a robot was their mother.

Because of security, Chi Chapter requires, at least one telephone conversation with a prospect, prior to being given our meeting location. Other times a "dressed" interview in a home or some public place, such as a restaurant is required.

There is nothing like the "personal touch", remembering the last conversation with the perspective, even though it was months ago.

In the past four years, Candace has made at least 14 "house calls". Two house calls have been made "En Femme" to single crossdressers in their homes: Bartlett and Aurora. Two were met at a hospital parking lot (Hoffman Estates and Central DuPage), as they needed that "human form" for confidence and were escorted to their first meeting.

One was met at a bank parking lot in downtown Lombard and driven to Transformations for a "do". Another was met in a electrolysis salon, in a shopping center in Rockford and had lunch in a public park. Another was met at Transformations and later after her "do" taken to a Chinese Restaurant in Elmhurst and for a drink at Temptations. And lastly, transportation has been provided for members with "restricted drivers licensees.

And then there are the calls from the wives and women friends of crossdressers. Most are curious needing understanding and sources of reference. Most want to talk to someone willing to be gentle and sympathetic to their issues as well; so some common ground can be established.

Some are angry and hurt. Their husbands have not told them about themselves from the start and they wonder what else has been "hidden" from them. Others feel "violated" when they discover their clothes have been worn by us (without their consent). And others are confused and are in need of the same education and understanding you require. Crossdressers are more whole with the support of a loving (accepting) partner.

Dear Members,

I would like to take this opportunity to tell you a little about myself and to explain why I want to be the next Vice-president of Programming of Chi Chapter. Hopefully this letter will make clear my goals and how I plan to reach them.

My name is Rachel. My wife Kate and I have been involved in Chi Chapter since 1996. I am deeply grateful that Chi Chapter was there for us. 6) A panel discussion of the aging crossdresser: changes in viewpoint, attitude, body and style.

7) A panel discussion of feelings, thoughts and opinions our wives and significant others would like for us to know but may be afraid to share with us.

8) Crossdressers as presented in history, art, film and literature.

9) Getting to know each other. An evening dedicated to the members of Chi Chapter getting to know each other better through various "icebreaking" techniques.

These are just a few of the ideas I and others have come up with. I am sure there are many more excellent ideas within the membership. I would hope that I could draw upon the entire chapter, to include P.A.L.S., for programming ideas. We have a terrific chapter and an invaluable resource for ourselves and those who will come. With your help I believe the chapter can become even better and stronger. In turn, we can help each other become better, stronger, and healthier.

This is a 25 year old arm of the American Baptist Church concerning pastoral care for gay, lesbian, bisexual and most recently transgendered persons. She made a plea to the attending clergy urging the recognition of pastoral care for the transgendered community. She was invited to join and participate in areas of her expertise.

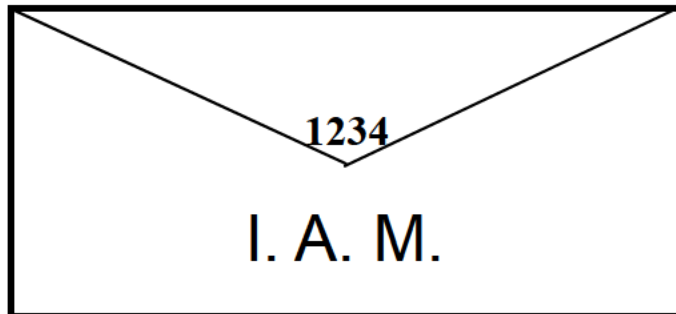

Proposal For An Amendment  
To The By-Laws Of Chi Chapter Of Tri-Ess

**Whereas:** We the undersigned believe in the mission of Chi Chapter of Tri-Ess as a support group for the heterosexual crossdresser and his family,

**And Whereas:** Current membership classes in Chi Chapter allow individuals who fall outside of the category of heterosexual crossdresser and his family to join as "Friends of Chi Chapter,"

**And Whereas:** Friends of Chi Chapter are denied voting privileges and are disqualified from running for office,

**And Whereas:** Criteria such as ethnicity, religion, sex, sexual orientation and gender identity in no way diminish one's ability to support the mission of Chi Chapter or perform the functions of an Officer of Chi Chapter,

**And Whereas:** We believe In a nondiscriminatory membership policy, and that diversity not only strengthens our community, but is key to its ultimate success,

Be it resolved that the By-Laws of Chi Chapter of Tri-Ess be amended as follows:

**ARTICLE VI- MEMBERSHIP**

**SECTION 1- Types**

A. Recognizing that the purpose of Chi Chapter of Tri-Ess is primarily for support of the heterosexual crossdresser and his/her family, membership is open to anyone who supports that mission. The following memberships will be available to those wishing to join Tri-Ess Chi-chapter:

- a. Member with standing in Tri-Ess National
- b. Affiliate Member

**SECTION 2- Membership Classifications:**

- A. Member with standing in Tri-Ess National: Any person who holds a current active Full Membership or Friend of Tri-Ess Membership in the National Society for the Second Self.
- B. Affiliate Member: Any person who does not qualify for Full Membership or Friend of Tri-Ess Membership in the National Society for the Second Self.

**SECTION 3- Restrictions**

- A. Membership shall not be withheld from an applicant because of sex, race, ethnic background, religious affiliation, sexual orientation, or gender identity.
- B. All members shall be at least eighteen (18) years of age.
- C. Chapter membership dues (see Article VIII, Section 1) for Affiliate Members shall be 50% higher than Member with standing in Tri-Ess National.
- D. Members with standing in Tri-Ess National and Affiliate Members may vote in elections and other issues which require a vote of the membership.
- E. Affiliate members are not eligible to run for office.
