## Stupid and Vulgar.

Speaking of Ellis Glenn, the female freak, who was brought to Parkeraburg yesterday from Hillsboro, Ill., the News of the latter place says:

"The fact is Ellis is a squeezed lemon, a chewed cud, a cake of pressed pomace. Business has been resumed in Hillsboro and the wheels of enterprise have again begun to turn, for the people are beginning to realize that they have for two weeks been suffering from nervous prostration over a vulgar and unromantic criminal and profesional forger who saw fit to masquerade in male attire that she might more successfully ply her felonious vocation. The party who deserves the most consideration and sympathy in this affair is Miss Ella Duke, the victim of Ellis Glenn's duplicity. Miss Ella is an innocent, pure and trusting girl, highly respected and a most worthy young woman. Her name has been brought into the affair through no fault of hers and she has been made an object of ridicule by many thoughtless people. While the affair between Ella Duke and Ellis Glenn may seem ludicrous, it has no funny features for Miss Duke. She was guileless and unsuspected, and was deceived and brought into ridicule by a designing female criminal, disguised as a man. Miss Ella has learned something of women's inhumanity to women, and has also gained an unpleasant notorietty."
