That night I couldn't say a word. I just froze. I only had a dollar and seventy-five cents in my purse. I tried to tell him that but my tongue was frozen. I could only stand helplessly and watch him take my purse.

There were a number of feelings that occurred during and after the theft. For those of you who get New Visions, New Spirit MCC's newsletter, and read my column know what those feelings were. That column was written two hours after the robbery. I knew that, with the passing of time, I couldn't express my feelings as well and capture all the emotions I was feeling.

Since then, I have had some experiences I would like to share. First, I tried to get a new driver's license. Guess what...the License Bureau wanted proof of social security. The preferred proof is your social security card. Of course the Social Security office won't issue a Social Security card without a valid driver license. Catch 22. Fortunately, I had a letter from IRS that had my Social Security number on it and the License Bureau accepted that letter as proof. The lesson I learned: make a copy of your Social Security card.

Then opportunity struck for me. As I applied for a new social security card, I was given a computer printout with my vital statistics to verify. As I read name, address, date of birth and so forth, I noticed that the "sex" designation had that nasty "M" in it. I then politely stated to the clerk that both my driver's license and my birth certificate list my sex as female. She said no problem and with a stroke of a key my social security records now carries my sex as female. Every cloud has a silver lining.

Having lived through this, some tips to pass on - what not to say to the victim. "What did you do, or did you give him your purse." Think about it, if someone sticks a nine millimeter gun in your face, that is not the time to open a discussion. You give them your purse and anything else they want. "Well he didn't get much." I beg your pardon, he got bits and pieces or my life. That's a whole lot of something. "Be grateful he didn't kill you."

Stoessal's confusion with the topic was very evident, at the end of the show he was back in the studio across from anchorman Hugh Downs where they had a brief conversation. Reading between the lines and by the looks on their faces it went something like this:

Downs: Who the hell were those transylvanians?

Stoessal: Transsexuals, Hugh.

Downs: Whatever, who were they and what are they?

Stoessal: I don't know, Hugh, it was pretty confusing.

**Major Political Breakthrough!**  
(With our "Thanks" to Diane Torrance)

Resolution to implement transgendered inclusion in the Stonewall Cincinnati Bylaws and Mission Statement:

WHEREAS,  
the transgendered and transsexual (hereinafter referred to as transgendered) communities confront the same system which



oppresses gays, lesbians and bisexuals, and therefore are the target of marginalization and loss of economic and civil rights;

WHEREAS,  
there is lack of understanding and information on this issue;

WHEREAS,  
Stonewall Cincinnati is a human rights organization dedicated to the achievement of equality for all individuals,

THEREFORE  
let it be resolved that Stonewall Cincinnati insert the word "transgendered" into appropriate bylaw sections as follows:

#### ARTICLE II. Purpose

Stonewall Cincinnati is an organization dedicated to the achievement of equality for all individuals. Stonewall Cincinnati particularly seeks to assist the gay, lesbian, bisexual and transgendered communities to achieve social change and to eliminate discrimination and violence against us through the promotion of public discussion, mass voter registration, and education of the general public.

#### ARTICLE VII. Committees

##### Section C. Public Information

The Speakers Bureau shall be responsible for providing qualified, trained speakers to represent Stonewall Cincinnati and the gay/lesbian/bisexual/transgendered communities to address and educate audiences about issues of concern to Stonewall Cincinnati.

##### Section D. Program

The Program area is responsible for the development of projects and programs that provide a service to the gay/lesbian/bisexual/transgendered communities.

#### LET IT BE FURTHER RESOLVED

that Stonewall Cincinnati will amend its Mission Statement to include transgendered.

#### AND LET IT BE FURTHER RESOLVED

that the Bylaws of the Greater Cincinnati Stonewall Political Action Committee (Stonewall PAC) be amended as follows:

#### ARTICLE II. PURPOSE

Stonewall PAC is a non-partisan organization dedicated to the achievement of equality for all persons, especially regardless of sexual orientation, gender or gender identity, race, religion, age or physical challenge through political action. Stonewall PAC further particularly seeks to assist the gay, lesbian, bisexual and transgendered communities to achieve social change, political recognition and eliminate discrimination and violence against us through: coalition-building with other

organizations sharing common goals, working for the election and/or appointment of public officials who are supportive of Stonewall PAC's issues, lobbying public officials to support specific legislation and actions that best serve the goals of Stonewall PAC.



### POST-Opinion

The on-line Bulletin Board Service (BBS) I find most interesting is the *TSMenace Digest*. The majority of those who post to this are activists in the gender community. Frequent contributors include Phyllis Frye, Nancy Nangeroni, Sarah DePalma, Riki Anne Wilchins and many other less well-known but equally eloquent activists and observers of our community. In the days that followed the 20/20 broadcast, ABC's treatment of us was quite naturally the main topic since many of us had participated in the press conference and the demonstration for Tyra Hunter, footage from which ABC chose to use at the beginning of the story. Not surprisingly, opinions varied from "they trashed us" to the more frequently heard, "Not bad, considering."

An M2F from South Carolina had this observation: "The 20/20 segment was a most outstanding and positive step in educating America. Wish we could have had a switch to make every TV (television) get only that program."

The opposite view was expressed by an F2M from Philadelphia. "Exactly WHAT 'sensitive' portrayal was that?! Did we even see the same segment? Are you people on the same channel, the transgender channel that is!"

"Recall, if you will, that they called Brandon 'Teena Brandon' throughout the segment, and if that wasn't disrespectful enough, they also called him a 'trans-gendered WOMAN' while consistently using 'she' as the pronoun reference. THIS IS SENSITIVITY???"

And another M2F wrote, "My sole complaint with the segment was that the narrator continually called him Teena Brandon' and called him 'she' and 'her.'"

My personal thought on this is, *Transgender* (formerly Tapestry) Magazine did the same thing ABC has been accused of. They wrote, "The murder of Brandon Teena, a woman living as a man, by two bigots who first raped her when they discovered her secret." If the publication which supposedly represents us - gets it wrong, how can we complain when a television reporter does the same?

Several people expressed dismay at the dialog between Hugh Downs and John Stossel following the piece. One person said, "I was annoyed at the "surprise" exhibited at the end when it was mentioned that many of us were not "gay," when the implication was that some of us are attracted to the sex opposite that of our birth (to my way of thinking, that makes me a lesbian now, not straight) while those who Stossel would term as gay are those that we would term as straight."

But Allison, a heterosexual crossdresser from Seattle thought, "They dispelled the rumor and public misconception that transgendered persons are all or even mostly gay. In fact, Hugh Downs made it a point to bring this point up so that the interviewer could say, 'No! They are NOT gay. Most crossdressers are NOT gay.'"

I agree with Allison. Hugh Downs was only asking the questions most of the viewers had. He did us a favor by asking this question, and John Stossel did us a favor by answering the way he did.

As a community, we have allowed ourselves to be defined by trash television. First Geraldo, then Springer have set the stereotype of what a transgendered person is firmly in the minds of the general public. ABC took a positive step to correct that image. Will one twenty minute segment miraculously change the perceptions of 250 million people? Get real... not in our lifetimes. But perhaps our children's children will benefit from what has begun.

Those of you who stuck around after 20/20 to watch the local news, saw an "area man(?) who had a sex change." Despite Kit Andrews' sensationalist promo, Channel 12 did a good job in the 90 seconds with which they had to work. While filming the interview, both the reporter and the cameraman showed concern for "Kate's" anonymity, yet still living within their journalist policy of not filming in shadows or using electronic "blurring" of the subject. On one occasion, they stopped filming and allowed "Kate" to look at a section of tape for her appraisal.

"Kate" was impressed by the professionalism of the crew doing the interview. They took great pains to make her feel at ease. She felt like she was just sharing a part of her life with a friend, and even wondered when the formal question and answer session was going to begin. She felt the final product showed transsexualism in a positive, though brief, light. She also thanks Dr. Kayla Springer for taking the time to add her thoughts.

"Kate" assures you that she has no shame in who she is. She does, however, have a life. Where she lives, works and

worships God, her gender, past or present, is not an issue. "Kate" feels that even though some might recognize her, the attempt at anonymity sends the message that she is not "out" and does not wish to be saddled with the label "transsexual." "Kate" does not have the option of changing identities by washing the makeup off.



## STONEWALL CINCINNATI

Stonewall Cincinnati's annual membership dinner will take place May 18th. At that time, the general membership will vote on the amendment to the by-laws to include "transgendered." How wonderful it would be if a large number of CrossPort people, who had the right to vote on this issue, were in attendance. That, of course, means a large number of CrossPort people must join before May 18th. I have membership forms with me at all times. Individual membership is only \$25.00. For that you get some clout when the Supreme Court decides Cincinnati must re-amend the human rights ordinance.

Additionally, because I was appointed to fill a board vacancy, I will have to stand for election to the board at the May meeting. Please consider this an undignified appeal for your vote. I feel I've earned my place on the board and I'm not there merely as the "token TS." In the words of Frank Jaymes, "Thank you for your support."

### "Those durned J. Edgars are on Springer again!"

Let me back track for a moment. My spelling of the word "trans(s)exual" above is intentional. Yes, I know how it is spelled in the dictionary with two "s"s but there is the contingency in our national community to spell it with only one. The very valid reason for this is one of politics and power and control in a society. An explanation is too long to expound on here.

My simple-minded reason for writing it in the above manner is simply to bring it to everyone's attention. If I only spelled it with one "s", people might think I just spelled it wrong or they

may not even know *how it's spelled*. This way, people know something's up.

My feelings on this are very simple also. I have always felt it should be the privilege of the minority group to call themselves what they wish and the rest of us just have to follow suit. In my early childhood, it was correct to refer to members of a particular race as "colored people". That switched to "black" and is now being replaced by "African-American" and will some day be replaced by something else. Gays invented that name for themselves to replace pejorative and clinical labels and it is now used throughout society (except by rednecks).

Likewise, we have replaced the clinical term "transvestite" with the more user-friendly: "crossdresser". This term is successfully leaking out to society and is replacing that quaint phrase "drag queen" which has been heretofore used by general society as a blanket term for most of us. But when the word crossdresser eventually is used casually by the mean-minded partisans of society we will again change it, maybe to something like: "naked potato dancers" or "J. Edgars" or "Buffyists" or "PantyMasters-of-the-Universe". It doesn't matter, *we get to choose in order to maintain respect and dignity for our personal minority*.

This is really no different than you choosing your own name. You are entitled to be titled as you so desire. If you want me to call you "Patrick" sometimes and "Patricia" at others, that is your prerogative. If you want me to call you "Miss Patrick" then I will. And for those of you who have changed your femme name numerous times - who's counting?

A minority's name should not just be a description or classification but should engender respect. Oftentimes in our society, a minority's title has a negative connotation and sustains divisiveness. And the more lines drawn in society, the more problems. At heart, we in the gender community detest categorization and just want society to love us for who we are. But, pigeonholers will always be with us.

I know that to many of us this whole terminology blitz sounds vaguely like a gender rendition of "Who's on First?" but the points are valid and proper discourse often depends on clarified terms. However, the truly important thing is: United we stand; divided, it's back to the closets.

Frankly, I don't think the one "s" spelling of TS is divergent enough to properly raise consciousness and it is still quite clinical. But I'm not entitled to call this one.



### Couples Get-Together

The date for the CrossPort couples get-together will be Saturday, March 2. This will be a casual pot-luck dinner (possibly featuring Jenn and Jackie's duelling lasagna's). There is no real agenda for this evening, the purpose is *not to indoctrinate partners into thinking crossdressing is the greatest thing since 3 Stooges movies. It is a non-crossdressing event to allow SO's a chance to meet and talk with their counterparts. Remember, this is a non-crossdressed function - and there will be a panty check*.

### A Stone Wall With a T-Brick

I had some very good news yesterday morning. Diane called and reported that the Tuesday evening Stonewall Cincinnati board meeting voted on whether to become "trans" inclusive and change their mission statement to include transgender people. The board voted unanimously in favor of this and it will now be forwarded to a constituency vote.

This is no minor feat. Last September we sat down with the Cincinnati Coalition and Community Center folks to re-commit CrossPort to their efforts. Trans-inclusion on a political and societal base in conjunction with organizations like Stonewall was certainly part of our agenda. Frankly, I did not expect results of this nature in this short of time.

Please do not dismiss the importance of this. When legislation is eventually and successfully passed in this area to protect *your rights, regardless how deeply closeted you are, it will stem from this very occasion. And you will have one very special person to thank for that - Diane. I do not want to dismiss the others who have been involved with Coalition and Stonewall events, but most of the credit for this is demonstrably due to Diane. Thank you.*

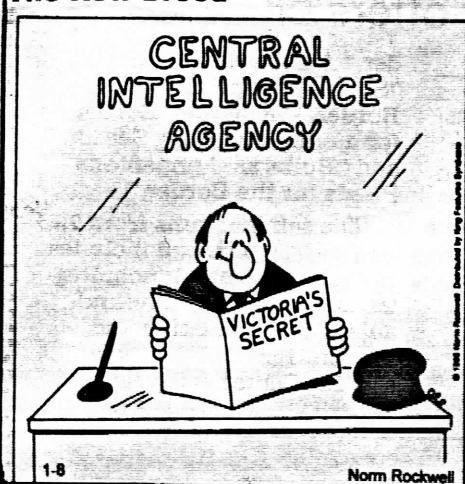

Matt walked over to the full length mirror and nearly gasped. He couldn't believe what his eyes were showing him.

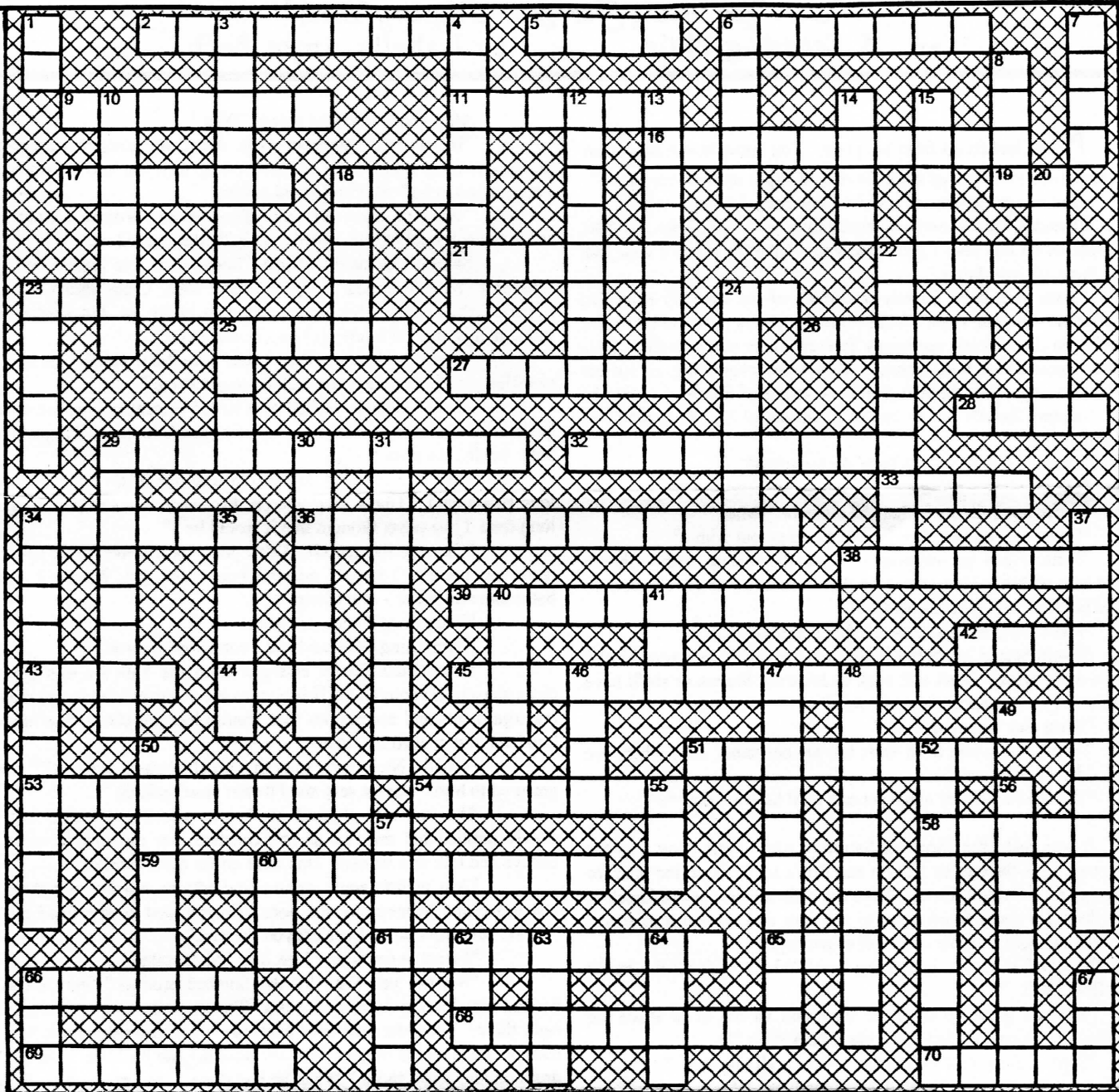
"You look absolutely gorgeous." Sharon whispered.
