Kinetic Incongruities and "Getting Read"

Call it *Gender Kinetics*. It's about how women touch each. How close they stand in relation to other women and men. How they smile and laugh. How they hold things. How they eat or sit. Passing isn't just about objective things like beard cover and breasts. It's also about subjective things like motion. The best made-up TV can give the game away with inappropriate movements.

Noon, downtown San Diego near 5th & C Street where there is a lot of pedestrian traffic. She had wavy blonde hair, a black long-sleeved sweater top, a 16-inch, clinging flowered skirt with opaque black hose. Miniskirts draw attention no matter who's wearing them. Now that my interest was piqued, I notice something different about her. Then it dawned on me — it's was a guy!

At first I couldn't define what led me to this. She gave off a certain indescribable "radiation of incongruity." Then I realized what it was — her movements. She had a tense, clipped stride, the way men walk. There was none of the comfortable, loose, fluid motions that women have. Now being crossdressed in public is nerve wracking, I know. But that nervousness transmits itself to body language. And this unease is transmitted to the causal observer subconsciously, if not consciously.

Now that I was examining her closely, I saw her lack of hips and broad shoulders, which clinched it. Let me say that she was not necessarily an obvious read. However, she gave off certain kinetic inconsistencies.

As genetic and social males, we tend to look at the material things while women look at the more spiritual and intangible ones. This attitude carries over into our crossdressing. We focus on type of beard cover, electrolysis, size of breasts, hormones, length of skirt, and

height of heels. But little attention is paid to the ethereal aspects of femininity, such as body language.

You can't "assemble" a female image the same way some male engineers would have it. You have to create it in a truly female way. Woman is as woman does

Anti-wrinkle drug wins FDA approval

After much debate, Renova — an inexpensive, low-risk way to combat the effects of aging — debuts this month

Does the acne drug, Retin-A reduce facial wrinkles?

For seven years, the federal government and the manufacturer, Ortho Pharmaceutical Corp., fought over that question.

A year ago, a truce was declared when the Raritan, N.J., company agreed to pay a \$7.5 million penalty for obstructing the government's investigation into whether it had illegally promoted Retin-A for wrinkles.

Now the saga has a new wrinkle: The Food and Drug Administration has just approved the product as a treatment for the rough skin, brown spots and — you guessed it — fine wrinkles that are part of aging.

"They should have done it long ago in a reasonable world," said Albert Kligman, the University of Pennsylvania professor emeritus of dermatology who developed Retin-A. "I think it was a tempest in a teapot. The drug works."

Ortho spokeswoman Lisa Adler didn't want to discuss the tempest: "I have no comment on that. We're just pleased we've gotten FDA marketing clearance."

Ortho Pharmaceutical won FDA approval of Retin-A (retinoic acid), a vitamin A derivative, for acne treatment in 1971. Under federal law, drug companies can't promote drugs for unapproved uses, although physicians are free to prescribe them for such so-called off-label purposes.

Dermatologists have for years prescribed Retin-A not only for wrinkle reduction, but for its apparent ability to help skin that has been damaged by too much sun, the leading cause of skin cancer.

Ortho is marketing its new wrinkle-reducing Retin-A formulation — a 0.05 percent tretinoin emollient cream — as Renova. A 40 gram tube, which lasts four to six months, will be available by prescription this month for \$60.

Initial redness, dryness

While there's no doubt Renova works for most people, it has pluses and minuses, dermatologists say.

Renova is inexpensive, low-risk and do-it-yourself. But it takes months to smooth and plump ageing skin, in contrast to the more immediate results of two newer anti-wrinkle treatments — alpha hydroxy acid skin peels and ultra-pulse laser therapy. The laser's effects are also more dramatic than Renova, because it penetrates deeper into the skin.

Renova initially causes redness, dryness and peeling of the skin. Almost all patients experience these side effects to some degree during the first several weeks of treatment, and the

symptoms often flare up after a six-month decline.

Renova also increases sensitivity to the sun, so patients are advised to apply a sunscreen and to avoid direct sun exposure as much as possible. On the other hand, because the drug appears to affect the way cells grow and change, it may provide protection against skin cancer. Scientists are now investigating this possibility.

Dermatologists and patients have raved for years about Retin-A's ability to bring out a more youthful skin texture and color. Now, even the FDA says those benefits have been scientifically proven.

Studies found that after 24 weeks, about one-third of users showed moderate improvement in fine lines and spotty discoloration, a third showed minimal improvement and a third showed no improvement.

In a 48-week study of 300 people ages 30 to 50, results were even better. Seventy-eight percent showed minimal to moderate skin improvement.

This minor miracle happens at the microscopic level. Kligman and his colleagues found that the drug causes cells in the epidermis — the layer beneath the skin surface — to proliferate and thus thicken. It also decreases the clumping, or keratinization, of epidermal cells; promotes sloughing of dead cells; increases blood flow, and decreases melanin clustering, which causes brown spots.

Dermatologist James Leyden, a clinical investigator of Renova and a colleague of Kligman, said patients normally notice a decrease in skin roughness within a month, a fading of brown spots within eight weeks, and a diminishing of wrinkles within three to six months.

'Educate your patients'

Philadelphia dermatologist Harold Farber said most problems arise from misuse.

"There are people who get into trouble with Retin-A if it's not used correctly. Somebody might be putting it on three or four times a day. And it can be harsh if you put it on wet skin . . . The key is to educate your patients. If they know how to use it appropriately and know what to expect, they'll do fine."

In most cases, the manufacturer says, a pea-size dab of Renova should be applied to clean, dry skin once daily at bedtime. However, patients with particularly sensitive skin have to gradually work up to daily use.

If Renova treatment is stopped, any improvements gradually diminish. However, the safety of using Renova for more than 48 weeks hasn't been established through clinical studies.

"You know you are an accomplished crossdresser when you can put on one heel while standing in the other."

This is all very understandable. After all, in the 1950s and 60s, Orange County sent Jimmy Utt to Congress. I mean, here was a man who not only saw a Red in every closet but thought fluoridation was a commie plot to undermine the integrity of America. But to Orange County, "He's our man."

And let's not forget John Schmitz, a card-carrying member of the John Birch Society. Orange County sent him to the State Senate. Yes Virginia, this was the same John Schmitz who later bolted the GOP to run for president in 1972 under George Wallace's American Independent Party. When he was asked just how conservative Orange County was, Mr. Schmitz joked that Orange County was so conservative he joined the Birch Society to attract the middle-of-the road vote.

Currently, Orange County is represented in Congress by Bob "B-1" Dornan. Even after Bob Dole has the GOP nomination mathematically wrapped-up, Dornan refuses to abandon the race for the GOP nomination citing the 1 percent of the vote he got in his own home state. I'm waiting for Dornan to tell Dole to get out of the race.

With this in mind, I am reprinting an article I read in the April 2, 1996 edition of the *Press-Enterprise*. The article originally ran in the *San Francisco Examiner*. Hopefully, it will encourage some of you to attend — Cyndi

In "Weird" San Francisco, it's Republican Rare
