"Dealing With Coming Out." The topic of our February meeting.

Not for you?

Maybe, Maybe not.

In the past, Coming Out was an issue primarily for transsexuals. After all, SRS is not something that one can easily hide from family, friends, and coworkers.

On the other hand, crossdressing is something that can be, and is done, clandestinely. In fact, I know one couple who were married near the end of the Eisenhower Administration. Recall the time? No John Glenn. No manned-space program. No Super Bowl. No Watergate. Heck, the Kennedy - Nixon debates weren't even a rumor. Most people couldn't find Vietnam on a map. Anyway, his wife did discover his "interest" until the end of the Reagan Administration!

Clearly, security is the Number 1 issue for many crossdressers. Entire clubs have been founded based on security. We rent P. O. boxes to receive our mail. We change in motel rooms to avoid family, friends and neighbors. We do all these things for very sound reasons. So why do we need a topic such as "Dealing With Coming Out."

Well, over the last, say 10 years (I chose this time period since Powder Puffs celebrated its 10th Anniversary last year) the public reaction to crossdressing has indeed shifted to our advantage.

DISCLAIMER: No, the public is not yet accepting. Yes, you can still get fired. Yes, your family may disown you, etc, etc.

I will not chronicle all the movies dealing with transgender themes. That has been written about extensively. However, look at what Dee has been writing in her columns. Television shows such as *The Drew Carey Show*, *Suddenly Susan*, *Ally McBeal* are showing transgendered

characters in a very truthful fashion.

For example, in a recent episode of *Suddenly Susan* Tony Curtis' character came out to Susan's mother on the show. The show pointed out he was not gay, but that crossdressing was something he had to do. Of course, he (she) did not "get the girl."

Why? Because he was a crossdresser?

No. Susan's mother declared that she "got over that." No Susan's mother dumped him because "he was a Republican." I guess there are some things worse than crossdressing.

I know a crossdresser from another club. When I first met this person, (s)he was very closeted. Now (s)he has started her own business within the Community and has told several of her friends and become a more visible. I was stunned.

At the last Powder Puffs meeting I talked with a couple who also has informed a few close friends. I was shocked.

Definitely, the past 10 years has seen a shift in public attitudes to crossdressing. What has fueled this change? I have my own theories, but that's for a later piece.

Admittedly, Coming Out is not for everyone. But a few of us are now being to come out. In the future, many of us may wish to deal with that issue so unthinkable a few years ago — Coming Out. Therefore, I encourage everyone to come to Powder Puffs next meeting. It really helps if you have some professional guidance.

I predict Coming Out will be the crossdressers' issue of the next decade (Century?, Millennia?).

The Changing of the Guard

I had a nice long talk with Nancy Nangeroni a few days before Christmas and I liked what I heard. I believe she's a very sincere person who is going to do her very best with the tasks that have been laid before her as executive director of the International Foundation for Gender Education (IFGE). Nancy appears to be ready and willing to take on the burden of that leadership. Without a doubt, she's got a tough row to hoe with IFGE's continuing financial burden combined with the latest controversy concerning the betrayal of trust over the borrowing of funds from the Winslow Street Fund.

I've been reading the explanations posted on the Internet by some of the principals involved in the "loan" from the Winslow Street Fund (WSF) and instead of getting straight answers the whole mess has gotten a lot more complicated. To compound matters, WSF chairperson Abby Saypen is talking out of both sides of her mouth at the same time. She's still proclaiming that the WSF is independent from IFGE with the funds being earmarked for worthwhile community projects, while at the same time declaring that the fund belongs to IFGE by virtue of its being carried on their balance sheet. The IFGE originally based their decision to borrow fund money on the rationalization that it would be better to do so than to face the possibility of the money winding up as an asset in the case of bankruptcy. While the IFGE has fully accepted this lame defense they continue to request donations using the same old promise of WSF independence. This fund raising tactic reminds me of a line used in the old western movie, *The Magnificent Seven*. When the Mexican bandit chief is asked why he continually robs the poor villagers he replies, "If God had not wanted them shorn, He wouldn't have made them sheep!"

In her heated defense of borrowing WSF money Ms. Saypen also let the cat out the bag by stating that this isn't the first time that IFGE has tapped in to the fund. The first raid occurred in 1992 when \$10,000 was used from the fund to use as a security deposit for the Waltham St. IFGE headquarters. In all of this heated exchange of charges and defenses there is one important question that hasn't been asked: Would the IFGE have kept secret the 1992 financial arrangement plus this latest money borrowing scheme if one of the trustees hadn't blown the whistle? All these years the fund contributors have been kept in the dark, and all indications lead to the certainty that they would

have been kept there in perpetuity had not one single individual stepped forward to tell the truth. Contributors would have continually led believe that their donations were being used for worthwhile community projects, while these clandestine backroom dealings were occurring.

To be perfectly fair, I also don't think anyone would have begrudged the IFGE of using money from the fund if the intended action had been openly presented and above board. The IFGE is constantly seeking donations from the community and I think that if they're to expect any more financial support they'd better come up with a policy of truth and honesty and forget the back room dealings.

Let me put it this way: If night-time dressing, short skirts, panne velvet in vibrating red or electric blue, and brilliant orange, green, and yellow 5" heels is your thing, then certainly this catalog probably has something for you. Jim also offers wigs, how-to videos, his cosmetic line, brightly-colored accessories, and an inexpensive line of non-silicone breast forms. On the other hand, if you're looking for daytime wear, sensible but stylish footwear with clothing and accessories in passable shades and tones, then you'd be better off shopping at one of the major department stores. The catalog content is definitely geared towards the standard Queen Mary Lounge Patron rather than the average transgender population.

On a scale of 1 to 10, with 10 being the best, here is how the catalog stands up.

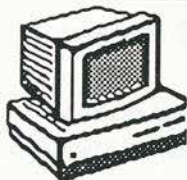

AEGIS AND ITA Initiate Merger Negotiation

WASHINGTON, DC and ATLANTA, GA--- January 16, 1998

The Boards of Directors of two national transgender organizations, the American Educational Gender Information Service, Inc. (AEGIS) and It's Time, America! (ITA) are pleased to announce that they have initiated serious discussions in pursuit of a merger of the two groups, with the intention of creating a new organization designed to meet the changing educational and advocacy needs of the transsexual, transgender, and other gender-different communities. The boards recently approved mission and values statements and are working to develop goals and projects to meet the community's needs. To better determine these needs, AEGIS and ITA have developed a survey form which solicits input from all interested persons and care providers. The respective boards hope to reach agreement on this merger in the near future, but in the interim, the independent operations of both organizations will continue. The American Educational Gender Information Service has provided a variety of educational resources for professionals, transsexuals, and other persons since 1990. It's Time, America! has advocated on behalf of transgendered and other gender-variant persons through state-level chapters since 1994.

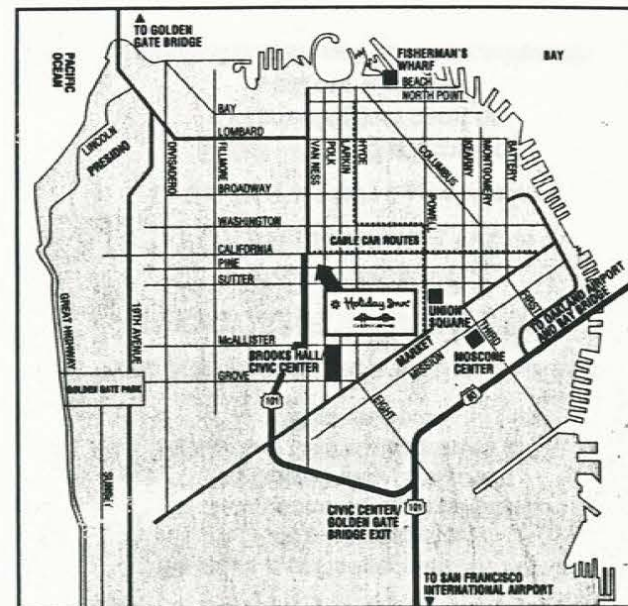
