Founded by the Outreach Institute, FANTASIA FAIR is held in the quaint, Cape Code town of Provincetown, Massachusetts. Crossdressers from the United States, Canada, Mexico and Europe have attended the four annual Fairs to date, providing a truly cosmopolitan mixture.

The purpose of FANTASIA FAIR is to view crossdressing and alternative gender lifestyles in as positive a perspective as possible. Every aspect of FANTASIA FAIR 1979 has been planned to give you the unique opportunity to express yourself in a tolerant, understanding, and positive atmosphere.

CONDITIONS OF PARTICIPATION

In these conditions the term "Institute" refers to Fantasia Fair, Ltd. and the term "participant" refers to the person signing the registration form.

(1) Registrations will be accepted from all persons who have reached their 18th birthday prior to 12 October, 1979.

(2) It is requested that femme attire, appropriate to the occasion, be worn throughout a participant's stay.

(3) The deposit of \$75.00 per person shall be treated as partial payment of the total sum due, as stated in this brochure and by agreement between institute and participant.

(4) All participants who have their accounts paid in full prior to 1 August, 1979 will receive a discount of 5% of the total cost of the selected plan.

(5) Except in cases of late registration, all payments are due no later than 1 September, 1979. If payments are delinquent as of 1 September, unless special arrangements are made, the institute reserves the right to cancel the reservation as per #6C below.

(6) If a registration is cancelled, the institute will refund to the participant all monies paid LESS the following amounts:

- (a) Cancellation before 15 June: \$35.00 (half of \$75.00 deposit)
- (b) Cancellation between 16 June and 31 August: 50% of total cost of selected plan;
- (c) Cancellation between 1 August and 1 September: 75% of total cost of selected plan.

No cancellations will be accepted after 1 October.

(7) The full program of Fantasia Fair Ltd. 1979 is based on a minimum participation of fifty persons. Should participation fall below this number all monies will be refunded except for a \$35.00 overhead charge.

(8) The institute reserves the right to make necessary program changes. Participants will be informed of these changes where possible, and will be offered these alternatives:

(a) to accept these changes.

(b) to cancel participation and accept a refund of 70% of all monies paid.

(9) Fantasia Fair participants are expected to maintain certain minimum standards of deportment that are appropriate to individuals of any respectable group. If a participant's behavior continues to be inappropriate, the institute reserves the right to terminate that participant's stay, refunding to the participant 50% of the charges for the time remaining at the point of termination.

(10) The institute reserves the right to make a service charge for a room/facility change made at the request of a participant once the fair period begins.

(11) Except where otherwise noted, the institute acts only as an agent in arranging lodging and other personal services. The institute will not be liable in the event of failure of contracting parties to honor their commitments. The institute will not be liable for personal injury whether arising from an incident during the fair or otherwise. The institute will not be responsible for consequential damages whether arising from an incident during the fair or otherwise. The institute will not be responsible for lost or damaged personal property.
