MEETING FEE . . . . .

Some years ago CHI Chapter had a \$7.00 "meeting fee," collected from each person who attended a meeting, to cover the cost of our meeting room and the refreshments. After our annual dues were established we soon accumulated an embarrassment of riches, and the meeting fee was reduced to the current \$4.00 which covered our actual costs. It was agreed at the time of the reduction that the meeting fee would be adjusted (up or down) whenever required by the state of our finances. During the past year we have met in motels quite often, rather than in private homes, and motel prices, postage, and other costs have risen due to inflation. At the October meeting the membership voted a nominal increase in our meeting fee, to help cover these increased costs. Effective January 1, 1979, our monthly meeting fee will be raised from \$4.00 to \$5.00. We don't feel that this increase should be a burden to anyone, and will help the financial position of the Chapter.

IT'S THAT TIME AGAIN . . . . .

Yes, it's the time that comes every year which we can't avoid - Dues Time!
