SHE IS COMPLETELY NON-JUDGEMENTAL IN HER ACCEPTENCE. SHE ALSO EXTENDS THIS UNCONDITIONAL LOVE & ACCEPTENCE TO EVERY LIVING BEING UNDER THE SUNIWITHOUT EXCEPTION. SHE EVEN SUPPORTS THOSE WHO WOULD CENSOR HER, IT'S THEIR FREE RIGHT TO TRY TO SILENCE HER.

IT'S THIS ATTITUDE THAT SHINES BRIGHT & CLEAR IN HER WORDS.
LES, AND ALL HIS WILD & WACKY WAYS (My judgement not news) ARE ALWAYS
PRESENTED POSITIVELY & STRONGLY WITHOUT APOLOGY. HE IS SHOWN AS
RATIONAL AND QUITE HAPPY. HE HAS BENEFITTED FROM A "REALLY

RADICAL FORM OF THERAPY"

IN REGARD TO USE OF PRONOUNS. ANNIE REFERS TO LINDA AS SHE, NOT LES! LINDA WAS A WOMAN, "SHE" IS THE APPROPRIATE PRO-NOUN. ANNIE IS THE UNOFFICIAL DEN-MOTHER OF OUR LITTLE WOLF-PACK, HERE IN NIY, (A.K.A. "F2M" support group) SHE CERTAINLY HAS MORE F/M T/S FRIENDS THAN MOST OTHER WOMEN. SHE KNOWS THAT WE ARE MEN, SHE DOESN'T THINK OF US AS WOMEN. SHE WOULDNEVER DREAM OF CALLING US "SHE" SHE WOULD BE THE FIRST TO DEFEND OUR MALENESS, REGARDLESS OF THE CONFIGURATION OF OUR FAMILY JEWELLS. SHE ALSO STRONGLY SUPPORTS OUR RIGHT TO CHANGE OUR BODIES IN ANY WAY NECCESSARY TO MATCH OUR PSYCHES.

BUT LES (BLESS HIS GUTS) IS NOT CONFINED TO ONE GENDER-IDENTITY, AS MOST OF US (ESPECIALLY T/S'S) ARE! HE'S NOT STUCK

IN HIS "GORILLA-SUIT", HE CAN REMOVE HIS MACHO-MASK, AND STEP OVER THE LINE THAT MOST OF US HAVE NO DESIRE TO CRUSS.

, AS A "PRIMARY TRANSSEXUAL" (someone with PERSONALLY, unrelenting TIS desires from parliest childhood), I FEEL THAT THE TERM "FEMALE-TO-MALE" TRANS-SEXUAL" IS A MISNOMER. I WAS NEVER FEMALE, I NEVER EVEN TRIED (VGH! GOD FORBID!) I WAS MALE RIGHT FROM THE START, I JUST HAPPENED TO HAVE AN UNFORTUNATE BIRTH-DEFECT. BUT LES, WAS A FEMALE (A Radical Lesbian Seperatist) HE MADE A CONSCIOUS DECISION TO BECOME A MAN; SO HE IS QUITE LITERALLY A FEMALE-TO-MALE TRANS-SEXVAL BUT SINCE HE'S NOT WHAT ANYONE WOULD CONSIDER A "PRIMARY TRANSSEXUAL", PERHAPS HE SHOULD BE REFERRED TO AS A "SURGICALLY-CREATED HERMAPHRODITE"; OR PERHAPS A "FEMALE-TO-MALE TRANSGENDERIST"; OR PERHAPS Á "FEMALE-TO-MALE TRANSGENDERIST WITH SURGICALLY-CREATED PUAL-GENITALIA"; OR PERHAPS WE SHOULD TOSS THESE CATEGORIES IN THE TRASH, AND START ACCEPTING PEOPLE AS INDIVIDUALS, WITHOUT REGARD TO GENDER-IDENTITY AND SEXUAL PREFERENCE.
