## CSUN Center for Sex Research Endorses 2<sup>nd</sup> Congress Here in '97

Plans for a *Second International Congress On Crossdressing, Sex and Gender Issues* took a step closer to reality last month when the Human Sexuality Education Program in the Graduate School of Education at the University of Pennsylvania agreed to be the academic sponsor for the event. William R. Stayton, Th.D., and JoAnn Roberts, Ph.D., co-chair the Steering Committee for the conference to be held in the late Spring of 1997.

The overwhelming response for the first congress was so positive that several members of the transgender community approached Vern Bullough, Ph.D., R.N., the organizer and co-chair of the first event, with the idea of holding the congress on a regular basis. Dr. Bullough, while supportive of the idea, did not want to be responsible for a second or subsequent conference. He did, however, encourage the exploration of possible sites for a second congress and pledged his advisory support if a suitable academic sponsor could be found.

While still at the conference, many people from both the transgender community and the professional community talked openly about when and where a second congress might be held. Several people regarded the University of Pennsylvania's program as an excellent choice for a sponsor and that 1997 would be the best timing. JoAnn Roberts agreed to seek the University's cooperation.

On March 17, 1995, Dr. Stayton at the request of

Dr. Roberts proposed the congress to the faculty of the Human Sexuality Education Program and they agreed to sponsor the event. Roberts then contacted Dr. Bullough and James Elias, Ph.D., Executive Director of the Center for Sex Research at Cal State University at Northridge (CSUN), to inform them of the decision by the faculty at the university.

In a fax on March 29, 1995, Dr. Bullough informed Roberts, "Jim [Elias] says the Center for Sex Research will be happy to co-sponsor, and endorse [the second congress] as our legitimate successor..."

"This is an opportunity for both the transgender and professional communities to work together again on a project of widespread importance," says Roberts. "We'd like the event co-sponsors and the Steering Committee to be even more eclectic than it was for the first congress," she said, "Where it goes after this will be up to whoever is willing to do the groundwork. There are several contenders."

Cooperation between the transgender and professional organizations will be critical to the success of this second congress. The TG organizations will provide both the seed funds and the bodies to do the behind-the-scenes work. The professional organizations will primarily be concerned with the programming and review of submissions.

A Call for Papers will be announced later this year, along with other details of the event.



## Happy 8<sup>th</sup> Birthday Renaissance!

None of the five co-founders of Renaissance in 1987 would have believed where the organization is today had someone been able to foretell the future.

That first meeting of 13 people gave no hint at the impact this small group would have on the transgender community at large.

Today, Renaissance stands as the only national membership organization for all transgendered people. It has grown from a local support group to a

federally recognized education association with four chapters (soon to be five) and seven affiliates in nine states, and it's still growing.

Renaissance members are community contributors, too, with members serving on the boards of IFGE, Outreach Institute, AEGIS, and Tri-Ess.

So, a Bronx cheer to those who thought Renaissance was just a "flash in the pan" and congratulations to all Renaissance members on your birthday.

### STOP THE PRESSES, IT'S A MAN IN A DRESS!

We really are popping up everywhere and not just in newsletters and 'zines. *Esquire* did a twelve page story in their April issue on the transgender trend. It's a pretty comprehensive job, covering such diverse people in the transgender community as Las Vegas Barbie **Jahna Steele** to legal eagle **Phyllis Randolph Frye**.

Jahna was featured in a sidebar to the main story, with enough photos included to keep any red blooded femmophile happy. Boy, does that woman look good! I'd take her home to mom. She told of how she had never felt like a man and had remained a virgin until after her surgery. She also stated that in order to maintain her beauty she has to take estrogen every day. ( She has lived as a woman since the age of 17. You can't start late and look that good.)

In the main story a TS named Martine Rothblatt said that since she had surgery she doesn't have to take hormones. Now, who is right? When in doubt, go with the showgirl. Jahna is

# IFGE Report: Inside Atlanta Action '95

Introducing a new logo and a new format for programs, IFGE's 9th annual "Coming Together-Working Together" convention convened in Atlanta, Georgia, on March 12, 1995. Entitled *Atlanta Action '95*, the focus of this year's gathering was to motivate local groups to become visible and active in today's society. To this end, the programs were designed to develop leadership at all levels of the community and to share successful endeavors between groups.

With approximately 125 registered participants and many local walk-ins, this year's convention may not have been a financial success, but it did achieve its objectives. Although not as well represented as at previous conventions, Renaissance's leadership was visible through those representatives who did attend.

Maryann Kirkland was appointed to a full three year term on IFGE's board of directors; thereby, continuing Renaissance's representation there. Maryann continues to serve as Program Chair for next year's convention.

Alison Laing, a co-founder of Renaissance, was chosen as the new Executive Director of IFGE. This position became vacant by the resignation of Merissa Sherrill Lynn, who founded the organization.

The new programming format was introduced on Wednesday with two all-day seminars. One session was a Boot Camp for Public Speaking led by Eve Burchert who chairs IFGE's committee for Public Education and focused on improving one's ability and confidence when addressing the public. The other session was a Community "Town" Meeting where groups and individuals focused on how to build a stronger and more visible community.

The programs on Thursday, Friday, and Saturday were varied with never more than three programs presented at any one time. A fourth room was available for "spill over" discussions

from the seminars or for just conversation between convention participants.

The Congress of Transgender Organizations (CTO) met twice during the convention. At present, the CTO has representatives from 110 of the 220 groups known to exist within the community. Membership is expected to increase significantly because of outreach toward the Tri-Ess groups. Anne Johnson and Maryann Kirkland were re-elected to the offices of Chair and Secretary respectively. Lynn Walker and Patricia Winn will share the office of Vice Chair.

Many exciting projects are being undertaken by the CTO. The direction and purpose of the organization were rewritten to more clearly indicate what the CTO is about. The new direction reads: "To facilitate communication and co-operation within our community and the community at large." The new purpose reads: "To promote and encourage the exploration and acceptance of diverse representations of gender identity within our community and the community at large." This newly defined direction and purpose incorporates the principles expressed in the "transgender alliance Pledge for Community" and requires organizations to subscribe to the pledge without actually signing the statement.

The CTO adopted a proposal to create an electronic home for the worldwide gender community on the Internet. A committee of four are working to make this proposal a reality in the near future.

The CTO endeavors to expand on the outreach efforts of several local organizations by contacting religious congregations at a national level.

The first ever STAR (Special Transgender Achievement Recognition) award was presented to Ms. Jennifer Richards of MAGGIE for Meritorious Service to the Community. This award is available to any organization that wishes to recognize an individual for dedication and

service on a local level. (Contact Anne Johnson or Maryann Kirkland for details on how to nominate a STAR.)

On Wednesday night, the Trinity Awards were presented to six people in the transgender community. This year's recipients were: Dallas Denny, founder and Executive Director of AEGIS; James Green, editor of F2M, the largest circulated publication for female-to-male transgender issues; Laura Caldwell, who led IFGE's Strategic Plan, Vision 2000; Leslie Feinberg, author of *Stone Butch Blues* and *Transgender Liberation: A Movement Whose Time Has Come*; Sharon Ann Stuart, director of the Military Law Project for ICTLEP; and Linda Peacock, board of directors IFGE and TRI-ESS, chair of SPICE.

The highlight of the Convention occurred on Saturday night with the presentation of the Virginia Prince Lifetime Achievement Award to Yvonne Cook-Riley, who has faithfully served IFGE as "financial wizard" since its beginning. Prior to jumping aboard the IFGE train, Yvonne was active in many local organizations in Indiana. Today Yvonne is making great strides in strengthening the bonds between the transgender and gay and lesbian communities.

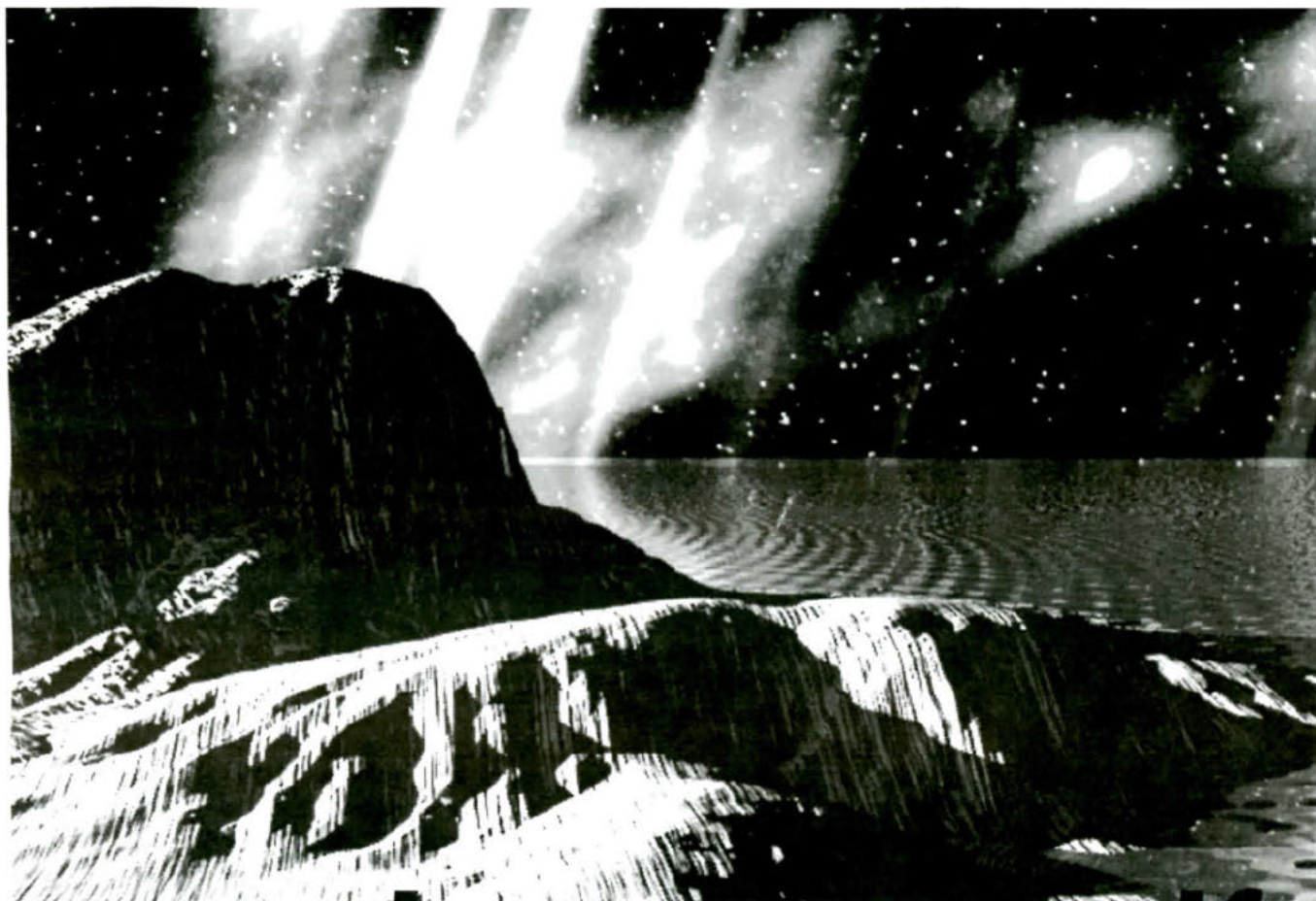

**PERHAPS WE CAN HELP.** We've been helping people explore the limits of who they are since 1985 with publications like *Art & Illusion: A Guide to Crossdressing*, Vols. 1 and 2 (\$US15 ea.), *Coping With Crossdressing* (\$US15) and the only book on feminine speech *Speaking As A Woman* (\$US10). But Cargile's public antics point out that if crossdressing is practiced in a spirit of openness and good humor—rather than semi-embarrassment and subterfuge—others can accept it at face value. There's got to be more of a motivation for all of us to crossdress than simply 'fun' but let us not be afraid to admit crossdressing is enjoyable as an end in itself.

### So Funny I Forgot To Laugh

It's nice to know that if I miss something of note in newsletterland, somebody out there will call it to my attention. Bonnie from the *Boulton & Park* group in Texas sent us a copy of a tongue-in-cheek piece that was published in the newsletter of the *Gulf Gender Alliance*. Unfortunately, I don't have the name of the author of this piece, which is a lucky break for whoever he or she may be.

The article was in the form of a 'Hazardous Materials Report' and the hazardous material being analyzed was a substance called "Woman," and you can begin groaning now.

Here is a brief sample of what was written [my comments in brackets]:

Discoverer: Dr. Adam R. Male  
[Even the most misogynistic clod wouldn't claim that man 'discovered' woman.]

Physical Properties: Boils at nothing, freezes without reason; melts if given special treatment; bitter if incorrectly used; yields when pressure applied to correct points. [This was men's magazine'-style humor from the 50's and 60's but this is 1995... isn't it?]

[Why waste time simply demeaning women when you can just insult them outright?]

The strike is over and the replacement players have been banished to the sandlots once again. And not a moment too soon, either.

I think this last batch of newsletters from which I cull the items for this column were written by replacement crossdressers because there seemed to be a dearth of interesting material.

So it'll be nice to have the major leaguers back at their word processors. I can look forward to a few hits, some errors, maybe a wild pitch, and the inevitable drag bunt. But please... no runners.

### If That's What You Call Fun

The January 16 issue of *The New Yorker* magazine carried a profile of socialite businessman and crossdresser Neil Cargile. It's an interesting study of a successful 'man's man' who happens to enjoy—quite openly—the thrill of public crossdressing.

My interest in this article was not the surface facts surrounding how "High Heel Neil" (as he is called by friends) goes about his crossdressing or his fashion choices. The descriptions of his outfits and the accompanying photo is not terribly flattering. Mr. Cargile is a ruggedly handsome fifty-something man. As a woman, he favors flashy, perhaps trashy, outfits that are unremarkable except in their brazenness.

John Berendt, the journalist writing the profile, attempts to understand the crossdressing phenomenon in general and Cargile's motivation to crossdress in particular. In this respect, it is an excellent basics course for the non-crossdressing public.

Cargile, who doesn't really use a femme name but sometimes refers to himself as She-Neil (as in chenille) is pretty blunt about his motivation to crossdress. "It's fun," he repeats many times whenever the author tries to pin him down on why he likes to crossdress. At times, the "fun" motivation seems to be a defensive explanation to keep more serious issues at bay. The only other reason that Cargile admits for his outrageously feminine crossdressing is that he enjoys attention, especially when he knows his audience is shocked and amused by his presence.

When he isn't wearing ridiculously short skirts and fancy women's hats in full drag, She-Neil enjoys mixing his masculine and feminine wardrobes. The author of the profile recounts his meeting with Cargile at New York's Tavern on the Green restaurant on a crowded Sunday afternoon—where Cargile showed up as his male self in a navy double-breasted blazer and dress shirt, coupled with a micro miniskirt and high heels. The tourists went crazy gawking at him/her and Mr. Cargile loved every minute, and snapshot, of it.

She-Neil isn't a member of any crossdresser's support group. And maybe that's a good thing because some support groups on which I've reported have dress codes against just the type of outrageous female dress and *gender-mixing* of wardrobes in which Cargile does his thing. And I'm sure there are some community leaders out there who find his insistence on having "fun" as somehow beneath the dignity of the "true" crossdresser.

If this supposedly humorous piece was found in the *American Beer Drinker's Journal*, it wouldn't be any funnier but maybe the context would make more sense. In a transgendered support group newsletter, it's unfathomable. Aren't we trying to emulate women? Aren't we supposed to have a more empathetic outlook on what it's like to be a woman in our society? Hell, forget all that: aren't we supposed to *like* women? What was the author thinking when he submitted this for publication? And which editor was asleep at the switch when this trainload of woman-bashing tripe came rumbling down the tracks?

I once wrote that our community newsletters were our calling cards to the outside world. A piece like this sends the wrong message to any intelligent person reading it. Someone outside the transgender community would be rightly suspicious about our stated interest in things feminine upon reading something like this item. Let's be more vigilant in what we publish and what we are saying about ourselves through our newsletters.

### Stifle Yourself Archie

The Memphis Transgendered Alliance puts out the newsletter *Powder & Pearls*. In their February issue, they printed an unsigned letter to the editor. Like the "humorous" article above, I could hardly believe the content of this letter appeared in 1995. Rather than paraphrase the writer, I'll let his own words stand for themselves.

"I must protest the apathy of this group (MTGA) on the subject of homosexuality," he or she begins. "[At] recent group meetings, there has been present an admitted homosexual. As a crossdresser, I ask for separation.

"...While I engage in occasional

crossdressing, I do not wish to be confused with the homosexual."

Our letter-writer then takes a few sentences to explain how heterosexual crossdressers must allay the fears of spouses that crossdressing partners may have homosexual tendencies.

"Ladies and gentlemen, I believe there should be an acknowledged separation between the transgendered and the homosexual," he writes before signing off with this kicker, "I agree we should be nice to our guest, but our guest should also be severely limited to the quantity of visits, say once, and also limited to our group resources, for example, our patience."

I was waiting for his suggestion that the homosexual member be required to wear a pink Star of David on her dress so that any new members would know that they were dealing with an "admitted homosexual."

MTGA is an open group, not limited to heterosexual crossdressers, and another uncredited member (presumably an officer) wrote a counter-opinion in favor of diversity and freedom within the group. In fact, the MTGA meets in the Memphis Gay and Lesbian Community Center, which would make the exclusion of homosexuals somewhat hypocritical, don't you think?

Unfortunately, there are probably more than a few heterosexual crossdressers who don't mind taking refuge in gay establishments because of the easy acceptance therein, while secretly harboring the worst kinds of prejudice against homosexuals.

It is true that most heterosexual crossdressers wish to maintain a distinction in the public's eyes between us and the stereotype of gay drag. But we won't get sympathy from anyone with two brain cells to rub together if we act like Archie Bunkers in high heels.

*The Transgenderist* is the newsletter of the TG Independence Club in Albany NY. A regular feature of the newsletter is a column by a member

writing under the name Miss Take and the name of the column is *Gotterdammerung* which I think is German for "Ve Are der Master Race". Anyway, the *Gotterdammerung* column is Miss Take's irreverent view of the transgendered experience.

In their March issue, another regular contributor to the newsletter, Callan [redacted] wrote to complain about Miss Take's less than serious approach to things. You see, Callan [redacted] is very serious about stuff like transgenderism, and usually takes up a page or two of each of their newsletters with her own views of things transgendered. Her letter of complaint to Miss Take was printed in full and is filled with references to learned studies on gender dysphoria, complete with words like "gynemimetic." All as a means to show the contrast between her own seriousness and Miss Take's coverage of things like Reba McEntire meeting her drag impersonator in a new Nashville revue. # Come Out, Come Out, Wherever You Are

I am amazed at the partners and wives, WHERE ARE THEY? Each and every month I read a dozen or so newsletters from around the country, hoping and looking to find an article written by a partner. But other than a very select few of us, we somehow remain, non-existent, invisible and silent. I find this silence deafening!

My emotions run from sincerely felt empathy, to downright *mad* at the (for the most part), total lack of partner participation. Once again, I ask, WHERE ARE YOU?

More often than not, I have found myself the only partner at a party, where most of the people are married. I can count on one hand the number of women that attended a non-dressed meeting. I find this very confusing. If our partners were into golf, or bowling, or tennis, and we weren't, wouldn't we take some interest in it? WAKE-UP ladies. Those are hobbies and can change with the seasons. His cross-dressing is *not* a hobby and is here to stay. Now, wouldn't it seem logical to learn more about it?

To make a point (I will use fictitious names): Just this past month, John/Jenny attended a party in someone's home, a party at a hotel, a board of directors meeting, and a non-dressed discussion meeting. He says he is "happily married" and his wife accepts his crossdressing. Well then, where is she? Doesn't she want to know where he is going? Isn't she curious about the people he is spending time with? He spends 3-4 nights out of the home every month, in places she has never been, sharing his life with people she doesn't know. Isn't there something wrong here? When he goes home, how can he talk about where he has been, or who he has spoken to? How can she know and understand what is going on in her partner's life? When it's his turn

to speak at a discussion meeting about his inner feelings and thoughts—she is not there to hear. Shouldn't what he is revealing be of more importance to her than to anyone else? Yet, on the many occasions when John/Jenny and I have spoken he is always proclaiming his "happy marriage." I can't help but shake my head in bewilderment.

I believe a couple should share their lives. Now, don't misunderstand me, sharing does not mean suffocating. If one partner is into something that the other partner isn't—shouldn't the other person be responsible to know enough about it so that they can, at the very least, have a conversation concerning the other person's interest? Shouldn't a couple be a team? Doesn't a team work together? How horrible would it be to attend a meeting? Many groups even have non-dressing meetings, if that's your problem.

In discussing this dilemma with many people, I have heard all the justifications. Everything from, "We would have to get a baby-sitter if I went" to "If I don't go with him, maybe it will go away."

May I repeat—IT'S NOT GOING TO GO AWAY! By alienating ourselves, we put up a wall in our relationship. Eventually this wall is too high for either partner to climb.

Personally I don't understand how a partner can "tolerate" her partner's crossdressing. How can you say you love someone, and just tolerate part of his being? Let's stop here for a second. Nowhere does it say that you have to stay in this relationship. *So get out.* What are you waiting for? A slow death. But before you end it, try a meeting or two. Talk with another women. Read a book on crossdressing. You may be surprised to learn that the "monsters" you thought were at these meetings are genuine human beings, from all walks of life.

I have taken the other route. I am very involved in all of my partner's crossdressing ventures. And *no*, it is not always easy. There are things that I have a very hard time with. But I can tell you this: We are a team! We are extremely close, and have a lot of fun together. We attend everything together, and I wouldn't have it any other way. When there becomes a problem, we work it out together, "Together" what a great word!

In order for a relationship to survive, your partner should be the number one person in your life. If you *both* feel this way, you are a loving team, and can only grow closer together. Although I'll be the first to admit it's not always easy, for the most part, we are very lucky women. Our men are gentle, warm, loving, and very devoted. These are the characteristics that made us fall in love with them in the first place. Our partners are exploring another side of themselves, and it's probably twice as scary for them, as it is for us. Share in their experience. Don't let him be alone or I can almost promise you, you will be the one *alone* in the end.








I have been privileged to attend many support discussion groups, and although the room echoes with an acceptance for one another, the people we want to accept us the most are the people we love. Be there for him. Love him. Take strength from each other. Share each other's fears, and be a part of his world. Be a team. Know that the road ahead will be bumpy for *both* of you. But, if you hold each other's hand, and keep the door for communication open, you will be on the winning team.

To all those people in the tg community who wish that drag queens and transvestites who dress provocatively would become invisible, I offer this quote by Michael Musto from the Oct. 1994 issue of *Spin* magazine: "... a gay man's job is not to represent all gays. It is to be himself, do his best work, and be the finest person he can think of. Only then can he make his mark and further the gay cause. I didn't come out of the closet to conform, to become a well-oiled goodwill machine. Why the fuck doesn't anyone ask the suits 'Aren't you afraid you might be hurting the gay movement because you're so damn boring?'"

The April issue of *Esquire* magazine carried an article titled "The Third Sex" which was really about the growing transgender rights movement. Writer John Taylor interviewed Phyllis Frye, Merissa Lynn, Yvonne Cook-Riley, Riki Wilchins, Martine Rothblatt, and Dallas Denny among others not so recognizable in the community. Phyllis Frye comes off extremely well in the piece. Overall, I thought the article was very positive and well-balanced. However, others did not feel Mr. Taylor was fair in noting his perceptions of transgender people. Wilchins, co-founder of Transsexual Menace, held a protest in front of the *Esquire* offices in New York. The Rikster, as she calls herself, felt that Taylor dissed Lynn and some of the other transsexuals mentioned in the article. I think there is sensitive and hyper-sensitive and Riki is hyper on this one.

This just in from Paris... the "official" length for skirts is to the knee. While that

Just before I stopped working for Southwest Research Institute in San Antonio, Texas, I was employed in the Safety Office as a Senior Research Chemist and I was responsible for seeing that all hazardous Waste generated at SwRI was disposed of properly. I was also responsible for maintaining a file of all the Material Safety Data Sheets for the chemicals at SwRI.

The "joke" referring to WOMEN as a Hazardous Material was demeaning, harassing, and not called for from a group of crossdressers who for some reason, I thought, liked to be treated like women. You, who dress as women because you hold us in such high regard. You, as crossdressers, wish to be accepted by the public and your wives and partners and this is the kind of trash you print in your newsletter?

I thought Joann Robert's article on the World Wide Web was excellent. There are so many wonderful T-resources springing up every month on the Internet. Today, for an investment of about \$1000 in a computer system, software and a SLIP/PPP account you can, without knowing anything about computers, have access to this world in one or two days. I highly encourage this, but thought some extra points should be added for our members not familiar with the net.

- **Passwords:** Whether you go through an on-line service (CompuServe or America On-Line, etc.) or through an Internet service provider, you will receive [a username and] a password. Your password is your first line of defense against computer hackers and fraud. Never give out your password to anyone. And change it at least every other month. Don't make it a simple word or name.

- **Credit Cards:** Be extremely careful about sending your credit card number on-line. There are commercial products available on the net which you can order by charge card. Be careful just as you do when using your card on the phone.

- **Lurking:** When subscribing to any Newsgroups, like alt.transgendered, or soc.support.transgendered, listen and read the postings for a period of time before sending your own post. This is called lurking and is encouraged. Make sure your post is appropriate for that newsgroup.

- **Watch for jarheads:** Just like any place in society, the Internet is filled with jerks. You need to be careful what you tell people, and be very careful about giving out your phone number.

- **Educate yourself:** There are hundreds of books on the net. Read one or two to become familiar it.

- **Watch the costs:** Know if your modem is dialing a local or long distance number. Internet sessions can last for hours, so be careful if going by long distance. All on line services charge fees for certain features and time. Know what they are, so you won't be shocked with a \$300.00 monthly bill.

- **The Internet has its own language:**

: - ) means happy or smiling.

: - ( means sad.

LOL means laughing out loud or laughing on line.

Newbie means a new person.

Flame means when somebody responds very angry to a post or topic.

Dear Doctor Bill,

I have been reading *News & Views* for several months and really enjoy it, particularly your column. I haven't attended a Renaissance meeting yet and while I'm sure I need to meet others like myself (I am a CD) I worry about what people will think of how I look. I know I need help with my makeup and such and I guess I'm afraid some one might make fun of me. I know that's silly but what can I do to get myself to a meeting?

Dear Alicia,

Your feelings are very normal. Whenever any CD goes out in public for the first few times, you wonder how your makeup is, will you be "read", will others be critical of you, etc., etc. First of all, within the cross gender community, you are your own worst critic. The cross gender community will understand what you are going through because each person has gone through exactly the same anxiety. They will be your greatest supporters.

Second, let me offer some suggestions: One option for you is to call the Renaissance office and tell the person you are talking to of your dilemma. They will be able to recommend a "big sister" to help you get ready and feel reassured about attending the meeting. Another option is to come dressed in your male attire and get a sense of the meeting and the people. I am sure you will go away feeling reassured and it will make it much easier to come cross dressed to the following meeting. One of the things you will learn from attending a meeting is how many wonderful people there are who are similar to you. The meetings are usually very interesting because they discuss subjects that are of concern to the cross dressing community. For example, at our last

meeting JoAnn Roberts spoke on "How to come out to your family and other loved ones". They often also have fashion and makeup consultants who give advice and counsel. At your first meeting there will be an orientation and that will introduce Renaissance and what it has to offer to you. Good luck to you on this exciting new adventure.

Dear Dr. Bill,

I have always felt that I am a woman. Since I was born into the male gender I guess that makes me a transsexual. I have only begun to try and do something about my physical state in the past few months but I have not started any therapy or hormone treatments. I have heard about the Benjamin Standards of Care and some of the debate that goes on about their use. I want to know why I should go through all of the hassle following them involves? I have friends who know where to get hormones and am seriously considering starting them. Tell me why I shouldn't, if you can.

Dear Janice,

Even though it feels right, starting hormones and moving towards eventual reassignment surgery is the biggest decision of your life. I would hope that you would want to do this process "right". Processes like the Benjamin Standards of Care were developed for your wellbeing, not to be road blocks for you. Several years ago a study came out that shook the transgender community. The claim was that on follow-up studies of post-operative transsexuals, it was found that the majority were either severely depressed or had committed suicide. On a closer look at this study, it was discovered that none of them had gone through therapy or followed any professional standards of care. The ma-

jority of surgeons who do surgical reassignment will only operate on persons who have gone through the Benjamin process. Because it is the most important decision of your life we want it to be done correctly. This is your best insurance for finding satisfaction and happiness in the end.

Regarding hormones, it is important that you be followed by a competent physician, such as an endocrinologist. Hormones are very powerful and the dosage must be customized specifically for you. The dosage for one person may cause damage or death to another person. It is important to know your and your family's health history. I had a personal friend (MtF TS), who got her hormones and the dosage "off the street." A couple of years after her surgery, she died of a blood clot while on the operating table for some fairly simple surgery. The blood clot was directly attributed to the hormone misdosage. While this story may seem like a scare tactic, it is true and carries a lot of pain for me as I tried very hard to get her to see an endocrinologist for years.

century. (It has been suggested it was between 1538 to 1542. If you have ever wondered where our present order of service came from, John Calvin is credited with the invention. Bet a lot of you thought the Baptists invented it.)

So where am I going with all of this? Simply to say the church in this world is not the final authority in the question of transgendered people. We pose a problem to them but not to God. Their treatment of us is a problem for God. In his infinite wisdom He foresaw this day and this problem so He became a man in the person of Jesus Christ. # Honey, You're Cleared to Land

I work in the aerospace industry. Hence, I tend to speak in aviation terms. I liken my relationship with my partner Suzanne, where crossdressing is concerned, to a small airplane approaching a large airport. With Suzanne being the air-traffic controller, my femme self being the small plane and crossdressing being landing.

If you or someone you know is a pilot, then you may be familiar with the difficult task of approaching and landing a small aircraft at a busy airport. It can be done, but it ain't easy!

As the plane enters the airport's airspace, the pilot can expect to be constantly adjusting speed and course to "fit into the flow" of traffic in the area. This is true even if a pilot has properly filed a flight plan and is arriving at the scheduled time. Often, a larger and faster aircraft enters the area. The controller may tell the small plane to attempt a sharper turn or increase air speed to maintain his position in the flow of traffic. If the pilot is unable to comply, the jet overtakes the smaller craft. This results in the light airplane being told to abort the approach and come back around.

Then, too, there are the unexpected things that occur. Perhaps some aircraft has to suddenly return to the field and this disrupts all of the air traffic.

The pilot of the small plane needs to land the aircraft, that is a given. However, due to a great deal of factors to-

tally beyond his/her control this necessary procedure becomes very complicated and frustrating.

Such is the case for a crossdresser who has a job, home, spouse/partner, children and relatives. The crossdresser has a need to express his femme self, in other words, to crossdress. If he is fortunate enough to have a supportive partner or spouse, they may assist in trying to schedule a time for the femme self to "land." At our house, it is more of a rule than the exception that numerous obstacles interfere with the "flight plan." Sometimes these disruptions are humorous, sometimes they are a great disappointment.

The pilot of a small aircraft would be shocked to radio in on approach to a large busy airport and then hear the controller say, "I knew you were on your way in, so I've cleared all other traffic out of the area. Take your time."

While it isn't possible for spouses and partners to always clear the other "traffic" out of the area for us, once in a while would be nice. Don't you think? "Honey, there's a bubble bath waiting and your clothes are laid out on the bed."

In turn, we need to recognize the desires of our spouses and partners. We, too, need to "clear other traffic out of the area" and give our undivided attention to their feelings and needs.

# Ask The Dermatologist

The largest organ in the body bedevils many crossdressers. It sprouts forth dark hairs crying "Testosterone made me!" It over-pigments, under-pigments, itches, hurts, gives rise to blisters, crusts, papules, pustules, scales, flakes, plaques and nodules. Exposed to the sun, it withers, thins and wrinkles. Still, it is the body's first line of defense against hostile organisms and influences from the environment. With proper care, however, it will make the appearance more attractive and even more feminine. It is the purpose of this column to answer questions about this organ to make it the best possible easel on which to draw your feminine image. We are, of course, talking about your skin.

As a Board Certified Dermatologist who has been in practice since 1977, I have had experience in dealing with the vagaries of the skin. Although my special interest is AIDS Dermatology, I see all sorts of dermatological conditions. Dermatology is a most fulfilling occupation, full of variety. The practice of dermatology is indeed a high form of art.

Before embarking upon this column, I will lay down one or two basic principles. Dermatology is a visual specialty. It is absolutely impossible to diagnose a condition without seeing it. Sometimes consultation with a pathologist is necessary to make a diagnosis. Nothing I say in this column will substitute for a visit with a trained specialist. The words, "it sounds like" will probably be frequently used. Needless to say, I will not prescribe any medicines, nor I will discuss problems in any field outside dermatology. My purpose here will be to answer questions about skin care, especially as it applies to transgendered people. I'll answer questions about products or ingredients, or diseases of the skin, hair, or nails.

Staying pretty depends on having healthy skin. With that in mind, I will tackle the first question.

Dear Dermatologist:

If I don't shave my legs regularly (at least once a week) I get tiny white head pimples on my thighs. If I pop them the spots get red and take a long time to fade away. I still have a few discolored marks from the last time this happened.

Are these pimples caused by in-grown hairs? They only occur after my leg hair has grown out for several days. Then, if I don't get out the razor they start popping up. Other than regular shaving, which I don't mind in the least, is there anyway to stop these things?

Pizza Thighs.

Dear Pizza Thighs,

It sounds as if you may be having folliculitis, a superficial bacterial infection around the hair follicles. Possibly the hairs are becoming ingrown after shaving, a condition known as Pseudo-folliculitis. The trapped hair acts as a foreign body, provoking an inflammatory response. In this condition, you may actually see ingrown hairs covered by a thin layer of red, inflamed skin. You are absolutely right not to manipulate these areas! Inflammation caused by "popping" may leave blood tattooing or pigmentation that can last as long as a year. Manipulating these areas may colonize them with staph bacteria from the fingernails, and may even cause permanent scarring.

To prevent these lesions, you might try shaving with an electric razor. Since you will not shave as closely, there will be less chance for hairs to ingrow. When shaving you should avoid using any oily or greasy lotions either before or afterwards. These block the entrances to the follicles and create a stagnant pool of oil, which bacteria find most nourishing. Gently washing the skin with Dial Gold before shaving will discourage their ardor. Your dermatologist can give you a prescription for topical Erythromycin which, used once daily, should improve the problem greatly. It is not particularly expensive, nor is it a frequent cause of contact allergies.

Your statement that shaving improves these lesions gives rise to another possibility. You might check the skin on the upper outer arms to see whether the follicle mouths have a rough, scaly material in their centers. If so, you have probably got Keratosis Pilaris, a hereditary condition in which the follicle mouths are plugged with skin cells. When severe, the problem feels almost like sandpaper or goose bumps. Lac-Hydrin, a relatively inexpensive lotion prescribed by a dermatologist, will frequently work on this problem. Sometimes the dermatologist will add Sulfacet Lotion or Retin-A at bedtime. Since this is an hereditary condition, you will have to stay on these topical medications to keep a satisfactory result.

Please rest assured, Pizza Thighs, that many times I "sausage" problems in my practice. It is important to deal with them properly so that they do not "mushroom!"
