Chapter Promotion and Activities

...Your Editor has been in contact with Leslie Borck, Ph.D., the Director of the Westchester Self-Help Clearinghouse. The Clearinghouse is an organization which helps groups like ours to get organized, and most importantly, they refer inquiries from people to the right place. I wrote Dr. Borck and briefly explained the goals and objectives of TRI-ESS, and I sent some literature concerning the Society for the Second Self. I related that it is our organization's policy to refer all inquiries to our national office, and I gave her Carol's address. Also, I asked Dr. Borck to:

- 1. List our organization in the Directory of Self-Help groups which the Clearinghouse publishes, and to add that there is a Chapter in the area.
- 2. To help us find a meeting place.

Dr. Borck's reply to my letter is found on page 2 of the newsletter. (No, your Editor will not be going to the Clearinghouse Fair held on November 7th; I do not have the "spunk", plus I do not have the literature in volume to do a respectable job.) I've replied to Dr.

I'm so glad you've contacted us. I'm sorry I don't have a phone number for you so I can talk with you personally. I'm certainly looking forward to speaking with you and the Clearinghouse will help you out as much as we can.

Two things first off:

We have an information and referral service to help people locate self-help groups and also publish a <u>Directory</u> of <u>Self-Help Groups in Westchester County</u>. Please complete the enclosed questionnaire as soon as possible so we can add you to both.

More immediately, the Westchester Self-Help Clearinghouse sponsors a yearly Conference and Fair of Self-Help Groups. The morning Conference is scheduled from 9:00 am to 12:00 pm and will be limited to self-help group leaders and members. The Fair of Self-Help Groups will be held from 1:00 pm to 5:00 pm and is open to the entire Westchester community. There will be no fee for either activity.

(In the interest of economy, I've eliminated two paragraphs of Dr. Borck's letter; they concerned the Clearinghouse Fair. Ed.)

I'd like to invite you to participate in both the morning conference and afternoon Fair. I do hope you will choose to come. I will need to know immediately of your interest in either activity of the day. Please call and we can talk about how else the Clearinghouse can assist your group.

From The Kitchen Of ... Mary Jane

Beer Stew Casserole

(No pun intended; Ed.) $1 - 1\frac{1}{2}$ lb. stew meat; cut up 4-5 white potatoes 3-4 carrots; add celery (1 stalk) and/or onion if desired. 1 envelope dry onion soup mix, 1 can beer. Dredge the meat in flour, brown in fryin pan with Italian salad dressing. Grease casserole with Italian dressing. Place browned meat in casserole; place potatoes, carrots, etc., over meat. Pour beer and soup mix into the pan where the meat was browned, and stir well. Pour contents evenly over vegetables and meat. Cover, cook @ 350° for 2+ hours. (Actually, this is a recipe of my wife; the smell and taste are delightful. Serves 3-4; check for taste after cooking 2 hours. Ed.)
