New To TRI-ESS

OVERCOMING FEARS TO HELP MYSELF

"This last summer was the summer I decided to help myself. I happened to see a promo ad, 'Happily married men who dress as women...Tomorrow on the Donahue show'. My pulse quickened. Did I really hear it?

The next morning I cancelled appointments so I could watch the show. I listened to stories that were like my own. I listened to a description of a national organization of heterosexual transvestites whose purpose included helping others 'out there', who thought they were alone and didn't know where to turn.

I couldn't believe what I had heard. It sounded too good to be true. I was skeptical and a bit afraid but not so afraid that I couldn't write and ask for more information about TRI ESS. I knew in my heart that if TRI-ESS was really like it was described in the show, then I'd join, if I could find the courage.



In a few weeks I received a letter and literature from Chicago. Then a letter came from the leader of the local chapter. I also was sent a recent newsletter from the local group. Everything sounded exactly as I hoped and I knew I wanted to join.

My history as a TV was like others. I had the 'curiosity that never went away', and I tried self cures. During all my years as a TV I never told anyone my secret. I never was seen by anyone dressed, and I never had a friend to talk with about being TV. I thought that I was the only TV who liked being male, being married and having an otherwise normal life. When I read the letters from the TRI-ESS members, I knew I wanted to join, but...I was still afraid.

I was afraid of meeting new people. I was afraid of being seen in public or semi public dressed as a female. I was afraid I'd look stupid. I was afraid of group pressure. I was afraid of others finding out my secret. I was afraid I'd get stage fright and back out. In general, I was afraid of the unknown.

But what were my alternatives? If I didn't generate up the courage to go to the meeting, what would I have to look forward to, alone?

* more self-doubt and confusion;

* sneaking around being dressed by myself;

* lack of companionship; * lack of assuring friends who share my 'special interest'.

So, I decided to go the the 1st meeting in September.

The night before 'I prepared my clothes and stuff as best I could. I had directions from my GAL, and her regrets that she wouldn't bè at the first meeting. I went to sleep that night with anticipation.

The morning of the meeting I was looking for an excuse not to go. I drove to the meeting place and drove past three times. I really had the urge to forget about it and drive home. But it came down to comparing what I had to gain (friends, understanding, and self confidence), with what I had to loose if I didn't go in (more loneliness, self-doubt and self-anger).

Since I was told I didn't have to dress if I didn't feel comfortable, I really didn't have that much to fear. I decided to face down this part of my fear, and I went in.

At this point I had overcome two of my fears: 1) making initial contact and, 2) going to a meeting. My third fear was the self disclosure that comes meeting new people.

FACING THE FINAL FEARS

While I was anticipating the first TRI-ESS meeting, it came to me what I hoped the 'talk' of the meeting wouldn't be like.

I hoped the climate of the talk would not be heavily theraputic in tone. I didn't want the type of talk you expect from therapists or zealous self-help groups.



I hoped the talk wouldn't be full of strategies and ploys like some of the techniques moonies use to recruit members. And, I hoped that the group wouldn't be evaluative, snobby, or difficult to talk with. I was relieved to find that I would not be disappointed.

I found the members to be talkative. They made inquiries about my situation, but it was not the repetitive, one - way probes you might get from a non - TV. Instead, it seemed that the questions were a way to facilitate a two-way, equal exchange. In other words, any topic a Sister asked about she was ready and willing to disclose about herself. The inquiries were a way to get to know each other and let the newcommer know 'you are not alone'.

The second element of the communication climate I found to be a relief was the spontaneity of the talk. Members dialn't gang-up on you with prepared arguements or pressure. They were friendly, natural, and relaxed. It seemed that we were always talking about the male heterosexual TV and his problems rather than the general topics of all TV's. I didn't find snobbery or excessive evaluating either. The Sisters were accepting and supportive. They were easy to approach and gentle in the way they approached and began conversation.

Within a few hours the atmosphere of the group made me feel like part of the organization. I didn't feel new or ackward. It was this climate that made it easy for me to get my clothes bag in order to join them.

The moment I had feared for so long, walking out dressed in front of others, turned out to be 'no big deal'. In fact, I wanted to be dressed to feel more a part of this special group. There were no announcements, no embarassments, no, special notice. I walked out, received a compliment and congradulations from Sisters I had been talking to shortly before.

The night sped by, although I was hot, tired, and faced a long drive home, I felt great. I found an organization of men with the same pleasures and problems. As it turned out, TRI-ESS was exactly what I hoped TRI ESS would be. The fears I had for so long were gone. And that, was the greatest relief of my life.

THE REWARDS

Since that night, I've been feeling the rewards of overcoming my fears. I feel more self - confident, motivated, relaxed, and better about myself in every way. I don't feel guilty, disappointed, or mad at myself. In the last few weeks I have had a different and better perspective on things in my life. I can see the difference at work and with my family. Joining TRI-ESS was the best thing I could have done for myself.

All of these positive changes are somewhat amazing. It was only this summer, not even three months ago, that I decided to do something to help myself."

We hope that your experiences, as so - well related in this article, will encourage others who are still groping with fear and guilt, to reach out and give the Chapter and its Sisters the chance to help them! Words like Edie's are most inspirational and could make the difference for a new Sister to take that 'bold step' and reach out by joining us and coming to our meeting.)

I came across an advertisement from Lee Mardi Gras. I wrote to him and asked for two books at that time I could get their catalog...I found the brochure intriguing to say the least, besides the

books from Chevalier Put., they also had books on exotic IViam like Drag, bondage, TV teens and so forth...Since I was intrigued, I bought over a period of time some of these books. Being that this establishment is on the East Coast, their mail delivery was a little faster than from Calif... I was told about a book put out by Chavalier Pub. called the 'Birth of Barbara', and I should enjoy reading it...At that time Virginia was in the process of selling Chavalier to Carol B. and I did not know how long I would have to wait before I got this book from California, so I decided to by it from L.M.B... At the time I received this book along with other books, I was behind in reading with books I bought from the Chev. previously, so it was over a month when I got around to reading the 'Firth of Barbara'... The first thing I noticed was that some of the letters in the book were broken and thin, I was suprised for I have read othe books I bought printed from Chavalier and the letters were nice and crisp. It was obvious that this book was printed by 'xerography' and to make matters worse, pages 37, 38, 59, and 60 were missing...The person who xeroxed the book left out that sheet, and the last page was so badly blurred I could hardly read it. With disgust I threw it in my box where I keep all my books on crossdressing and promised myself not to buy any more Chevalier books from that place again and promptly forgot about it...A few weeks ago I got an advertisement from L.M.B., telling me about a get to gether he was going to have in Provincetown for the Columbus Day weekend and along with the info he had a brochure on some books he was selling. It has been a few years since I bought anything from L.M.B., so I thought I'd give him another try and buy something and mention about the poor quality of the book I bought from him previously...Now if he was anykind of a professional and on the level in selling his books, you'd expect an 'apology' for selling me this poor quality book and offer to replace it with a good one, 'right'?, 'wrong', what I got was an indignant note, returning my check for the order placed, and telling me they would not check any books that I have ordered to make sure they are in good quality. Then, he ridiculed me by calling me 'childish' for wanting them to make sure the quality of the books they sell is good. Now I'm not saying he zeroxed this book or am I saying that Chevalier Pub. did. What I am saying is when he puts his name on the back of this book, and received money for it, I think that it is his responsibility to make sure what he sells is in good quality...So I am criting this to warn our Sisters in our Chapter; and when Carol B. reads this in our newsletter, I hope that she will print it in the FEMME MIRROR so all our Sisters, national and international, will beware of what kind of practices this L.M.B. does, and avoid it if you can... Crossdressing and the Law ******************************

Part 4

(Ed. Note: this is a continuing presentation of our June meeting when Mr. Chris Hansen, Esq., of the American Civil Liberties Union, visited us to discuss this topic. "Q"=question, "A"= answer, "C"=comment.)

"(C). I must say that I agree with you that if you are stopped while out (by the police when dressed), to tell the truth and not try to decieve them.

(C) Someone raised an issue on the phone with me about a child custody issue. (Q) Yes, that was in Bergen County, New Jersey. (A) That doesn't matter what state you are in because the custody laws are basically the same all over. (C) That person is not here tonight, I'm sorry she isn't. (A) Well, I'll tell you the answer anyway. The standard for deciding who has custody of the child is what is in the best interest of the child. So, what is going to happen is that the judge is going to toss everything possible fact he can into the 'pot', and if it ultimately is decided by the judge, he is going to consider all the relevant factors. Therefore, if the issue actually goes before a judge and there is a custody fight, I would strongly recommend a good deal of education of the judge if the issue (crossdressing), is going to arise. With a degree of education, I don't think that it is an think that it is an incurmountable problem. l've never seen a case in point, but it has come up a



lot lately in the gay rights context and gays are generally starting to win these, especially in the last 5 years, getting judges to hold that fact, alone (being gay), is insufficient to justify custody denials. So, I would be reasonably optimistic in a child custody context. (C) She has two children, and the oldest daughter 'knows' and the son doesn't 'know'. It has also been brought up in court because the wife has been trying to get the children. (A) Its still true that wives generally win custody issues. It is less true than what it used to be, particulary the younger the kid the better. I think that visitation cases are winable, even if she (the Sister), is denied visitation rights. If she wants to put herself through the agony of taking it further, you have to start with that as a premise, I think that if you fought it further, that there would be a very good chance of getting somewhere. Never a guaranty, I can't give that. (C) The children would rather be with the father than the mother.

(C) Ok, let me go into another area. I'm driving home in New Jersey and the tail light is out and a cop pulls me over. How would you advise me in dealing with a state trooper or a local cop? Things to say, things not to say, speciffically.

(A) I don't think there is a guaranteed way to handle that. I would try to handle it, as normally as possible and hope that the cop says, 'fix your light, lady, and goodbye'. If there is an additional problem he wants to talk about, then I would be honest about what the problem is. If the cop says, 'let me see your driver's license', I wouldn't hand him up a phony driver's license. That, by the way, is an additional crime.
