Can We Talk?

Christmas really brings the crossdressers out of the closet. It is the one time of the year when they can shop to their heart's content feeling safe in the belief that the store clerk really believes those size 12 shoes are for the wife. As a result, I have been getting a lot of new calls on the hot line. Many of these calls won't flower and bloom for a number of months yet but at least they have taken the first step.

February 2nd was National Crossdresser Day. It is reported that the "Official Crossdresser" spent the entire day getting ready for the "Official Trip to the Bar". She ventured out of her darkly lit closet at about 7:30 pm dressed in her "Official SPRING Outfit". Fortunately, the head lights of a large truck, passing by, caused her to see her "Official Shadow" and she ran back into the closet. It looks like we will be having 6 more weeks of long sleeves and leather skirts. Hurray for the truck!

On January 26th I was on WHIO radio 1290 AM, in Dayton, from 9:00 am until 11:00 am and on WHIO TV 7 from 9:30 am until 10:00 am The show went very well although I did have the most number of negative calls I've ever had.

One of the more puzzling thoughts to come out of the show was the number of people who believe I should seek counseling. When I told them I had eight years of it and that my doctors support me in my current direction, they say I should seek more counseling or be locked up. Why do so many people believe that counseling provides only one answer to every question? They say I should see a counselor but they do not accept what the counselors say. I guess the counselors are sick and should seek counseling also.

On February 9th I will be speaking at Miami University in Middletown. The professor said they had been trying to get someone to talk about crossdressing for several months.

The talk at the Suicide Prevention Center in Dayton was videotaped and as soon as I receive my copy it will be made available to members of Cross-Port. I felt it went very well. My thanks to Annette Scarazzo for inviting me to speak.

The other day I received a call from one of our TS's. She had gone to Thriftway to get her prescription for hormones refilled. The druggist on duty refused to fill it on the moral grounds that it is wrong to give female hormones to a man and questioned her about this matter in front of other customers. He said he would transfer the prescription wherever she wanted She refused. The acting store manager said he could not do anything about it.

The following day I talked with the assistant store manager and the TS talked with the main office of Thriftway. They apologized to her and told her they wanted her business. They said they would speak with the druggist who was paid by them and that they would give her a discount on future prescriptions. When she returned to the store the druggist apologized I, for one, am happy that she was willing to stand her ground and not allow one druggist to dictate his moral judgement upon her. I am also happy for the way in which the Thriftway management handled the situation. I wonder however, how they would handle the situation if they were paying her salary instead of taking it.

I won't be at the February meeting (it's the first I've ever missed in 3 1/2 years) and doubt I'll have a column in March but I hope to see you all soon.

Here are two places in Hamilton, Ohio where I have shopped which may be of interest to those of you who live in the area.

The first is Susie's Wigs at 319 High Street. It is a brand new shop run by a Korean gentleman. Their wigs come in a variety of styles and colors. They also have jewelry, make up, silk scarfs, belts, purses and a few other things all for women I have been there twice so far and both times they were very kind and helpful. To me their prices were very reasonable, and because I went in when they were just opening, they threw in some extra "baubles" at no extra charge

The other place is the Valley Thrift Store in the Hamilton Plaza shopping center. Cash Only !!! It is a used goods store with a lot of very nice clothes from childrens sizes to adults. Their clothes for women come in a lot of different styles and include prom, wedding or evening gowns, sweaters, skirts, dresses and pajamas and nightgowns. They also have coats, including fur coats. Also in stock are bras, girdles, panties, slips, lots of shoes and even some perfume and purses.

Their prices are really cheap Most of the clothes run from 90 cents to 4 or 5 dollars. Coats, however, can go as high as 40 dollars depending on what kind it is. Check all of the clothes before you buy to make sure they are not ripped or stained and also that it will fit. Once you buy it there is no returning it. Most of the clothes are quite nice though and I have bought a lot of my clothes there. Happy shopping!

Women's clothing has so many sizes that I never cease to be amazed. Just when I think I have them down, I run across a size I didn't expect, like a 24.5 in Stuarts which never has anything bigger than a 14. There is a lot of overlap in the bust, waist and hip measurements, particularly in between the Misses and Womens sizes. Look at the measurement called back length. This is the distance from the base of the neck to the center of the waist. That is where the real difference is.

That is a question which bothers all of us. Since what we do is not the accepted norm in society, we all run some kind of risk whenever we leave the sanctity of our homes (of course the Supreme Court has ruled there are some kinds of behavior the State can ban even if it is within the privacy of the home). In the end we must rely upon the kindness of the people we meet while in public. This is what actually determines if we "pass" or not.

As far as the legalities involved, please read the next article. It should answer most of your questions. -- Eds.

Dealing with the Police

It is not against the law to crossdress in any jurisdiction I am aware of in southwestern Ohio. There is an ordinance against it in Covington, Ky. I checked with a police officer I know and he gave me this information.

The best way not to get into trouble 1s to avoid it (sounds like a policeman doesn't it). Obey the traffic laws, don't speed, don't try to beat yellow lights, stop a full three seconds at stop signs and above all-- don't drive intoxicated.

If you do get pulled over, you must surrender your driver's license. Driving is a privilege granted by the State, not a right. You are required to give your date of birth and in some jurisdictions, your social security number In any situation where a police officer has reasonable suspicion, and you are asked to provide identification, you must do so.

Do not argue, raise your voice or threaten an officer. If he does not approve of your lifestyle, the easiest way for him to cause trouble for you is to arrest you for disturbing the peace and/or resisting arrest.

If you are being written a citation, many forms include your place of employment. You are not required to give this information, it is there to help the police locate you if they feel it is necessary You may answer this question selfemployed, or unemployed. Be aware that if you have gotten a previous traffic ticket while not dressed, and your place of employment was on that ticket, it is now public knowledge which the police in the jurisdiction the ticket was issued have access.

It is against the law in both Oh10 and Kentucky to enter a bathroom marked for the opposite sex This can be extended to dressing rooms if your presence 1s undesired. Again, disturbing the peace is cause enough for an unsympathetic officer to arrest you

Finally, avoid places where prositutes hang out. Most police officers assume that a man dressed as a woman in that kind of situation is there for only one reason -- and they will hassle you.

A side note on Covington's ordinance. The officer I spoke to is familiar with several Covington officers. He said that ordinance is in place to give Covington an added punch against she-male prositutes to get them off the streets (if they can find no other excuse to do so) and also to prevent men from dancing in the girlie bars as women (kind of a consumer protection against misrepresentation). I was told that chance of being arrested simply for driving through Covington while dressed is almost zero, even if you are dressed while stopped for a drivingviolation.

Transsexuals Issues: The Medical Profession by Heather Peerson

About a year ago I had a day which was filled with appointments. I dressed as Heather, which I was not doing full time then, and started

off to the first which was my dentist. They had never seen me as Heather. When I registered I signed under my male name then put Heather behind it. The receptionist checked the book and said "Heather please come with me." The dentist was off that day, but the receptionists and hygienist in the office treated with respect all the time I was there. He has since retired and I now see another dentist who's office personnel also treated me the same way.

From there I went to see the person who was my hair dresser at that time. He knew about my dressing but had never seen me that way. While he admitted is was a little hard to get used to he said he had no problem with it.

Later that day I had to go to a neurologist. This guy charges \$150 for the first visit He had a staff of about 6 nurses and two receptionists. From the moment I walked in I received stares and snickers. While I sat in the waiting room each nurse slowly walked by and looked. When I saw the doctor he asked me some questions and admitted that he had never treated or met a transsexual before.

Why do I bring all of this up now? It has occurred to me that one of the worst enemies of the transsexual is some of the medical professionals. These are people who, even though they may not had dealt with a TS before, should be trained to treat any type of patient with respect. Yet many of them do not. Their attitude is reflected in a large percentage of the medical profession

Some months ago, Larry King had a show about female to male transsexuals. One of his guest was a doctor from New York who is also a lawyer. He is trying to get all transsexual surgery stopped on the grounds that it is dangerous, elective and is not a cure for a psychological illness.

In a New York court case in which a male to female TS filed a petition to get a birth certificate changed so that she could get a marriage license, the board of health asked the New York Academy Of Medicine to make a recommendation. Their finding was:

1. Male to female transsexuals are still chromosomally males while ostensibly female;

2. It is questionable whether laws and records such as the birth certificate should be changed and thereby used as a means to help psychologically ill persons in their social adaption.

With this type of attitude still so prevalent in

the medical community is it any wonder that the congress and courts are reluctant to grant us our rights or that we may be treated poorly by persons who call themselves medical professionals?

I recently had a conversation with a friend who works in one of the mental health clinics here. She told me that while they do have a policy about treating gay and lesbian clients with respect and dignity they do not have such a policy for gay and lesbian staff and employees, therefore many of the gays and lesbians who work there are afraid to come out of the closet. I question how anyone can help people have dignity and pride about themselves when they are also placed in a position which strips them of their own dignity and pride. I also would question the ability of the clinic to help me deal with my problems when they seem willing to ignore their own problems.

There are a lot of medical professionals who truly are caring and willing to work with us and treat us with the dignity we deserve. Seek them out. Do not allow yourself to be treated with anything less than respect when dealing with doctors and nurses and refuse to pay any bills incured from a doctor's office where they have not treated you with respect. It is the only course of action we can take.

In the Greater Cincinnati area, ethical complaints against physicians can be addressed by calling the Academy of Medecine Executive Board at 421-7010. In addition to this, you can follow up by calling the state licensing board for physicians. --Eds.

The Washington D.C. Court of Appeals has ruled that a man waving at cars in a high-prostitution neighborhood could not be convicted of soliciting. In a 2-to-1 decision, the court also ruled that the fact the defendant was wearing a matching black jacket, mini-skirt, leotards and a wig was "immaterial." Being in "the "wrong' place, wearing the 'wrong' clothes and acting in a manner which might be consistent with a desire to engage in a sexual activity cannot form the basis for conviction for solicitation," the judges' opinion said.
