# RUPERT GRUMBLES



Rupert, Editor "Grouch", grumbles and gripes

Sorry for the delay in getting this and the last issue out to you, folks, but there isn't a hell of a lot of incentive when 1'm bustin' my huns (without pay - overworked and underpaid) for a mere 43 paying customers (33 renewals and 10 new members/subscribers) and another 40 "comps" (21 Professional Consultants - only 3 of which paid their dues this time around, 4 additional professionals, and 15 peer-support group leaders/newsletter editors who exchange subscriptions with us). If I were to claim payment for all the other telephone calls made to members, subscribers, professional consultants, peer-support group leaders/newsletter editors/counsellors, etc., MMRF would probably be

"in the red" now or bankrupt).

More grumbling...The atten-dance at the Annual General Meeting was disappointing, to say the least (only 17 people showed up - just about half the number expected, and two of the scheduled guest speakers cancelled at a late date although one of these was not firm, nor was the third). Do you know that I was up till 2 a.m. both nights before the meeting, preparing the Financial Statement, the Executive Director's Report and the Chairman's Address? And, do you know that both of my promised rides to the AGM didn't show up and I had to take public transportation to get there and back? # ANNUAL GENERAL MEETING

The third Annual General Meeting of the Metamorphosis Medical Research Foundation, Inc. was held at the Bond Place Hotel in Toronto on Sat., April 26, from 2 to 8 p.m.

Seventeen of an expected 25-35 members and guests attended, including 5 couples, 3 F-Ms (two of whose mates didn't attend), 2 M-Fs and 2 non-TS guest speakers from: Ohio, Pennsylvania, Hamilton, Kingston area, Ottawa and Toronto.

Speakers included: MMRF Executive Director Rupert Raj, Board member Dr. Lenard M. Hughes (who spoke about his future plans to perform phalloplasty), Board member (and FACT Executive Director) Susan C. Executive Director Rupert Raj also sent greeting cards on behalf of membership and reported special event in Feb. newsletter.

# F-M SEX REASSIGNMENT SURGERY IN SINGAPORE

We do not have any published data on female-to-male transsexuala in Singapore although we have been carrying out surgical procedures on them for sometime. However, I will try to give you a descriptive account of what we do and how succeasful we have bsen.

Like every other centre in the world, we are very stringent in screening patients who come to us for reassignment procedures. They go through the full psychiatric end psychologocial assessment and once they are certified as transsexuals of stable mind who would benefit from a reassignment procedure, we would start them on hormone therapy until they come in for surgery. In the case of female-tomale transsexuals, the waiting time can range from weeks to months.

As you probably know, the female to-mele reassignment involves a number of procedures. We undertake Stage 1, Stage 2, and Stage, 3, that is, bilateral mastectomy, total hysterectomy, bilateral salpingo-oophorectomy, and the raising of e penile pedicle in one sitting. In all our reassignment procedures, we are acutely conscious of the problem of identity, pay more attention to gender than sex, and therefore, try very hard to minin-ize scars that would remind or help others identify the past gender of the individual. For this reason, we carry out the bilateral mastectomy either through a circum areola incision or a trans-areola trane nipple incision and then perform the subcutaneous mastectomy. This then does not leave a scar across the breasts on either side and we feel that the individuals find it so much better than the traditional scar used for mastectomy.

As for the penile pedicle, we started using flaps from the thigh

gracilis muscle, but found this unsatisfactory because most times one went through cicatrisation (ie. healing by scar formation). We then went on to use tube pedicles from the iliac fossae (ie. the con-cavities of the iliac bones of the pelvis) and this, again, was not terribly satisfactory and we have now settled for a midline sub-umbilical tube pedicle, the base of which sits on the position of the normal flaccid penis. We then undermine the skin and subcutaneous fat on either side, going right back. We open the abdomen through a midline inclaion through the rectus and peritoneum (ie. the sercus membrane lining the abdominal cavi-ty), perform a total hysterectomy, bilateral salpingo-cophorectomy, and having closed the rectus, we then pull the lateral skin edges across to the midline and suture them together bensath the flap of skin that we had raised to form a penile pedicle. We then bring the edges of the flap together, thus forming a tube pedicle. It resembles a handle on the abdominal wall. About three months later, we detach the upper end of the tube pedicle, which falls and resembles a flaccid penis. This stage can be done under local anaesthesia to save cost to the patient.

The fourth stage involves the inaertion of a medico-silastic proathesis into the pedicle. It gives stiffness to the pedicle making it appear as a permanently erect penis but it is flexible at the base so that one can strap the penia against the abdominal wall and wear tight underwear so as not to cause social embarrassment. We also mobilize the clitoris upwards and bury it within the base of the pedicle to give the person erotic sensetion with the thrusting movement during coitus. The next stage involves the cloaure of the vagina and, if the patient desires, the insertion of a testicular prosthesis.

Our attempts so far to creat a penile urethra (ie. a canal for the discharge of urine) has not been terribly successful. We had tried to use the vaginal spithelium (is. the tissue lining the vagina) to create the urethra and the furthest that we have got to is for the meatua urinarius (is. the external opening of the urethra) to open at about 3 centimetres from the base of the penis. We have just imported medico-silastic urethral tubes from France and we hope that we will be able to use this to create a penile urethra. I hope you find this explanation useful.

I must remind you that I am not a plastic surgeon although I was originally trained as a general surgeon with special interest in plastic surgery. I am a gynaecologist and I will be quite happy to serve on an advisory depacity to your organization.

# REDGRAVE ROLE: Man-To-Woman

Vanessa Redgrave will star both as a man and a woman in Linda Yellen's Lorimar-CBS production of "Second Serve", based on the true story of Dr. Renee Richards, the leading eye surgeon and tennis player who underwent male-to-female sex reassignment. Filming of the TV-movie began January 1986.

Yellen originally toyed with the ldea of having the dual roles played by Peter and Jane Fonda. "I'm not at all sure a woman should play this role, but if one does, I think it should be me," said Redgrave.

"Vanessa makes a very handsome man," said Yellen. "She's fooled a lot of people on the set during tests. As you know, men have played women on the screen several times. But for a woman to play a man in a serious work and get away with it, that's something challenging. Forgetting about 'Yentl', which was a different sort of story, I can't think when it has been done. You'd probably have to go back to he London stege, years ago, when Serah Bernhardt pleyed 'Hamlet'. But here we were asking an actress to attempt it using this intimate medium that shows everything."

Redgrave has never met Richards, but she, Yellen, and others attended a transaexual group meeting in Santa Monica. "What's interesting," Yellen said, "is that women to men have a much easier transition than men to women. From often being treated like second-class citizens, women suddenly become first-class. Men have an enormous psychological adjustment tomake when they become women. There are aspects of being a woman that men cannot possibly imagine."

#### ABSTRACT

GENDER IDENTITY AND INTERNALIZED OBJECT RELATIONS: A Comparison Of Female-To-Male Transsexuals, Lesbians And Heterosexual Women

The present study explored the complex interaction of the three components of gender identity, 1) core gender identity, 2) sex roles and 3) sexual orientation, by comparing matched samples of femaleto-male transsexuals, lesbian and heterosexual women. The primary hypotheses of this study were: 1) transsexuals would be more identified with their fathers than either the lesbians or heterosexuals. and 2) transsexuals would show evidence of more primitive internalized object relations. It was also hypothesized that transsexuals would be male in gender and more masculine in their sex roles than the lesbian and heterosexual women. Instruments used were the Block Qsort, the Bem Sex Role Inventory, the Object Relations Technique, the Derogatis Symptom Check List and a Demographic questionnaire.

The subjects were 10 transsexuals, all of whom had lived in the male gender at least one year, 10 lesbian and 10 heterosexual women, the majority of whom resided in the San Francisco Bay area.

Contrary to expectations, the transsexuals were no more identified with their fathers than were the other groups, nor were they or any other group more identified with either parent. Similarly, transsexuals showed no more evidence of primitive internalized object relations than did the other groups. As was anticipated, the transsexuuals were male in core gender, while the leshians and heterosexuals were female. Transsexuals also tended toward more masculine sex roles than did their counterparts....

However, they showed evidence of similar levels of feminine sex roles, as did the heterosexuals. The lesbians were somewhat lower in measure of feminine sex roles than either other group. No differences were found on the psychopathology screening device, the Derogatis Symptom Check List.

It was concluded that core gender identity is an intrinsic part of identity and does not appaar to be related to identification with the parent of the same gender or internalized object relations. Rather, it was suggested that etiology may be due to complex factors involving multiple features.

#### BOOK REVIEW: INFORMATION FOR THE FEMALE-TO-MALE CROSSDRESSER AND TRANSSEXUAL by Louis G. Sullivan, 48 pages, \$6.00 Order: L. Sullivan, 1827 Haight Street #164, San Francisco, California 94117

Transsexuals have been viewed by society, over the years, as some sort of freaks - or as people in some kind of weird limbo between freakishness and homosexuality. Until recently, almost nobody took them seriously. Virtually all of the attention was given to "men who felt they were women trapped in male bodies", When female-tomale transsexuals came out in the open, the world was forced to take a closer look at the phenomenon of transsexuality. Some medical and mental health professionals began to realize that, if the condition was not confined to generic males wishing to become females, it must be something more than a few "drag queena" who were seeking attention. In point of fact, female-to-male transsexuals who openly declared themselves as such, provided more credibility to the feelings maleto-female transsexuals expressed about themselves.

Although the number of femaleto-male transsexuals who come forward each year is nearly equal to the number of male-to-female transsexuals declaring themselves, the literature and body of knowledge is heavily weighted toward the male-to-female phenomenon. L. Sullivan now presents us with a very important, informative, helpful, and unusual survery of female-tomale transsexuality. The book also contains much information which could be of help to loved ones and others trying to understand the condition.

Admittedly, the book is short (a sigh of relief can be heard by book reviewers who have to wade through so many ponderous tomes), tut it is comprehensive and covers much ground. Not only does Sullivan examine the biological and medical aspects of transsexualism in detail, but he also comments extensively on the psychological aspects and feelings female-to-male transsexuals experience. Further, he discusses the attitudes society has toward the phenomenon currently, and presents a dramatic phototext overview of female-to-male transsexualism from a historical perspective.

One example of the distance in knowledge that lies between women who want to become men, and men who want to become women is reflected in the attitudes of most surgeons. Almost all surgeons who perform genital surgery routinely operate on male-to-female transsexuals who have lesbian orientations in new roles. Surgeons who operate on female-to-male patients, however, adamantly refuse to operate on patients who indicate they identify as gay males. One has to wonder how such arbitrary and illogical lines are drawn in the minds of these surgical practilioners.

INFOR MATION FOR THE FEMALE-TO-MALE has numerous photographs and sketches of women who have lived as men earlier in this century, and centuries past, which are fascinating; particularly so when one reads the stories behind them. All of this and more. Not bad for a forty-eight-page book.

Mr. Sullivan has provided a valuable educational tool on the subject of female-to-male transsexuality. He is to be commended for presenting such a worthwhile and interesting look at this intriguing subject.

Trying to begin to integrate into the male world wothout any help or knowing how to get such help without being found out, and fears of being called "perverted" or "crazy" and being rejected or cast out scared me. So, I chose to become a "house case" (if I wasn't at work, I would be at home).

Liviag in a touriat town wasn't essy as there was always something goiag on, and avoiding the constant outings was rough and the excuses were getting old. The winter months were like a breath of fresh air as the activities dropped off and I could escape to the deserted beaches along the Gulf Coast for long, solitary walks.

Here, I could walk and think things through like I never could before. A peace was present that I couldn't begin to explain. You'd have to experience it to really understand what I'm talking about. The beaches were my escape and soon became a weekly relaxation routine and still are today. Sometimes, if only for a few minutes, or in really bad weather, I will park the car in silence and again experience a oneness of mind and body.

Two years ago, I finally had gender-reassignment surgery, and now I needn't say "No" anymore unless I really want to. Don't get me wrong, it's very hard for me to say "Yes" and go out with my wife and have a good time. But, for the first time in my life, I try to make an effort to have a good time. To be totally honest, I had forgotten exactly how to have a good time - I've been so serious for so long. However, I'm now slowly learning the ins and outs of this social endeavour and it isn't easy. But, then again, staying out of circulation so long, all wrapped up in myself, wasn't "a piece of cake" either.

All in all, I've learned a lot about me and <u>why</u> I am, and why I have done and still do a lot of the things I do. The sensitivity I've always been ashamed of while growing up no longer bothers me as I've learned that it's more of a blessing than a curse. And today, in a new job with a futre, it has come in very handy as I work with some very special clients and this gift of being in touch with myself has proved very rewerding - sharing the tears and the laughter along the way.

The social hurdle that I've just about licked, for the first time in my life, has taken me about 15 years and yet, I have made it.

Inside, I still hurt like hell and keep in a lot of emotions I find hard to share with anyone even my wife. But, there's always a way. Don't give up. Set your goals and go for it! Thia is what life's all about after all is said and done - getting from one place in time to another the best way we can. Learn to understand and like yourself. You can do it - I have faith in you.

I walk the beaches and go fishing during a 97-hour work-week divide between two jobs that has me out of town two nights a week. Othera I know hook ruga, knit, jog or lift weights, garden and do woodworking. The idea is to pursue a hobby or activity you enjoy, and make time to do this on a routine baais. Once into your chosen venture, you'll find that mentally you can relax, and slowly, this can break up a lot of pent-up anger and hostility, and even help you to formulate decisions for living.

I don't have the answers. I just know that if I didn't change some of the habits I've developed over the years, in my endeavours to hide and pass unnoticed, I would surely have gone crazy or ended a very sad and confused life. Life is rough, and when you make a change such as a gender-change, it takes a lot of patience and mental and emotional stability, but, most important for me, it took people. I lost some of my best friends over my decision to change, but, for each one I lost, I feel I have gained three in return, and these new friends are true friends who know and understand me. 1 also have a world of friends, on and off the job, who don't know of my female past and I'm very close to these people.

Change is good, my friends, and I feel I've made it. So, I'll end this now and let you meditate and absorb what I've tried to relate. Hang in there...

As a matter of fact, I wrote a paper "Gender Dysphorie as a Social Disease" nearly a year ago and have not published it yet. I took it to Guelph (Ontario) to bounce off a class of seniors, but did not use it as there were too many questions.

#### Gentlemen:

Thank you for the information you have forwarded to the Ontario Human Rigbts Commission.

As you are aware, sexual orientation is not a prohibited ground of discrimination under the current Human Rights Code. However, complaints have been taken in the past from transsexuale who believe they have been discriminated against because of their sex. In this instance, if a Female-to-Male transsexual believed he was denied a right under the <u>Code</u> because of his sex conversion, a complaint might be taken for investigation. Of course, each situation would require a more detailed discussion of the facts before proceeding.

#### Dear "Anonymous":

I was overjoyed to read your letter to Rupert regarding your identity as a gay man. I have been searching so long for others like myself. I, too, am a F-M gay man, and have lived as such for the past 13 years (Igraduated from high school the year of the Stonewall Riots). Back in those days, I was too honest with some gender programs and I've been informed that, while their clinics do not question at all a M-F who wishea to be a lesbian, a F-M who wants to be a gay man is unheard of and no doctor wants to be the first to operate on one, elthough there are no sexual preference requirements in the Harry Benjamin International Gender Dysphoria Association Standards of Care. Fortunately, I have located doctors on my own and I'm enjoying life tremendously!

My advice to you, "Anonymous", is to always over-emphasize those few sexual encounters you have had with females to the doctors and admit to, but don't stress, your sexual encounters with other men. They'll be able to handle your bisexuality easier than your total homosexuality. You would do all of us guys a favor by letting the doctors know that we are, afterall, intereated in the male sex. You should have no problem getting doctors on your own though, especially since you've been living as a male without bormones (good for you!). It's better than having to follow the regime of a program.

And thank you, Rupert, for telling us you know of at least six gay F-M men.\*
