


Meet the Candidates

Chet Cagle, aka Chet Emperor Candidate

Being elected Emperor of the Imperial Court of New York would be an honor and obligation that, as your representative, I would uphold with dedication, dignity and pride. In 1991, I became involved with the Court when my lover, Sal Galano, was elected Empress VI Saleen. During those first few years, I became very involved with both New York and out-of-town events.

The Board of Directors made me an honorary member in 1994 after Saleen's death because I wanted to continue my involvement with the Court, but due to personal health reasons was unable to attend many events. In early 1997, I returned to a full involvement with Court activities.

I bring many years of fundraising experience within the Court as well as community related fundraising. I am active, dependable, loyal, organized, visible, and always willing to help. For the past two years, I have been very involved with Court activities. Now, it is time to use my talents in the capacity as your Emperor.

As Emperor, I will continue to dedicate myself to the work of the ICNY and the International Court System. I want to be your representative, a representative that you can be proud of, a representative living with AIDS for ten years, who is ready to reign as Emperor and achieve enormous accomplishments.

Second, recognizing that though we are so strong, because of our drag, transgender, transsexual, and lesbian community, we must find roles for men in the Court. Beside being escorts for beautiful royalty, our talents as performers, fundraisers, and leaders must be recognized and utilized.

Third, a strong liaison with the leather community that has expressed its profound interest in becoming involved in our events; as we should be involved in their events.

Fourth, the Court should involve itself with more joint fundraisers for national events and organizations.

Fifth, I will work diligently to have sponsors of the Night of A Thousand Gowns where large donations are sought in exchange for journal advertising and tables at the ball. As an organization, we can raise so much more money for our beneficiaries. Some targeted sponsors could include pharmaceutical companies, doctors, philanthropists, and club promoters.

Sixth, I propose that members who perform at various fundraisers not be required to pay the admission price.

My final goal is for 1,000 tickets (gold and silver) to be sold for the ball in the year 2000.


Besides increasing the attendance at the ball, many cost cutting measures must be considered, in order to give a larger donation to our beneficiaries. For example, elimination of the Viennese Buffet would save around \$10,000. Reducing silver ticket prices would make our ball more financially feasible to a larger segment of our community, while increasing profits. These and other cost cutting measures should be investigated.





These are truly exciting times. However, with newfound recognition and success, there are new challenges. I invite everyone one to you to join hands as we venture towards






Thom Hansen, aka Panzi Candidate for Board Member


Damien Ross Candidate for Board Member

Robert Sorrell, aka Swana Swarovski



first century. My record of attending both general membership and Board meetings since joining the Court show that I have a true commitment to this organization.


