THE TV'S WIFE

I was given a paper some months ago by the wife of one of our members titled "Women Married to Transvestites: Problems and Adjustments". It was written in 1986 by "Thomas Weinberg and Vern Bullough". Each month since, I have wanted to write something about that report but both time and space have prohibited it. Well, here is the space, and now is the time.

It is a research paper involving about 70 wives of transvestites. The ranges of age, length of marriage and the degree of crossdressing vary greatly among those who have participated in the study, however, some common facts seem to come out.

To me, the first and most important fact is that the longer into the marriage that the wife found out about the husbands crossdressing, the harder and less likely she was to

accept it. Wives who found out later well into the marriage generally felt betrayed, deceived, and a degree of quilt.

When then is the best time to tell a wife? The most obvious answer to me is, before she is your wife. Entering a marriage and staying in it is difficult enough without entering with this kind of secret hidden from the other. Unfortunately, most men don't find this out, don't realize the importance of their crossdressing, or are not willing to risk losing the woman they love for it until their second or third marriage. Even so, telling before the marriage and her acceptance does not guaranty a happy long lasting marriage. It only makes one less obstacle the couple will have to face and over come later in life.

What about those who are already married and their wives don't know? How and when can/should they be told? In the end only you can make that decision. I can only share my feeling about it.

First, should she be told? I believe each person in a marriage has the right of full disclosure. I have often heard "What she don't know, won't hurt me". That simply is not so. A secret of this magnitude kept from some one so close can become the corner stone of a communications barrier. Not only can it build resentment in the person unable to share an important part of themselves, but it can breed the feeling that as long as I am keeping one secret what's one more. Soon there can be more secrets kept than there are things shared. Secrets, can be like parking ticket, the longer they are kept, the greater the penalty.

Second, how do I tell her? If you already have lines of communications built in your marriage the "How" part will be easier. I suggest the first step is preparation. Get books and other information, especially articles and letters from other wives of crossdressers. Read them yourself and have them ready should the occasion arise. Don't slant the information by getting only totally positive views. A person is more likely to identify with a letter in which the person writing speaks of problems to which the reader can relate. Your wife is more likely to feel that the woman who wrote the letter actually experienced the same thing she did. Second, look for opportunities. Watch for radio and television shows, and newspaper and magazine articles that talk about the problem. Use this chance to state your feeling that you don't see why these people should not be permitted to do what they do. LISTEN to her reaction to the show and to your comments. Get a feel for where she is and what you might be up against.

Have a picture in which you look your best, ready. This will allow you to present yourself without worry about how well you did your make-up and without breaking the conversation. It also affords her the ability to continue to talk to you without seeing you dressed should she find it more than she can handle. Under no means should you rush in and dress just to show her or suddenly surprise her by being dressed when she comes home.

Lastly, have another crossdresser and his supportive wife on call. There are a number of places that you can line up this kind of support and be ready to have them help out. This is a good idea even if you don't plan to tell your wife. She still could find out at any time.

Only you can determine the right time, but being prepared can help make a difference in her final acceptance. In the cases studied only 3% of the wives were given literature to read before they were told. It is not surprising that the most common reactions were confusion, surprise and shock.

Next month I'll take a look at some of the other findings of this study.

CAN WE TALK!

The month has only just begun and already it has been a full one. I received a call from a very good friend on Wednesday September 30, telling me that one of the local radio talk show host had requested that if any TV's were listening they should call in. I called and talked to the program director who said they would call me back. He called back within two hours and asked if I would be a guest on the show the following day from 4:00 until 5:45 p.m. I agreed.

I must admit that I had never listened to the show since I don't listen to talk shows as a rule. When I mentioned the appearance to my wife and a couple of other friends they said I might be in for a very rough time. It seems the two people that do the show are known for their attacking of guest that they disagree with. A friend, Kim, offered to go along and give me support.

We arrived at the station about 10 minutes before 4:00 and to my surprise we did not meet with any one before I went on the air. While the news was on at 4:00 they took us to the broadcast booth where we met Jim and Baily, the male and female hosts of the show.

They seemed pleasantly surprised at meeting me and made several nice comments about the somewhat "Prepie" outfit I was wearing. I had decided to wear a denim skirt, white blouse, a pink and white sweater, and gray boots. One of the staff remarked later, that when she heard I was coming dressed she had expected me to show up in lingerie.

The comment was made on the air that I looked like the average, ordinary woman. I took that as a complement. It was a call in show and the male host stumbled around for words when asked if he would go out with me if he weren't married, by one of the callers. I bailed him out by stating that I would not be interested I him anyway.

When Jim, finally asked the "All Important" which bathroom question, I told him I had bet someone \$5 that the question would come up and \$10 that he would ask it.

By the time the show was over, fifteen minutes longer than they had originally stated, they seemed genuinely impressed with me as a guest and my ability to have a sense of humor about what I was doing. They asked if I would be willing to return sometime. Naturally, I said any time.

The second thing that occurred was a request from a friend, that I do computer work for, to consider working part time on a more regular basis. Since the first of the year I have only had to do a about 10 hours of work for him. He needs someone to work a couple of nights a week.

He knows about Heather, so I told him I was interested but that for me to give up that much of my own time I would need to be able to work my way, as Heather. I explained that I would not be hurt or have a problem with his saying that he could not handle that. I understood, it is his business and he must look out for his interest. He said he did not have a problem with it. How I worked was my business. So Heather finds she now has a part time job, and so do I.

That brings me to my next comment. Working the new job will require even more of the time I have been spending for Cross-Port. I have stated that I will not be able to continue with my same level of involvement after the first of the year. To date, no one person or group of persons has expressed an interest in taking over. When the group began two and a half years ago. A steering committee was formed to set the group in a growing direction. The committee consisted of a Chairwoman (me), a secretary, a treasurer, and a vise chairwoman in charge of membership. Though I am the only original person still with the group and on the committee, the committee survives.

One year under a steering committee is a long time for a group, mush less, two and a half years. The group is established. We have a sizable treasury for a small group and about 40 paid members. It is time to decide whether we are a group or not. We should have by-laws, election of officers and the paid membership getting involved. Support is a two way street and those who choose to come only when it is convenient, when they feel like it or fail to get involved can not offer much support. Supporting others means thinking of others, not just yourself.

I have been told, time and time again, "I just don't have the kind of time you do." I didn't have the time either. I cared about you, so I MADE time. If you care about others you'll MAKE time. We set up meetings to be at the same time, and the same place every month for a reason, so you can plan around it.

We set up low cost due and meeting fees yet some people can not find \$2.50 a month for the support they claim they need and must have. Yet they spend money for drinks at the meeting and on clothes and doctors and other things that must be more important.

Everyone of us, at some time in our lives, has hoped, and prayed, just to meet some one else who crossdressed. I find it hard to imagine going back to those days, but we may be very near that. Yes, we are all different. Yes, we each have different needs. Yes, none of us receives from a support group everything we need. But, each of us has gotten something and more than that, we each have a lot to give.

If you truly wish to experience the femininity that each of you claims to have, try looking past the clothes, past the wig and past the make-up to your heart. Remember all those women, yet to me, who are hoping and praying to meet some one just like you. Will you be there, as some one was for you, or will you simply say "Let the other person do it. I don't have the time."?

When January 21st, 1988 comes will you have some where to go? If not, will you care? What about six months or a year from now when you would like to talk to some one but you've lost touch with all the other girls? Only you can make that decision. If you wait until January it will probably be too late. Stop looking at the girl in the mirror long enough to find the woman in you heart.

The Second Annual TV/TS convention is scheduled for February 24 through March 1 at the Ramdada O'Hare Hotel in Chicago. There are a number of different kinds of programs being presented including programs for the helping professional. The cost this year is \$175 per person and \$275 per M/F couple. Accommodations are not included. See the attached flyer for complete details. The date to receive the 20% discount for pre-registration has been extended to November 1, 1987. This will be the last one in this part of the country for a couple of years so I hope you all will take advantage of this wonderful week- end experience.

Both 1470 West and Christopher's Lounge will be having Halloween Parties though I don't know what nights they are having them. Please check them out since some of us will surely be going to one or both of them.
