Most weekend nights you will usually find a nice crowd. Parking is good, Old Street has a large lot. There is also on street parking. The drinks are reasonably priced. The customers and employees are

friendly. It has been remodeled and the dance floor has been expanded. The music is, of course, country and western. It is the modern country that you hear on radio stations like Y Country. They also have been known to play rock-a-billy. Old Street has a D.J. and I have found that the D.J. is very good about playing requests. Most of the patrons spend the majority of their time on the dance floor. Line dancing is very popular. If you are like me and you don't know how to line dance, you are in luck. Each Friday night at 8:30 Old Street offers free line dancing lessons. Yes free. The instructor is very good and has lots of patience. The lessons last about an hour or so. The idea is that you stay and practice what you learned on the dance floor. If you prefer the two step, Old Street offers two step lessons on Wednesday night at 8:30 again they are free. Now there may be those who rather pay for lessons, for you there is Sunday at 4:00 PM. The charge is reasonable. The bar is not open at that time. It is located in Clifton near and behind Bogarts. Chasers also features a D. J. but the music is rock. The dance floor is large. There is plenty of seating and drinks are priced competitively. COURTROOM
vs. TV/TS

PART ONE:

It may be difficult to believe, but it is true never-the-less, that transvestites and transsexuals occasionally receive fair and sympathetic treatment from our courts.

Two Ohio decisions, as well as from other states, have dealt with the validity of statutes that attempt to criminalize the wearing of clothes of the opposite sex. these Decisions have either struck down such statutes, or refused to apply them to transsexuals.

The most important decision was a unanimous one by the Ohio Supreme Court in 1975: Columbus vs. Rogers, 41 Ohio St. 2d 161, Ohio ops. 2d 308, 324 N.E. 2d (1975) [This citation may be useful to our sister attorneys]. The facts are

sketchy: we know only that one John H. Rogers was arrested for "appearing in public dressed in the attire of the opposite sex," in violation of a Columbus ordinance. Mr. Rogers argued that this ordinance deprived him of his freedom of expression. The Ohio Supreme Court reversed his conviction on a much narrower ground. It held that the ordinance was unconstitutionally vague, because a person of ordinary intelligence would not always know whether or not clothes were in the exclusive domain of a specific gender:

"Modes of dress for both men and women are historically subject to changes in fashion. At present (i.e. 1975) clothing is sold for both sexes which are so similar in appearance, that a person of ordinary intelligence might not be able to identify it as male or female dress. In addition, it is not uncommon for individuals to purposely, but innocently wear apparel which is of the opposite sex."

It should be noted that even if Mr. Rogers was not confused as to his female attire, he still could not be prosecuted under a statute which is too vague to be applied in other, more general situations.

Although the result if Columbus vs. Rogers is welcome, the reasoning is ironic because TV/TS wear their clothes precisely because they are identified with the female gender. It is unfortunate that the Roger's Court could not have rested its decision on higher grounds, which would have proclaimed more broadly our right to express our feminine feelings by our manner of dress and appearance (this could be based on freedom of expression, protected by the first amendment or the interests protected by

the fourteenth amendment). However, the bottom line result remains much the same - we cannot be prosecuted or fined for dressing as we please in public (at least not in Ohio).

"I'm 11 years old and my name is Alice. I found my dad's suitcase full of women's clothes in the basement about six months before my parents told me anything about Joanne. They never knew that I knew and I didn't tell them.

When my parents told me about Joanne they explained her in a very open minded way. I was curious about how Jo looked, so they showed me a photograph.

At first I thought it was Halloween. They promised me that dad hadn't changed, that he was the same as he always was. It was important for me to understand this and it made me feel a little better.

The way I see it, Joanne wants to understand more about women and that's why she likes to dress up like one.

Some of my friends were over one day, and one girl noticed how long my dad's fingernails were. I told her my dad was an electrician and needed his nails to work with long wires.

I am learning to cope with stress because of my dad's hobby. I worry that one of my friends might drop in when he's dressed up. My mom and I are the only ones who know, and sometimes I think I want to tell one of my friends, but I am afraid they will not understand. It's hard keeping a secret. I can't have anyone over for a slumber party because Daddy's dressed up. I go out with mom and Joanne for

dinner, and I'm afraid someone will see us, even though we go to smaller out of the way places.

If I hadn't heard about the good side of crossdressing from my mom and dad, I might not have understood their side of the story. If I had learned about how some other people think of it, like the ones that don't like it or think it's bad it would be harder for me to accept my dad when he does it.

I think they told me about it at the right time. I want to be an actress, so I understand about having fun dressing up."

Joanne ought to be very proud of her daughter Alice. To have a son or a daughter that knows, accepts and understands is something that I think all crossdressers who are parents desire. In the article I see a little girl who has an immense love for her father, a love that would make any father proud of his son or daughter.

But sad to say girls I also see pain. Because of Alice's love for her father she is willing to give up part of what would be a normal childhood for a little girl. While Alice is willing to give up of herself for her father, I don't think she should have to. Is it right that she can not have friends come over, is it right that she can not have things like a slumber party? These are things that are important to a little girl, things that she can share with her children when the time comes.

In Alice I also see the pain that many wives feel. The need to keep things a secret and the need to have someone that she can talk to and share feeling with. The fear of what might happen if she did confide in someone.

In the article Alice said that some of the people at her fathers group were uncomfortable when they saw her at the club simply because she was only 11, and yet how much better would it be for Alice if one of the other members had a son or a daughter who knew,

who also attended the meeting then Alice would have someone she could talk to and confide in.

As crossdressers we have strived hard to show society that we are normal males who simply wish to express rather than suppress our feminine qualities. But how much normality is there in causing pain for those we love? groups should provide more in the line of family type of activities, activities that do involve the wives and children.

Perhaps Joanne could arrange to spend a night at a motel so that Alice could have a slumber party. Perhaps she can arrange a few nights per week where she does not dress, or does not dress before a certain hour so that Alice can have friends come over. I am certain that Alice's friends would understand if Alice said that certain days of the week were family days where it was only the family and no friends at her house. This of course would allow Joanne to come out at home and still relieve Alice of her fears of friends dropping in when Joanne was around.

I hope that Joanne see's this article, and I do hope that she has as much love for her daughter as Alice has for her, enough love that she is willing to work with Alice to help insure that Alice has as much of a normal childhood as any other little girl.

Just as it is important that we COMMUNICATE with our wives, I think it is also important that we communicate with our children, especially when they know of our femside, and remember girls, communications involves listening as much as it does talking.

Just as our children have an immense love for us, let us also show them our immense love for them. Let us do all that we can to insure that they have as normal of a childhood as any other boy or girl.

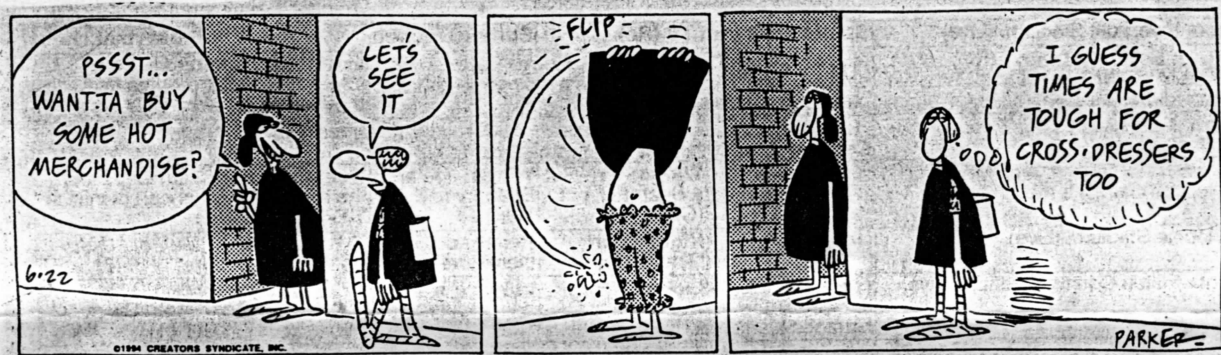
