# Renaissance

## Transsexual Divides All-women College

The sole remaining all-female college at Cambridge University [U.K.] has broken 126 years of tradition by admitting to its fellowship a woman who started life as a man. The decision to admit Dr. Rachel Padman, 43, as a Fellow of Newnham College has caused discord among senior academics, including Germaine Greer, the leading feminist who is a member of the college's governing body.

Dr. Padman, a physicist specializing in star formation, underwent a sex-change operation to become a woman in 1982, and legally she remains a man [in the U.K.] According to the statutes of the college, which was founded in 1871, all fellows must be women. Although Dr. Padman advised Dr. Onora O'Neill, Newnham's Principal, of her past before taking up her fellowship last October, the news is only now beginning to circulate in the college. The issue has caused disharmony and brought distress to Dr. Padman, who is a committed and well liked teacher.

Dr. Greer, who admires Dr. Padman's work, is horrified that she has been admitted as a fellow because of the apparent breach of college statutes. "We have driven a coach and horses through our statutes and I can't believe we did it. It's disgraceful that Dr. Padman has been placed in this situation. It makes me very angry," she said. Although Dr. Greer regards sex-change operations as mutilations, her opposition is based on principles not personality, she said. "I like Dr. Padman. We all know she is a distinguished physicist, but what is the point of having clear statutes if we just ignore them? We should have answered these questions before her appointment. We have to be true to the spirit of the original bequest to the college as a women's college for women." Dr. Greer said her position was supported by a number of senior colleagues. "Our position is not that Dr. Padman should resign but that she should never have been placed in this situation in the first place. The dignity of the college is marred by this unfortunate event." She added that many members of the governing body, which includes all fellows, were unaware of Dr. Padman's past. "Dr. Padman's past was kept secret from us. We were told by people outside the college making fun of Newnham and, frankly, we feel we have been

made monkeys of." Dr. Greer, whose first instinct was to resign, is now considering calling an emergency meeting of the governing body. Dr. O'Neill, who became Principal in 1992, declined to discuss the legality of Dr. Padman's appointment.

Dr. Padman's status was known to senior staff who wholeheartedly support her, Dr. O'Neill said. "Dr. Padman's change of state is ancient history. Furthermore it is not secret, covert or unknown among colleagues."

Dr. Padman, said she would consider resigning if colleagues were unhappy with her position at the college. "If I thought there were any significant number of women in the college who were, despite what I perceived, unhappy about me being there because of my past, then I would resign. Obviously, I don't want to go because it would be losing something I love. It is an exhilarating feeling being surrounded by clever and intelligent women," she said. Dr. Padman was initially reluctant to join Newnham because of her operation and rejected the first letter of approach from Dr. O'Neill. "I wrote back to her saying that there was this in my past and that I wouldn't want to bring the college's name into disrepute. I said I didn't think me joining was a good idea." Dr. O'Neill replied saying she was aware of Dr. Padman's sex change and again invited her to join the college. Last October Dr. Padman, who studied at St John's College for a Ph.D. in 1977, took part in a ceremony at the Principal's Lodge admitting her to the Fellowship. She swore an oath promising to uphold Newnham's best interests.

Dr. Greer said that one way to resolve the situation could be for Newnham to vote to admit men as fellows. The last time the issue was debated in 1990, it was rejected by a small majority.

If there were to be a vote, however, Dr. Padman said she would oppose the admission of men. "Newnham is the only college I would like to be associated with because of its special status. I like women and I like the idea of an all-women environment. "If there is another vote I would want to keep Newnham single sex. I think the admission of men would lead to a diminution of opportunities for women in Cambridge and I want to keep the college's special status."

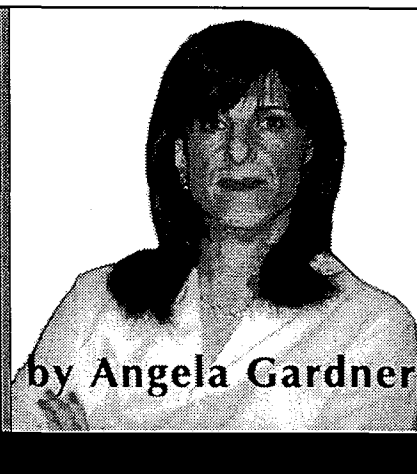

# Hate Crimes Developments in D.C.

There is a great deal of momentum around the hate crimes issue just now. First, the informal coalition of major civil rights organizations here in Washington continues its efforts to assemble a bill that would broaden the Department of Justice's (DOJ) hate crimes investigatory and prosecutorial jurisdiction to include actual or perceived (i) disability, (ii) sexual orientation & (iii) gender. Gender activists briefed coalition members, DOJ and certain critical actors on the Hill on the idea of ensuring through legislative history that gender is construed broadly enough to cover gender difference. If this effort comes to fruition, DOJ would be able to act when, for example, state or authorities refuse to investigate a rape of a Brandon Teena because Brandon purportedly "lies" about his gender and is therefore deemed untrustworthy. If this bill is introduced, you will be informed with the hope that you will contact your Congressional representatives and express your views concerning the bill's merits.

Second, the White House is planning a hate crimes conference in November, and the hate crimes coalition will have a role in structuring the event. The plan is to push for the conference to cover in some way the topic of hate crimes against those whose identities, physical characteristics or manner of expression transgress gender-based stereotypes. If you or someone you know has been victimized by such a hate crime, please contact me if the victim would be willing to consider coming forward. I can help

prepare the victim's statement with him or her (or s/him, whatever...).

I should say something about what a hate crime is. There is a difference between an assault or a murder, and an assault or murder that constitutes a hate crime. In a hate crime, in addition to the violence itself, there is evidence that the perpetrator has an animus against a group, and "selected the victim as a representative of that group."

The argument often is made in policy circles here that gender different folk do not need specific protection as such, because they will be covered by sexual orientation-based laws. (We've all heard this in the ENDA context, right?) In order to counter that argument in this context, we must demonstrate that gender-different folk are being specifically targeted as such. Brandon Teena's murder makes a fairly good example. It is difficult to argue that anti-lesbian bias was involved in his murder, for he lived and presented as a man. Arguably he was killed because he violated the gender-based stereotype that a male sense of self and masculine expression exist only in individuals assigned to the male sex at birth (a stereotype we all know to be nonsense).

Hopefully you get the idea of what I'm looking for. If fortune smiles, we will profit from both the hate crimes bill and the hate crimes conference by having a greater number of Americans see us as human beings with civil rights problems much like those of other marginalized groups.

# Criticism of IFGE Convention Was Unfair

[Ed. Note: Last month we printed an article by Richelle G., from the *Born Free* (Riverside, Calif) newsletter that was highly critical of the IFGE's role in the Cal Unity convention in Long Beach, Calif. Here is a verbatim response to the author from IFGE's Linda Buten.]

Dear Richelle,

I am responding to your editorial in the *Born Free* newsletter that was reprinted in *Renaissance News & Views*. Let me enlighten you on a few items:

**California Unity** — Keep one important thing in mind, the California contingent and IFGE were 50/50 partners on this project. It is no one partner's job to pat the other on the back. As at all conventions, things will go wrong. Volunteers negate assumed responsibilities, people are no-shows, and Murphy's Law will hold true to form. Considering the circumstances, difference in venues, personality conflicts, etc., etc., I felt those who grunted the responsibility, Alison Laining and Joan Goodnight, did an admirable job. I have attended over 50 gender conventions in the past 15 years, participated in approximately 20, and completely organized a BE ALL two years ago in Cincinnati. While we all can see room for improvement, it certainly did not deserve the bull whipping you passed out.

**FtM track** — You stated that "For the first time at a convention of this sort there was a... track for the Female to Male TSs." In all due respect, this is the eighth time it has been repeated at an IFGE Convention. A similar program has been around for 5 years at Southern Comfort, and smaller versions have been at previous "Be All" weekends and "First Events." IFGE was not only the pioneer of such programs, money from IFGE helped fund the first FtM International Conference. (BTW- Seed money and leadership from IFGE also helped material-

ize the first "SPICE Convention", the "American Boyz Convention, the International Conference on Sex & Gender, ICTLEP, and the New Women's Conference.)

**Board Members** — You said IFGE Board members seemed non-existent. This is somewhat true, but what you don't realize is, the convention partners agreed that no one person be singled out. IFGE directors nor anyone else were permitted to wear identification ribbons as in past conventions. I personally attended every luncheon, dinner, cocktail party and function that time would allow. I even went bar hopping and dancing every night with new groups of people. I spoke with as many individuals as humanly possible. I always saw many of the other board members present. If you don't know them, how do you know they were there or not?

**Recognition** — You stated that, "the IFGE leadership and Board Members did not recognize the efforts of the local volunteers." Again it was decided by the partners that there would be no special awards for those who worked on the convention. Born Free members are part of the California Team, not exactly a group of outsiders. I don't know anyone who attended that convention that did not realize that the local groups played a large part in making it a success. It was in all the printed literature and announced several times at the podium. (BTW - IFGE did present a special award for Joan Goodnight, but I guess you missed it.)

**Thursday night** — Thursday night was a fund raiser for IFGE. I remember no promise or even a suggestion of dinner, only entertainment. Jim Bridges and members of the Gay Community freely donated their time to help us raise money, that in return goes back to the Community.

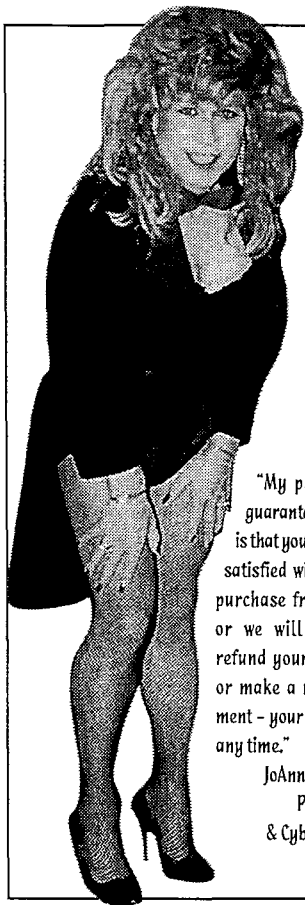
I have no idea why you think this was so offensive. The Gender Community is striving to be inclusive of everyone with gender issues — including many Drag Queens. Your statements

about them are leaning towards just being divisive, something we need a lot less of in our community. You may see Jim Bridges only as a money sucking entrepreneur who lives off the community, but if you would get to know the real person, you could have never made this statement.

**Background** — IFGE was established 13 years ago by individuals like you, from existing groups like yours. It was never designed to be an umbrella organization, and does not claim to be. (I hear this term used repeatedly by people who do not understand the IFGE concepts.) The purpose was to bring together community leaders and try to accomplish things no small group could do by itself. The IFGE "Coming Together Convention," is everyone's and anyone's forum. It was a tool where a local group or groups can entertain a national convention in their home town. The local group is expected to do most of the work on the local level. The conventions serves as a platform where leaders come together for many different reasons. The awards night is one of those reasons.

**Community Awards** — The IFGE Awards night is not an evening where IFGE gives awards to IFGE volunteers. Years ago, community leaders felt it would be grand to honor anyone who worked for the common good of the Gender Community. A separate group of individuals called the Selections and Awards Committee was formed for this purpose, and it is they who determine who is nominated and receives awards. A member of our board, Winnie Brant in this case, helps organize and maintain this committee, but the Committee speaks for itself. The cost of the awards is provided though the IFGE general fund, but the awards do not bear our name, nor do the Board have a say on who receives what. This year there were eleven awards presented at the banquet, three of them went to current and past IFGE Board Members. Over

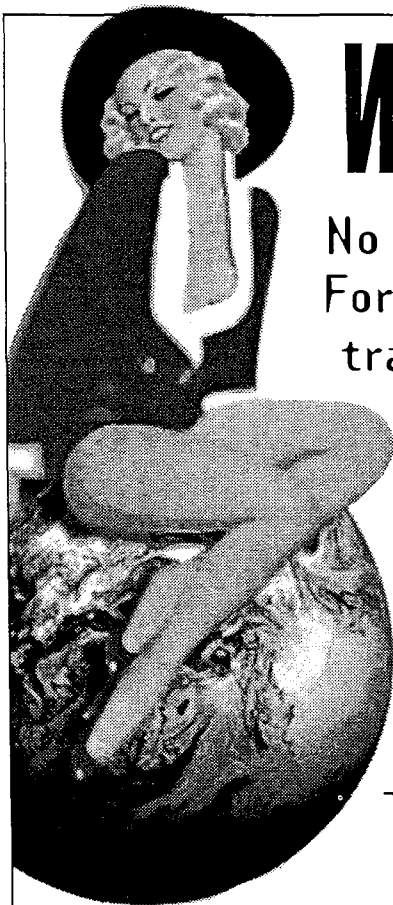

### A HOUSE DIVIDED?

A few columns ago, I wrote about the brouhaha over by-laws in the Chi-

cago Chi Chapter of Tri-Ess. Apparently, the controversy lingers on. The March issue of the *Chi Tribune* newsletter carried three interesting articles that reflected the sniping going on over those dreaded by-laws.

In a column titled "Who is Miranda Stevens?" Miranda tells a little about her work as an officer of the Chi Chapter and identifies herself as a human rights activist. She writes that she "has a very difficult time... knowing that our own membership policy is discriminatory." Chi Chapter, as a Tri-Ess sorority limits full membership to heterosexual crossdressers only. Miranda continues, "I strongly believe membership should be open to all. For that reason, I voted against the adoption of the Chi Chapter by-laws."

**Gloria Wright** authored a column she titled *Disease!*, in which she warns the members of Chi Chapter against the tendency of some transgender support group leaders to become autocrats. She says that the old **Gateway Gender Alliance** support group came undone because of the tyranny of their leadership, who saw the group as their own club and everyone else be damned. I may be reading too much between the lines of Gloria's article but it seems she may be taking a sideways swipe at the current Chi Chapter leadership who adopted the by-laws without a general vote from the membership.

**Denise Peters**, the Chi Chapter President, concludes her "President's Podium" column with a denial that dissenting views are being kept out of their newsletter. Apparently, at least one member charged that Denise, as both Editor and President, has the power to omit from the newsletter any

opinion pieces that disagree with the officers' viewpoints. Denise claims this is untrue and only space restrictions force her to withhold some contributed pieces from the *Tribune*.

It should also be noted that Chi Chapter elections are coming up and all the current office holders are unopposed. In my mention of the by-laws controversy from February, it was discovered that most rank and file members had no strong opinions about by-laws, pro or con.

That is too often the "problem" with our support organizations in a nutshell. A few concerned individuals who try to manage the group in the way they think best, a few dissidents who disagree and stir the pot, and a vast majority who simply don't care that much for the political aspect of the enterprise.

### AIRHEAD? MOI?

One of my first *Vis a Vis* pieces way back when was a review of an article titled *If You're Going to be a Female, Please Don't Be an Airhead*, written by the wife of a crossdresser. The gist of the piece was that too many crossdressers focus on the more shallow issues of femininity and come across more like airheaded bimbos than complete women.

The original article was one of the most popularly reprinted pieces in the history of newsletterland, appearing in almost every group's newsletter over the past couple of years. Now, there has been a response titled *If You're Going to Be Female, Do the Best You Can* written by a Lanette W., and it too is appearing in many newsletters across the land.

Lanette defends the crossdressers, who may indeed seem like bimbos at times, on several counts. Firstly, most crossdressers have not had the years of experience necessary to swim past the shallow end of the femininity pool. Even though most crossdressers in support groups are thirtysomething and up, their feminine alter egos may only be a few years—or even just a few months—old. No wonder we may seem fixated on nail polish, shoes and hairstyles. We need to get through that stage before we move into more weighty issues.



She points out that crossdressers do not intentionally try to mock real females by focusing on surface appearances and lightweight topics. In fact, "we would give anything to share the full female experience," she says. The trouble is that we start with the outward trappings of femininity and then have a hard time finding others with whom to share anything deeper. For a lot of married crossdressers, spousal support is strained, thus shutting out any sharing with the one real woman in their lives. Support groups should be a source of help but if the room is filled with crossdressers stuck in the same development stage, they could all be airheads together, and that is how the original complaint came to be filed in the first place.

So Lanette lays out a fairly decent response to the criticism leveled at us. She concludes her article by saying, "I am still learning, and I am hoping that more understanding genetic females will help me find the answers. The answers will reside in being afforded the opportunity to share in the female experience with those who are understanding and willing enough to allow us in."

### WELCOME TO THE RENAISSANCE-A-THON!

In a letter sent to members of Renaissance, JoAnn Roberts and Angela Gardner informed us that our organization is having financial difficulties. In fact, the difficulties are so serious that they wrote, "If not for some of the income produced by the Congress on Sex & Gender, Renaissance National might have closed its doors by now."

This news came as something of a shock to me and I'm usually clued in to stuff like this. I can imagine that it is perhaps a greater shock to the general membership and other individuals in the TG community.

Renaissance has always been a strong and growth oriented organization. Aside from our core chapters in Philadelphia, Lower Susquehanna Valley, Delaware, and Lehigh Valley, we also have affiliate organizations scattered throughout the US. Financial shortfalls are not uncommon in growing enterprises as costs climb faster

than revenues. That Renaissance now finds itself in dire straits only points up that no organization or its membership should ever become complacent in its support base.

The activities of the Renaissance Chapters are distinct from the Renaissance National organization but their success in membership helps fund the National organization through dues and newsletter subscriptions. If the Chapter memberships dwindle, support to National dwindles likewise. That is why it is vital to have dynamic leadership at our Chapter levels to retain and increase membership by having something to offer those who come through the doors each month. But it is also incumbent on the membership to support their local Chapters by participating or getting involved to improve things if they see deficiencies.

The National Board is requesting a one time contribution of only \$7 per member to see them through this crisis. That is a small price to pay for the benefit of having an organization like Renaissance to call your home away from home. Perhaps out of this difficulty, we will see some renewed vigor out of our leadership and the general membership to insure our continued success.

# Gender Reflections

## Counseling The Partner of the Crossdresser

Elaine came to see me because of rage and frustration with her husband Eddie who is a transvestite. She refused my offer to meet with them together first and then individually. At our first meeting I learned that Elaine believed crossdressing was a bad habit, although not an illness, and therefore did not see the need for counseling for her husband. She however, came for help in dealing with Eddie and helping him to get over this habit.

The above scenario is not unusual although there are several variations on the theme of trying to change one's partner. There is the mental illness scenario, the one that involves sin and redemption, and the one which confuses sexual orientation and gender identity and may cause a partner to doubt her heterosexuality as well as that of her spouse.

What all these situations have in common are:

- The woman is almost always ignorant about transvestism. She does not understand that it is not a condition of

illness, sin or homosexuality and she needs help to know that she plays no role in her husband's gender expression. Prescribing books that render a comprehensible explanation of this behavior is very useful along with building a trusting therapeutic relationship.

- The couple's sexual relationship is frequently compromised. Transvestites often want to crossdress prior to or during sex with their wives. To the woman who doesn't understand and is frightened, disgusted or upset by this inclination, sex may become an ordeal or an event subject to conditional agreement. Eventually a situation may evolve in which each partner takes turns enjoying sex. For example, "Tonight we are doing it my way, or we are not doing it at all!" The remedy to this requires the participation of both partners in treatment and I encourage them to meet with me together.

- In all cases the woman is powerless to change her partner's need for periodic crossdressing. No technique, no seduction, no punishment will dis-

courage the expression of his feminine persona for long. However, with his agreement, such expression can be managed or shaped to better conform to her expectations of a husband. Again, counseling is most effective when both partners participate.

- Wives of CDs seeking counseling either have a terror of discovery of their husbands' transvestism or a need to expose them to the people who are most meaningful in his life. Either of these needs, if unexamined and not understood, may contribute to the death of their relationship—if not the end of the marriage. Individual counseling can be very effective in giving the spouse a window into her unconscious motivation to cause either herself or husband such pain.

In counseling the partners of a CD, I address the above issues and any individual concerns that are raised. Dealing with children sensitively and with primary emphasis on what is in the children's best interest often is a focus of treatment. Arranging for sufficient privacy to process what is occurring between them, becoming reassured of husband's discretion, and establishing fair rules surrounding costs involved in husband's purchase of clothing and membership in gender organizations, are some of the variety of concerns specific to certain but not all couples.

## EEOC Comes to ICTLEP

The keynote speaker at the International Conference on Transgender Law And Employment Policy's (ICTLEP) sixth annual conference, Transgen '97, was Commissioner Reginald E. Jones of the Equal Employment Opportunity Commission (EEOC). He is one of four people directing the affairs of the mammoth agency, charged with enforcing all federal statutes concerning employment discrimination. At the time of his nomination [to the Commission], Mr. Jones had served as Senior Legislative Counsel in the office of Senator James M. Jeffords (R-VT), since January of 1993. Previously, from 1989 to 1993, he had been the Minority Counsel and Staff Director of the Labor Subcommittee on the Senate Labor and Human Resources Committee. Mr. Jones also worked on a wide variety of legislative issues during his years in the Senate, including successful enactment of the Civil Rights Act of 1991 and the Americans With Disabilities Act of 1990, as well as many other, less renowned efforts to revise federal employment civil rights law.

Commissioner Jones spoke to the ICTLEP convention about the battle to end employment discrimination against transgendered persons. He

traced tg activists' efforts, starting with Karen Kerin's contacts with Senator Jim Jeffords (R-VT) as early as 1993, through the transgender national events in D.C. in October of 1995 and February of 1997, to recent discussions in his office at the EEOC. He mentioned EEOC's early efforts to use Title VII and its sex-discrimination protections on behalf of transsexuals, and their rebuff by three Federal Appeals Courts. His opinion of these decisions is succinct, "For me it is a matter of intuitive common sense that such discrimination should be included within the sex category of Title VII... I think both the result and the basis for the analysis are wrong."

Before his appointment to the EEOC in 1996, Jones worked on Capitol Hill for many years and discussed the legislative history of the Employment Non-Discrimination Act (ENDA) from that perspective, and suggested ways in which the transgender community can work effectively for legislative change.

The U.S. Equal Employment Opportunity Commission was created by Congress and enforces Title VII of the Civil Rights Act of 1964, which prohibits employment discrimination based on race, color, religion, sex, or national origin.

## NOW Passes Transinclusion Resolution

After years of debate and dialog, the National Organization for Women (NOW) has passed a resolution on transinclusion. The successful vote followed personal support by NOW President Patricia Ireland, and concentrated efforts by NOW-NJ President Bear Atwood and NOW Lesbian Rights Coordinator Kim Ward.

The measure was originally introduced and unanimously passed at NOW-NJ's State Conference in 1994, and then introduced at the 1995 National Conference in Columbus, Ohio. A dozen gender activists showed up with petitions supporting the measure. But, in spite of signatures by over half the attendees, the measure was tabled by the National Board, where it languished for the next 2 conventions.

The breakthrough was prompted by an invitation Ms. Atwood extended to transgender activists to address the State Coordinators Conference in San Francisco several months ago. As more State Presidents got behind the measure, Ms. Ireland asked activists to address the NOW National Board at the current conference.

Well, well. Guess who just slapped the gay community across their collective face? The **Georgia State Attorney General's** office, that's who. See, there was this woman who was offered a job with the Attorney General's office there which was later revoked when it was discovered the woman was **lesbian**. Now, I'll bet you thought that she was protected from discrimination because of her sexual orientation. And well she might have been if that would have been the argument used to rescind the job offer. It wasn't. The 11th Circuit Court of Appeals found that the woman was let go not for her sexual orientation, but because she seemingly did not appreciate the importance of appearances. They said the case was about "**conduct**" and "**appearance**" not "sexual orientation." Gee whiz! Appearance? Now I wonder what law that gets covered under? It's certainly not covered under the recently proposed **Employment Non-Discrimination Act** (ENDA) supported by the gay community's **Human Rights Campaign** (HRC). But, it might have been if the 1997 ENDA proposal had been tg-inclusive where appearance is the heart of the issue. If the ENDA backers are smart, they'll learn from this.

Maybe HRC is starting to see the wisdom of a tg-inclusive policy. They're sending lobbyist **Nancy Buermyer** to this year's **International Conference on Transgender Law and Employment Policy** (ICTLEP) to present a Q&A session on HRC and its relationship to the tg community. That's easy. It doesn't have one if HRC thinks talking to one or two people from the community is a relationship. **Phyllis Frye**, ICTLEP Executive Director, has an interesting take on the tg-exclusive ENDA bill. She calls it a bill asking for "special rights" for gays, lesbians and bisexuals. That should put a knot in HRC's pantyhose. Finally, Frye announced she will no longer produce the annual conference after this year. No word yet on whether the ICTLEP board will continue to hold the conference.

Want to understand more about appearance on the job? Maybe we should ask **Kristine Holt** to talk to HRC. Holt, a male to female transsexual in transition, was fired from her job for allegedly violating her employer's dress code. Holt responded by filing suit alleging her firing violated the **Pennsylvania Human Relations Act** (PHRA). The court ruled Holt had no claim under PHRA and on appeal the lower court ruling was affirmed by the state's Supreme Court. It was clarified that a person seeking protection under PHRA must demonstrate a physical or mental disability that substantially limits one or more of life's major activities and that transsexualism does not fall within that definition.

You lose one and then you win one. A federal district court in New York held that **transsexuals are protected** under New York State and City Human Rights Laws. (Maybe Holt should move to New York.) Although every federal court that has considered the question of transsexual employment discrimination under federal **Title VII** has generally rejected it, this court found that the "in-

terpretation of the [state] HRL and city HRL is independent of federal analysis."

I received a review copy of lesbian writer/activist **Pat Califia's** *Sex Changes: The Politics of Transgenderism*. I was not at all pleased with it. Califia totally ignores the contributions of crossdressers to tg politics. She builds her case solely on the ideologies of transsexuals, as if they had an exclusive right. In fact, speaking of transvestites she states, "Their cultural history overlaps and is linked with the politics of the transgendered community but is not identical to it." She lost me right there. That one sentence told me Califia doesn't have a clue as to who and what make up the "transgender community" and its "politics." She reviews, extensively, **Virginia Prince's** *The Transvestite And His Wife* and refers to Virginia as "he" totally ignoring the fact that Virginia created the word "transgender" and that she has lived as a woman full time for the past 30 years. Instead Califia uses this 30 year old book as if it is the TV Manifesto, and we all know how outdated it is now. I find it hard to believe that Califia could not find any positive contributions to tg politics by CDs. I wonder if she ever heard of the **Bill of Gender Rights**? Or maybe she wasn't told that CDs played a major role in forming **GenderPAC**. This book needed a lot more research before publication.

If you haven't yet seen **Con Air** with **Nicholas Cage**, **John Malkovich**, and **John Cusack**, then you've missed one of the great summer blockbuster movies. But there's another reason to look for **Con Air** — **Sally Can't Dance**. That's the name of one of the convict characters in the movie and Sally is transgendered, most likely transsexual. Sally is played by New York actor **Renoly** (just the one name) who says that, "...Sally is the bravest character in the film. I wanted her to be feminine and sexual and daring, and that's who she is." Ap-

parently some of the gay watchdogs didn't appreciate Sally and were enraged according to the July 22 issue of *The Advocate*. I say who cares if a few gays were upset over Sally. She isn't one of theirs; she's one of ours, convict or not. I thought Sally was played quite well. Renoly has his thoughts about the gay ire: "I often see gay people making fun of drag queens and looking down on transvestites and cross-dressers. To me, for someone to look at their own image and criticize a gay person for being feminine is a sign of not really caring for and accepting your own kind." You go girl! Sally *can* dance.

As the partner of a transgendered man, perhaps the most difficult thing to understand is what the crossdresser feels when dressed en femme. I hear that question all the time from women in transgendered relationships, and I, too, have often asked that question.

Some years ago, I had a CD friend express joy at having the wind whip the skirts around her legs, and the feeling of air against stockings. It gave her that "Marilyn Monroe" feeling—you know, when she stood over an air vent and the air whipped her skirts up? Well, I tried to relate to what my friend was saying, but short of knowing how free the wind made me feel, I couldn't relate to the rest of her statement.

My partner, Vanessa, gets a feeling of deep satisfaction when wearing breast forms. It is a real sense of pleasure and completeness for her. I enjoy her breasts, but I have never had that feeling about my own. They are simply part of my body, neither big nor small, and not necessarily important to me. Likewise, Vanessa enjoys the feel of silky lingerie and the tightness of briefs. I enjoy wearing sexy lingerie but mainly for the look, rather than the feel. So, here again, I could not relate.

However, the other day, upon leaving the office, I dropped my keys as I

was putting them in the car door. I had on a long skirted denim dress, and as I stooped (in a hopefully ladylike way) to pick them up, my skirt swirled out around me, onto the pavement. I experienced a sense of complete delight at this, feeling overwhelmingly feminine at that moment. As I drove home, I realized that I had experienced a sensation that my partner, Vanessa, must experience, as do all crossdressers.

I began thinking about this pleasurable feeling and remembering things similar to this that happened to me in the past. As a teenager, I loved to dress up in flowing robes with lots of scarves, and I would (in the privacy of my room) swirl around, fantasizing that I was a dancer and part of a harem. Childish fantasies but fun, and I did enjoy the feel of the flowing cloth around my legs, and the silky feeling of the scarves.

I also remembered how much I have always enjoyed wearing long skirts and dresses. My first thought was that they covered up my hefty legs, but on second thought, I admitted to myself that I enjoyed the femininity of the long skirts, that they made me feel soft and sexy and beautiful.

Ah, at last I had found the common ground with my partner, Vanessa. Just as I experience the pleasure of certain types of clothing, so, too, does Vanessa.

She does not get these feelings when dressed in male clothing; nor do I. She experiences a sense of pleasure, a softness, a rightness when she is dressed in women's clothes; so do I. I detest androgynous clothing or wearing any type of male-like clothing. So does Vanessa.

Comfort often dictates to us what we wear; yet, comfort can be unfeminine at times. An old Tee Shirt is so comfortable, but when I am feeling particularly sexual, I want the feeling of silk and satin against my skin. When Vanessa wants to feel feminine and sexy, that's what she wears. Even when dressed as her male self, she wears something soft and feminine underneath, a reminder of the feelings which mean so much to her. Likewise, I always try to wear a sexy, rather than comfortable, bra and undies, simply because they make me feel feminine.

I think I've finally found that common ground with my partner and it is a realization that took me years to reach. I find that I prefer my partner as Vanessa, and this added realization of what she feels makes me feel even closer to her. It adds to the intimacy of our relationship, that inner communication we have. It makes things even better. Well, gotta go—Vanessa and I have some shopping to do!



# It's The Journey That's Important

A by product of our goal-oriented society is that we tend to place far greater value on the destination, or end result, than we do on the journey. I looked around and something just didn't seem right. There was no "scoring" as would be typical in an archery tournament in the west. The targets had no such provisions for a "bull's eye," nor the surrounding rings. I asked my friend, "How do they know who wins?"

"Win?," my friend repeated. "Oh,

you misunderstand. They are not competing against each other. It is not like that at all."

I then asked, "How do they keep their own score. Is one part of the target more points than another?"

"Target?," again my friend replied with question. "The target isn't important at all. It is simply to stop the arrows from going into the trees."

"This isn't a tournament. What's the purpose?" My friend, who often found me to be quite lost in such concepts, replied, "The object is not the target. It is the drawing of the bow. The arrows will find the target on their own. Watch."

I did as I was told. It was simply amazing. The archers, possessing great strength and discipline, were able to pull back their long bow strings so slowly, that it almost appeared they were not moving at all. It took several minutes from the time the arrow was placed in the bow, until the time the arrow was released.

It was then that I finally learned the

"secret" of Eastern ways. It's the process, the journey, that is important. This can be seen in every aspect of their society. Perhaps the most popular example is the "Tea Ceremony." To an outsider, this at first appears to be an over elaborate, ritualized, waste of time to prepare a not so tasty cup of green tea. However, the tea is not the point. It is the process, the pleasure of watching someone prepare the tea, the porcelain pieces, the bamboo brush, the clothing, and the frame of mind one achieves. The tea itself, is the least important part of the entire ceremony.

In the impoverished areas of the Orient, this attitude is even more obvious. Regardless of the person's station in life, or their task, they take pleasure in whatever it is they are doing. Imagine watching a street sweeper, with a straw broom not a machine, singing and sweeping. There was the newspaper recycling man who always carefully wrapped and tied up the bundles of old papers, in perfectly uniform packages. Why go to such effort? By the end of the day these were going to be thrown into some enormous shredding

machine. The answer is in an underlying teaching, "Take pleasure in what you are doing at the moment, whatever it is."

So it is with crossdressers. Linda and I speak with a great many couples. One of the complaints we often hear from spouses and partners of crossdressers is, "It just takes so long for him/her to get ready. It's a great waste of time."

No, it is not a "waste of time." It's the pleasure of the process. The transformation process, is one that should be relished, not rushed. Like the slow, disciplined drawing of the bow string, it should be enjoyed. Just as the target is not the object, neither is the completed external feminine image. It is the process, not the result.

When one takes the time to enjoy the process, whatever the task, the result will follow naturally. Much the same as the arrows found their target.

One dear sister of mine, out of necessity, often transforms herself in her truck or van. This is sad to me. While I know that she has the pleasure of being her femme self for a time, I feel

While I dress quite often, when I am going out, I have a certain "ritual" or "ceremony" that I follow. Much like the tea ceremony, it is the pleasure of each step that I relish, the end result follows naturally.

# Making Sense of It All

## Why?

For most of my life I have asked, "Why?" Why am I the way I am? Why am I different? Why do I have to have these feelings, these wishes to be feminine, when I know my body is (or was) that of a man? Why can't I be like everyone else? Why, why, why? It has taken me a lifetime (least a good portion of it) to understand at last that the "why" I have been asking is the wrong one and that there is another "why" which is more productive both for me and ultimately for those around me.

The "why" which has plagued me all my life has a self-pitying sound to it, as if I were asking, "Why me?" It sounds more like a complaint than anything useful. To keep asking "why" in this manner is to keep looking for a culprit. What I have finally learned is that blaming is useless, except as a way of avoiding responsibility for one's self.

Rather than spend time and energy trying to figure why I am the way I am and blaming someone/something for my feminine wishes, I have finally seen the truth of the matter. The truth is that my life would be fuller and more productive if I could simply accept myself for who I am the way I am. My so-called "condition" might be better seen for what it really is: my identity as a person. Just as the sky is blue and the grass is green, so, too, is my sense of self a gift from God. If I do not respect that gift, who will? It is time to treasure this gift of life and to be kind to it. I should feed it right, though not excessively, clothe it properly and enjoyably, allow it to find personally satisfying work and hobbies, and perhaps most important of all, help it to find fulfilling human relationships. Maybe I will even allow myself to reach into the unknown to realize the sacredness of all that I feel and do in this life of mine. I will then see that I am only a small but nevertheless important part of the scheme of things and that I must

do my best to make my life, and the life of each person with whom I come in contact, a better experience.

It is out of this effort to live more fully in the present, especially as a transgendered person, that I have begun to know the true meaning of the question, "Why?" It is that meaning, introduced above, along with some answers out of my own life experience, which I have tried to capture in a poem called, appropriately, "Why?":

## Why?

For sunsets  
that pave a lake with gold,  
and mornings  
when hope resounds  
in every chirp.  
For deep skies at night  
with stars that hypnotize,  
and the sun at noon  
which heats the hunger's blood.

## Why?

Because babies smile  
and kittens purr  
and horses prance  
and butterflies dance.  
Because God speaks  
in thunderclaps  
and signs His name  
in lightning bolts  
and takes you in His arms  
with every ocean swell  
and every wilderness breeze.

## Why?

To see the fields  
of wild flowers  
that decorate the valleys  
in the high country,  
to smell the hay just cut  
and the animals  
that fertilize the pastures,  
to taste wild berries  
and trout just caught and cooked,  
to swim and run and love and sleep  
and live those moments  
the memory keeps.

## Why?

To meet old friends  
and meet with new ones,  
to dance and drink and laugh  
and play  
and learn of life  
both good and bad,  
to cook a meal,  
to read a book,  
to write a poem,  
to feel the sand,  
to share one's soul  
and hold another's hand.

## Why?

That I may listen  
to my favorite melodies,  
to my favorite souls  
and to myself,  
that I may be  
and be with others  
till the rains cease  
for me.

And so at last I am beginning to ask a "why" which yields meaningful and useful answers to the daily challenges of my life as well as to the challenge of my life as a whole. It is true that my gender confusion is itself proving to be at least a partial explanation of the general and mystifying unhappiness I experienced during a good portion of my life, which included childhood, teenhood, and adulthood. I never thought that something called "gender confusion" could be a major factor in my unhappiness. After having spent a great deal of time and effort trying to solve the riddle of my being, it turns out that my self-recognition and self-acceptance as a transsexual seem to have settled a lot of my inner turmoil. But I no longer have an interest in asking why I was so confused about my gender in the first place. I simply want to face life with the answers I find to the fundamental human question we all must ask, regardless of our gender: "Why?"



# The Name Game

In perusing the newsletters from around the country, I see that the name game is once again enjoying immense popularity. It seems like we rather enjoy the mostly nonsensical pastime of determining what those of us in the gender community like to call ourselves. Now the most general terms bandied about are: transvestite (TV), transsexual (TS), and transgenderist (TG). Within each of the first two terms there are variations to the nomenclature, i.e., a transvestite is also known as a crossdresser (CD), drag queen (DQ), no-op, etc.; a transsexual can also be identified with a descriptor of being pre-op, post-op, male to female (MtF), and female to male (FtM).

The term transgenderist, however, was coined by none other than the dowager empress herself, Virginia Prince, to identify those macho males that wish to live full time as women, wear all the exotic and erotic frilly foos associated with the fairer sex, but do not wish to partake in the ultimate pleasure and fantasy of genital amputation. # Shopping With Jessica

Greetings, girlfriends! May your air conditioner be in perfect working order and your makeup stays put when you go out! Following my foray into the wide and wonderful (?) world of television, courtesy of my little article on Ellen DeGeneres, I've torn myself away from Dan Patrick, Charlie Steiner, Linda Cohn, Bob Ley and the rest of the gang on *SportsCenter* just long enough to regale you, my ever loyal readers, with more shopping tips and tricks.

Back in April, I had an opportunity to partake of a different and unique experience and I wish to share it with you now. Early in the month someone put me in touch with Selena Lesko, a local Mary Kay representative here in the Philadelphia area, who was interested in expanding her client base to include crossdressers. I called Selena, who told me of her services, and said she wanted to come to a meeting of the Greater Philly Chapter to do a demonstration.

Selena's idea was to take, for lack of a better term, a guinea pig at the meeting and make up said subject totally from scratch. Extremely curious about what sort of cosmetics Mary Kay (and their Avon brethren) have to offer, I volunteered to be the test subject. Happy to oblige, Selena suggested I come to her home for a dry run prior to the meeting so she could determine what to use on me beforehand, so she doesn't waste time doing same during the demonstration.

Armed with my "big hair" wig and a sampling of the cosmetics I regularly use, I journeyed to Selena's home.

Never having dealt with a Mary Kay rep, I was pleased to be treated very well by Selena from the moment we met. We went to her home office where she had all the tools of her trade, which included loads of sample items, brushes, pamphlets and books. Suffice it to say, Selena had enough stuff on hand to make up every face that comes to a Philly meeting!

After looking over the sample stuff I brought along, Selena consulted a large loose leaf binder to determine what colors would look best on me, and that book had literally dozens of examples. Once she selected the right one for me, we began the session with cleansing, toning and moisturizing—Selena would do half my face in front of a mirror to illustrate how it should be done, then she would have me do the other half. Once the canvas was clean we started putting color on it.

Using only the smallest amounts of foundation and powder, just enough of each to fill a thimble, Selena was able to achieve sufficient coverage. (Which surprised me greatly.) She did half, then I did half. From there, we went on to eyeliner—violet of all colors—which made quite a dramatic difference in how my eyes looked. Then it was on to eyeshadow, brow pencil, cheek color, lip pencil and lipstick. All the while, Selena explained in great detail how each item worked and how I should use it.

Then, she showed me something really cool—lipstick adjusters. This is a cream that when mixed with lipstick changes its color. The adjusters come in four shades: warm (pale yellow in

color), cool (pale blue), light (beige) and dark (almost black). I was wearing a bright red, and when Selena added the dark adjuster, the color changed to a sultry looking magenta! It was amazing! With all four adjusters at one's disposal, one tube of lipstick could yield four entirely different colors!

All during the dry run (which I enjoyed, by the way) Selena made notes on what she used so she could repeat the procedure at the meeting. Then she gave me samples of what we used so I could experiment at home. She also provided me with brochures of the Mary Kay product line, including one tailored specifically towards women of color. That brochure features 9 shades of foundation, 25 shades of eyeshadow, 24 shades of blush, 14 shades of nail polish and 23 shades of lipstick. Quite a large selection to say the least!

Along with cleansers, toners and moisturizers, skin products, hair care products, tanning products, fragrances, makeup removers and men's products (YUCK!), Mary Kay most definitely has a lot to offer. The prices were quite reasonable, well within the range of those of you out there who might balk at buying high-cost cosmetics in a department store. In my opinion, I think this would be well worth investigating. Oh yeah, and the makeover at the meeting was a terrific experience.

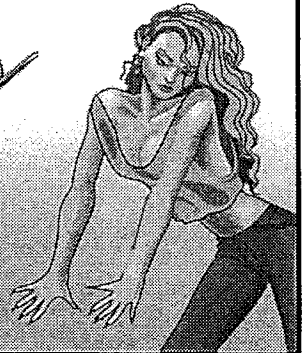
