FROM THE EDITOR ...

I'm Baaaack!...

I cannot begin to describe to you the feeling I got when I crested that rise on I-80, and caught that first glimpse of San Francisco, framed between the two bridges, far off across the shimmer of the Bay. I literally had this rush of goosebumps run up and down my body. I found myself whispering a silent

thank you to the Goddess, to my family, to my friends (those that I left behind, and those that awaited my arrival), for my safe and sound return home.

Home. As I write this, I've begun my search for an apartment in the City, so can't say I've got a permanent roof over my head yet, but it doesn't affect the feeling I have that I am back where I belong. And girl, it sure feels good!

The long drive (1,900+ miles), towing close to two tons of trailer and goods, with an eight-lunger Oldsmobile sedan not designed to haul such a load, started out precariously enough. Not three hours out of Janesville, MN the car lost power and began running extremely rough. I was lucky in that this occurred just as I was entering a town called Windom, MN. I found a garage that would take a look at it later that afternoon, but Al, the mechanic, said from the sound of the engine there was a lot of blowback through the carb happenin' and it could mean a bad valve or worse. Geez, just what I needed, right?

So I ended up losing a day's drive chilling out in a Super 8, while Al made his diagnosis. Late that afternoon we hooked up and he told me I was lucky – just a broken rocker arm, and that he could have me back on the road by checkout time the next morning. Right on, Al! I tipped him a twenty when he proved true to his word. But after that little setback, the car ran great and I cruised, coaxed, limped and pushed my beast of burden half way across the country in 5 days and 4 nights. All told, about 44 hours of actual on-the-road driving time. It was long, hot, boring and exhausting, with stops that Tuesday night in Kearny, Nebraska, Wednesday night in Rock Springs, Wyoming, and Thursday night in Reno, Nevada.

Average speed? Perhaps 40mph. There were many hours lost in climbing the grade up the Rockies from Nebraska, and that drive across upper Nevada had a couple of steep summits that found me on the right shoulder, in first gear, pedal to the metal and creeping upwards at 5mph. Those were the times when I could only grip the steering wheel and pray that the car wouldn't stall or stop altogether, because I knew if she did, we would go no further. But darn if that Delta 88 didn't pull that puppy over each and every crest, slowly but surely. I love that car.

Once the cat and I got settled in Reno with only one more hill to climb, I changed into a nice dress and caught a cab to the Silver Legacy Resort. I wanted to treat myself to a nice steak dinner and drop a couple twenties at slots. The fact that the "hill" I faced in the morning was the Sierras did give me some cause for concern, but for the moment I wanted to relax a bit, maybe get lucky and generally unwind after the day's 16-hour drive.

Ended up watching those 160 quarters disappear - oh well...worth a shot. But I made myself walk away and caught a taxi back to the motel, only to discover the cat was no longer in the room! I freaked of course – after all he and I have been through together, this was absolutely a disaster in the making. I discovered that the door didn't shut properly unless you pulled it really hard,

Well it is once again time to get the planning effort for the Cotillion in high gear. This year we are planning to have 4 days of events planned around the Cotillion effort. I am currently looking for a good hotel to use as the central meeting place and to reserve a block of rooms for

people who will be coming in from out of town. I was trying for the Hyatt Embarcadero because of the distinctively "San Francisco" views from many rooms but price may result in moving the host hotel up Market a bit. Just to give you an idea of what we had in mind, I thought I would give you an outline.

On the Thursday before the Cotillion, February 1st, we will have a reception suite at the host hotel for all the people coming into town to gather and socialize. The reception suite will open around 12:00 noon and feature light snacks and soft drinks. The main focus of the reception Suite is to socialize. Later that evening, starting around 8:00pm we will be having a show at Diva's that will feature a number of our very talented members. The show will last around 2 hours but participants can stay until the bar closes if they like.

The next day, Friday February 2nd, we will be running a tour to the wine country. At about 11am, all the people who have signed up for the wine tasting trip will board air-conditioned transportation (a small or large bus based on the number of people who want to go), and head for 3 to 5 wineries in Napa valley. We will be making advanced preparations for the group to visit up to 5 wineries and to have lunch at one of these stops. We will return to the host hotel in the early evening (6:30ish) to give people a chance to change for dinner. At around 8:30 the we will be taking the group to an area restaurant (right now the plan is to go to Asia SF) for dinner and then on to a club for dancing. The club I have in mind is one that Darcy told me about, it is at the top floor of a building and offers a view of the city.

On the day of the Cotillion, February 3rd, we will offer an early afternoon shopping trip to the San Francisco Shopping Center. The shopping excursion will last from 11am to 3pm and get people back to the hotel in plenty of time to get ready for the big event. The Cotillion will once again be held at the prestigious San Francisco Design Center Galleria.

The four days will end with a brunch in the host hotel. We would like to have all the contestants present at the brunch so the people from out of town have a chance to meet them. In fact, all contestants will be encouraged to attend any of the events that do not conflict with their rehearsal schedule.

As you can see there is a lot planned, so if you see something that you would like to do just let me know. We will need guides for most of the events. We may need some bus drivers, we could use some social coordinators for the reception suite and if someone would like to plan and execute the brunch we would certainly not object. What we would like to do is make an event which really takes advantage of the exceptional things San Francisco has to offer to the TG community.

ExCom Meeting Minutes

The monthly meeting of TGSF's Executive Committee was held in Berkeley at the Pacific Center on August 27, 2000 at 4:00 p.m. In attendance were President Nicole Cook, Vice President Aiyana Eveningstar, Treasurer Deborah, Outreach Co-Chair Kalani Makalani, Outreach Co-Chair Telzey Adams, and Education Co-Chair Stephanie Ann Blythe. Secretary Debbie Cook, Social Co-Chair Tianna DeVil and Social Co-Chair Serena Anderson were absent. Education Co-Chair Jennifer Antoinette arrived at the end of the Special Topics portion of the meeting. Roxanne, and Rachael Janelle were our guests. The meeting was called to order at 4:20 p.m.

President Nicole indicated that she had received the application for becoming an affiliate of the Renaissance organization, and reviewed the requirements with the ExCom. The requirements were that 3 members of TGSF also be members of Renaissance and there was a \$25 per year fee. Nicole mentioned that she was already a member and Telzey was also a member so we would like to find another member from the group. Nicole also mentioned that Renaissance provides affiliates with web hosting service or a link to your current web site.

Nicole also identified two topics that she wanted to bring up for the Special Topics portion of the meeting. They were 1) Working with other area TG groups on the Cotillion and 2) Endorsing or Supporting Joan Roughgarden for office.

Nicole also proposed that TGSF adopt a event repayment policy similar to SGA's for reimbursing Miss TGSF for the events she attends. The current Miss TGSF has been attending several additional events, this gives the group additional exposure and allows us to develop ties with other parts of the community. Just attending these events is a non-trivial commitment of time and frequently money on the part of the group's representative (Nicole made reference to her role as Miss SGA in attending events). Right now Miss TGSF only gets reimbursed for a few required events. The SGA method for handling this situation (which Nicole is proposing that we use) The "Miss" is reimbursed for up to \$500 worth of events as long as the funds are available. There was general agreement from the members present, however, No vote was taken because a quorum had not yet arrived (5 ExCom members were present). A vote is expected at the next ExCom on this issue.

Vice President: Aiyana went over the results of the first 2001 Cotillion planning meeting. We have selected the date, February 3rd 2001. Several of the initial volunteer positions have been filled but we can always use more help. As usual the Vice President Aiyana Eveningstar will be the producer for the Cotillion. Rachael Janelle will be handling advertising, Leslie and Lulu will be looking for Sponsors and Jamie Faye will be the Show Producer. Stephanie Ann has agreed to help organize the judging (we hope to have Cheryl working on this too), and with coordinating the volunteers for the day of the event and Dale has agreed to help with the music. Nicole and Debbie will be producing the four days of events surrounding the Cotillion and have also agreed to set up and maintain the 2001 Cotillion web page and produce the initial advertising material. The next Cotillion Planning meeting will be September 14th, 7:30pm at Aiyana's house. Jamie is currently trying to lock down the Director so we can identify the MC and the theme of the show, no word from her yet on this effort.

Rachael Janelle mentioned that Jo-Ann was very helpful ir. getting her started on the advertising effort. She plans to have advertising packets ready by the next ExCom meeting for people to hand out to potential advertisers. She is also looking for more material that will give her advertiser ideas. Nicole and Telzey agreed to get her a 2000 Pride Parade program for this purpose.

Secretary: In Debbie's absence, Nicole covered these areas. Nicole indicated that she forgot the correspondence and would mail any critical items to the appropriate person. Other items would be distributed at the next meeting.

Last month's meeting minutes were approved. (We have a Quorum now) $% \label{eq:constraint}$

Editor: Due to the early meeting the newsletter had not gone out yet. No change from the budget was expected. Nicole did have the proof copy with her & indicated the newsletter would go out with 1 or 2 inserts. One insert would be for the Dr. Preecha event. Nicole could not remember what the other insert was at the meeting (it was to solicit help from members in sponsoring rooms for the Cotillion, to allow us to reserve more rooms without additional risk to the TGSF bank account).

Publicist: No new report

Treasurer: Deborah shows a balance on TGSF's account as \$6,784.58. So far the TGSF computer has not been set up and Debbie has provided balance information based on the bank statements and known expenses for the newsletter. Deborah will be relocating to the Sacramento area, effective September 11th. She may not be available for events Monday through Thursday. Debbie will handle payments during these days. The ExCom did not see any problems with the relocation of the Treasurer. Nicole mentioned that due to Nicole & Debbie's frequent trips to Sacramento she did not think this would be a problem. Deborah planned to set up the TGSF computer in the new location.

Social Chair: In Tianna's absence, Nicole covered these topics. The August End of Month will be the show at Diva's. Nicole showed the TGSF Ad in the Sacramento Ducal Ball program that talked about the show. She pointed out the potential for more people attending since we had two court performers in the show. The September End of Month will be the joint education makeover seminar (RSVP) and Photo theme social. The Idea being to take pictures and to have people bring pictures to bridge the 1993-1998 gap in the organizations photo albums. The Halloween party is scheduled for October 21st at Diva's. We will be using all 4 floors (party open to everyone), with the costume contest happening on the 3rd floor. Diva's will be taking care of all the details including, insuring we do not lose money on the event, decorations and clean-up. We will also have a few members performing in the DIVA's show on the first floor at 11:30pm. Only snack food will be provided at the event. We will organize a dinner gathering at Quetzals (a block away, under the parking structure) at 7pm before the event. Nicole indicated that she was trying to move the event to the 28th because of the conflict with DVG's dinner, Carla's party and the Exotic Erotic ball, but this is unlikely due to venue availability.

Outreach Chair 1: Kalani discussed several speaking opportunities in September at the College of Notre Dame and one in Hayward. Roxanne and Deborah expressed an interest in some of these events. Nicole and Debbie would be doing a speaking engagement at Humboldt State in Arcata on October 19th. Kalani indicated she would be doing a new mailing to the school contacts next month. Kalani also indicated she was shooting for an October 14th or 15th date for a speaker orientation class at the Blue Muse.

Outreach Chair 2: Telzey asked Nicole about the calls Nicole & Debbie were getting on the hotline during their shift. There were some discussion about a few calls.

Education Chair 1: Stephanie Ann indicated that we are all set for the Seminar with Dr Preecha at the Women's center. We will be paying \$70/hour for 4 hours and there was a \$125 refundable security deposit. Telzey mentioned that someone phoned in on the hotline to ask if we are going to tape the seminar. They would not be able to make it but would like to see it on tape. Stephanie Ann indicated that she could provide a camera to tape the event. Stephanie Ann indicated that the flyers for the event have been distributed to several of the locations that the TG community visits. Nicole indicated that the flyer will go out in the September Newsletter. Stephanie Ann indicated that we could use some folding chairs or large projection screens, otherwise we will rent them. We are expecting around 100 participants and the Women's center has about 70 chairs in the main room. Jamie will be providing technical support for the event.

Stephanie Ann indicated that the Post op panel event may happen in October but she needs to coordinate with Kalani since she was looking at October 14th as a potential date. She was thinking of using a smaller room at the Women's center for this event.

Education Chair 2: Jennifer had not arrived yet.

Adjournment: At 5:18 p.m., Nicole makes a motion to close the meeting, Stephanie Ann seconded the motion, the motion was passed.

Next ExCom Meeting is on Sunday, October 1st, at 3:30 p.m. at the Pacific Center in Berkeley.

Special Topics Meeting: Nicole introduced two topics for discussion in the special topics meeting.

The first topic was to open the Cotillion to production participation by several area groups. Nicole discussed the possibilities of running the Cotillion as a joint effort by several area TG Groups. She has already talked to Dion (President of FTMI) and he was quite positive about the idea. This may result in calling the Cotillion "The San Francisco Transgender Cotillion - Brought to you by.. TGSF, FTMI, DVG etc". Nicole also introduced the idea of calling the "Mr" winner, "Mr. FTMI" if FTMI were willing to play a significant part in the production and support roles for the event. There was some discussion on making sure we did not have too many contestants and that we could do the show without running long. Some ideas to control the debutante parade were discussed. Nicole also introduced the idea of having DVG, RGA, SGA and other area groups to sponsor some of the events on the Thursday, Friday and Sunday around the Cotillion.

Glama-Rama! is proud to exhibit the art of the late Doris Fish and the late Miss Kitty Litter-Green, two of San Francisco's preeminent Drag pioneers.

When examining current drag and performance culture, it's important to look back to find out how we got here. In the 80's and 90's, San Francisco was a hotbed of creativity and inspiration. A new sense of alternative art and expression took hold of the LGBT community and lifted the tired old female-bashing stereotypes of drag and gave birth to a fresh highly stylized uber-femme representation. Out of this environment emerged a few who revolutionized the way that we approach drag and would forever leave their imprint on our art and history.

Doris Fish, primarily known as co-creator of "Vegas in Space", spent a great deal of her leisure time painting. Her bold use of color in her own drag persona can also be seen in her painting. Drawing from 60's Day-Glo style and classic film imagery, the visual impact of her art and drag was refreshing framed against the bearded drag queens of the time. This half of the exhibit was originally shown at GLBT Historical Society of Northern California earlier this year.

Another great visionary of our recent past is the incomparable Miss Kitty Litter-Green. Her bold art and drag still resonates in the performance art community today. Sometimes wearing nothing more than a ripped T-shirt and ballet tutu, she dared to test the boundaries of self-expression. She believed that beauty was an asymmetrical and sometimes surreal form with many facets showing different degrees of the self. Her paintings exemplify that same spirit and celebrate the colorful life that she lived while ushering in a reality that is at once arresting and seductive.

Both artists mostly used themselves as the main subject of their paintings and we get a sense that their life and art simultaneously imitated each other. Please join Glama-Rama! as we celebrate the lives of two very important drag pioneers whose legacy permeates our culture today.

ANNOUNCING THE TRANSGENDER Political Caucus

San Francisco, CA

The Transgender Political Caucus (TPC) is an all-volunteer organization committed to affecting change in San Francisco Bay Area politics. There are numerous groups already in existence which advocate for transgender civil rights at the State and National level, but few which focus exclusively on grassroots issues and candidates. The TPC has coordinators in each of the local regions, including the City and County of San Francisco, East Bay, North Bay and South Bay.

The TPC is an inclusive organization. Transgender, as defined by the San Francisco Human Rights Commission, includes "female and male cross-dressers, transvestites, drag queens or kings, female and male impersonators, intersexed individuals, pre-operative, post-operative and non-operative male-to-female and femaleto-male transsexuals, masculine females, feminine males, all persons whose perceived gender or anatomic sex may be incongruent with their gender expression, and all persons exhibiting characteristics and identities which are perceived to be androgynous."

It is the objective of the TPC to coalesce individuals, leaders and groups from all factions of the transgender community in the region into one voice. The organization will focus the energy, creativity and resources of its members on addressing transgenderspecific issues and help elect political candidates who are supportive of our basic rights as human beings. Membership in the TPC is open to all individuals who self-identify as transgender; family members, domestic partners or friends of transgender; as well as all others who are sympathetic to transgender issues. There are no costs to be a member of the TPC, merely a commitment to the basic human right of gender self-expression.

The TPC is not affiliated or aligned with any candidate, organization, political party or PAC. The TPC is not authorized nor does it intend to express the opinions or positions of any organization, club, political party, candidate or business with whom its members may be affiliated. The TPC is an independent voice of individuals in the transgender community.

The Charter Committee of the TPC is comprised of individuals who have distinguished themselves as leaders in the fight to improve our daily lives and represents a wide range of geographic, ethnic, racial, economic, social, age, educational, sexual and gender identities. There are no celebrities on the Charter Committee, all simply share the common bond of self-identifying as transgender.

The Charter Committee of the TPC is in the process of developing specific questions on fundamental issues impacting our lives. These include (trans)gender profiling, harassment and violence by law enforcement; discrimination in employment, public accommodations, housing, medical care and education; and, the current epidemic of transphobia, hate crimes and bias against the transgender population. These questions will then be submitted to candidates for public office in district elections in San Francisco and in other local races in the Bay Area.. The candidates will be asked to answer each question for the public record. These responses, or lack of responses, will then be forwarded to all members of the TPC and the media. The transgender community needs to insist that candidates to go on the public record with their positions on our issues. Now is the time for that to happen. Once candidate positions have been identified, the members of the TPC are encouraged to commit their time and resources to help elect those who are sympathetic to our issues.

An example of one such question might be: "Given that many private sector businesses in San Francisco openly discriminate against transgenders, would you support publicly funded educational, training, internship, public relations, outreach or other programs designed to educate employers on the transgender condition and actively promote legislation to integrate qualified transgenders into the mainstream workforce?"

If you want to be counted as a member of the TPC, simply send back a reply e-mail to Transgender PC @aol.com with the words "IM IN" in the subject box. Include the geographic region where you live, as in SF (San Francisco), EB (East Bay), SB (South Bay) or NB (North Bay). In San Francisco, also designate the district. For example: SUBJECT: IM IN SF8 or IM IN EB.

The Transgender Political Caucus needs your support, not your money. The larger the membership, the greater the impact. The TPC needs help. The TPC needs members. The TPC needs you. Now is the time for a unified transgender community to send a clear message to the political establishment that we are here; we vote; and we speak with one voice. We will no longer tolerate being ignored, abused or discriminated against. All citizens are guaranteed certain inalienable rights under the Constitution of the United States and we intend to continue to fight until ours are fully restored.

THE LEGISLATIVE BEAT

There were two bills before the California Legislature in the term that just ended that directly affect the Transgender Community. In addition, the lower house of the Netherlands Legislature recently approved a landmark law authorizing same-sex marriages.

Change of Birth Certificate

Assemblyman John Longville, a Democrat from Rialto, authored the first bill, AB 1851 It changes the existing law which permits a person born in California to obtain new birth certificate reflecting the change of gender and any change of name. Existing law requires that a petition for the issuance of a new birth certificate in those cases be filed with the superior court of the county where the petitioner resides. This bill also permits these petitions to be filed in the county where the petitioner was born.

It also establishes a new procedure for the issuance of a Certificate of Sex Change from the State Registrar to California residents who have resided in California for at least six months and do not have a California birth certificate. This procedure requires a petition in Superior Court similar to that for an amended California birth certificate. The cost of this certificate is set at \$20, subject to annual increases.

This bill passed both houses of the Legislature and was sent to the Governor for his approval. As of September 15 there was no indication on the Governor's Web Site about whether he had signed or vetoed the bill.

Discrimination in Housing and Employment

The second bill was authored by Assemblyman Fred Keeley of Boulder Creek. It would have provided that the definition of "sex" in the existing law banning discrimination in employment and housing would also include "gender." The definition of "gender" would mean a person's actual sex or the perception of the person's identity, appearance, or behavior, regardless of whether different from that traditionally associated with the victim's person's sex at birth. This definition is currently part of the law which provides for increased penalties for persons convicted of committing a "hate crime."

The bill passed the Assembly but died in the Senate Judiciary Committee.

Same-sex Marriage in Holland

A bill providing for same-sex marriage was approved by the lower house of the Netherlands legislature on September 12. According to an Associated Press article, "gay couples can convert their current 'registered same-sex partnerships' to full-fledged marriages, complete with wider adoption rights and guidelines for divorce." The law is restricted, however, to permanent residents of Holland, and adoptions must be within the country as well. According to the article, approval by the upper house is likely.

TG Candidate Running for SF Public Office!

An Interview with Joan Roughgarden

The following is an interview I did with Joan Roughgarden. Joan is a TG candidate running for public office in San Francisco. She is also a member of TGSF. We decided to do this interview to give Joan's candidacy some visibility in the TG community and to let our members who will have the opportunity to vote in Joan's area some background into Joan's stance on the issues. This interview was held on September 17th, 2000 at Joan's home in San Francisco's District 6.

(NC) What I did, is to try and come up with some questions to give people an idea of who you are, what's going on and if it effects them. Feel free to add in information. What are you running for?

(JR) I am running for Supervisor of District 6, this is one of 11 supervisors for San Francisco. This year is the first year since Harvey Milk was assassinated that the supervisors come from specified geographic districts. This represents an attempt to make the city more responsive to neighborhoods. District 6 includes: South of Market, the Tenderloin, part of the Mission district, Hayes Valley, South Beach and the Mission Bay Project under development. It also includes Treasure Island. On a per capita basis, it is the district with the lowest income & highest fraction of renters. Historically it has been a home for marginalized people, that's why I really love the potential of representing it. Transgendered people have been here for decades, gay and lesbian people and all kinds of minorities as well. We may have the largest Transgendered people in this district.

(NC) How many other candidates are running for the position of District 6 Supervisor?

(JR) Well there are 17 total candidates running for District 6. In some districts a single candidate is running unopposed, but there are 17 running for this position. I have a genuine chance.

(NC) Has your TG status been an issue in your campaign?

(JR) No, perhaps even surprisingly so, because I am not stealth, and I transitioned on the job, and it is known professionally that I am Transgendered.

(NC) You said you transitioned on the job, where were you working?

(JR) I am a Stanford University Professor. I have been interviewed by the New York Times for a profile in the Science Times, I am a Biologist. I am probably one of the most well known academics to have transitioned on the job. This would be profiled in the science times, and so my being Transgendered will be discussed in about 50% of that article.

(NC) Will that come out before the election?

(JR) Yes, that will come out in a few weeks. It is possible once that article comes out that my being Transgendered will become a factor. But up until now it has not been a factor at all, and that is partially because at least 50% of the candidates are gay or lesbian and one other is Transgendered. (NC) What do you think are the key issues for your district?

(JR) Displacement in housing is the single biggest issue. A number of us who are progressive are focusing on displacement and housing. My particular contribution is to try to plan for and stop the displacement that is in the pipeline. I feel that a lot of the candidates are fighting battles that have already been lost. If we see the causes of displacement that is going to

occur we can actually prevent it and do something about it. But the people who are complaining about dot coms for example and the displacement that they are causing are arguing about something that has already occurred. The real issue is to get ahead of displacement that we can see coming. I have been focusing on Mission Bay, pointing out that displacement is in the pipeline coming from that and arguing that we need to increase housing in that area and then down into the Bay View - Hunters Point area to pick up 20,000 more people.

The other major priority we have is to develop community facilities for District 6. We don't have playgrounds, we don't have much in the way of parks. So my idea has been to take piers 48 and 50 and to develop it as a plaza that I would call diversity plaza, and to put in a statue that would be the statue of diversity, which would be to the west coast what the statue of liberty is to the east coast. It's a great symbol and we would be able to attract national funding for it. We could then use the whole complex as a way to get community facilities. The idea of a statue of diversity really resonates in District 6, actually it might resonate in the whole country too.

(NC) This sort of leads into my next question, What would you do different from the incumbent to address the key issues?

(JR) Well there is no incumbent. This is one of the interesting things about District 6, it has never really been represented. It will be new to have these neighborhoods have a voice in City Hall. And what I would do differently than the other candidates, is to foresee what's happening a bit better. I bring a different skill set to the table, I am an ecologist. I am use to working with systems. I would bring a systems perspective into city government.

(NC) Do you have any planned campaign events?

(JR) No, I probably should. I have mostly been going to neighborhood events that exist. I haven't planned rallies. There have already been three debates and there are also the candidate forums which are essentially debates which various groups organize. That's what I feel that the Transgendered community could do, is to have a candidate forum. It would probably be the most effective to put on a forum, and to circulate the questions that you want the candidates to address in advance. Have a moderator, and they would all sit there and answer the questions. BE CAREFUL OUT THERE!

When we go out in public as women, we lose many privileges that we have as men. We face the same threats that women have had to deal with all of their lives. As transgendered individuals we face potential threats of hate crimes as well. In addition, when we are wearing dresses and heels we do not have the option of fleeing potential threats as easily.

I have learned many of these lessons personally. While I was in a bar with friends in Reno, a man groped me in the rear. More recently a man groped me in front while I was leaving *Diva's*, where *TGSF* now meets. Even in supposedly "safe" venues men have approached and asked me to perform sexual acts with them.

One night when I was walking home from the bus stop a man pulled his car over in front of me and tried to pick me up. This has happened to me often since. In a neighborhood that I considered "safe" a man once tried to snatch my purse.

Also, one of a group of men attacked a friend of mine in a convenience store of men simply for being a transsexual.

Julie Freeman, the spouse of Donna Freeman, the leader of Diablo Valley Girls, expressed her concern in an article posted on the TG Forum web site (www.tgforum.com).

I found myself admiring those wives and significant others who had no problem venturing out at night with their crossdressed spouses. I could not help wondering what would happen if they ran across someone not so understanding about alternative lifestyles, someone like those individuals that Matthew Shepard encountered. Fear then and now has always been a factor in my behavior.

What can be done to protect our safety while out in public? Many answers are the same common sense that we employ in our daily lives.

First, do not go to places that you consider unsafe or uncomfortable! This is especially true at night. Second, do not do anything to escalate verbal confrontations. The best thing to do when they arise is to ignore the taunts and to leave. Third, make it clear to any man who is trying to pick you up that you are not interested.

There are many viewpoints on how to defend yourself if you are attacked or are threatened physically. Some people advocate carrying guns, knives, or other deadly weapons. I do not.

Once, while dressed as a man, I warded off an attack by a young man brandishing a two-by-four at me by displaying a small knife that I was carrying. I ended up handcuffed in the back of a police car for a while. Fortunately, that incident was captured on a security video, and the police accepted my account. Remember that police, and ultimately prosecutors, judges, and juries, may be called on to judge your actions.

Police recommend that one carry pepper spray in places where that is legal. Formerly in California one had to attend a special class and obtain a permit to carry mace. The store where you purchased it was also required to register each purchase with your local police department. Currently in California pepper spray is available over the counter at many stores. Bear in mind, however, that it is still illegal to bring pepper spray into the secure area of airports, onto aircraft, or into many government buildings. Likewise it is still illegal in certain states, and cannot be carried across international borders.

Just having pepper spray in one's purse is of no benefit. If you are walking alone, especially at night, it has to be in your hand ready to use. Another useful item to have readily accessible is a police whistle to attract attention.

There is no guarantee of safety in public, no matter how we are dressed. We have to be continually on our guard, and be prepared to take the necessary steps to protect ourselves.

Lesbians' plans to wed look legal BEXAR COUNTY RULING COULD PAVE WAY FOR TRIP DOWN AISLE

A lesbian couple from Houston plans to legally marry in Texas next month, a prospect that has stymied the Texas Christian Coalition and its social conservative allies. Next Wednesday, Robin Wicks and Jessica Wicks plan to travel to San Antonio, said their attorney, where the county clerk promises to grant the two women a marriage license. It would be the state's first legal recognition of a lesbian marriage, and it is made legal because one of the women used to be a man.

Robin Wicks was born a female, Robin Manhart. Jessica Wicks was born a male, Grady Roland Wicks, and had a sex-change operation. Robin legally changed her name to Wicks because of their love for each other and their desire to wed. The two women declined to be interviewed but agreed to be photographed and have referred all questions to their attorney, Phyllis Randolph Frye. Bexar County Clerk Gerard C. Rickoff confirmed he will grant the women a license. He cited a San Antonio appeals court ruling that determined, as he put it, "you are what you are by your creator."

The two women were turned down in Harris County three weeks ago, when the Houston clerk cited the Texas Family Code's prohibition against same-sex marriages. The appeals court decision in San Antonio, however, gave Frye the idea to go there to seek the license. Now, the couple are happily planning a Sept. 16 wedding.

In a different gender case last year, the 4th Court of Appeals in San Antonio ruled in a wrongful death medical malpractice suit filed by a widow. That court ruling blocked the suit by negating the widow's seven-year marriage to the deceased man. The court ruled that the widow, Christie Lee Cavazos Littleton, who had undergone a sex-change operation, had been born a man and therefore the marriage wasn't legal. The court said sex is determined by chromosomes, not by medically induced genital alterations.

Even the Texas Legislature's staunchest opponent of samesex marriage says he sees no legal impediments to the marriage of Robin and Jessica Wicks. "What a twisted world we live in," said state Rep. Warren Chisum, R-Pampa. "I agree that gender is based on chromosomes, so I think that would set precedent, and I can't disagree with that. I don't know anything legislatively you can do about that. You strike up the most bizarre situation in the world, and the law's not always able to contend with it."

Attorney Frye, a transsexual herself, said that if chromosomes matter but genitals don't, the court has cleared the way for samesex marriages involving partnerships in which one person was born a male and the other a female. "We are trying to point out how stupid the Littleton ruling was," said Frye, who represented the appeal of Christie Littleton, who lives in San Antonio. Frye said the Texas Supreme Court has twice refused to consider the arguments in that case, but the U.S. Supreme Court will decide in September whether or not to hear it.

"We're making it an issue with this (Wicks) marriage because the conservatives thought, with the Littleton decision, the prevention of same-sex marriage was secure," Frye said. "We're going to start encouraging all the transgendered people in the state who are in gay and lesbian relationships to take advantage of the Littleton decision and start seeking marriage licenses."

COURT GRANTS ASYLUM TO MAN PERSECUTED IN MEXICO

After a five-year legal battle, the U. S. Court of Appeals in San Francisco overturned a ruling of the Immigration and Naturalization Service, and granted political asylum to Geovanni Hernandez-Montiel. The three-judge court panel unanimously decided as a matter of law that gay men with female sexual identities in Mexico constitute a particular social group, and that Geovanni is a member of that group. The court, however did not rule on whether Geovanni is a transsexual, or whether transsexuals would also constitute a particular social group.

In deciding whether Geovanni qualified for asylum from his native Mexico, the examiner from the INS had initially found that Geovanni had failed to demonstrate persecution on account of a particular social group, classifying his social group as homosexual males who wish to dress as a woman [sic.] and that his decision to dress as a women [sic] is volitional, not immutable, and the fact that he sometimes dresses like a typical man reflects that respondent himself may not view his dress as being so fundamental to his identity that he should not have to change it. The court, however, rejected this, and held that Sexual orientation and sexual identity are immutable; they are so fundamental to one's identity that a person should not be required to abandon them.

According to the court's written opinion, an alien establishes refugee status if he is unable or unwilling to return to his country of nationality either because: (1) he was persecuted in the past; or (2) he has a well-founded fear of future persecution on account of race, religion, nationality, membership in a particular social group, or political opinion.

Professor Davies specifically noted that Geovanni is a homosexual who has taken on a primarily female sexual role. Based on his expert knowledge, review of Geovanni's case, and interaction with Geovanni, Professor Davies opined that Geovanni would face persecution if he were forced to return to Mexico.

This case has received international attention from the media. Geovanni's attorney is Robert S. Gerber, a partner in the firm Sheppard, Mullin, Richter & Hampton, LLP, which has offices in San Francisco, Los Angeles, Orange County, as well as San Diego, where Mr. Gerber is based. In a radio interview on the BBC World Service program *Outlook* Mr. Gerber said that he was pleased with the decision, but reserved since the case could be appealed further. However, he felt that since the panel included two conservative Reagan-appointed judges that the INS was unlikely to receive a warmer reception in any petition for rehearing to the Ninth Circuit or petition for writ of certiorari to the United States Supreme Court.

His attorney told of how Geovanni had realized that he was attracted to the same sex at age eight, and how at age 12 he began dressing as a woman. He was expelled from his elementary school, and pushed away by his parents. His sister committed him to a special home to be "cured," where his long hair was cut, his nails were trimmed, and he was forced to wear men's clothing.

In Mexico he had been arrested and detained by police four or five times, without being charged with a crime, and stated that twice he had been raped by the police. He also stated that was also attacked with a knife by a mob of gay-bashers. According to his attorney, he is not really a transvestite but more of a transsexual, and is undergoing hormone treatments.

A representative of the INS stated that this case is now a precedent for other asylum applications.

(NC) How do you see the position that you are running for as being able to effect the welfare of the TG community?

(JR) There are several things. The board of supervisors is sort of like a legislative body. As compared to the mayor which is an Executive body. We initiate legislation, and we are responsible for passing the budget, and we also pass resolutions. The supervisors can actually direct the department heads. Because of passing resolutions, you can make public statements that get picked up in the newspaper. So we could as a matter of legislation, make sure that the schools and the police did not act in discriminatory ways to Transgendered people. We could pass resolutions to the effect that Transgendered people need to be correctly represented in the media, we can also pass resolutions that point out the good things that Transgendered people bring to the table. We bring a lot of different experience, and one of the things I like to say is "we have a heightened sense of what's possible". Anyone that has been through what we have been through thinks that solving the city's problems is a piece of cake.

(NC) Are you planning on being on TV or Radio ? Is there somewhere if someone reads this article where they could listen to you?

(JR) Well I am turning up at all these community forums. A person whose stage name is Kitty Castro is going to interviewing both Denise and me on local television. I would love to make more television appearances but more to the point I will simply go and meet with people. Whenever 2 or 3 are gathered together, I will turn up, if they want me.

(NC) Are there any other topics you would like to cover?

(JR) I would like to say that I want to work to get Transgendered surgeries like SRS included in the medical coverage for both city employees and for the employees of companies that contract with the city. I think we are at a point where this should be done.

(NC) If you met a influential constituent in an elevator and had less than a minute to tell her why she should vote for you, what would you say?

(JR) The reason you should vote for me is that I am committed to neighborhood, and I am committed to diversity, and I bring new skills to city hall. I'm centrist, I'm pragmatic and I can really deliver on neighborhood and on diversity.

Dianne Hardy-Garcia, executive director of the Lesbian-Gay Rights Lobby of Texas, said the Wicks marriage breaks new ground not only in Texas but also, apparently, nationally. "This is really new, and I don't know of any other case," she said. "Certainly Phyllis Frye out of Houston has been at the cutting edge of transgender activism for many years. Texas has one of the most outspoken transgender communities in the nation."

Rep. Glen Maxey, D-Austin, the only openly gay member of the Texas Legislature, said the unusual case in Houston shows exactly why government should not be getting involved in the private lives of its citizens. "Because government got involved in something they should have never gotten involved with," he said, "you have these absurdities and seeming irrationalities."

On this point, the Texas Christian Coalition appears to agree.

Although the group believes in the sanctity of the male-female marriage, the Wicks situation boggles the mind, said Chuck Anderson, the coalition's executive director. "Leave it to lawyers to come up with all these situations," he said. "It's creepy. I don't think anyone could even speculate in their wildest dreams that this could come about."

Great news. Two more women sought a legal same-sex marriage license in San Antonio. I was not even aware of it and was called yesterday by the reporter. The story and my comments are below.

2 More Women Obtain County Marriage License By John Gutierrez-Mier Dexpress-news.net)

For the second time in two weeks, the Bexar County clerk's office Wednesday issued a marriage license to two women. The couple, who reside in Corrales, N.M., presented County Clerk Gerry Rickhoff with two Ohio drivers' licenses that identified both as female.

But one of the two, Lori D. Killough, 63, had changed her sex through a surgical procedure and was able to present a birth certificate showing she was born a man. And that makes her legally a man in the 32 Texas counties covered by the state's 4th Court of Appeals, whose year-old ruling that one's sex at birth determines one's sex for life continues to reverberate nationwide.

Rickhoff said he was stunned when Killough and her partner, Cynthia J. Young, 51, walked into his office and requested the license, but he readily granted it. "I had only seen my first case a few weeks ago, and I didn't expect another couple wanting a license this soon," Rickhoff said. Just 14 days earlier he had issued a license to Jessica Wicks and Robin Manhart Wicks of Houston.

Each couple based their request on an appeals court decision that rejected a wrongful death lawsuit filed by a San Antonio transsexual, Christy Lee Littleton, against Dr. Mark Prang, whom she accused of malpractice in the death of her husband. The 4th Court of Appeals, by a 2-1 vote, ruled that Littleton had never been legally married because she was born male and thus had no standing to sue. The case has been appealed to the U.S. Supreme Court. Attempts to reach Killough and Young for comment were unsuccessful.

The law requires a 72-hour waiting period after a license is issued before couples can actually marry. After the period is up, couples have 30 days to get married by a justice of the peace or judge or a clergy member.

Phyllis Frye, a Houston lawyer who represented Littleton and the Wicks, said she knew nothing about the New Mexico couple. "I was unaware that this had happened, but I'm glad they did it," said Frye, who is e-mailing transsexuals across the country, encouraging them to come to San Antonio to get married. "I think this is great."

Rickhoff said he couldn't predict how many more same-sex couples would seek marriage licenses, but if they are legally male and female, he said, they will be treated like any other couple that come to his office.
