LETTER FROM THE MID-ATLANTIC REGION . . . . .

Dearest Friend,

The cross genderest as a human being is subject to the same weaknesses and problems as any other human being. This burden is enough. To subject this person to an ordeal of self guilt combined with social persecution because of gross genderal behavior is an unwarranted cruelty. This is especially true when it is well known that this natural behavior pattern has existed in human society at all times and in all cultures.

As cross genderests, who have watched "Posom Buddies" or "M.A.S.H." one night and heard horror stories from real life about our dearest friends the next, we feel that the time has come to do something constructive about improving our condition in life.

The recent successes of the homophile movement in proving that to be gay is to be simply human has caused us to start an effort through the Harry Benjamin International Gender Dysphoria Association to present the case for the cross genderests. Therefore, on March 7th, Michelle Williams, Betty Ann Lind, Glenda Jones, and Ariadne Kane framed a resolution and presented it to the 7th International Gender Dysphoria Association Conference. The signatures represent a cross section of the association: surgeons, psychiatrists, psychologists, social workers, and various leaders of the paraculture of cross genderests. It was passed unanimously:

R E S O L U T I O N

WE THE UNDERSIGNED MEMBERS OF THE HARRY BENJAMIN INTERNATIONAL GENDER DYSPHORIA ASSOCIATION PROPOSE, AS AN ITEM OF NEW BUSINESS, THE FOLLOWING STATEMENT OF PURPOSE WHICH UPON FUTURE DISCUSSION WILL SERVE AS A PRINCIPAL POSITION OF THE ASSOCIATION BEFORE OTHER PROFESSIONAL SOCIETIES:

"The desire to emulate the behavior of the opposite gender/sex in dress, modes of behavior activities, and the like is a transcultural transtemporal phenomenon. As such, it must be regarded as a natural variant of human behavior which in and of itself is not an illness or psychiatric disorder."

WE HEREBY MOVE THAT A COMMITTEE WITHIN THE ASSOCIATION BE APPOINTED TO STUDY THE ABOVE AND TO FORMULATE A STATEMENT OF POSITION FOR THE ASSOCIATION AT ITS NEXT REGULAR MEETING.
