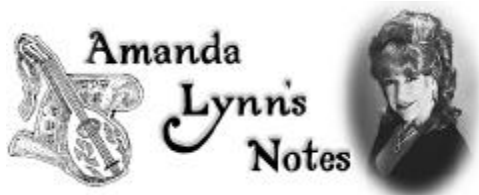

## Feminine Boy Shakes Up Small School

CARROLLTON, Ga. (AP) -- Patrick Nelson had heard there was a cross-dressing boy enrolled at his high school. But darned if he could figure out just who it was.

"I looked for him the first couple weeks. The honest truth -- I didn't even know," Patrick said.

One day, he was talking about the mystery to a friend, who smiled and pointed to the pretty blonde at the desk next to his.

"I said, 'No way, that's too weird!'" Patrick recalled. "Then I thought about it, and I said, 'So what's so weird about that?'"

But while Patrick and his friends were willing to accept Matthew "Alex" McLendon's feminine appearance and mannerisms, others in this rural, conservative western Georgia community of about 20,000 weren't.

And so 15-year-old Alex withdrew from school under pressure, leaving supporters of the popular, easygoing student wondering what threat they had supposedly been protected from.

"Alex wasn't causing any problems. She got along well with everybody," said classmate and friend Meayghan Denkers. "She wasn't trying to change anybody to be like her or anything."

After a heated meeting of the board of the small, private Georgian Country Day School on Oct. 6, Alex was "invited to withdraw" or face expulsion. Alex, who had enrolled in September after attending public school, was cited for wearing a tongue ring, but had been called before school authorities earlier about his female dress, makeup and hairstyle.

Most of Alex's classmates -- including some of the boys -- wore bows in their hair in protest until ordered to remove them by the principal. Some indignantly quoted their school handbook, which urges acceptance of "diversity in opinion, culture, ideas, behavioral characteristics, attributes or challenges."

"Alex represents something that's way beyond the experience and the comfort zone of the very conservative people we live with," said Lori Lipoma, Meayghan's mother and a drama teacher at the school. "I really think we all lost something very precious that night."

School officials would not discuss the case.

"We make no comments on students," said Rex Camp, chairman of the board of the school, where tuition is more than \$5,000 a year for the 50 or so high school students. Kindergarten and elementary students are in a separate building, but one parent of a 6-year-old expressed concern at the board meeting about Alex's effect on younger children.

## Proposed Amendment to Chi Chapter By Laws.

The following amendment was voted on by the Chi Chapter board and presented in writing to the membership on June 19th, pursuant to ARTICLE VII, SECTION 1 of the Chi Chapter ByLaws. Ratification by the membership will take place on August 21st.

**All Changes are in bold/underlined type.**

\*\*\*\*\*

### ARTICLE V

#### SECTION 2

**ADD: C. The Board of Directors shall be responsible for adopting rules and procedures governing the operation of the chapter, which rules and procedures shall be published from time to time in the newsletter. Any rules or procedures considered by the Board shall require a majority vote of the membership for adoption or repeal.**

**D. The board of directors is responsible for establishing committees and appointing committee heads as needed.**

### ARTICLE VI- MEMBERSHIP

ADD:

#### Section 4 - Application

**A. All persons seeking membership in Chi Chapter shall submit an application to the chapter. The confidentiality of application information shall be governed by Article XII.**

**B. Membership applications shall be accompanied by payment of National and Chapter dues for the calendar year at the time of submission.**

**All applicants must be accepted as a National member prior to finalization of Chapter membership.**

**C. All applications are subject to review by the Board of Directors to insure compliance with National and Chapter By-Laws. If a Board member believes an application or applicant to be ineligible for Chapter membership due to non-compliance with National or Chapter By-Laws, said Board member shall notify the President and the matter shall be presented as an agenda item for review at the next scheduled Board meeting. The applicant shall be entitled to present evidence and witnesses showing compliance.**

**D. Membership applications submitted for Board review shall require a majority vote of the quorum of directors present for acceptance.**

**E. Any rejected applicant may reapply after six months. Dues shall be promptly refunded to any rejected applicant.**

### ARTICLE IX - ELECTIONS

#### SECTION 2- Ballots and Campaigning

#### **REMOVE:**

**C. Members must be present at the November Saturday night meeting to vote, or present at the October meeting to obtain an absentee ballot..**

ADD:

**ADD: C. Members must be present at the November Saturday night meeting to vote, or have previously requested an absentee ballot..**

NOTE:(Deletes requirement to be present, in person, at the October meeting to obtain an absentee ballot.

### ARTICLE III - CODE OF CONDUCT

ADD:

#### SECTION 5 - VENDORS

**A: Vendor is defined as anyone, a member of the chapter or not, who advertises in the Chapter Newsletter and/or attends chapter meetings and/or events for the purpose of sales of products or services to our members.**

**B. Vendors must submit a completed code of conduct agreement to the board of directors, and receive their approval prior to advertising and or attending meetings, events.**

**C. Code of conduct form utilized must be approved by the Board of Directors and completed copies of same may be distributed to other groups as stated on the agreement.**

**D. Vendor need only complete one Code of Conduct Agreement. If the vendor has signed the agreement with another group, a signed copy of the agreement, which was submitted to the other group, is acceptable. This Code of Conduct Agreement will be acceptable by all participating member groups of the Great Lakes Council of Gender Groups.**

### ARTICLE XIV - DISCIPLINARY PROCEDURES

#### SECTION 3- EXPULSION FROM CHAPTER

**5. Any member expelled shall no longer be afforded any rights or privileges of members or guests of members and shall not be allowed to attend any Chapter sponsored events unless such event is co-sponsored with another organization and the individual is attending as a member of the co-sponsoring organization. Further all written material shall be immediately terminated to this individual.**

"I believe in sexual standards in society, and I want my child in a school that holds the same sexual ethics that I do," said Craig Neal.

Alex, who speaks in a soft, feminine voice, began cross-dressing two years ago and considers himself "95 percent girl."

Larry Harmon, a Dade County, Fla., psychologist who counsels patients on sexual identity, said such feelings appear to fit a rare condition called gender-identity disorder. He said it doesn't necessarily imply homosexuality, and it's difficult to know how many youngsters have it and why.

"I'm not homosexual," Alex said. "I just look like a girl and I dress like a girl. It wasn't anything flamboyant, not sequins or anything. But because I'm a guy."

He has since enrolled in night school and hopes to pursue a career in fashion merchandising and modeling.

At the Georgian Country Day School -- where Alex said he enrolled to get a better education -- he struck up a friendship with Meayghan and was soon invited to spend nights over at her house. The first couple of times, Meayghan's mother popped in on them unannounced just in case.

"They'd be sitting there doing hair, or painting nails, and I said to myself, 'This is a girl,'" Ms. Lipoma said.

A few weeks into the school year, he and his father were summoned to a meeting with school officials. They said that parents had complained, and that he had to dress like a boy, Alex recalled. He refused and was sent home. A special board meeting followed.

Under the law, a public school would have had to show that Alex was disrupting education or undermining safety. A private school has more leeway.

Alex's mother died when he was young. He said that his cross-dressing initially caused a rift with his father, but that the older man stood with him in the dispute with the board. Mack McLendon declined an interview.

"School is supposed to be preparing you for life," Alex said. "Parents are trying to protect their kids by covering their eyes. It's going to be a real shock for some of these parents when their kids get out into the real world."

mortgage etc. In an announcement on March 25th they declared that "Our primary concern is the protection of the American Public." "The changes close a loophole...by strengthen the private mailbox ID procedures and .... maintenance of ongoing customer lists."

Well, as you can see, this will be a problem for some of you. I would recommend a regular PO Box, they are less intrusive and additional names (Fem) may normally be added with no problem or ID. You may also use UPS or Fed-Ex delivery to a "Mail Box" street location...they don't come under post office regulations and they don't inspect your mail. Check with your local store regarding setting up a 'UPS only' account. It will cost a little more but keeps your mail private.

Effective October 24, any mail addressed to a private mail box which has the prefix APT STE or no PMB prefix will be returned to sender. A separate flyer will be enclosed with this newsletter if we believe that you may be effected by this rule.

Now, in defense of the USPS I must mention, if the Post Office wasn't a quasi government agency, it would have been broken up as a monopoly many years ago. Ala AT&T.

Lest we forget the havoc caused by that little move and the high cost of phone calls and the mess that made, we do have it easy in the service and cost of mail delivery.

Now, what about that proposed USPS tax on each and every E-Mail message which you send on the internet???????

Don't worry, they announced that it was never considered and they do not intend to consider it.

Yeah, I remember Ameritech, a few years back, when they sent out a letter saying that they have not considered nor would they ever, in the foreseeable future, change the area code of a local area. A week later Ameritech announced that they were changing area codes in that area...

Joking aside, Unfortunately this will impact many crossdressers. it may put many of them back in the small closet and they will have no contact with the outside CD world.
