1994 IFGE CONVENTION - Winnie [REDACTED]

This year's IFGE Convention was held at the Hilton Hotel in Portland, Oregon on March 12-20, and was co-hosted by the Northwest Gender Alliance (NWGA) of Portland and Emerald City of Seattle. I flew out on Saturday, 3/12 and arrived on time; unlike the obstacles I faced in getting to the Texas "T"-Party last month, the weather cooperated this time. After checking in with my friend and room-mate Linda [REDACTED] from New Hampshire and changing, we joined a group for dinner at an oyster bar in downtown Portland, followed by a nightcap at the Hilton.

The next day, a lesbian friend who last year moved from New England to the Northwest paid us a visit; we spent the afternoon walking around the "Saturday Market" in Portland (even though it was Sunday!). That evening, we got together in a group and drove to The Chart House for dinner; this is a first-rate steak house located on a hillside with a panoramic view of the city, which looked impressive at night.

On Monday, I went on a sightseeing tour organized by the host groups. Nine of us boarded the van driven by our tour guide Burdran, who provided a snack of coffee and muffins by the roadside on the way. While there was green grass in the valley, there was plenty of snow on Mount Hood,

where we dropped off five to go skiing at Timberline Lodge at the 6,000 foot level. The lodge was built by the WPA during the Depression, and is of impressive stone construction with much hand-carved wood decoration inside.

Leaving the high ground, the remaining four of us headed for the Columbia River and lunch in the Dalles. We saw parts of the last hurdles on the Oregon Trail, where the pioneers had the choice of either clambering over the mountains or braving the Cascade rapids on the river; in either case, their wagons were a problem. We stopped by an old lock, that first bypassed the rapids, and then by the Bonneville Dam which has now tamed the river. After visiting a fish hatchery, we headed back up Mount Hood to pick up the skiers just before dusk.

Before leaving Timberline Lodge, we climbed the stairs to the third floor, which was high enough to reach above the snow banks, and had a drink or two at the Ramshead Bar. Three of the skiers were novices, and reported that the instructors and lift operators were much amused by their antics. Linda Buten had to learn how not to poke off her wig with her pole as she fell on her fanny-pads, which got soaked! On the way back, we all stopped at the Zig Zig Inn for dinner, then went to bed early that night.

On Tuesday morning, I sat in on the IFGE Board meeting for a while. In the afternoon, Linda [redacted] and I took a cab to see Patti, a beautiful tall blonde and our favorite hairdresser, who was on the staff at DREAM, from 1973-83. The cab driver was recently from Iran, and had to call Patti for directions to her place in the suburbs! It was so good to see her again, and we reminisced as Patti gave me a perm. Then, Marilyn, who had organized DREAM, showed up to deliver her wigs for Patti's styling, and we met Ashley, a CD friend of Patti. Marilyn gave us a ride back to the hotel, three of us in the front seat, since the back was crammed full of her things!

The major business of the convention started on Wednesday, with an official welcome and a presentation of *Vision 2000* by the IFGE Strategic Planning Committee - there was a brief discussion of this at a TGIC meeting in January. To carry out the plan, IFGE needs the support of all of us. This was followed by a luncheon, with Linda Peacock the keynote speaker.

In the afternoon, Linda Jean introduced me to her brother, just arrived from Phoenix, Arizona, who she had not seen in many years, and wishes to follow her into sisterhood. Unfortunately, he was called home on an emergency and had to leave the next day; Linda followed on Friday and I did not see her again until we linked up at the Chicago Airport on the way back.

Wednesday night there was a buffet dinner and the presentation of the six **Trinity Awards**, given this year to: **JoAnn Roberts** and **Alison Laing**, both very active in Renaissance and other organizations; from Seattle there was **Marilyn [redacted]** who gave us her DREAM and **Marsha [redacted]** who has assisted many through the Ingersoll Center; **Ginny [redacted]** (the S.O. of Nancy Ann [redacted] who has devoted her love to ETVC in San Francisco; and **Wendy [redacted]** of Los Angeles, who is the Mark Russell of Genderland. **Jennifer [redacted]** served as Mistress of Ceremonies and sang a couple of numbers in her own voice; she is very talented.

The Annual Meeting of the Congress of Transgendered Organizations took place on Thursday morning. TGIC is a member and I am your representative, mainly because few from our Club go to the Convention, and they are busy with other matters. The Congress passed a resolution on health care (see elsewhere in this newsletter) and resolved to support and endorse the **Stonewall 25 March and Rally** on June 26, 1994 in New York City. This is the 25th Anniversary of the Stonewall Rebellion in which gays, including many crossdressed, fought back against the police ejecting them from a tavern. However, note that many in our community cannot whole-heartedly

support **Stonewall 25** because they do not specifically include "Transgendered" in the title of the March.

In other business, the Congress heard reports of Regional Coalitions in several parts of the U.S.A. A few years ago, TGIC, EON, the CD Network and other groups in upstate NY attempted to form such a coalition, and supported the "Autumn Accord" in Syracuse for two years. Further progress floundered because of lack of people to do the necessary work. If any members of TGIC would like to try again, please let me know.

Also, Renaissance announced the signing of an agreement to raise funds for a transgender film project, requiring between \$250,000 and \$500,000 in grants and donations, which will be tax deductible according to 501(c)(3) rules. The project was endorsed by the CTO, and we will hear more of this later. A new slate of CTO officers was elected, Anne [redacted] replacing Alison Laing in the Chair. Melissa [redacted] was designated IFGE Rep. to the CTO.

On Thursday afternoon, I chaired the meeting of the IFGE Nominations & Awards Committee, including the Selections Academy. Together, these groups are responsible for conducting elections to the IFGE Board of Directors and selection of the Trinity and Virginia Prince Award winners. We passed several resolutions aimed at clarifying and improving the election process, and I spent much of Friday afternoon preparing a report for the Board of Directors. At the Board meeting on Saturday, a board member presented our proposals in a formal resolution. Unfortunately, there were conflicts with the recommendations of the Strategic Planning Committee, and the resolution did not pass. So, I will be busy in the next few months negotiating a compromise. But I can assure everyone that the elections have been and will be fair.

For me, the DREAM Reunion on Thursday night was the highlight of the Convention. I attended all seven DREAMs, beginning in 1973 and ending in 1983; see my article in

The Transgenderist, Nov/Dec 1993, or in *Tapestry* #67. It was great to hug Marilyn [redacted] Glorea [redacted] Patti and other old friends again. It was fun to reminisce and look through the albums of old photographs and see the fading Kodachrome slides projected on the screen. How young we all looked 20 years ago! There was one guy at the reunion who I did not recognize at first: he was Renee, who rode a motorcycle all the way from Phoenix, Arizona to Oregon for DREAM, with feminine clothes rolled GI-style and stuffed into saddle bags; but what a beautiful transformation he made after arrival and Patti's taming of his long, blonde hair!

The reunion event was organized by Jennifer [redacted], who also served as Mistress of Ceremonies; what a splendid job she did! Jennifer, then of Portland, performed a duet with me at the 1983 DREAM; she now lives in St. Louis and is still a dynamo. We released balloons with thoughts for those who could not come to the reunion, and especially for some who are no longer of this world.

On Friday, I said goodbye to my room-mate and went to the Keynote Luncheon, where Phyllis Randolph Frye spoke on political and legal issues; she is chief mover and shaker of the Transgender Law Conference, to be repeated in Houston, TX this year for the third time. This is of interest to all who wish to assert the rights of transgendered people, and not only to lawyers.

Friday evening was "A Night of ESPRIT", another fun time produced by the host organizations that sponsor the annual ESPRIT event in Port Angeles, WA. There was an hospitality hour with Mexican buffet, followed by a Casino Night, and ending with a Pajama Party back in the host suite. At the Casino, I managed to win enough play money at Roulette and Black Jack to make the winning bid on a beautiful nightie at the final auction.

The second session of the IFGE Board of Directors meeting took place on Saturday. I sat in to listen to some of the proceedings,

which ran smoothly and effectively under the guidance of Linda [redacted] as Chair and Sharon Ann [redacted] as Vice-Chair and Parliamentarian. Sharon is a member of TGIC and also leads our local Tri-Ess group. She must have memorized Robert's Rules of Order, and no one challenged her decisions on these matters. As mentioned above, I was involved as Chair of the N&A Committee. In between all these meetings, I found time to attend some of the very interesting seminars taking place throughout the week.

Saturday night highlighted the week with the Virginia Prince Award Reception and Banquet. This year honored Ellen [redacted] in her home town of Portland. Ellen is a long-time member of Tri-Ess and a co-founder of NWGA, and has held offices in both groups. I first met Ellen many years ago, at one of the DREAM events, when she introduced me to the fun places to go in Portland. She is an IFGE Director and was host Chair for this 1994 Convention. In 1991, she received a Trinity Award. For the evening's celebration, Wendy [redacted] was Mistress of Ceremonies, beginning with a recap of the previous V.P. Award winners. The ceremonies were lightened with a number of skits performed by the *Drama Queens*, Sabrina and Callan (AKA Paul).

After finishing my roll of film, I returned to my room and packed my bags, ready to get up early on Sunday morning and catch a 10 am flight home. So, I missed the final wind-down and passing of the ball to next year's convention hosts, who will be the same people that have made Southern Comfort such a good event. Mark your calendars to take a week of vacation March 12-19, 1995 and go to Atlanta, Georgia, where it will be even warmer than Oregon was this year!

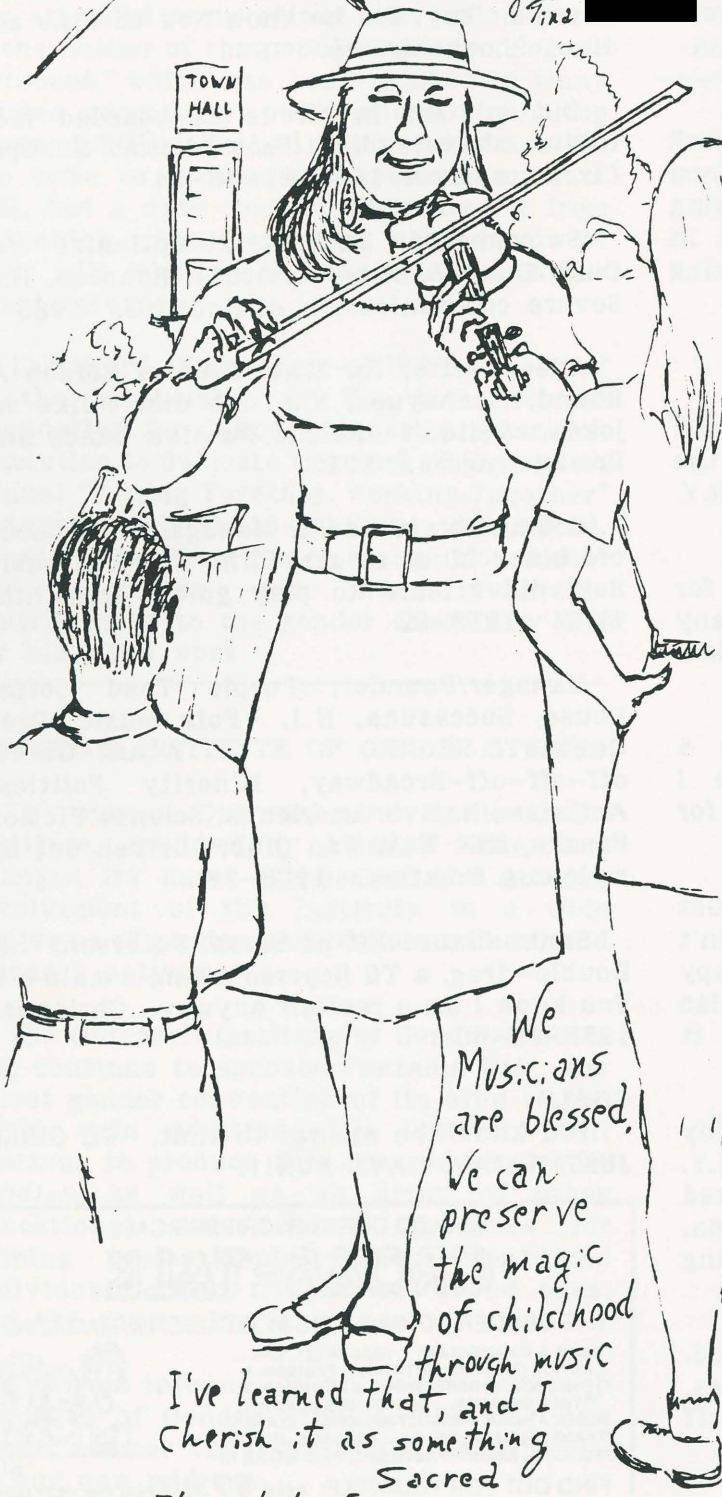

"TRANSGENDER" ADDED TO OFFICIAL TITLE IN S.F.

"Transgendered" has been added to the official title of a standing committee of the San Francisco Human Rights Commission (HRC), a move which establishes the first governmental body in California to formally represent transgender people. A resolution creating the Lesbian/ Gay/ Bisexual/ Transgendered Advisory Committee was approved by the Human Rights Commission on February 24, 1994.

The HRC also passed a resolution to hold a special hearing on May 12, 1994 to hear testimony on the problems and discrimination faced by transgender people in areas that include employment, housing, medical care, public accommodations and treatment by police. Testimony is certain to disclose how transgender people are routinely harassed, demoted and fired from their jobs. Many landlords refuse to rent to the transgendered and we are subjected to violence which often goes unaddressed by local police services. Public services, including medical and social services, are often denied transgender people - particularly the poor and homeless.

Recommendations on how to address these concerns, including an ordinance making it illegal to discriminate against transgender people, are expected to come out of the hearing. *(This news was passed to TGIC by ETVC, a sister group of more than 450*

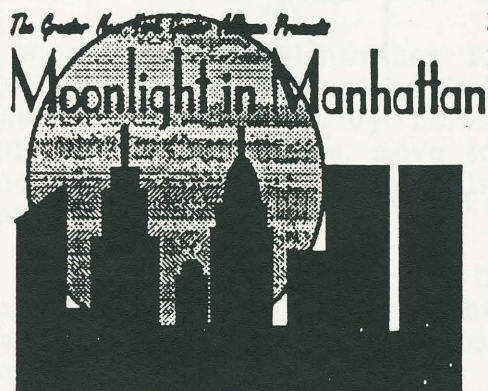
transgender people in the S.F. Bay Area, and the largest organization of its kind in the world. Several of its members are involved in the effort now ongoing before the HRC to eliminate legal discrimination against transgender people).

HEALTH CARE RESOLUTION - CTO

The following resolution passed by the Congress of Transgendered Organizations at the IFGE Convention on March 17, 1994:

It is noted with regret that President Clinton's proposed **American Health Security Act** specifically excludes "sex change surgery and related services" from the **Guaranteed National Benefit Package**. We believe that this unjustly discriminates against American men and women who seek such treatment for the condition known as **gender dysphoria**. Sex reassignment surgery is an accepted, proven, and necessary medical procedure. We find that the exclusion of sex reassignment surgery and related services denies vital health services to a whole class of men and women who are struggling to cope with gender dysphoria. We find this exclusion to be objectionable, callous, and unjust. In this light, we **strongly urge** President Clinton, Congress, and Hillary Rodham Clinton, as Chief Health Policy Advisor, to **guarantee access** to this vital medical treatment within the proposed **American Health Security Act**.

ANONYMOUS HIV ANTIBODY TESTING

CBS used its *DESIGNING WOMEN* sitcom to focus on cross-dressers in the May 7 episode, written by Daniel Margosis and Robert Horn, and directed by David Steinberg.

Carlene and other series regulars discover that Carlene's new boyfriend is a cross-dresser. "I'm not gay," he explains. "I'm a heterosexual guy who just happens to like dressing up in women's clothes."

He appears in one scene wearing a wig, a dress and women's accessories. In the closing scene, Carlene decides to "identify" with him, so she dresses in a man's suit.

Along the way, scenes featuring these confused characters provide ample opportunity for jokes about genitalia and erection.
