# IMPERIAL COURT OF NEW YORK ELECTION OF MONARCHS

## QUALIFICATIONS FOR CANDIDACY

MINIMUM TWO YEARS MEMBERSHIP IN GOOD STANDING AT THE TIME OF ELECTION, BEGINING FROM THE END OF THE FALL MEMBERSHIP CYCLE FOR THAT FISCAL YEAR.

## PROCEDURES IN SELECTING CANDIDATES

CANDIDATES WILL BE SELECTED BY THE NOMINATION COMMITTEE

CANDIDATES MUST SUBMIT AN APPLICATIONS FORM BY DATE TO BE SET BY THE NOMINATION COMMITTEE

CANDIDATES WILL HAVE INDIVIDUAL INTERVIEW BY THE NOMINATING COMMITTEE

NOMINATING COMMITTEE WILL SELECT A MAXIMUM OF THREE CANDIDATES PER MONARCHY POSITION

NOMINATING COMMITTEE MAY DECIDE NOT TO PRESENT ANY CANDIDATES FRO A SPECIFIC POSITION IF IT DEEMS NO CANDIDATES QUALIFIES FOR THE POSITION

## GUIDELINES IN SELECTING CANDIDATES FOR MONARCHS

ACTIVE PARTICIPATION WITHIN THE COURT

ACTIVE PARTICIPATION WITHIN THE COMMUNITY

COMMITMENT TO THE MISSION OF THE COURT

GOALS AS MONARCHS OF THE COURT

## ELECTION OF MONARCHS

MONARCHS SHALL BE ELECTED BY THE GENERAL MEMBERSHIP AT THE FIRST GENERAL MEMBERSHIP MEETING FOR THE FISCAL YEAR (SEPTEMBER, 199-)

ALL MEMBERSHIP IN GOOD STANDING WHO HAVE BEEN WITH THE COURT AT LEAST SIX (6) MONTHS ARE ELIGIBLE TO VOTE FOR THE MONARCHS.

MONARCHS MUST RECEIVED A MAJORITY OF THE VOTE (51%)

IN CASES WHERE THERE IS ONLY ONE CANDIDATE PRESENTED FOR A POSITION, CANDIDATE MUST RECEIVED A MAJORITY VOTE OF APPROVAL

ONLY VALID AND SIGNED PROXY FORMS WILL BE ACCEPTED DURING ELECTION

## **NOMINATION COMMITTEE**

NOMINATION COMMITTEE SHALL CONSIST OF 5 MEMBERS, 3 OF WHICH SHALL BE MEMBERS OF THE BOARD OF DIRECTORS. THE OTHER 2 POSITIONS SHALL BE FILLED BY A MEMBER IN GOOD STANDING WHO SHALL HAVE BEEN WITH THE COURT FOR ONE (1) YEAR AT THE TIME OF ELECTION, AND ELECTED BY THE GENERAL MEMBERSHIP.

ALL CANDIDATES FOR MONARCHS ARE NOT ELIGIBLE TO SERVE ON THE NOMINATION COMMITTEE

ANY AVAILABLE SPOT NOT FILLED BY THE BOARD WILL BE OPEN TO ELECTION BY THE GENERAL MEMBERSHIP.
