### IT ISN'T EASY!

Gender Review first appeared in June 1978, since when there have been twenty issues. The first eight of these, which included one double issue, were edited by Nicholas Ghosh. Susan Huxford managed to publish only four issues in the 21 months between February 1981 and November 1982 before she was succeeded by Paula Paula managed five issues in 15 months, to be succeeded by Susan Huxford for the second time. Susan manaded three issues during eight months in 1985, since when there have been no further issues.

This patchy history tells an important story: it\_isn't\_easy! Susan combined the duties of Editor with those of Executive Director of In February 1986 she FACT. celebrated her sixty-fifth birthday. She made quite clear her intention to retire from these duties and called together a group of FACT reinstate the members to old Constitution. This group accepted Susan's resignation and revised the Constitution. At the same time a member of this group volunteered to become Editor of Gender Review. After some months, this editor-elect discovered the task to be too onerous and, at a meeting of the interim Board on November 14, 1987 announced her withdrawal from the position.

The interim Board of Directors is aware that paid-up members of FACT expect to see something for their money. Furthermore, they recognize that there are subscribers to Gender Review whose subscriptions have not expired. Susan Huxford therefore suggested that an issue of FACTual News be prepared so that subscribers to Gender Review might be informed of the latest developments. It then became apparent that some Board members were prepared to make material for available some Sufficient material publication. thus came to hand before Christmas to justify an abbreviated issue of Gender Review.

Subsequent developments have convinced Susan that a further issue of Gender Review should not be prepared by her. She has found that responsibilities that she has tried repeatedly to relinguish have returned to roost on her desk. She has therefore determined that this shall not happen in 1988. This present update on the status of FACT is accordingly being published as a GenderServe newsletter and is not a FACT publication. Ιt i 5. nevertheless, being circulated to all subscribers to Gender Review and to such former members of FACT as it i 5 considered may still he interested in the activities of the Foundation.

Efforts to incorporate FACT as the Foundation for the Advancement of Canadian Transsexuals have run into repeated roadblocks in the Ontario Ministry of Consumer and Commercial Relations. Susan does not believe that these difficulties are insurmountable, but she is no longer prepared to do the necessary (Continued overleaf)

spade work. If FACT is considered to be necessary to the gender dysphoric community, then that community must from now on accept full responsibility for its operation. This means that a new editor must be found for Gender Review, otherwise no further issues will be published.

It should be clearly understood that GenderServe is no longer the administrator of FACT. A new Provisional Executive has taken office and comprises Dawn (Acting President), Patricia (Acting Vice President), Frankie

(Acting Vice President), Frankie (Acting Secretary), Susan Huxford (Acting Treasurer) and Michelline (Board Member).
