## IFGE in Philly for '93

Philadelphia has been selected by the International Foundation for Gender Education (IFGE) as the site city for the 1993 *Coming Together* Convention. Renaissance will be the host organization.

Convention site selection was discussed at the 1990 IFGE board of directors meeting in Boston. Sites for 1991 and 1992 were announced as Denver, Colo. and San Antonio, Texas, respectively.

During a program planning meeting at the 1990 Boston convention, Maryann Kirkland (Greater Philadelphia Chapter representative to IFGE) noted that the '93 convention site had not been confirmed. According to Merrissa Sherril Lynn, Executive Director of IFGE, the fantastic job that ETVC did in San Francisco for 1989 "scared" off two potential host groups. After a hasty conference between Renaissance board members in attendance, the

offer to host the convention in Philadelphia was extended to IFGE, pending approval of the full board and general membership.

The executive board approved and the general membership of the Greater Philadelphia Chapter concurred. (Greater Philadelphia is expected to take the heaviest share of the work with support from the other three chapters.) IFGE was notified and has since confirmed the site and Renaissance as host.

Hosting this convention is no little task. The '93 convention could potentially draw as many as 400 people to the city. Renaissance must provide coordination with IFGE programs and develop its own activities for the conventioners. It will be pure hard work.

### *To be or not to be . . .*

Employed, that is, as the great Bard used to say. Well, maybe not.

'Twas in the March issue that I first wrote of getting that first job. Many of you who read it probably thought there was no more to know about finding employment. Wrong!! Though this column is not going to be eternally devoted to this issue, I thought it appropriate to devote another chapter covering more issues of finding employment.

Believe me, for the transsexual seeking that first job, or any job for that matter, and needing to keep the rent and electricity paid, employment is a big issue.

The reason I unearth this topic from the editor's morgue stems from a very personal situation of recent origin. Though I am a professional photographer and teacher, occasionally I want new equipment or there is a lull in business. So, I sometimes take a temporary position doing something else until my business picks up. Remember the rent?

In March I was hired as an executive secretary to the administrator of a medical facility. In that capacity I do a whale's share of typing. Part of that is what I call "Thanks but no thanks" letters for unsuccessful hopefuls. Prior to sending out letters to these sad souls I often take the time to browse through their applications to see why they weren't hired.

I've hired many a person for various organizations so I'm familiar with what to look for. But, in this secretarial position, I admit, my eyes were opened to new realities of the job world. From what I've seen many of these people didn't get hired due to their own carelessness! They blew their chances of employment because of dumb things. I mean, why go to all the trouble to fill out an application form and hand it in just so your mistakes will disqualify you. Do you want the job or not?

How does this relate to transsexuals seeking work? Transgendered people have two strikes against them already. Everything they can do to improve the odds of landing a job needs to be done.

Let me share some of what I've concluded from my observations, and I'll let you make up your own mind whether they are valid or not.

First, when going to pick up a job application, always wear nice clothes. Always look your best. There are two reasons for this: 1) Often the secretary/receptionist has the authority to enter a code on your application stating whether or not they think you might make a good employee, based on your appearance and manners, and; 2) If you fill out the form, wearing blue jeans and T-shirt, the prospective interviewer may walk by and see you in those shabby clothes — the first impression will already have been made before the interview.

Always treat receptionists with courtesy and professional respect. If you get her/him mad at you, believe me, your application won't even make it to personnel.

I can't stress this next item strongly enough; fill out the application form *legibly*. Type written is best. If you must handwrite it, do it clearly so even your old grandmother with failing eyesight could read it. I don't know how many applications I've seen that were printed neatly but in a style that was harder to discern than Egyptian hieroglyphics.

Fill in *all* of the questions and spaces on the form. Don't leave anything blank. Some employers see blanks as a lack of attention to detail and in the trash can it goes.

I see a lot of applications bearing prison records. Though I give the people credit for being truthful, a criminal record looks very bad to a potential employer. 'Nuff said.

If the personnel manager calls you up to set an appointment —

*keep it.* Many of our department heads are continually frustrated because they call someone for an interview and they don't show. Nor do they call to cancel. This is rude. It baffles me why one would go to the trouble of filling out an application and not show up for the interview.

When you do go to an interview, try to guess the type of questions you may be asked. Rehearse for the interview in front of a mirror or while driving the car. That's not as crazy as it sounds. When I was on the stage and television, we rehearsed in front of the mirror all the time to see what we looked like. There is no replacement for preparation and there's nothing worse than being caught off guard in an interview. Be prepared.

Always dress professionally. Make that initial first impression a good one. I have one dress I've worn to five interviews, and I've landed the job each time. I call it my interview dress. It works.

If you are applying for an executive level position, it is customary to follow up the interview with a thank you letter. And, you refresh yourself in the interviewer's mind.

During the interview, be aware of your body language. Don't slouch. The silent language of the body can speak much louder than your voice ever can, especially to someone who knows what body posture means. When you speak, look the interviewer straight in the eye. Don't look out the window or play with your hair. Know what may be construed as sexual or flirting gestures. Many experts say women should use little or no perfume.

My suggestions may be obvious to some but not to others. I've seen the job market from all sides as I hired/fired, coordinated applications, looked for jobs, prepared resumes, and suffered through hundreds of interviews. These recommendations do work. Try them.

## Backstage Performance Tops

Just a few blocks off South Street is one of Philadelphia's best kept secrets; a fine restaurant with delightful decor, pleasant service, and both a clientele and staff who are open minded regarding lifestyles. Having been there several times for light fare (dessert, drinks, coffee), I thought it about time to try a full meal. My partner, two friends and I arrived at our reservation time and were seated immediately. The place filled within the next 15 minutes. Reservations are a must.

We began with cocktails, all of which were well made and generous. Our friends shared a Shirley Caesar salad (\$7.50 for two), while my partner and I split a Shrimp Louie De Palma (\$8.00) which provided four jumbo shrimp and a hard boiled egg with greens, dressed in a

fabulous la Maize sauce. The shrimp was from part of the menu titled Act I and the salad from Act II. Some of the other stars from Act I were Paté La Belle, a forcemeat of filet mignon, chicken liver, and veal seasoned with spices and Cognac (\$5.50), and Prosciutto Bardot, prosciutto and crab meat, en croustade, topped with Hollandaise sauce (\$7.00). For Act III (entree) our friends selected Crab cakes (\$16.50) which were spectacular. I chose Princess Steak Di (\$15.50), two lovely prime filets with a sauce of essence of veal, mushrooms and shallots. My partner had the Oscar winner of the evening with her selection of Daffy Duck (\$16.00), medium-rare slices of succulent duck breast in a light wine sauce. This dish alone could earn the restaurant at least a couple of stars in

any gourmet rating. Each entree was accompanied with a side dish of vegetables al dente and potatoes au gratin. Other Act III offerings range from Mae West, breast of chicken with honey mustard sauce (\$11.00) to Rhett Butler, an 8 ounce prime center cut filet mignon (\$19.00), plus the Esther Williams catch of the day, on our night it was Norwegian salmon with a lobster cream sauce.

It must be apparent by now the theme of this restaurant is the theater and they carry it off well with Hollywood decor and posters of the all-time movie greats.

We ended the meal by ordering four different desserts. Our waiter (whose femme name is Blanche) realizing we were taking our meal seriously, returned with a selection of *all* the desserts, each one better

Now for some important news.

In an attempt to reduce Medicaid costs, the state of Oregon has proposed a system to rate the medical procedures it will pay for. The rating system takes into account the cost of the procedure, the number of people suffering from the particular affliction, and the quality of life after the procedure is performed. Later, the state legislature will draw a line across the list; procedures above the line will be paid for by the state, those below the line will not. The goal, officials said, was to have more money to spend on more people.

Sex change operations come at the bottom of the list, and are likely to be dropped from the Oregon Medicaid program.

A transsexual attorney from Texas is trying to get the Houston Gay and Lesbian Political Caucus (GLPC) to add “transgenderal” to its name.

GLPC has so far resisted Phyllis Frye’s motion for a name change. Caucus vice president Larry Lingle said the change was unnecessary because the organization’s bylaws provide for the inclusion of many groups of people. Furthermore, “this is not an issue in any other gay and lesbian organization anywhere else in the country,” he said. “The term she is using (transgenderal) is not even an accepted term anywhere.”

Lingle said the question was a “fringe issue” that “distracted” from the main goals of the organization.

Frye disagrees. Bigots, she said, will selectively exclude any group not specifically included when legal gains are made in the area of civil rights. She said she wants to make sure that transsexuals and transvestites are not lost in the shuffle.

Another transsexual political activist, Terri J. Pohrman, finished second in the race for mayor of

Yountville, Calif. But she promises to try again.

Pohrman made no attempt to hide her transgendered status, and even ran with the campaign slogan “A Change Will Do You Good.” Her candor made the mayoral race news around the world.

And in still more political news, transsexual Leslie Elaine Perez lost her bid to become chairwoman of the Harris County (Tex.) Democratic Party. She received only 19 percent of the vote, while her opponent Ken Bentsen Jr. received the rest.

It appears that Perez’s transsexuality didn’t play a large part in her defeat. For one thing, her opponent is the nephew of Sen. Lloyd Bentsen (D-Tex.), and for another, Perez served time in prison as a man for a 1961 murder.

Speaking of prison, Marty Phillips has won a lawsuit against prison officials who tried to stop her from becoming a woman.

At the age of 17, Phillips began taking female hormones. Later she added breast implants and facial surgery to the process. But the hormones were halted when Phillips began serving a life term in a Michigan prison for a 1985 murder.

Phillips sued prison officials in federal court to resume the hormone doses. In February, U.S. District Judge Richard Enslen agreed, and officials were only waiting the formal ruling before giving Phillips her hormones. They said they had stopped the treatments because female hormones increase the risk of stroke in uncastrated males, but Phillips said she was willing to take the chance.

Gene Mountain, a pre-op male-to-female transsexual, has a beef with officials at the Oak Park Heights State Prison in Minnesota.

For example, young Thai men in Singapore have taken to wearing

red nail polish in their sleep in hopes that it will ward off death during the night.

So far, about 200 apparently healthy young men have died in their sleep from a mysterious illness. While doctors are looking for the cause, other Thais think they have the answer — a female ghost on the prowl for husbands. The nail polish, the men believe, will fool the ghost into thinking they are women.

Brown Sugar, hailed as Denver's leading lady of illusion, has broken new frontiers in a profession not known for respecting conventions. ## Would you like to be a Big Sister?... Terry M., South Jersey & 3R

One of the greatest joys I've had since I came out of the closet has been the support and encouragement I've received from the people I've met in the gender community.

I, like many of us, lived alone with my secret. I dared not share that secret with anyone else. I dressed alone, shades drawn, in fear, and always felt guilty about it afterward. So, I would throw everything out and vow never to put on those clothes again. However, purging the apparel did not solve my problem. I could not ignore that fact that I wanted and needed to dress in feminine clothing. I just did not know why. I did not understand that my dressing was and is an expression of my own natural feminine energies.

It was a huge step for me to creak open my closet door and reach out for help. At first, I wrote and made contact by mail. I contacted Tri-Ess and Renaissance and was delighted to receive responses from both. Next, I contacted a producer of a TV getaway weekend. There I first came out as Teresa. I also met for the first time real flesh and blood human beings who all had similar stories to my own. I started to attend Renaissance meetings on a regular basis.

I am grateful to all the people who have put these support groups together. I do not know what I would do without them. I do not think I would be able to stand anymore time back in that closet.

But, as is the case with a twelve step recovery program that I involved with, the most important person in the room is not the person who has been there for a few months or years. Nor is it any of the officers.

The most important person is the one who walks in for the first time, the newcomer. It is with the newcomer that I best identify.

I know how scary it is to put on a dress and actually go to one of the meetings for the first time. It is a journey over miles, over fears, and over a lifetime of loneliness. What a wonderful feeling it is for me now to talk to new sisters. How exciting it is to see them come back and literally blossom.

The importance of supporting new sisters, of helping them feel at ease and at home, cannot be understated. It is one of the things a support group is all about. We help ourselves by helping others. We grow by helping others grow. This can take many forms but most of all it simply takes a willingness to share. I would like to propose a "Big Sister" program to assist newcomers. A "Big Sister" would simply be someone willing to give her time to someone new. This may involve phone or postal contact, or it may involve personal contact outside of the meetings. Ideally, a "Big Sister" might encourage a new person to come to her first meeting. I know how much it means to know somebody first and then get to a meeting. I know that other Renaissance members have talked about doing something like this and are anxious to help a newcomer. This would not be something to replace any of the ways we already reach out to people but would rather serve to enhance those efforts. If there is anyone else interested in becoming a "Big Sister", please let me or one of the officers know.

Yet, I have never spoken to many members for the same poor excuses I am trying to combat with this very article. I just met a girl at one of our dance parties who I always felt was a little intimidating or standoffish. Not only was she not standoffish, she was very friendly, open, and leads an interesting life. It was my loss in not making her acquaintance months ago.

And that brings me to another friend-related topic. Once you meet some of our members, you realize how diverse and interesting some of our lives are - as if transgenderism wasn't enough!

Have you ever thought of extending your Renaissance acquaintances to your 'other' life? There's no law that says we should only see each other once a month, dressed en femme. ## Additional comments to Transsexual Issues...Jackie K.

I have to agree with the analysis in the Editor's Comments (Renaissance News, Vol.4, No. 4). There are many reasons why someone may feel that "going the TS route" may be an answer for them.

Reassignment surgery has developed to the point where the results are very good, aesthetically and functionally. It represents a "solu-

tion" for some to gender dysphoria.

However, people fail to recognize that reassignment is *not* a "solution" but a form of treatment for a specific diagnosis — transsexualism. A person with a female gender identity in a male body, the "classic" TS, is only one of many people with transsexual feelings, most of whom are *not* candidates for surgery. A

person with a primarily male gender identity with accompanying strong feminine identification, such as a transvestite, would be making a big mistake to try to "become" a TS.

Being a transsexual is something that comes from within, is something you have no control over, and cannot be intellectualized.

We have heard from other professionals that there is a movement afoot to label all sexual minorities as compulsive or addicted and attempt treatment through various models, such as 12-step programs.

The main problem we see with this approach is most transvestites don't want to be "cured" of their crossdressing; they want to be able to dress without feeling guilty about it. That's the main purpose for our support group structure.

We suppose as long as someone still believes that transvestites are "sick" people, they will keep looking for a "cure."

CHICAGO — The heat is on. That is it's turned on Dr. Glenn Humphrey for the conclusions reached from his doctoral dissertation, *Cross Dressing in Males: The Attempt to Retain the Comforting Object* (See *Survival*, May 1990, and this issue for details).

Chicago Gender Society president, Laura, agrees with our JoAnn Altman Stringer that Humphrey's

research design was flawed.

The item that seems to cause the most controversy is a "finding" that Sex Reassignment Surgery (SRS) is a "momentary palliative" (i.e. a temporary fix) and does not resolve a transsexual's search for security.

Stringer and others strongly disagree with this conclusion as a generalization for all transsexuals.

We would agree with that position but must point out that it may be true for Humphrey's sample population. Further, it may be pointing out a serious problem with the current system of counseling transsexuals for SRS; many people presenting themselves as transsexuals are getting through the "system" when they shouldn't.

On the brighter side, his findings seriously call into question the DSM classification of transvestism as a paraphilia.

One hand giveth and the other taketh away.

## Comments on Dr. Glen Humphrey's gender research

Last month, JoAnn Altman Stringer wrote in her *Survival* column about gender related research conducted by Glen Humphrey, Ph.D. Stringer noted several conclusions reached by Humphrey and strongly disagreed with them. She is not alone in her assessments.

But, first, there is one item of note in Humphrey's research that Stringer did not mention. He is opposed to listing transvestism in the DSM-III-R. This is of great significance to many of us since we do not see ourselves as mentally ill. Stringer left this out of her column as it did not relate to Humphrey's conclusions about transsexuals.

In addition to the items listed by Stringer last month, there are two other "problems" with Humphrey's research. One relates to transsexuals alone and the other concerns both TVs and TSs.

Humphrey stated that some

transsexuals seemed soothed by the wearing of women's clothing and therefore, he concluded, those transsexuals had unresolved issues about transsexualism. The problem may not be in Humphrey's conclusion but in taking the self-diagnosis of transsexualism at face value. What Humphrey may be seeing in his sample are not true transsexuals but transvestites that have convinced themselves they *ought* to be transsexuals. Richard Docter has noted in *Transvestites and Transsexuals* that some male transvestites, in later years, become convinced they are transsexuals. Docter calls this "secondary transsexualism." There is some question whether these secondary transsexuals are in fact transsexuals.

The last question that arises from Humphrey's research in the connection between anxiety and crossdressing. For many years,

we've been led to believe that when transvestites experience anxiety, crossdressing relieves that anxiety. Could it not be the other way around? Could it not be that the lack of opportunity to express the feminine side of our nature causes the anxiety and when finally permitted to dress that anxiety is ameliorated? Likewise, could it not be that a transsexual who believes herself a woman is anxious in the male role and that anxiety is soothed when she is permitted to be herself in a female role (crossdressed)? Which came first, the chicken or the egg?

In conversations with transvestites who have unlimited opportunity to dress, they say they no longer experience the anxiety related to dressing. Many transsexuals say they finally find peace in their lives when they begin the Real Life Test. It is possible, then, that Humphrey has misinterpreted his data.
