After I married, I told my wife about my secret urge. She did her best to be understanding but then forced me to see a therapist, who insisted I had to give up cross-dressing to save my marriage. It was very painful at first, but I did it.

I still think about cross-dressing, and even writing about it causes me pain, but I owe my kids a decent upbringing, and my sexual fulfillment is less important than they are. I hope Tom resolves this dilemma before he marries.

Dear Ann Landers: One of the most valuable aspects of your column is that it lets troubled people know they aren't alone. I felt a knot in my stomach when I read the letter from the woman whose fiance, a successful attorney, confided that he loved to wear women's underwear and frilly gowns.

My husband is also a transvestite, only it was our young niece who dropped by unexpectedly and caught her "Uncle Ed" in a chiffon housecoat and high heels. She was totally freaked out, but I had the presence of mind to manufacture a story about Uncle Ed practicing for a part in a play.

We are both in counseling now, and I have accepted the fact that he will never change. Our sex life has always been good and still is. Is this guy kinky? Of course, but my counselor explained it this way: "He doesn't drink, do drugs or cheat on you. He's a good husband and a great father. His harmless deviation isn't worth breaking up a home for. Overlook it."

Even crossdressers who love men, drag queens, usually think of themselves as in cos-tume, and not in their own clothes. This is often "Do you really leave your house and go to church like that?" asked the same crossdresser who doesn't like to be called the "wrong" name based on clothes. Yes, I do. I see the clothes that I wear as my clothes, not crossdressing at all, just another form of expression --like the difference between wearing jeans and a suit. I want to be seen as an integrated person. I worked long and hard to come to that place of comfort, and it can still be difficult for me. But when men in costume, and not in their own clothes. This is often phrased by dividing up the wardrobe into "his clothes" and "her clothes," even if they are all worn by the same human. When someone asks if "Biff" or "Suzy" will be coming tonight, simply denoting the clothes that one person might wear, they are firmly entrenched in the costume mindset. I rankle. A.V. N This costume part of us that is clearly just a persona and not a fully integrated person. This costume phase of identity exploration is important to all people. Many of the outfits we wear during adolescence are costumes, abstracted and exaggerated displays of part of our character. We try these to help us explore various facets of ourselves by bringing that side to the front, playing with it, and seeing how people react. After a while, though, we are expected to find costumes that represent us in a more whole way. We do change clothes based on what we are doing and what image we want to present, but the expectation is that the change clothes based on what we are wearing a costume. After all, no matter what clothes we choose to wear, we are always wearing a costume. It's simply that after wearing a well constructed outfit for a while, it feels natural, like it is an extension of us rather than just some facede that we put on to conceal part of who we are. In other words, a good outfit is organic, revealing parts of us in a comfortable, natural way, rather than concealing who we are in a crude and bold All costumes are constructed, but the better constructed, the more they fit the shape of a wearer's body and soul, the more natural and elegant they look. For people who pursue a path that transits gender lines, sooner or later they will probably choose to find an outfit that is not simply a costume that conceals, but a suit that reveals who they are. They will stop crossdressing, stop wearing clothes that they feel belong to someone else, and start simply wearing their own clothes, be it a tie or a dress. They will simply be who they are, no matter what they are wearing, always a transgendered person, in jeans or silk. At this point, they will feel no dissonance when someone calls them by name whatever they are wear-ing. They will feel the nuances of the range of their own gender in any clothes, be it admiring some beau-tiful jewelry or feeling the power of a hot car. This is what we expect of people, that they find a way to ex-press and admire both the feminine and the mascu-line, in themselves or in the world, without having to be dressed a certain way.

To transgendered people who have gone past the costume stage of transgender, being with people still in it can be frustrating. Crossdressers assume that if they are a man in a costume, then every other person born male who wears a dress must also be a man in a costume. Many must assume this for their own peace of mind, for if they believe that transformation is pos-

- Gender "feeling" : Masculine

- Conversion Operation (SRS) :May consider in fantasy. Rejected
- Hormone Therapy/Estrogen Therapy : Rarely interested. / May help to reduce libido.
- Psychotherapy : May be successful in favorable environment.
- Remarks : May imitate male & female double personality with male and female names.

- Gender "feeling" : Uncertain Wavering between TV and TS. May reject "gender".
 Dressing Habits and Social Life : "Dresses" often as possible with insufficient relief of gender discomfort. May live as man or as a woman.
- Sex Object Choice and Sex Life : Libido low. Genrally asexual or autoerotic May be bisexual.
- Conversion Operation (SRS) : Attractive but not required.
- Hormone Therapy/Estrogen Therapy : Needed for comfort & emotioal balance.
- Psychotherapy : Only as guidance, most often refused and unsuccessful.
- Remarks : Social life dependant on circumstances. Often identifies as "transgenderist".

TYPE V - True Transsexual - Moderate Intensity

- Gender "feeling" : Feminine "Trapped" in a male body.
 Dressing Habits and Social Life : Lives and works as a woman if possible. Insufficient relief from "dressing
- Sex Object Choice and Sex Life : Low libido. Asexual, autoerotic, or passive homosexual activity. May have been married and have children.
- Conversion Operation (SRS) : Requested.
- Hormone Therapy/Estrogen Therapy : Needed for a substitute for or preliminary to SRS operation.
- Psychotherapy: Rejected. Unless as to cure. Permissive psychological guidance.
- Remarks : Operation hoped for and worked for, often attained.

TYPE VI - True Transsexual - High Intensity

- Gender "feeling" : Feminine. Total "psycho-sexual" inversion.
- Dressing Habits and Social Life : Usually lives & works as a woman. No relief from "dressing" • Gender discomfort intense.
- Sex Object Choice and Sex Life : Intensly desires relations with normal male as a "female" if young. Later libido low. Heterosexual, bisexual or lesbian identification. May have been married and have children.
- Conversion Operation (SRS) : Urgently requested and usually attained.
 Hormone Therapy/Estrogen Therapy : Required for partial relief.
- Psychotherapy : Psychological guidance or psychotherapy for symptomatic relief only.
- Remarks : Despises her male sex organs. Strong danger of genital self-mutilation or even suicide if
