CHI'S SEPTEMBER MEETING

During our July meeting we discussed the general goals and procedures of Tri-Sigma, especially as they applied to local Chapter activities. A summary of this discussion, covering the initial membership process, visitors attendance at meetings, annual dues and the dues period, etc. was sent to our national leadership for consideration along with the comments of many other individuals and Chapters from across the country. From a letter recently received by your Editor, it appears that many of these suggestions will be accepted and implemented within the very near future. Although there will be no compromise with the basic principles of individual security or overall goals of our organization, certain procedures will be simplified to bring us "in step with the times" and provide a more workable organizational effort. Many from CHI Chapter will be attending the Tri-Sigma convention in New Orleans September 27th-30th, and we hope to bring back more details about the new procedures.

The Chapter discussed the problem of holding a Chapter meeting during the month of August, as explained in detail in our September newsletter. The consensus was that we would not have a formal Chapter meeting in the future during the month of August, but that if an individual member wished to sponsor an informal get-together in her home during that month the Chapter would cooperate in notification of the membership, and underwriting the cost of refreshments.

Deanna brought up the subject of refreshments at the Chapter meetings which are held in motels, noting that on many occasions the lunch meat, salads, etc. were not consumed and had to be thrown out. Because of the current high cost of these "Deli" refreshments, it was decided to provide only coffee/pop, and perhaps potato chips and dip, at our motel meetings; if the members at a particular meeting decided they wanted more, we could send-out for pizza (or even tacos, as one member suggested). 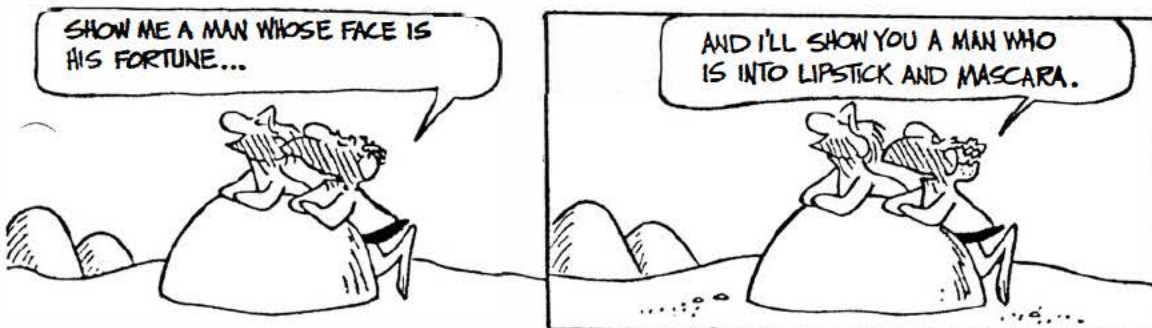
SEMINAR

JOINT MEETING OF CHI/DELTA CHAPTERS

The joint meeting of CHI and Delta Chapters will be held on Saturday and Sunday, November 10th and 11th, at a motel near Holland, Michigan, site of the joint meeting in November of last year. We will again have the same accommodations -- a set of three very pleasant modern apartments located together in a building which is separate from the main motel. There are no other rooms in this building, so this arrangement affords us complete privacy.

You can arrive as early as 2:00 P.M. on the 10th, and stay as late as 12:00 noon the next day. Because of the location, most of you will want to stay overnight. The sleeping arrangements in the 3 apartments are as follows: Three master bedrooms with a double bed and private bath (TV/GG couples will be given first choice for these), three bedrooms with two twin beds each, and four sofa beds in the various living rooms. In addition, rollaway beds will be provided by the management if necessary. Depending on our total attendance, some sleeping areas may have to be shared; your preference in this regard should be indicated on the form below. You also have the choice of staying in the main motel, or elsewhere, and either arriving dressed or dressing at the apartments (a dressing area will be available). At the present time only the apartments are reserved for our exclusive use; your separate reservations for accommodations other than at the apartments should be individually made as soon as possible.

We are requesting an accommodation fee of \$25.00 for TV's staying overnight in the apartments, \$30.00 (total) for TV/GG couples, and \$5.00 per person for those who will not be staying overnight in the apartments. The fee schedule allocates \$20.00 for overnight accommodations in the apartment (private rooms in the main motel, or elsewhere, will be more expensive), and \$5.00 from each individual for the refreshments on Saturday evening. Although a Buffet Supper will be provided, it is B.Y.O.B. Any surplus funds over and above actual expenses will be refunded to those attending on a pro-rata basis. If expenses should exceed the fees collected, voluntary contributions will be requested but any remaining deficit will be assumed by CHI and Delta Chapters. Should it appear that there will be insufficient attendance to justify a joint meeting (but we hope that this will not happen), the meeting will be cancelled about one week before the scheduled dates and any accommodation fees collected will be refunded in full.

We urge all of you who are interested in attending to complete the form below and return it as soon as possible. Final date for mailing to insure guaranteed reservations will be October 15th, although late reservations will be accepted as long as space is available. Although this meeting was conceived as a joint meeting of CHI and Delta Chapters (and its location chosen with this in mind), all Tri-Sigma Area members are welcome and encouraged to attend. Those returning the form and fee will receive a map and directions to the motel, and an update on expected attendance. Although the attendance last year was small, those who were there had a marvelous time and most didn't go to bed until about 4:00 in the morning. The joint meeting will be an excellent opportunity for you to see old TV friends and meet new ones, to learn about Tri-Sigma and Chapter activities and plans, to hear first-hand the news about the Tri-Sigma Convention in New Orleans and the annual Fantasia Fair from those who attended those events, and to enjoy your Femmeself in a pleasant and totally secure atmosphere.
