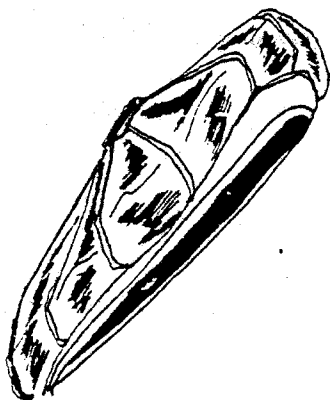

## Dr. Jekyll and Ms. Hyde

**S**helly Ball was arrested in February, 1977, for the stabbing murder of a middle-aged man. But the "woman" who was arrested in the Edmonton hotel where the murder occurred turned out to be Sheldon William Ball, 26, of Chilliwack, B.C. Ball was subsequently convicted of murder and sentenced to life imprisonment, but the court also ruled that his hormone therapy—part of a previously begun sex change—should continue in jail. Now the federal government is faced with financing the rest of a series of surgical operations designed to transform the still-male Ball to a woman. And that change, prison officials suspect, is going to present the Canadian penitentiary system with a unique problem: where to put Shelly Ball for the remainder of his or her term.

"I ask myself, 'What do you do with a case like this?'" says Dennis Weir, assistant director of organization and ad-

ministration, of the Edmonton Institution. According to Weir, Ball's sex-change operations had gone far enough to allow him to live as a woman and work as a prostitute when the murder interrupted his plans to go to the U.S. for the continuation of his transsexual surgery schedule. After extensive psychological examination, the court that convicted Ball of murder agreed that his hormone treatments should be continued but final approval for the operations was to come from Ottawa, which foots the bills. Since prisons are

charged with providing the best of health care for their inmates, the approval probably will come, perhaps within a year. However, Weir is "concerned" about the reception that Ball will get from female prisoners after being transferred to Kingston, Ontario, where the only Canadian penitentiary for women serving long sentences is located.

Ball has been "getting along fine" with the male inmates at Edmonton Institution, where he was transferred a few months ago from the Prince Albert, Saskatchewan, penitentiary, "but he obviously can't remain in a male institution when he is no longer male," says Weir. Weir speculates that if Ball needs protection after the sex-change is completed she could be temporarily lodged in a provincial jail, where she would be isolated from other prisoners, or that Kingston will have to work out some system of providing her with either protective custody or an entirely new identity to prevent her prison life from being made miserable, or worse. But that is a decision that federal officials won't have to make for at least a year.

Meanwhile, Ball is the Edmonton Institution's most famous inmate, the first federal prisoner in Canada to undergo a sex change while in custody. And there is not much likelihood the problem will go away—Ball isn't eligible for parole until 1988.

# CONTOURING FOR YOUR FACE TYPE

You can subtly change the shape of your face by using make-up to create some optical illusions

From the Textbook of Cosmetology

The purpose of corrective make-up is to minimize poor features by drawing attention away from them. By using a foundation cream or lotion that is darker or lighter than the skin color, you can produce highlights and shadows that create optical illusions. In the eye area, eyeshadow can be used to achieve the same effects.

## SEVEN BASIC FACIAL SHAPES

There are seven basic facial shapes: oval, square, round, triangle (or pear), diamond, inverted triangle (or heart) and oblong. An oval face is considered to be ideal. Your facial shape is determined by your bone structure. If your face is not oval, you cannot change your bone structure to make it more oval. However, you can use make-up and hairstyling to make your face seem more oval. This is done by using the principles of optical illusion.

The measurements to determine facial shape are taken at three different places on the face:

1. Across the forehead, from hairline to hairline.
2. From cheekbone to cheekbone.
3. Across the chin line at the hinge of the jaws.

The faces of most people do not perfectly fit any one of the categories. However, a face will usually be "most like" one of the basic shapes even though it may have some of the characteristics of another shape. To determine your facial shape, read the descriptions of the various shapes and look at the illustrations that follow. Then pull your hair away from your face and look into a mirror. Your facial shape should be apparent.

## OVAL

This face is considered to be perfectly proportioned (illustration 1). No corrective make-up is required but care should be taken to use make-up evenly so that no one feature of the face overpowers another.

## SQUARE

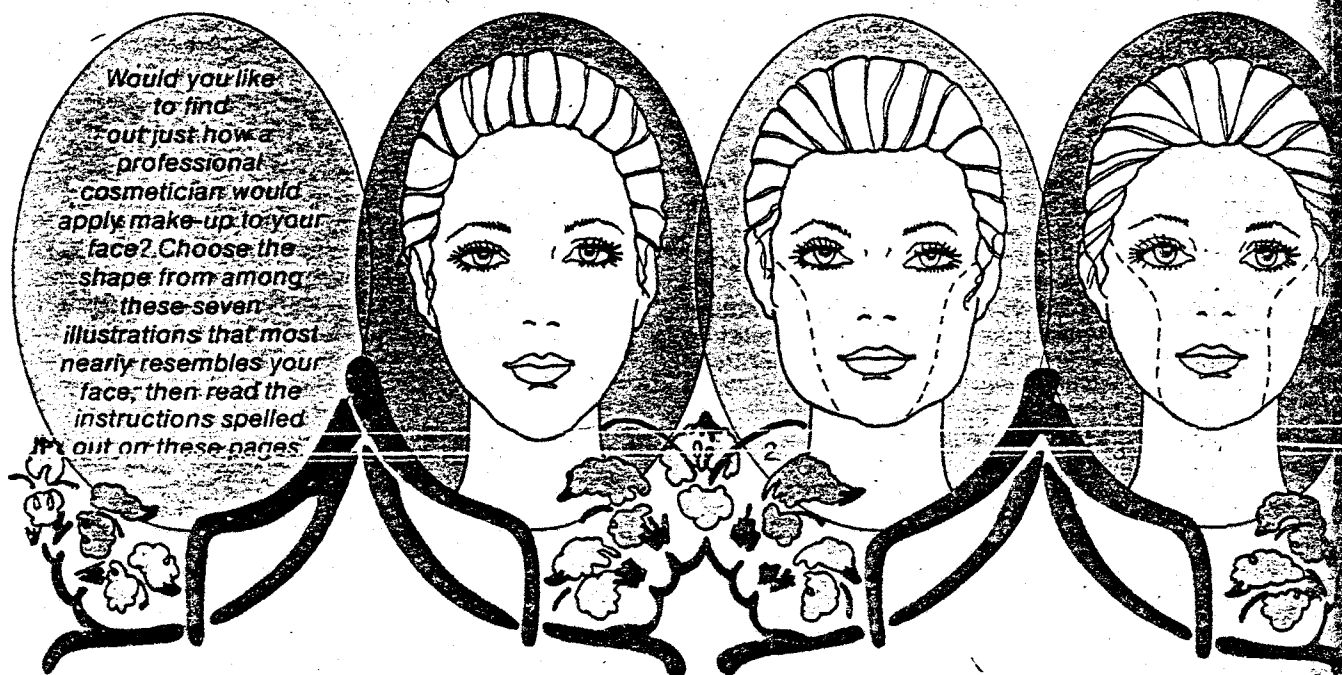
The forehead and chin line across the jaw are almost equal in width. Apply corrective make-up as follows (illustration 2):

1. To make the face seem longer, arch the eyebrows to a high, natural-looking curve.
2. Subdue the square jaw by using a darker foundation on the sides of the jaw. Make sure you blend in the foundation well.
3. Use heavier eyeliner at the center of the upper eyelids.
4. Place eyeshadow across the upper lid and blend out to the corner of the eye.

## ROUND

The cheeks and jaw are wide and full (full-moon face). Apply corrective make-up as follows (illustration 3):

1. To make the face seem longer, arch the eyebrows to achieve a winged effect.
2. Reduce the roundness of the face by using a darker foundation from the temples to the jawline.
3. Keep the eyeliner as close to the upper lashes as possible. Extend the lines past the outer corners



- of the eyes, turning the lines up at the ends.
- Place eyeshadow across the upper lid. Use more color at the inner and outer corners of the eye. Blend the shadow from outer corner of the eyelid to the brow.
  - Avoid all circular lines on this facial shape.

#### **TRIANGLE (OR PEAR)**

The forehead is narrow and the jawline is wide. The eyes are usually close set. Apply corrective make-up as follows (illustration 4).

- To make the forehead seem wider, move the highest part of the eyebrow arch to the outer corners of the eyes.
- Tweeze the brows slightly so that they do not extend to the inner corners of the eyes.
- Use a lighter foundation between the eyes and on the bones under the eyebrows. Make sure you blend well.
- Draw a very fine line with eyeliner from the center of the eyes to the outer corners.
- Place eyeshadow at the center of the eyelid and blend it to the outer corners of the eyes.
- Shadow the broad jaw with a darker foundation.

#### **DIAMOND**

The forehead and chin are narrow; the cheekbones are wide. The eyes are near the widest part of the face. Apply corrective make-up as follows (illustration 5):

- Arch the eyebrows and gradually narrow them at the ends.
- Subdue the wide cheekbones by shadowing them with a darker foundation.
- Apply eyeshadow to the upper lids and blend up to the brows.
- If eyeliner is used, make a very thin line close to the lashes. Do not extend the line.

#### **INVERTED TRIANGLE (OR HEART)**

The forehead is wide and the chin narrow. The eyes are often set far apart, and the cheekbones are prominent. Apply corrective make-up as follows (illustration 6):

- To bring the eyes closer together, extend the eyebrows toward the bridge of the nose past the inner corner of the eye.
- Eyeshadow should be heaviest from the center of the eye to the inner corner of the eye.
- The eyebrows should just barely arch.
- Apply eyeliner close to the lashes. Do not extend it beyond the lash line.
- Use a lighter shade of foundation at the center of the jaws. Blend well.

#### **OBLONG**

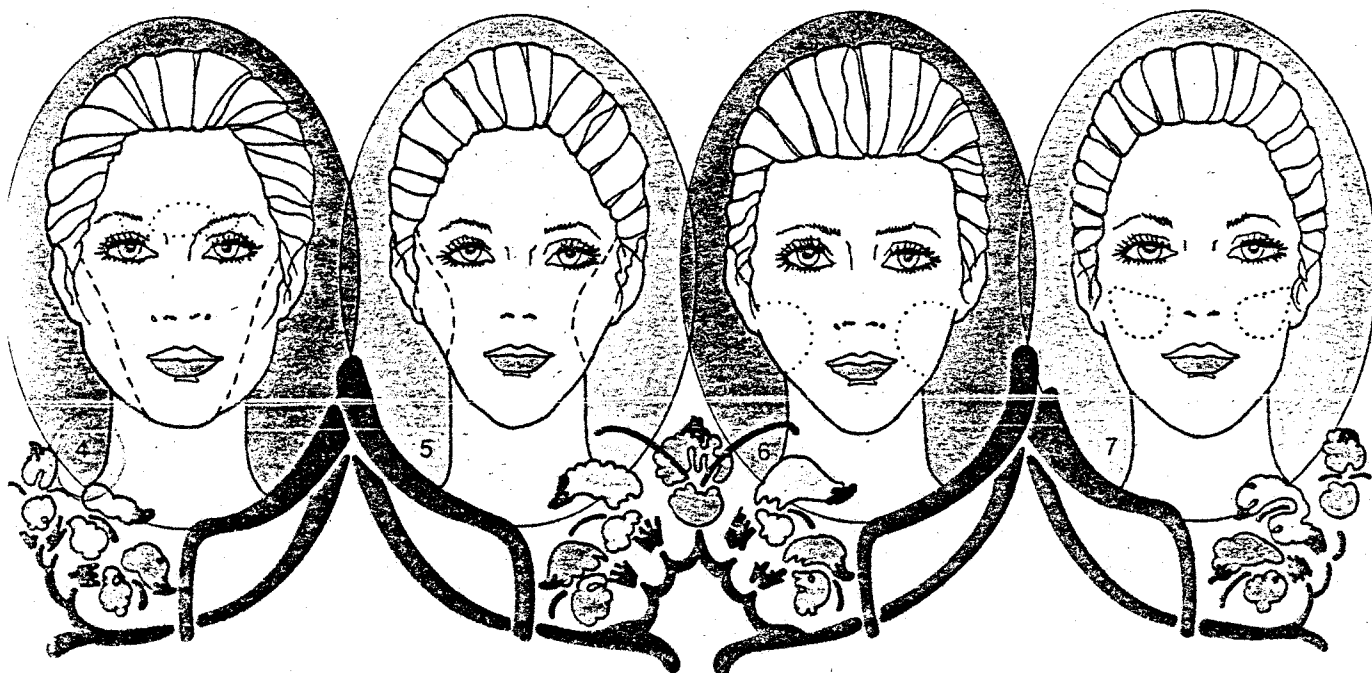
This face is usually long and angular with fairly straight lines. Apply corrective make-up as follows (illustration 7):

- The brows should have a natural rounded arch. Avoid turning the ends down.
- Blend eyeshadow across the eyelid.
- Eyeliner should be heaviest in the center of the eyelid. Give the line an upward sweep at the outer corner.
- Use a darker foundation at the tops of the cheekbones.
- If the nose is long, apply a darker foundation along the center.
- If the cheeks are hollow or sunken in, use a lighter foundation in the hollows of the cheeks. Blend the foundation well.

#### **THE KEY TO SUCCESSFUL MAKE-UP APPLICATION**

All make-up, especially corrective make-up, should look natural. Make-up should be applied so skillfully that it is hardly noticeable. This takes practice. When using foundation creams or lotions for correction, always make sure that you blend them in well. Corrected areas should not appear to be darker or lighter than the rest of the face. If you use a darker foundation on one area, you should blend it in so well that the tone changes very gradually. *Always try to preserve a natural look.*

## MORE HELPFUL SUGGESTIONS ABOUT CORRECTIVE MAKE-UP USING OPTICAL ILLUSIONS

Shadows are created by the use of darker colors. Darker colors give the impression of decreasing the size of facial features. Highlights are created by the use of lighter color. Lighter colors make the features seem larger. You are probably familiar with these principles with regard to clothes. A black dress makes a woman look thinner than she really is. A white dress will make the same woman look heavier.

Lines are also used to achieve optical illusions, especially in the eye area. Lines drawn with an eyebrow pencil can be used to increase or decrease the length of the eyebrow in order to achieve facial balance. Eyeliner can also be used to make the eyes seem wider or narrower.

Since eyes are the most important feature of the face, proper eye make-up is very important. When necessary, lines, shadows and highlights can be used to create optical illusions in order to achieve facial balance.

Eyes can seem farther apart when there is a greater distance between the eyebrows, and when the eyeshadow is concentrated at the outer corners of the eyes. The eyes will look closer together if the eyebrows have been drawn closer together and the eyeshadow is much heavier at the inside corners of the eyes.

### CORRECTIVE NOSE MAKE-UP

1. A wide nose can be made to appear narrower by using a darker foundation on both sides of the nostrils (illustration A).
2. A thin nose can be made to appear fuller by using a lighter foundation on the sides (illustration B).

### CORRECTIVE CHEEK, JAW, AND CHIN MAKE-UP

1. Large cheekbones can be subdued by using a darker foundation on them (illustration C).
2. Hollows under the cheekbones can be filled out by using a lighter foundation (illustration C).
3. Large, heavy jaws can be made less noticeable by using a darker foundation on them (illustration D).
4. Very narrow jaws can be made to seem wider by using a lighter foundation on them.

5. A double chin can be eliminated by applying a small amount of darker foundation to a triangular area directly under the chin.

### CORRECTIVE LIP LINE

Changing the natural line of the lips is very difficult, and so correction of this type is not recommended. The natural outline of the lips is very definite, and the texture of the skin of the face and the skin of the lips is different. Adding color to the skin above the lips or below the lips for correction can look too obvious. The length of the lip can be altered by the use of a heavier or lighter application of color in the corners of the mouth.

To accentuate the lips try the following ideas:

1. Outline the rim of the lip with a darker shade of lipstick or lip color, using a very fine, stiff sable lip brush. Then fill in the inner part of the lip with a lighter shade.
2. Outline the outer rim of the lip with a shade of brown. Then cover the same area with a shade of red and blend this color into the full part of the lip. Finally, add a lighter shade over the full part of the lip. Wield lip brush and color gently for the prettiest look.

### SOME RULES TO MAKE CONTOURING EASIER.

For best results sharpen eyebrow pencils and eyeliner pencils after each use. Sharpen the pencils with a sharpener made especially for eyebrow and eyeliner pencils. Do not use an ordinary pencil sharpener.

Always clean mascara, eyebrow and lip brushes after each use.

Discard soiled sponges and powder puffs.

When using face powder, try placing some in the palm of one hand. With a cotton ball, apply powder lightly to your face. Remove any excess powder with a clean cotton ball or a clean sable brush.

Remove cream from jars with spatulas, not the fingers, to avoid possible contamination.

A toothpick or an orangewood stick is helpful in applying just a dot of make-up when that's all you need to work with.

Always apply lipstick with a lip brush for better control of color.

EXCEPT FOR A THIRD GROUP I WENT TO, IT HAS BEEN MORE THAN A PLEASURE FOR ME. IT FIRST GAVE ME AN OPPORTUNITY TO DRESS !!!, AND IT GAVE ME A FEELING OF WHAT OTHERS CAN DEAL WITH THEIR SOCIAL NON-ACCEPTANCE.

JUST TO GIVE AN IDEA OF THEIR INTEREST, A MEETING USUALLY LAST AN HOUR OR SO ... THE FIRST WAS STOPPED AFTER A STEADY 2 HOURS, AND THE OTHER LAST 3 HOURS. IT ENDED AROUND MIDNIGHT, AND OUR POOR HOST WAS EXHAUSTED. HE'S NOW EX-HOSTED.

AT FIRST, THEY THOUGHT I WOULD GO ON FOR AWHILE ON MY OWN. I JUST BRIEFLY SAID THAT A TV IS MORE OFTEN A MARRIED-HETEROSEXUAL, AND THAT TV'S DON'T NECESSARILY DRESS FOR SEX!

I SAID THAT DRESSING AS A WOMAN BRINGS A SATISFACTION FOR SURE, BUT IT CANNOT BE EXACTLY THE SAME MOTIVE FOR ALL OF US... ANY WOMAN, A DAY OR THE OTHER, WILL DRESS AND MAKE-UP JUST FOR HER VERY OWN SATISFACTION, AND NOT FOR SEX APPEAL, FETICHISM, ETC..

THEN THE SHOW WENT ON BOTH TIMES! THE GROUPS HAD A FEW COMMON THINGS TO POINT OUT: THERE WAS SOME PURE INFORMATION, SOME ACCUSATIONS, SOME EFFORTS TO TRULY UNDERSTAND, EVEN SOME CARE ABOUT DIFFICULTIES IF WE GO OUT. THERE WAS ALWAYS SOMEONE WHO FOUND WHY I WAS A TV!, AN OTHER ONE BELIEIVING I CAUGHT THAT BAD DECEASE FROM SOMEONE !, AND FINALLY, THEY HAVE TO SEE HOW MUCH HOMOSEXUALITY IS INVOLVED.

THE ONLY PROBLEMS I HAD WAS AT THE FIRST MEETING, A GUY THOUGHT THAT A GIRL WAS ATTENDING THE 'MEN-ONLY' MEETING. HE WAS VERY

UPSET UNTIL HE WAS CONVINCED BY THE ANIMATOR (A VERY NICE PERSON) TO COME BACK... ANYWAY, WHEN HE HEARD ME, HE DIDN'T HAVE MUCH DOUBTS LEFT !!! THE OTHER TROUBLE WAS TO BE CRUSED!

THEY APPRECIATED THE FOR EVER CLASSIC FROM 'T A M' :  
' WHAT IS CALLED A GROUP OF TV HAVING A LUNCH ? ...  
A TV DINNER !!! < ADD HA-HA HERE >

THEY CAME UP WITH VERY PRECISE POINTS. ONE SAID, 'WHAT DO ANSWER TO THE FACT THAT TV ARE DESTROYING OUR EFFORTS TO BE ACCEPTED FROM THE POPULATION ? ' I ANSWERD THAT MAYBE GAYS ARE ALSO CAUSING PROBLEMS TO US IN THE SAME WAY! THIS IS NOT A TRUE REPLY, BUT IT BRINGS THE DISCUSSIONS TO A BETTER LEVEL.

THEY ACCEPT THE DIFFERENCES IN THE TV COMMUNITY, BUT THEY STILL TRYED TO FIGURE OUT IF WE ARE MORE OF A WOMAN THAN A MAN. THE INFORMATION I STARTED WITH, WAS A ROUGH DEFINITION OF TYPES OF TV'S. ONE OF THEM IS THE TV WHO IS GOING THROUGH PHYSICAL ALTERATIONS, LIKE TS'S DO, BUT THEY DON'T WANT ANY SEX CHANGE. THEY SOMETIMES LIVE FULL TIME AS A WOMAN.

THIS TYPE MIGHT BE THE ONE THAT POPULATION SEES MORE OF. THEY LIVE IN PUBLIC AND THEY ARE SOMETIME DEMONSTRATIVE! AN OTHER TYPE IS COMING OUT OF THE ONE BEFORE, BUT GOES THROUGH SEX CHANGE AND BECOMES LESS VISIBLE. IT SURE IS POSSIBLE TO GET A SEX CHANGE WITHOUT BEING A 'GENUINE TS' WITH TIME AND \$\$\$\$.

AN OTHER TYPE IS THE ONE THAT POPULATION DOESN'T KNOW ABOUT. IT IS A MAJOR PART OF THE TV COMMUNITY ( ESTIMATED AT 2/3 ). WE FIND IN THE COMMUNITY HOMOSEXUALS IN THE SAME PROPORTION THAT IN THE POPULATION IN GENERAL. CROSS-DRESSING AND HOMO-SEXUALITY ARE NOT CORRELATED, BUT YOU CAN FIND INDIVIDUALS IN BOTH GROUPS, AS YOU CAN FIND ANYTHING ELSE !!! FROM SOME STATISTICS IN USA, FOR A CITY THE SIZE OF MONTREAL, THERE WOULD BE 10-15 % OF GAYS.

THIS DESCRIPTION DOES NOT SUPPORT WHAT PEOPLE CAN THINK, AND IT BRINGS CONFUSION. IT PERMITTED TO BREAK A SORT OF AGRESSIVITY TOWARDS TV'S, TO MAKE PEOPLE MORE COMFORTABLE WITH THE TV GROUP, AND EVEN TO COME TO A KIND OF A DEAL ... WE

COULD GIVE US A HAND !

A PROBLEM ARISES FROM ALL THAT. IT IS THAT EITHER GAYS OR TS'S ARE USING TV'S, WHICH THEY ARE ASSOCIATED TO, TO BUILD THEIR IMAGE. IN REJECTING THE TV'S, THEY FOCUS ON THEIR PERSONNAL RIGHT TO DO WHAT THEY WANT. TS'S CAN ALSO USE THE STRONG APPETITE FOR MEDICAL STORIES TO GAIN ACCEPTANCE, BUT IT IS VERY HARMFUL TO US TV'S.

FOR ME, GENERALLY SPEAKING, A TV IS MORE A MAN THAN A WOMAN. MARRIED AND HETEROSEXUAL IN MOST CASES. DRESSING AS A WOMAN AT HOME, WITHOUT GOING OUT. HE LIKES WOMEN SO MUCH HE WANTS TO FEEL SOME OF THE THINGS HE LIKES SO MUCH. DRESSING IS A VERY PERSONNAL AND INDIVIDUAL ACTIVITY, SATISFYING PHYSICAL SENSATIONS, MORAL, SEXUAL, NAME IT ! EVEN FETICHISM ( EVEN IF NO ONE REALLY KNOWS WHAT IT IS !! ). TRYING TO IDENTIFY THE TRUE REASON IS A WASTE OF TIME IF YOUR ARE NOT A HEAD SHRINKER. OTHER PROBLEMS ARE MORE IMPORTANT.

THAT'S WHY A GROUP LIKE 'T A M' IS SO HARD TO GET ORGANIZED AND FORMALIZED. BUT TAM IS IMPORTANT BECAUSE IT TELLS, AND IT CAN SHOW TO OTHER TV'S THAT THEY ARE NOT THE ONLY ONE IN MONTREAL, IF THEY HAPPEND TO FEEL SO. IT TELLS THAT ONE TV IS NOT ALONE, HE'S NOT THE ONLY ONE AND WE ARE A LOT LIKE HIM, AND, IN A WAY, A LOT LIKE HER.

### TIME TO TALK

After a 2-3 year existance, TAM has come to a point where it has to go on his own. It means O U R own... In fact, david cassidy has to do the correnspondance, coordination, finance, etc... But every time he starts a new group or step into a new thing, others must be old enough to be independent.

in this way, David becomes a ressource person for recruting, and public relations jest to mention a couple of items.....

Last meeting, where 6 of us attented, we had a talk on that matter. The situation can be resumed around 3 points:

1. Financial support is not sufficient. David has to back it up too often, and we do not have enough money to pay the expenses. As we are not a large group it is hard to raise money and keep the membership contribution low.
2. Appartment or local for tam whould be a need if we keep meeting. It is expensive, but different possibilities are interesting. The only ways to assure us such a room are "in advance" financial contributions from members and sharing a local or appartment with other groups like 'women' and gay groups. We then could reduce the cost and define a schedule for for each group. This would permit a place to dress every week, to do corespondence, etc....
3. Activities must be discussed. Members are not maintaining their attendance for different reasons which are not all known, but real! We then need to know what members want, what they're looking for, and so on. A permanent staff must take the logistic of the group, the planning of activities, some researches must be done to explain the cross-dresser situation, etc..

This formalisation process might seem misplaced in such a group, but it sure is a way to make it grow older.

One of the solutions is finance. Here are the ways we spend it;

### Jail styles queried

SYDNEY, Australia (UPI) — Transvestites in a Sydney jail recently complained about the poor quality of women's panties being issued to them and are now receiving "French-type underwear." Instead, an opposition member charged in Parliament. Richard Healey of the Liberal party said female impersonators were also being hired to show inmates how to put on make-up and dress in female clothes. He claimed the Labor government was pandering to transvestites in the prison system at the taxpayers' expense. Corrective Services Minister Anthony Haigh said there were about 20 transvestites in New South Wales prisons and they were allowed to wear make-up, slacks and female underclothing, but no other women's apparel.

### Dress ban rescinded

HOUSTON — (UPI) — City Council has rescinded an ordinance prohibiting persons from dressing in clothing of the opposite sex. A federal judge earlier this year ruled the ordinance violated the civil rights of transsexuals who were required to dress in the clothing of the opposite sex before undergoing sex change surgery.

Dear Sisters:

This is my second article to you on the prison in Canon City, Colo. Have any of you out there lived in a "Closet"? Well the conditions here at the Colorado State Prison were taken to Federal Court in the first part of this year by the inmates. Things such as living conditions, exercise, church, food preparation, medical facilities, and medications were just a few of the things that were argued in court, but to no avail.

This prison was constructed in the early 1800's and is still being run as if it were back then. The living quarters where we live are approximately 7' by 4' X 3', with a sink and toilet in the same cell. We are locked up for twenty-two of the twenty-four hours, and receive only three showers a week. The Federal Court's ordered that the prison be closed down as it has been condemned, but the state has appealed this ruling so that they wouldn't have to release anyone, and that they could continue with their mediaeval existence. So this prison is still open and running as strong as ever.

The Transsexual's and Transvestites's that testified of the conditions are constantly being put through abuse, wheather it be verbal or physical, there is no stopping this harassment. There are guards here who treat the Transsexual and Transvestites worse than the inmates themselves do. It has established a fear in all of us because we have to do what they want or suffer the consequences.

This prison looks like an old western movie set, and the guards have the same mentality. The only thing that could or would change the conditions of this place were if a demolition crew came in and destroyed the place. The prison is privately owned and state operated. There is enough iron and steel in here to make some one rich for the rest of there lives. So while the appeal is in and the new prison is going up at the rate of one cell house a day. This (the old prison) or what some call the old max, is still open and being run with the total disregard and disrespect as it always has and will continue to be run when the new prison is completed.

So this sister is asking for your help, for all the sister's in here. We need donations so that we may hire an attorney to help all the Tansvestites and Transsexuals to be transfered or released from this "Hell-Hole" we now live in. Any donations to this cause would be greatly appreciated. We are trying to raise a thousand dollars for a very good and costly attorney.
