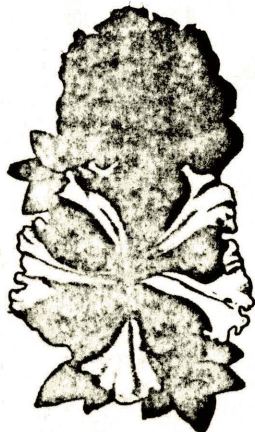
For the Spring of 1984 we have tentatively scheduled a program on self-defense for TVs, and a program on the religious aspects and implications of crossdressing.

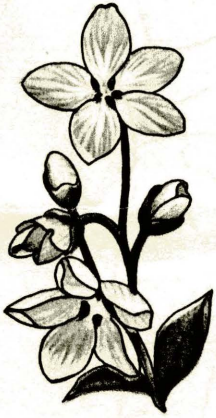

Part 2

(OUR TRANSCRIPTION OF THE NEW YORK AMERICAN CIVIL LIBERTIES UNION, AS REPRESENTED BY MR. CHRIS HANSEN, ESQ., CONTINUES.)

"We talked a little bit earlier about having a lawyer available in case you face criminal law problems. I think that that's very good advice. I think that arrest is a very traumatic experience and it would be a particular traumatic experience if it happens to you. Traumatic and embarrassing and I think that is very good advice to have a lawyer you can call. You should understand that you are going to need a lawyer who you can reach off hours and non business hours and be sure that if you have a lawyer and these problems arise, that you have the lawyer's home number so that there is some way you can reach him or her off business hours otherwise you're likely to spend the evening in jail waiting for some one to come and deal with the problem, that is, if you run up against a police department determined to do something like that.

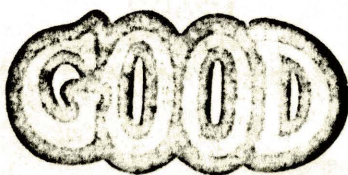
The next question that was raised with me is what is the general attitude among law enforcement people and the legal profession toward the behavior which all of you engage and I haven't the faintest idea as to how to answer that question. I suspect that the range of attitudes varies as much in the legal profession and the police profession as it does in any profession. I suspect that there are many lawyers who are very sympathetic and many lawyers who are totally unsympathetic. I suspect that the same is true of the police. My guess would be that in recent years police have become more, if not sympathetic, aware, and probably lawyers as well. But I think you meet with the full range of attitudes.

What should you do if you are stopped by the police for a traffic violation or something like that? I don't know the answer to that. As a lawyer I am obligated to tell you that the answer is to tell the truth and you should not be deceptive in any way. And that is probably good advice even if it were the only thing I'm ethically supposed to say. Its probably good advice because the degree to which you are deceptive increases the risk of a particular officer.

being unhappy or angry with you and given the vagueness of the kinds of laws that apply, and give the laws that exist that would be inaccurately but possibly applied, it is probably a good idea anyway. So I guess my advice would be to be perfectly honest about the situation. I would also not make a big deal of it; I would downplay the situation as much as I could. I wouldn't volunteer complications where they don't exist. If you're being stopped because you have a busted tail light and the cop is simply telling you to fix the tail light, I wouldn't volunteer any information that you don't need to volunteer. But if asked I would be honest about it.

The next question asked me is what recourse do you have should you be intimidated or threatened by you employer. And I guess the next one which is a related one is should you be degraded or embarrassed after public incident what recourse do you have. As I said earlier, the Constitution only applies to public action, action by the government. So, if an employer fires you because he has learned of the behavior or embarrasses you, there is no Constitutional recourse for that at all unless the employer is a public agency. If it is a public agency, you may well have some recourse. The law says that in addition to all the union kinds of things you can't fire a public employee for reasons unrelated to the job. I am unaware of any case in which the precise issue has been raised as to whether your off hours behavior would be considered related to the job in any way. It seems perfectly clear to me that it is not, but the issue has never been raised as far as I know. And the same thing I've said about police and lawyers is true of judges; some of them are sympathetic and some are not, some are understanding, and some are not. So if it is a public employer you may have some recourse, if it is a private employer you probably don't have any recourse unless you have a contract or a union, or unless the city or state in which you live has passed some sort of special law protecting your particular rights. In New York City as you may or may not know there is a special order issued by the mayor which protects against discrimination on the basis of 'affectional preference', in any employment. People who contract with the city. To the best of my knowledge this has never been applied in this context (our situation). Whether it would be applied in this context or not, I just don't know.

But that raises the more general question. What we've been talking about so far is essentially what the law is and what the potential rights you actually have at the present. As I've said at the beginning, the purpose of the Civil Liberties Union is to try to

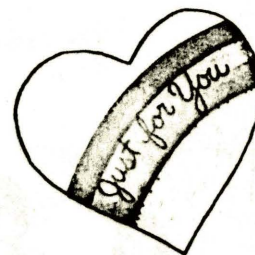


extend peoples' rights and to create new rights for people. The New York State ordinance had been challenged unsuccessfully in the mid '60's. Similar ordinances, however, have been challenged in other states, more recently, successfully, and have been struck down as unconstitutional. And, in legal terms, the difference between the mid '60's and the mid '80's is reasonably considerable. It is possible that if a similar issue was raised today a different result would obtain. I can't say that it is likely, but is possible. And similarly, as I talked about another example viz. the mayor's Executive Order, as I said no one has ever raised the question as to whether the mayor's order might apply to your group or not. That is another area in which there is room for litigation if somebody wanted to make a challenge to those kinds of problems. The difficulty with raising challenges to the statutes, the mayor's Executive Order, or any of the other kinds of statutes that you might face as a test case issue trying to challenge the Constitutionality of these issues. The problem with that is that it is time consuming, can be reasonably public, and there is no guarantee of success. In the instances of challenges to these kinds of issues...what were the facts of your arrest, but is there a way we can challenge the law, the Civil Liberties Union would be sympathetic to discussing representing you in that context. But as I say you have to understand that challenges to the Constitutionality of the New York State statutes or to interpretations of the mayor's Order or the other kinds of issues that might arise could conceivably leave you open to a lot of attention.

And we can and do try in situations like this (the abortion context is the best example), to make the plaintiffs as anonymous as possible, but there is never a guarantee of that occurring. On the other hand, if you have been arrested and for some reason convicted, it may be worth the effort for the embarrassment might be over at that point and it might be worth the effort to fight it. I would urge, as I said earlier, each of you to make some sort of contact with a lawyer in your area who you think might be sympathetic. If you have doubts about finding such a person I'd be happy to refer you to one, at least in the city. I suspect that if I got in touch with the New Jersey or Connecticut offices of the ACLU, they could do as well.

Then, in addition, if the issue appears to raise a broader concern, that the statute is unconstitutional, that there are new ways in which we can extend the rights of the population, I think that you should feel free to call us in whichever state the incident occurs. In New York it would be me. I'd be happy to discuss the possibility of representing any of you should that situation arise."

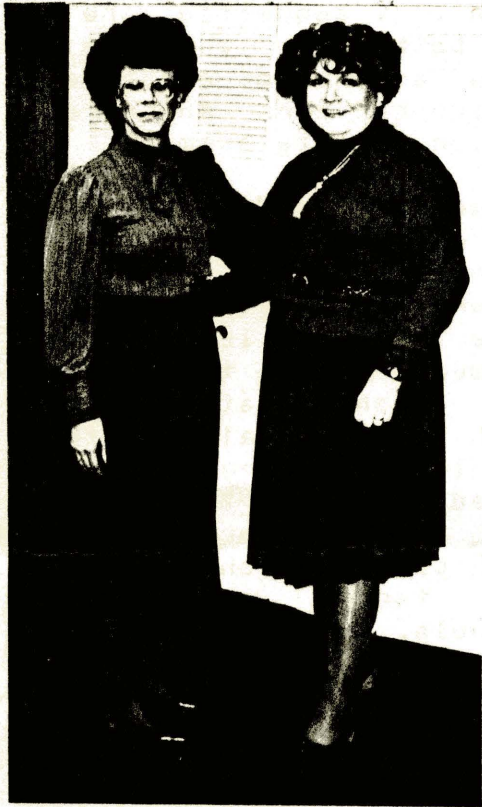

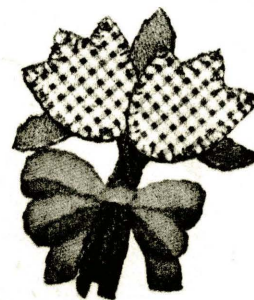
'Oh, just the usual stuff, beach, bike riding, and just plain fun'. 'Good', said my uncle, and they were off to the city.

... "Here's a good hint for the TV members and also for our wives. Cover Girl has a 'new' (how new I don't really know), item called Gloss Boss. Its a nail buffer on one side and two surfaces on the other side for: 1) very fine emery abressive and 2) even finer abressive. Follow the directions: use blade 'buff' (the emery), every 2 weeks or so, followed by the white buff. Finish with the gray (finest), for a high gloss. Use the gray every day or two to keep the high gloss. Actually, the result is almost as glossy as using clear polish. I don't use clear polish but some of the men I know do. 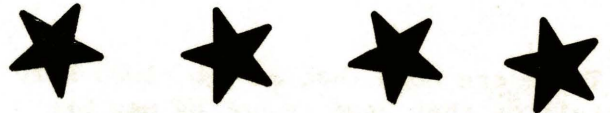

SOLUTION

There are more than enough clues here to help the solver. For instance, Clues 2 and 4 tell us that Jane cannot be Ms. Green and Jean is not Ms. Brown. But let's start with who ordered which drink.

Ms. Green ordered a Tom Collins (Clue 2). Since Ms. Gray ordered neither Sangria or ginger ale (Clue 1), but did choose a drink without distilled spirits (Clue 7), her preference was white wine. The Sangria drinker is not Ms. Brown (Clue 1) or Ms. White (Clue 5), so she must be Ms. Black. Ms. Brown did not order ginger ale (Clue 1); the person who did was Ms. White ... and Ms. Brown requested the Dacquiri.

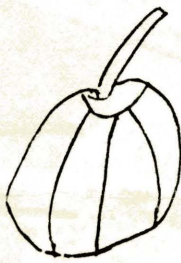
Jean ordered neither a Dacquiri or white wine (Clue 3), nor did she order a Tom Collins (Clue 2) or ginger ale (Clue 6). Her preference was Sangria ... and her last name, therefore, is Black.

Ms. Brown, who enjoyed the Dacquiri(s), is not Jane (Clue 4), Jan (Clue 3), or Joan (Clue 7). So her first name is June.

Since Ms. Gray ordered white wine, she cannot be Jan (Clue 3) or Joan (Clue 7). Her name is Jane. Joan didn't order a Tom Collins (Clue 7); she selected ginger ale ... and is Ms. White. Ms. Green's first name, therefore, is Jan.

To summarize names and refreshment orders:

Jean Black	- Sangria
June Brown	- Dacquiri
Jane Gray	- White wine
Jan Green	- Tom Collins
Joan White	- Ginger ale
